# E ect of A tom ic C oherence on A bsorption in Four-level A tom ic System s: an A nalytical Study

#### Abstract

A bsorption pro le of a four-levelladder atom ic system interacting with three driving elds is studied pertunbatively and analytical results are presented. N um erical results where the driving eld strengths are treated upto all orders are presented. The absorption features is studied in two regim es, i) the weak $m$ iddle transition coupling, i.e. $2 \ll 1 ; 3$ and ii) the strong $m$ iddle transition coupling $2 \gg 1 ; 3$. In case i), it is show $n$ that the ground state absorption and the saturation characteristics of the population of level 2 reveal deviation due to the presence of upper level couplings. In particular, the saturation curve for the population of level 2 show sa dip for $1=3 \cdot W$ hile the populations of levels 3 and 4 show a $m$ axim a when this resonance condition is satis ed. Thus the resonance condition provides a criterion for m axim ally populating the upper levels. A second order perturbation calculation reveals the nature of this $m$ in im a ( $m$ axim a). In the second case, I report tw o im portant features: a) F iltering of the A ulter-T ow nes doublet in the three-peak absorption pro le of the ground state, which is achieved by detuning only the upperm ost coupling eld, and b) control of line-w idth by controlling the strength of the upper coupling elds. This lering technique coupled w ith the control of linew idth could prove to be very useful for high resolution studies.


## 1 Introduction

It is well know $n$ that the controlof absorption and em ission properties of atom $s$ $m$ ay be achieved by controlling the nature of atom ic coherence. D riving eld strengths and detunings provide the necessary tuning param eters to achieve th is control. M ulti-levelatom shave the advantage of providing a larger set oftuning param eters. Three levelatom s show a class of phenom ena which are absonption
inh ibitive [ill while four-level system s have show $n$ absonption inducive features
 seen in four level system s is attributed to the interaction of double dark resonances [1] [ which has also been reported earlier [1].]. O ther features which have been re-
 (tw o-photon absonption) [G] [G], fast sw itching of nonlinear absonption [T] $]$, enhance$m$ ent and suppression of two photon absonption [ig and the occurrence of three
 properties and the $m$ odi cation of the ground state absonption due to the additional upper transition couplings. In section II the details of the model is described and the equation of $m$ otion is set up. P revious studies [1] ] have revealed that the dynam ics of four-level atom $s$ interacting $w$ ith three driving elds $m$ ay be classi ed into tw o broad dom ains, i) the weak $m$ iddle transition coupling and ii) the strong $m$ iddle transition coupling. H ence, the analysis is presented separately for these tw o cases in sections III and IV respectively. In both the cases analytical results are derived perturbatively and the qualitative features are com pared w th exact num erical calculations which are illustrated graphically.

## 2 Equation ofm otion.

The model we consider consists of a four-level ladder system shown in F ig 1. The only dipole allowed transitions are $1 \$ 2,2 \$ 3$, and $3 \$ 4$ coupled respectively by the Rabi frequencies $1 ; 2 ; 3$ and the $B$ ohr frequencies are denoted by $!i_{i} i=1 ; 3$. The decay constants corresponding to the respective levels are denoted by $\quad i, 1,4$. T he frequency of the applied elds are denoted by $!_{L_{i}} ; i=1 ; 3$ and the detunings are denoted by $i ; i=1 ; 3$ corresponding to the three couplings. T he analysis presented here can also in principle be valid to any other type of 4-level system w ith transitions such that not m ore than tw o dipole transitions share a single level. This could include ' $N$ ' type system s as well as the $m$ irror re ected ${ }^{N}$ ' type system $s$. $T$ his particular ladder system $m$ ay be identi ed, for exam ple w ith the Rb hyper ne levels. For instance, the $5 s_{\frac{1}{2}} ; 5 p_{\frac{3}{2}}$ and $5 d_{\frac{5}{2}}$ could correspond to the three levels $w$ ith an additional hyper ne levelcorresponding to either $5 p_{\frac{3}{2}}$ or $5 d_{\frac{5}{2}}^{2}$. In fact the decay param eters of the $m$ odel have been chosen to be the sam e as the decay constants of these levels, $2=6 ; 3=$ and ${ }_{4}=$ in term $s$ of the ground state life time which is chosen to be one for convenience. The density $m$ atrix equations ( [12 $\left.2^{1}\right]$ ) are w ritten in the rotating wave approxim ation as

where $i$ are the decay constants of the levels $i$ and $i_{i}=!_{i ; i+1} \quad!_{i}$ are the laser detunings $(i j=j i$ and $\operatorname{Tr}=1): W$ e study the steady state behaviour of the system for various values of the driving eld strengths and detunings. In the general situation, we present the num erical solutions to the populations and coherences where the driving eld strengths are treated up to all orders. The m odi cation of the absorption pro le of the ground state as well as the upper levels $w$ illibe studied analytically by perturbatively solving for the density $m$ atrix elem ents in 2 or 1 as the case $m$ ay be.

## 3 W eak m iddle transition coupling.

In the case when the transition $2 \$ 3$ is weakly coupled, i.e. when 2 is very sm all com pared to ${ }_{1} ; 3$, the equation of $m$ otion for the density $m$ atrix elem ents can be solved perturbatively in 2 . The set of fteen coupled equations decouples into three subsystem $s$ of equations which are solved independently to obtain analytical solutions. In fact, the density $m$ atrix elem ents given by the sets f 11 ; 22 ; 12 ; 21 g;f 33 ; 34 ; 43 ; 44 g and f 23 ; 13 ; 14 ; 24 form three subsystem s . The zeroth and rst order solutions for $i j ; i ; j=3 ; 4$ rem ain zero, while the coherences $\mathrm{f} 23 ; 24 ; 13 ; 14 \mathrm{~g}$ are nonzero in the rst order and are listed in the A ppendix. T he steady state second order solutions for ij are listed below :

H ere, for convenience we have relabeled $i=2$ everyw here by $i$. The second order steady state solutions for the set of coherences f 23 ; 13; 24; 149 are the sam e as the rst order solutions given in the A ppendix.
$N$ ote that, in the lim it $2!0$ and $3!0$, the solution for 12 and 22 are given by the zeroth order solutions which is the usual absonption and population of tw o-level system driven by a eld of strength 1 . There is very littlem odi cation in 12 and 22 due to the rst order contribution. H ow ever the inclusion of the second order contribution introduces additional term s. Before investigating this further, let us look at the graphical ilhustration of the ground state absonption as a function ofdetuning which has been solved num erically for all orders in the driving eld strengths. In $F$ ig 2 the curve corresponding to (a) show s the absorption in the presence of only $1 \$ 2$ coupling, (b) corresponds to the absorption of the ground state ( $\mathrm{g} . \mathrm{s}$. ) in the presence of the $1 \$ 2 \mathrm{as}$ well as the $2 \$ 3$ couplings and (c) show s the m odi cation of the $g \mathrm{~s}$. absorption in the presence of the 1 \$ 2 the rst excited state coupling $2 \$ 3$ and the $3 \$ 4$ coupling. H ere the $s m$ alldip in the line center is not due to population trapping but due to the population transfer to the upper levels which is because of the inclusion of the upper most transition coupling. This becom es m ore clear by looking at equations (2) and (3) which willbe discussed shortly. Let us look at

the variation of the populations of various levels as a function of 1 and 3 for very weak ${ }_{2}$. Fig3-5 show the variation of populationsw r.t. 1 and 3 which have been obtained num erically. N ote that 22 shows a dip in the absonption when ${ }_{1}=3$. There is how ever a corresponding increase in the populations of the upper levels. Fig4 and Fig5 show a sharp increase in the absonption by level 3 and 4 respectively as 1 approaches 3 and show $s$ a maxim a for $1=3$ when $2=2$.

O ne can explain this analytically by looking at the second order solutions. C onsider the situation $w$ hen all the detunings are zero and ignoring the contribution of the decay param eters $O\binom{2}{i}$ i.e. assum ing $1 ; 3 \gg \quad 2 ; 3 ; 4$ for $i=0$, the populations reduce to the sim ple form

It is obvious from these expressions that there is a resonance at $1=3$. The populations ${ }_{33}^{(2)}$ and ${ }_{44}^{(2)}$ show a shanp rise as

1 ! 3 since the num erator is positive. Thus to populate the levels 3 and 4 $m$ axim ally $w$ hen the $m$ iddle level coupling is weak, it is su cient to $m$ atch the requirem ent ${ }_{1}=3$. The absonption pro le Im ${ }_{34}^{(2)}$ also show sa sim ilar trend. W hile the second term in ${ }_{22}^{(2)}$ and ${ }_{21}^{(2)}$ are negative and the role of the resonance in the denom inator is to introduce a $m$ inim a when ${ }_{1}=3$. Thus the role of the second order term in this case, is to introduce a dip in the line center in an otherw ise two-level absonption pro $l e$ and hence a depletion in the population of level 2. A s one increases 2 this perturbative expansion is no longer valid. $M$ oreover, the num erical calculations upto all orders in 2 reveal the fact that the resonance condition becom es weaker and the shapp features vanish. This is dem onstrated graphically in F ig6-8.

Thus, in a four-level system w ith m iddle transition coupling very weak, the condition for $m$ axim ally populating the upper levels is to satisfy this resonance condition. The population transfer to higher levels occurs at the cost of depletion of population in the second level. This modi cation is m ediated by the contribution of the coherences, which at three photon resonance are

## 4 Strong m iddle transition coupling

I next consider the case when the 2 ! 3 transition is strongly coupled i.e., $2_{2} \gg 1$; 3. Treating 1 perturbatively, the rst order absonption of the ground state takes the simple form

where 2 is assum ed to be zero. The denom inator is quadratic in ${ }_{1}^{2}$ and hence has two peaks corresponding to the usual A utler-T ow nes doublet. The w idth of this E IT w indow is proportional to $\left(\begin{array}{llllll}2 \\ 2\end{array}+\begin{array}{lll}2 & 2 & 2 \\ 2\end{array}\right)^{2} \quad 4\left(\begin{array}{ll}2 & 3\end{array}{ }_{2}^{2}\right)$. The absonption for $1_{1}=0$ (at the line center) is proportionalto $1 \begin{aligned} & 1\end{aligned}=\left(\begin{array}{lll}2 & 3\end{array}{ }_{2}^{2}\right)$ which is negligible since it is of the order ${ }_{1}={ }_{2}^{2}$. The absorption in the presence of the third driving eld for $2=0 ; 3=0$ takes the simpli ed form

 in ${ }_{1}^{2} \mathrm{w}$ th the three roots corresponding to the three absorption peaks, two of them correspond to the usual A utler -Tow nes doublet and the absorption at the line center is due to the three photon interaction and is proportional to

This three peaked absonption in four level system s has been observed earlier and has been frequently referred to as the splilting of the EIT w indow. W hile the role of the strong 2 \$ 3 coupling was to introduce transparency at the line center, the role of the $3 \$ 4$ coupling is to induce a narrow absorption at the line center w ithin the EIT w indow. Thus the two photon absonption was responsible for the coherence 31 which in tum lead to non-absonption while, the three photon absorption which introduced a coherence betw een levels 1 and 4 (41) which in tum induced this shanp absonption feature. T hus there is a contrast in the nature of the quantum interference in the case of two and three photon interaction.

On the other hand consider the case when the detuning 3 is nonzero. Let $1_{1}=0 ; 2=0$, the absonption now reduces to

This is a Lorentzian w ith w idth proportionalto $\quad 2 \quad \frac{2}{3}={ }_{2}^{2}$. This implies that the line w idth can be subnatural $(<\quad 2)$ for $\quad 3<2$. N otioe the novel feature here which is the absence of the A utler-T ow nes doublet unlike the case when only

1 was nonzero. Thus, we now have obtained a pow erfultechnique for ltering the A utler-T ow nes doublet and retaining only the narrow absorption at the line center in addition to gaining controlover the linew idth. This could prove to be a useful technique in high resolution spectroscopy.

A num ericalillustration of these novelfeatures is presented in $F$ ig 9 w here the steady state solutions are obtained for all orders in the driving eld strengths. $F$ igure 9 clearly show sthe di erence in the behaviour depending on the strength of the $m$ iddle transition coupling. a) corresponds to weak $2 \mathrm{while} \mathrm{b)} \mathrm{corre-}$ sponds to strong $2 \cdot F$ ig $9 A$ to show s the three peaked absonption while $F$ ig9B to show sthe elim ination of the A utler-T ow nes doublet by detuning the driving eld coupling 3-4 transition as predicted by the perturbative calculations. Likew ise for sm all 2 , only the narrow absonption dip at the line center is seen by detuning 3 ( $F$ ig 9A -a and $F$ ig9B $-a$ ). A gain, $\operatorname{Im} 32$ for $s m a l l ~ 2$ is very strong ( $F$ ig9C-a) as the perturbation calculation indicate (section III) and this absonption is not very signi cant for large 2 since the resonance condition weakens and the contribution of higher order term $s$ in 2 dom inate. Lastly, the absonption pro le of the uppem ost transition does not seem to vary m uch $w$ th either of the detunings 1 or 3 ( $F$ ig9 $\mathrm{Eb}, \mathrm{F} \operatorname{ig} 9 \mathrm{~F}-\mathrm{b})$. Th is is very m uch sim ilar to the narrow g.s. absonption at the line center. Further, both the absorption of the g.s. (line center) and the upperm ost transition Im 43 are una ected by the detunings $1_{1}=3$ since they occur at exact three photon resonance. O ne w ould expect this absonption feature also to be D oppler-free like the g.s. absonption ["].

N ext the variation of the absorption of the g.s., Im 21 , the rst excited state Im 32 and the second excited state $\operatorname{Im} 43 \mathrm{w}$ th the driving eld strength 3 and the detuning 3 are num erically ilhustrated in $\mathrm{Fig} 10-12$. T he purpose here, is to dem onstrate the three photon e ect. W hile the ground state absonption increases $w$ ith 3 , the $m$ iddle and the upper transition absonptions rise sharply for sm all 3 and fall rapidly to zero. A ll the absorption occurs only for $3=0$. $T$ he variation $w$ ith 2 show $s$ lot $m$ ore structure and $w i l l$ be $m$ ore appropriate to present it else where.

To sum $m$ arise, it is show $n$ that by satisfying the resonance condition ${ }_{1}=$
3 one can $m$ axim ally populate the upper levels at the cost of depleting the population of level2 (for sm all 2). In the case of large 2 it is shown that one can get narrow absorption features at the line center by ltering of the A utlerTow nes doublet. O ne also has a control over the linew idth by controlling 2 and 3. The quallative features predicted by perturbative calculations seem to agree very wellw ith the num erical results.
