Electronic Noise in Optical Homodyne Tomography

The e ect of the detector electronic noise in an optical hom odyne tom ography experiment is shown to be equivalent to an optical loss if the detector is calibrated by measuring the quadrature noise of the vacuum state. An explicit relation between the electronic noise level and the equivalent optical e ciency is obtained and con meed in an experiment with a narrow band squeezed vacuum source operating at an atom ic rubidium wavelength.

a. Introduction Optical homodyne tomography (OHT) is a method of characterizing quantum states of light by measuring the quantum noise statistics of the electrom agnetic eld quadratures at dierent phases. Theoretically proposed in [1] and rst experimentally implemented in the early 1990s [2], OHT has become a standard tool of quantum technology of light, in particular in quantum information applications.

OHT is prone to a variety of ine ciencies, of which the main one | the optical losses (OLs) | is due to absorption in beam paths, non-unitary e ciency of the photodiodes, in perfect balancing of the detector, and, partially, in perfect mode matching between the signal and the local oscillator modes β]. A lso, the presence of non-mode-matched signal light appears as added noise in the detector, raising the apparent noise oor β]. A ll O Ls can be modeled by an absorber in the signal beam path. The e ect of OL in quantum state reconstruction is wellunderstood, and there are ways of both its quantitative evaluation and compensation for its e ects in the quantum state reconstruction procedure [4, 5].

An important additional ine ciency source is the electronic noise (EN) of the hom odyne detector. Its e ect is the addition of a random value to each quadrature m easurement, which blurs the marginal distribution and causes errors in quantum state reconstruction. Unlike the optical ine ciency, the EN, to our know ledge, has not yet been studied, and is usually neglected whenever an e ciency analysis is made [6{12].

The purpose of this paper is to llthis gap and to analyze the role of the electronic noise in OHT.We show its e ect to be equivalent to that of optical losses. The key to this equivalence is the detector calibration procedure, which involves m easuring the quadrature noise of the vacuum state. Applying this procedure to the vacuum state contam inated with the EN results in rescaling of the eld quadratures, analogous to that taking place due to optical absorption.

We con m our experimental ndings in a squeezing experiment, in which we vary the local oscillator power to achieve di erent signal-to-noise ratios of the hom odyne detector. The squeezed vacuum source is a narrow band, tunable continuous-wave optical parametric ampli er operating at a 795-nm wavelength.

We begin our theory by writing the e ects of both ine ciency types on the reconstructed W igner function (W F).

b. The beam splitter model for optical signal boss A coording to the beam splitter model of absorption, nonunitary optical ciency modi es the W F W (X;P) of the signal state as follows [4]:

This transformation can be understood by visualizing the absorber as a ctional beam splitter with the signal beam entering one port and the vacuum state entering the other. Transmission of the signal eld through the beam splitter rescales the eld amplitudes by a factor of

 $^{1=2}$. The vacuum state re ected from the beam splitter into the signalm ode adds noise, which expresses as a convolution of the W F w ith a two-dimensionalG aussian function of width $\frac{p}{1}$.

c. E ect of the electronic noise In the absence of the electronic noise, the electric signal (voltage or current) V generated by the hom odyne detector is proportional to the quadrature sample X : V = X. The coe cient

has to be determ ined when quantum state reconstruction is the goal. This is usually done by means of a calibration procedure, which consists of acquiring a set of quadrature noise samples fV_{0ig} of the vacuum state, prepared by letting only the local oscillator into the detector. The vacuum marginal distribution,

W hen the EN is present, the observed probability distribution of the electric signal is a convolution of the

scaled m arginal distribution pr(X) of the state m easured and the electronic noise histogram $p_e(V)$:

(the factor of is added to retain the norm alization of the marginal distribution). Under realistic experimental conditions of a broadband electronic noise, its distribution can be assumed G aussian:

where T is the mean square noise magnitude.

Consider the detector calibration procedure in the presence of the EN. According to Eqs. (2), (4), and (5), the vacuum state m easurement yields a distribution

with a mean square of $W_0^2 i = (^2 + T) = 2$. If no correction for the EN is made, the quantity

is interpreted according to Eq. (3) as the conversion factor between the electric signal and the eld quadrature.

In a hom odyne m easurem ent of an unknown state, one acquires a set of samples from the hom odyne detector, and then applies the calibration factor 0 to rescale its histogram $pr_{\rm E\,N}$ (V) and obtain the associated m arginal distribution. Using Eq. (4), we write

Introducing a new integration variable X $^{0} = V ^{0} = ^{0}$ and utilizing the EN distribution (5), Eq. (8) can be rew ritten as

This rescaled, noise contam inated marginal distribution is then used to reconstruct the W igner function.

Because the marginal distribution is tom ographically linked to the W F, $\frac{7}{2}$

d. Equivalence of the e ciency loss mechanisms C omparing the above expression with Eq. (1) for the W F of a state a ected by optical losses, we not that the two are equivalent if we set

In other words, we may treat the electronic noise as an additional optical attenuator with a transm ission equal to $_{\rm eq}$. A coordingly, the known num erical procedures for correcting for optical losses can be readily applied to the electronic noise.

This result m ay appear surprising. The eld quadrature noise m easured in the presence of the EN is a convolution of the W F's m arginal distribution with the noise histogram. In the case of OL, on the other hand, the convolution is preceded by rescaling of the quadrature variables. The similarity between the e ects of the two ine ciency emerges due to the detector calibration procedure. The vacuum state m easurement is distorted by the EN but not the OL, hence there is additional rescaling of the quadratures in the presence of the EN.

For experim ental applications, it is more convenient to express the equivalent e ciency in term softhe signal-tonoise ratio of the detector. By the latter we understand the ratio between the observed mean square noise of the vacuum state (in the presence of the EN) and the mean square electronic noise, i.e. the quantity

A sevidenced by this equation, reasonably low electronic noise does not constitute a signi cant e ciency loss. For exam ple, the original time-dom ain detector of Sm ithey and co-workers [2, 6], featuring a 6 dB signal-to-noise ratio (i.e. the rm s quadrature noise being only twice as high as the rm sEN) has an equivalent quantum e ciency of 75%. A similar equivalent e ciency is featured by a high-speed detector by Zavatta et al. [13]. A 14-dB time-dom ain detector of H ansen and co-workers [14] has an equivalent e ciency of 96%, and a typical frequencydom ain detector with a signal-to-noise ratio of 20 dB has an e ciency of 99%.

e. Experiment W everify our theoretical ndings in a squeezing experiment. The squeezed vacuum source is a continuous-wave optical parametric amplier (OPA), operating at the 795-nm wavelength of the D1 transition in atom ic nubidium. We have constructed this source to perform experiments on interfacing quantum information between light and atoms, in particular storage [15,16] and R am an adiabatic transferring [17,18] of light in atom ic vapor. Sim ilar sources have been reported very recently by two groups [19, 20]




FIG.1: Quadrature noise spectrum of the squeezed vacuum generated by the OPA, obtained by a simultaneous scan of the local oscillator phase and the detection frequency. The green line is the shot noise spectrum.

The optical cavity of the OPA is of bow-tie con guration com posed of four mirrors, among which two are at and two are concave with a curvature radius of 100 mm. The cavity is singly resonant for the generated 795-nm wavelength. As the output coupler we use one of the at cavity mirrors, which had a re ectivity of 93%. O ther cavity mirrors had an over 99.9% re ectivity. W ith these parameters, the cavity had a 460-M H z three free spectral range with the resonant line width of 6 M H z

The source employs a 5-mm long periodically poled K T iO PO₄ crystal as the nonlinear element. The crystal, manufactured by Raicol, features a 3.175 m poling period and double antire ection coating on both sides. It is placed at the beam waist between the curved m irrors.

The OPA is pumped by up to 240 mW of 397.5 nm light. The pump eld is the second harmonic of a frequency stabilized titanium -sapphire master laser. The same laser is used to provide the local oscillator for the hom odyne detector. The OPA cavity is locked at resonance by m eans of an additional diode laser phase locked to the master oscillator at 3 free spectral ranges of the OPA cavity. The cavity lock is in plem ented using the Pound-D rever-H allm ethod, using a beam m odulated at 20 M H z and propagating in the direction opposite to the pumped m ode.

The circuit for hom odyne detection uses two Ham am atsu S3883 photodiodes of 94% quantum e ciency in a back-to-back" con guration, akin to that employed in Refs. [13, 14], followed by a OPA 847 operational pream pli er. The detector exhibits excellent linearity and an up to 12-17 dB signal-to-noise ratio over a 100-M Hz bandwidth, with local oscillator powers up to 10 mW. At a 1-M Hz sideband relevant for this experiment, the highest signal-to-noise ratio of the detector exceeds 17 dB, which, according to Eq. (14), corresponds to equivalent optical losses of only 2%. The detector output is observed in the frequency dom ain using an A gilent E SA spectrum




FIG.2: Experimental results. a) Observed shot noise as a function of the local oscillator power. A loo displayed is a linear t and the electronic noise level. b) Observed squeezing as a function of the local oscillator power. The solid line is calculated using Eq. (4).

analyzer.

Figure 1 shows the electronic spectrum of squeezed vacuum eld generated by the OPA.Up to 3 dB of squeezing is observed within the cavity linewidth.

To verify the predictions of Eq. (14), we stabilize the pum p level at 140 m W and set the spectrum analyzer to run in the zero span mode at a detection frequency of 1 MHz. The signal-to-noise ratio of the detector is varied by changing the local oscillator intensity. At each intensity value, we record three spectrum analyzer traces: electronic noise (measured by blocking both photodiodes of the hom odyne detector), shot noise (m easured by blocking the squeezed vacuum signal) and the phasedependent squeezed vacuum quadrature. The highest $(hQ_{+}^{2} i)$ and lowest $(hQ_{+}^{2} i)$ quadrature noise levels of the squeezing m easurem ent are then determ ined and norm alized to the shot noise level. The uncertainty of hQ^2 i is estim ated as 0.2 dB; it is much sm aller for the shot-noise and electronic-noise data. The results of these m easurements are shown in Fig.2.

To determ ine the quantum e ciency, we use the fact that for the pure squeezed state, the product of the m can square quadrature uncertainties is the m inimum allowed by the uncertainty principle, i.e. $\ln Q_{pure;+}^2$ in $Q_{pure;+}^2$ i = 1=4, where the norm alization factor corresponds to the




FIG.3: Equivalent quantum e ciency $_{\rm eq}$ as a function of the detector's signal-to-noise ratio S. This ratio is expressed in decibels as 10 \log_{10} S. Both the experim ental results and the theoretical preediction (14) (multiplied by an optical e ciency factor of 0.51) are displayed.

shot noise level. A fler undergoing an optical loss, the squeezed state rem ains G aussian, but loses its purity. Using the beam splitter model of absorption, we nd that upon propagating through an attenuator of transm ission

, the quadrature noise reduces by a factor of , but gains excess vacuum noise of intensity 1 :

M easuring hQ_{+}^{2} i and hQ_{-}^{2} i and solving Eqs. (15), we can nd the value of , i.e. how much loss a pure squeezed state would have experienced to generate the state with the quadrature noise levels observed [21]:

The result of applying this method to our squeezed vacuum data is displayed in Fig. 3 along with a twith Eq. (14) multiplied by an overalle ciency factor of 0.51 (emerging due to various optical losses). The experimental data matches well to the theoretical prediction.

f. Conclusion W e have found that there is a strong sim ilarity between the e ects of optical absorption and electronic noise on the state reconstructed by m eans of optical hom odyne tom ography. Therefore, the detector's G aussian electronic noise can be treated as an additional optical loss which is related to the detector's signal-tonoise ratio by Eq. (14). The nding is veried in a squeezing experiment involving a narrow band nonclassical light source suitable for experiments on interfacing quantum information between light and atom s.
