## Building Gaussian Cluster States by Linear Optics

The linear optical creation of G aussian cluster states, a potential resource for universal quantum com putation, is investigated. We show that for any G aussian cluster state, the canonical generation scheme in terms of QND -type interactions, can be entirely replaced by o -line squeezers and beam splitters. M oreover, we nd that, in terms of squeezing resources, the canonical states are rather wasteful and we propose a system atic way to create cheaper states. A s an application, we consider G aussian cluster com putation in multiple-rail encoding. This encoding may reduce errors due to nite squeezing, even when the extra rails are achieved through o -line squeezing and linear optics.

Introduction. | The cluster-state model for quantum computation [1] is a conceptually interesting alternative to the more conventional circuit model [2]. Once a suitable multi-party entangled cluster state has been prepared, universal quantum gates can be e ected through the cluster via only single-party projective measurements and feedforward. Though originally based upon qubits, the cluster-state model can be also applied to other discrete-variable systems (qudits) as well as to continuous quantum variables [3].

Linear optics represents one of the most practical approaches to the realization of quantum inform ation protocols, both for discrete-variable (DV) [4] and continuous-variable (CV) in plementations [5]. In the DV case, e cient entangling gates cannot be achieved with single photons and linear optics. Nonetheless, probabilistic gates can be applied o -line to an entangled multiphoton state that eventually serves as a resource for the on-line computation [6]. A similar approach uses DV photonic cluster states, leading to a signi cant reduction in the resource consumption [7, 8]. However, the generation of the optical cluster states remains highly probabilistic in this case.

A lthough up to six-qubit single-photon cluster states have been created via postselection using nonlinear and linear optics [9, 10], a possible determ inistic, unconditional realization of optical cluster states would be based on continuous variables. Here, the resources are squeezed states of light and the G aussian cluster states m ay be created via quadratic quantum nondem olition (QND) interactions [11]. These interactions, how ever, cannot be realized through beam splitters alone. Additional \on-line" squeezers are needed for every single link of the cluster state, again rendering the mechanism for cluster generation rather ine cient with current technology. M oreover, the squeezing of the resource states will always be nite, inevitably resulting in errors in the cluster computation. In this paper, we will address both issues: the avoidance of on-line squeezing in cluster-state generation and the reduction of nite-squeezing induced errors in cluster-state com putation.

W e will show that for any G aussian cluster state, the canonical generation scheme in term sofQND -type interactions, can be entirely replaced by o -line squeezers and beam splitters. Moreover, we propose a system atic way on how to build alternative cluster-type states from potentially cheaper squeezing resources than needed for the canonical states. In any of these linear-optics schemes, the resource states require correspondingly m ore squeezing to compensate for the lack of extra squeezing in the beam -splitter network that replaces the QND coupling of the cluster nodes. Nonetheless, the main features of the canonicalQND-made clusters can be preserved. As an exam ple, we consider G aussian cluster com putation in multiple-rail encoding. This encoding may reduce errors caused by nite squeezing. W e will see that multiple-rail encoding with linear-optics-m ade clusters, though requiring supposedly more o -line squeezing for the extra links of the larger clusters, can still lead to the same error reduction as for the canonical cluster states.

We de ne cluster-type states as those multi-mode Gaussian states for which certain quadrature correlations become perfect in the limit of in nite squeezing [11],

Perfect correlations uniquely de ne the corresponding graph state (for the DV case, see [12]). Here we use the dimensionless \position" and \m om entum " operators,  $\hat{x}$ and  $\hat{p}$ , corresponding to the quadratures of an optical mode with annihilation operator  $\hat{a} = \hat{x} + i\hat{p}$ . The modes a 2 G correspond to the vertices of the graph, while the modes b 2 N<sub>a</sub> are the nearest neighbors of mode a.

C anonical cluster states via linear optics. The canonical way to build CV cluster states would be to send a number of single-mode squeezed states through a corresponding network of QND gates [3, 11]. Each individual QND gate could be realized via two beam splitters and a pair of on-line squeezers [13]. However, by including the initial single-mode squeezers into the QND network, the resulting total circuit corresponds to a big quadratic H am iltonian applied to a num ber of vacuum m odes. This total transform ation can be decom posed into a linearoptics circuit followed by single-m ode squeezers and a second linear-optics circuit [13], where the rst linearoptics circuit has no e ect on the vacuum m odes. Eventually one has just one linear circuit applied to a num ber of single-m ode squeezed states; in principle, this works for any cluster (or graph) state. Let us explain this in a little m ore detail.

The canonical generation of CV cluster states [11] from momentum-squeezed vacuum modes via QND-type interactions can be described by  $\hat{x}_a^0 = \hat{x}_a$  and  $\hat{p}_a^0 = \hat{p}_a + \frac{P}{b_{2\,N_a}} \hat{x}_b$ , where  $\hat{x}_a = e^{+r} \hat{x}_a^{(0)}$  and  $\hat{p}_a = e^{-r} \hat{p}_a^{(0)}$ , 8 a 2 G, with vacuum modes labeled by superscript (0). Note that, according to Eq. (1), the canonical cluster states become perfectly correlated for r ! 1. We have the following linear Bogoliubov (LUBO) transformation,

U sing  $a_1^{(0)} = \dot{x}_1^{(0)} + \dot{i}\dot{p}_1^{(0)}$ , we can extract the LUBO m atrix elements for canonical cluster generation:  $A_{aa} = \cosh r$ ,  $B_{aa} = \sinh r$ ,  $A_{ab} = B_{ab} = (i=2)e^{+r}$  (8 b 2 N<sub>a</sub>), and  $A_{a1} = B_{a1} = 0$  [8 1 2 N<sub>a</sub> (1  $\epsilon$  a)]. Now the input m odes of the LUBO transform ation are vacuum m odes instead of the squeezed input m odes of the QND network. The next step is to decom pose this LUBO transform ation into a linear-optics circuit V<sup>y</sup>, a set of singlemode squeezers, and another linear-optics circuit U [13]. Using the singular value decom position for A and B, we have to satisfy V = A<sup>y</sup>UA<sub>D</sub><sup>1</sup> = B<sup>T</sup>U B<sub>D</sub><sup>1</sup> and U = AVA<sub>D</sub><sup>1</sup> = BV B<sub>D</sub><sup>1</sup> for the unitary matrices U and V. Here  $A_D^2$  is the diagonalized version of AA<sup>y</sup> and A<sup>y</sup>A; sim ilarly, we use  $B_D^2$  for BB<sup>y</sup> and (B<sup>y</sup>B)<sup>T</sup>. The singular-value m atrix equations lead to the conditions for U,

The expressions  $\frac{A}{1}$  are the singular




FIG.1: Dierent generation schemes for a canonical twomode cluster state. The input modes are always vacuum modes; a) canonical generation via QND interaction; b) QND gate replaced by a beam splitter (BS), two on-line squeezers, and another beam splitter [13]; c) generation of a standard two-mode squeezed state (via two squeezers and a beam splitter) plus two local squeezers [14]; d) sim plest generation schem e with the QND gate replaced by a beam splitter.

values of A and similarly for B. Equation (3) can be incorporated into the column vectors of U ,

psing  $\operatorname{ReU}_{k1}$  with the constraints of Eq. (4), and  $_{1}(\mathfrak{a}_{1})_{k}(\mathfrak{a}_{1})_{k^{0}} = _{kk^{0}}$  for unitarity. These conditions autom atically satisfy  $A = UA_{D}V^{y}$  and  $B = UB_{D}V^{T}$ , where the diagonal matrices  $A_{D}$  and  $B_{D}$  contain the corresponding singular values. Thus, we electively constructed a linear-optics circuit U that exactly outputs the canonical cluster states when applied to the oline squeezed input m odes with squeezed quadratures  $\mathfrak{X}_{1}\dot{p}_{1} = \overset{A}{\underset{1}{}} \overset{B}{\underset{1}{}} \mathfrak{X}_{1}^{(0)} \dot{p}_{1}^{(0)} e^{\operatorname{R}_{1}} \mathfrak{X}_{1}^{(0)} \dot{p}_{1}^{(0)}$ . The vacuum modes,  $\mathfrak{a}_{1}^{(0)} = \mathfrak{X}_{1}^{(0)} + i \dot{p}_{1}^{(0)}$ , are vacuum to vacuum modes after the rst linear-optics circuit V<sup>y</sup> that has no elect.

Let us consider the exam ple of the canonical two-m ode cluster state. It corresponds to two m om entum -squeezed m odes (squeezed by r) coupled through a quadratic QND gate  $e^{2ix}$ , see Fig.1a. In this case, we have  $\stackrel{A}{_1}$   $\cosh^2 r + e^{+2r} = 4$ ,  $\stackrel{B}{_1}$   $\sinh^2 r + e^{+2r} = 4$ ,  $C_1(r) = C_2(r)$  C  $^1(r)$ , and  $D_1(r)$  1. Thus, in the equivalent linear-optics scheme (Fig.1d), two equally squeezed m odes are com bined at a beam splitter described by U with colum n vectors as in Eq. (6), l = 1; 2, N = 2; the constraints in Eq. (4) are always satis ed.

A possible solution for U, choosing  $_{12} = _{21} = 0$ , is

Each input mode is momentum squeezed with  $R_1 = \ln \frac{A}{1} + \frac{B}{1}$  R.Forr = 0, we obtain  $\frac{A}{1} = 5=4$ and  $\frac{B}{1} = 1=4$ , and thus  $R = \ln [(1 + \frac{p}{5})=2]$ . This is the

residual squeezing com ing from the QND gate, which is now additionally applied o -line before the beam splitter. Note that the QND gate here is not simply replaced by a beam splitter followed by two single-mode squeezers and another beam splitter [13], all together applied to two initial squeezed states (Fig.1b). Instead, the circuit is further simplied, and only one pair of squeezers followed by one beam splitter operation act upon initial vacuum modes. How ever, in order to produce exactly the canonical state, this circuit is rather wasteful in terms of squeezing resources. The most economical two-mode entangled state is a standard two-mode squeezed state (TM SS) built from two single-mode squeezed states with a 50/50 beam splitter. Like any pure Gaussian two-mode state [14], also the canonical two-mode cluster state can be obtained from a TMSS via local Gaussian transformations, including local squeezers (Fig.1c).

C om paring resources, for example, an excess noise of one vacuum unit in the quadrature correlations  $\hat{p}_1$ ¢ and  $\hat{p}_2$  $x_1$  can be achieved with a TM SS built from two 3 dB squeezed states (see below). The canonical two-mode cluster state with these correlations (r = 0), would require two 4.18 dB squeezed states combined at the asymmetric beam splitter in Eq. (7). In general, the canonical N -m ode cluster states are always biased in x and p [15],  $h x_a^2 i = e^{+2r} \in h p_a^2 i = e^{-2r} + M_{N_a} e^{+2r}$ , unnecessarily requiring extra local squeezing to achieve a certain degree of correlations and entanglem ent; they cannot be obtained from N-mode pure Gaussian states in standard form [16] without the use of local squeezers. In the following, we shall consider a whole family of states producible via linear optics and exhibiting clustertype correlations. This fam ily will include states cheaper than the canonical cluster states.

C luster-type states via linear optics. In order to create states with correlations as in Eq. (1) via linear optics, we consider p-squeezed input modes,  $\hat{a}_1 = e^{+R_1} \hat{x}_1^{(0)} + ie^{-R_1} \hat{p}_1^{(0)}$ , and a general linear-optics transformation,  $\hat{a}_k^0 = {}_1 U_{k1} \hat{a}_1$ , with a unitary matrix U. Using  $\hat{a}_k^0 = \hat{x}_k^0 + i \hat{p}_k^0$ , one obtains the output quadrature operators, and in order to satisfy the correlations in Eq. (1), we assume the large noise terms (those proportional to  $e^{+R_1}$ ) cancel. This is possible if and only if

A fier inserting these conditions into the excess noise terms (those that vanish for in nite squeezing  $R_1 \mid 1$ ), we not that every quadrature correlation of Eq. (1) labeled by a has an excess noise variance

times one unit of vacuum quadrature noise (1=4 in our scales) which we omit in the following. These excess noises will lead to the errors in the cluster computation [3]. Let us consider two-mode cluster-type states.

Look at the simple circuit described by

applied to two m om entum -squeezed m odes. The circuit is a 50/50 beam splitter with Fourier transforms of m ode 2 before and after the beam splitter. It clearly satis es the conditions in Eq. (8). The resulting state is the standard TM SS up to a local Fourier transform of m ode 2. No extra local squeezers are needed to obtain this clustertype state from standard two-m ode entanglement. A ccording to Eq. (9), the excess noises in the cluster-type correlations are  $2e^{2R_1}$  in  $p_1$   $\frac{1}{2}$  and  $2e^{2R_2}$  in  $p_2$   $\frac{1}{2}$ , corresponding to the optim al entanglement for a given input squeezing. Note that the solutions in Eq. (10) and Eq. (7) coincide for r ! 1 when C (r) ! 1.

Incorporating Eq. (8) into the column vectors of U leads to

Using this form alism, for any given graph state, one obtains a set of geom etrical conditions for N real vectors  $_{k}^{T}$  ( $_{k1}$ ;  $_{k2}$ ;:::;  $_{kN}$ ). For instance, a linear 4-m ode cluster state has  $_{1} - _{3} = -_{2} - _{4} = 1 = 5$ ,  $_{1} - _{2} = -_{1} - _{4} = -_{2} - _{3} = -_{3} - _{4} = 0$ ,  $jj - _{1} jj = jj - _{4} jj = 3 = 5$ , and  $jj - _{2} jj = jj - _{3} jj = 2 = 5$ , achievable, for example, with  $_{1}^{T} = (1 = 2; 1 = 10; 0; 0)$ ,  $_{2}^{T} = (0; 0; 2 = 10; 0)$ ,  $_{3}^{T} = (0; 2 = 10; 0; 0)$ , and  $_{4}^{T} = (0; 0; 1 = 10; 1 = 2)$ . This, together with Eq. (11), where we set N = 4, de nes a possible solution U. In general, any 4-m ode transform ation U can be decom posed into a network of 4(4 1)=2 = 6 beam splitters [17]. However, for the linear 4-m ode cluster, there is a minim al decom position




FIG.2: Examples of cluster-type states producible via linear optics; each optical mode/cluster node a is represented by a vector  $\sim_a$  (see text): a) linear 4-m ode cluster, nonlinear 6-m ode cluster; b) \EPR/GHZ-type" [18] clusters: linear 2 and 3-m ode clusters, T-shape and cross-shape clusters.




FIG. 3: Error propagation when an input state is attached to and teleported through a) a linear 3-m ode cluster; b) a 4m ode diam ond cluster; c) an N -m ode multiple-rail cluster; all clusters are generated via o -line squeezing and linear optics.

of U into a network of only three beam splitters U =  $F_4S_{12}F_1^{y}B_{34}^{+}(1=2)B_{12}^{+}(1=2)B_{23}^{-}(1=5)F_3^{y}F_4^{y}$ . Here,  $F_k$  (Fourier transform of mode k) is the 4-mode identity matrix  $I_4$  except ( $F_k$ )<sub>kk</sub> = i,  $B_{k1}$ (t) (beam splitter transformation of modes k and l) equals  $I_4$  except ( $B_{k1}$ )<sub>kk</sub> = t,  $(B_{k1})_{k1} = \frac{1}{1} + \frac{2}{t}$ ,  $(B_{k1})_{lk} = \frac{1}{1} + \frac{2}{t}$ , and  $(B_{k1})_{ll} = t$ , and the matrix  $S_{12}$  swaps modes 1 and 2.

Similarly, one can nd linear-optics solutions for other cluster-type states (Fig.2). The example of a nonlinear 6-m ode cluster in Fig.2a (a potential resource for two-m ode evolutions) leads to two orthogonal subspaces  $f_{k}; \sim_1; \sim_m g$  with fk; l;m g = f1;3;5g and fk; l;m g = f6;4;2g, where  $\sim_k \sim_1 = 3=10$ ,  $\sim_k \sim_m = \sim_1 \sim_m = 1=10$ , and  $j_{k}; j_{j} = p j_{k}; j_{j} = 7=10$ ,  $j_{k} \sim_m j_{j} = 3=10$ . Appossible solution is (1= 5;1= 2;0;0;0;0), (1= 5; 1= 2;0;0;0;0), ( 1= 20;0;1=2;0;0;0) for vectors f1;3;5g, respectively, and also (0;0;0; p1= 20;0;1=2), (0;0;0;1= 5;1= 2;0), (0;0;0;1= 5; 1= 2;0) for f2;4;6g. Redundant encoding for error Itration. As an application, we consider multiple-rail encoding in a Gaussian cluster computation protocol [3]. Look at the diam ond cluster state in Fig.3b. In this case, the vector conditions become  $\sim_1 \sim_2 = \sim_1 \sim_3 = \sim_2 \sim_4 = \sim_3 \sim_4 = 0$ ,  $\sim_2 \sim_3 = \sim_1 \sim_4 = 2=5$ , and  $jj_k jj_3=5$ . This can be satis ed, for example, via  $\sim_1^T = (1=3; 2=15;0;0)$ ,  $\sim_2^T = (0;0;1=3; 2=15)$ ,  $\sim_3^T = (0;0;0; 3=5)$ , and  $\sim_{4}^{T} = (0; \sqrt[1]{3=5}; 0; 0)$ . A simple cluster protocol would be to teleport an input mode onto mode 1 of the diam ond state and from there to mode 4 (Fig.3b). For simplicity, we assume that the input mode is attached to mode 1 through the QND gate  $e^{2i\hat{x}_{in}}\hat{x}_1$  such that  $\hat{p}_1$  !  $\hat{p}_1$  +  $\hat{x}_{in}$  and  $\hat{p}_{in}$  !  $\hat{p}_{in}$  +  $\hat{x}_1$ ;  $\hat{x}_1$  and  $\hat{x}_{in}$  remain unchanged. Now p-measurements of the input mode and modes 1 through 3 (with results  $s_{in}$ ,  $s_1$  ) <sub>3</sub> would transform mode 4 into the input state up to some known corrections and excess noise coming from the imperfect diam ond state.  $\hat{x}_{i}$ , and x-displacements  $\hat{x}(s)$  such that  $\hat{x}! \hat{x}+s,m$  ode 4 is described by  $\hat{x}_{out} = \hat{x}_{in} + (\hat{p}_{1} \quad \hat{x}_{2} \quad \hat{x}_{3})$  ( $\hat{p}_{1} \quad \hat{x}_{2} \quad \hat{x}_{3}$ ) and  $\hat{p}_{out} = \hat{p}_{in}$  ( $\hat{p}_{2} \quad \hat{x}_{1} \quad \hat{x}_{2}$ )=2 ( $\hat{p}_{3} \quad \hat{x}_{1} \quad \hat{x}_{2}$ )=2. Here,  $\hat{p}_{in}$  and  $\hat{p}_{1}$  correspond to the momentum operators of the input m ode and m ode 1 before the QND coupling.

W e see that the imperfect teleportation delities depend on the correlations of the diam ond cluster, Eq. (1) with Fig.3b. In the corresponding excess noise variances, Eq. (9), let us consider only the e ect of nite B, and  $R_4$ , assuming  $R_1$  $1 \text{ and } \mathbb{R}_2$ 1. This leads to negligible excess noises, a = 1 and a = 4, in  $\hat{x}_{out}$ , because the vectors  $\sim_1$  and  $\sim_4$  live in the two-dimensional subspace l = 1;2. In  $\hat{p}_{out}$ , according to Eq. (9) with a = 2and a = 3, we nd a total excess noise of  $(13e^{2R_3} +$  $5e^{2R_4}$ )=12 =  $3e^{2R}$ =2, assuming  $R_3 = R_4 = R$ , which is half the excess noise compared to any linear 3-m ode cluster protocol (Fig.3a) with twom odes highly squeezed and one nitely squeezed by R; the generality of this result can be easily proven using Eq. (9) and Eq. (11) for the 3-m ode protocol, with  $\hat{p}_{out} = \hat{p}_{in}$  ( $\hat{p}_{2} \quad \hat{x}_{1} \quad \hat{x}_{3}$ ) and  $\hat{\mathbf{x}}_{\text{out}} = \hat{\mathbf{x}}_{\text{in}} + (\hat{\mathbf{p}}_1 \quad \hat{\mathbf{x}}_2) \quad (\hat{\mathbf{p}}_3 \quad \hat{\mathbf{x}}_2) \quad \hat{\mathbf{x}}_{\text{in}} \cdot \mathbf{M} \text{ ore generally,}$ we obtain a pexcess noise of 3 e<sup>2R</sup> = m for multiple-rail encoding (Fig.3c), where m is the num ber of interm ediate nodes (num ber of rails) between mode 1 and the output mode [19]. As a result, the excess noise in cluster com putation may be reduced by teleporting the input through multiple paths. Remarkably, the linear-optics-m ade clusters achieve the same error reduction as obtainable for QND-m ade clusters with QND gates freely available.

Conclusion. | We showed that any Gaussian cluster state can be built via o -line squeezing and linear optics without QND couplings. Sim ple vector conditions lead to potentially cheaper cluster-type states. In multiple-railencoded cluster computation, the same error reduction as for the QND -m ade clusters can be achieved. Our results pave the way for experim ental realizations of sm all-scale cluster computation with continuous variables.
