## Optim alm ulticopy asymmetric Gaussian cloning of coherent states

W e investigate the asymmetric G aussian cloning of coherent states which produces M copies from N input replicas, such that the delity of all copies may be dierent. We show that the optimal asymmetric Gaussian cloning can be performed with a single phase-insensitive amplier and an array of beam splitters. We obtain a simple analytical expression characterizing the set of optimal asymmetric Gaussian cloning machines.

#### I. IN TRODUCTION

The perfect copying of unknown quantum states is forbidden by the linearity of quantum mechanics [1]. This observation lies at the heart of novel quantum communication protocols, such as quantum key distribution (QKD) which allows the provably secure sharing of a secret key between two distant partners (see, e.g., [2]). Any eavesdropping on a QKD system introduces noise into the transmission, which can be detected by the legitim ate users. The optim al individual eavesdropping attacks on m any QKD protocols consist of the optim al (approximate) copying of the quantum states transmitted in the channel, where one copy is sent to the legitim ate receiver while the other copy is kept by the eavesdropper and measured upon at a later stage. A fter the sem inal paper by Buzek and Hillery  $[\beta]$ , where the concept of universal quantum cloning machine was introduced, the issue of quantum copying has attracted considerable attention (see, e.g., [4, 5]). This e ort culm inated in the recent years with the experim ental dem on stration of optim al 1 ! 2 cloning m achines for polarization states of photons based either on param etric am pli cation [6, 7, 8] or on the sym m etrization of the multiphoton state on an array of beam splitters [9, 10]. The latter technique was also exploited lately to realize the universal symmetric cloning machine for qubits that produces three clones [11].

In applications such as QKD, one is often interested in asymmetric cloning where the delities of the clones are di erent. This is indeed necessary to study the trade-o between the inform ation gained by the eavesdropper and the noise detected by the legitim ate users. The optimal 1! 2 asymmetric cloning of qubits and qudits has been studied in detail [12, 13, 14] and very recently an experim ental dem onstration of 1 ! 2 asym m etric cloning of polarization states of photons [15] based on partial teleportation [16] was reported. Going beyond two copies, multipartite asymmetric cloning machines have been introduced in [17], which produce M copies with di erent delities  $F_{i}$  (j = 1; tipartite asym m etric cloners for qubits and qudits were presented in [18, 19].

In the context of the rapid developm ent of quantum in-

form ation processing with continuous variables [20], the cloning of coherent states has been extensively studied over the last years [21, 22]. It was shown that the optimalN ! M symmetric cloning of optical coherent states that preserves the G aussian shape of the W igner function can be accomplished with the help of a phase-insensitive amplier followed by an array of beam splitters that distributes the amplied signal into M modes [23, 24]. It is also possible to exploit the o-resonant interaction of light beams with atom ic ensembles and perform the cloning of coherent states into an atom ic m em ory [25]. The cloning of a nite distribution of coherent states was studied [26], and a reversal of cloning by means of local operations and classical com m unication was suggested in [27].

On the experim ental side, the 1! 2 optim alG aussian cloning of coherent states of light was recently dem onstrated in [28]. There, the phase-insensitive optical am plier was replaced with a clever combination of beam splitters, hom odyne detection, and feedforward, which e ectively simulated the amplication process. Using homodyne detectors with very low electronic noise, it was possible to achieve a cloning delity of about 65%, very close to the theoretical maximum of 2=3. In another experim ent, the 1! 2 telecloning of coherent states of light was also realized [29].

In this paper, we extend the concept of multipartite asymmetric cloning to continuous variables and present the optim al multipartite asymmetric Gaussian cloning m achines for coherent states. These devices produce M approximate replicas of the coherent state j i from N input replicas, such that the delity F<sub>i</sub> of each clone is generally di erent, and, for a given set of  $F_1$ ; :::;  $F_{M-1}$ , the delity of the M -th clone  $F_M$  is the maximum possible. The multicopy asymmetric 1! M cloning of coherent state was previously studied by Ferraro and Paris in the context of telecloning [30]. Here, we rigorously prove that their scheme is optimal, and present a generic optim alasym metric cloning machine for any number N of input replicas, as well as its optical in plem entation. We M). Several examples of such mulalso consider the related problem of the optimal partial state estim ation of coherent states.

> The rest of the paper is structured as follows. In Section II, we present an optical cloning scheme based on

phase-insensitive am pli cation and passive linear optics. We also derive the trade-o between the delities (or, equivalently, added therm al noises), which fully characterizes the class of the optim alm ultipartite asymmetric G aussian cloners. In Section III, we describe an alternative cloning scheme where the am pli cation is replaced by measurement and feedforward. In Section IV, we shortly discuss the relationship between the optim al asymmetric cloning and optim al partial measurement of coherent states. Then, the proof of the optim ality of the asymmetric cloning machine is given in Section V. Finally, Section VI contains a brief summary and conclusions.

# II. ASYM M ETRIC GAUSSIAN CLONING OF COHERENT STATES

In what follows, we restrict ourselves to Gaussian cloning transform ations. Note that it has been found in [31] that the optim all ! 2 cloning transform ation for coherent states (i.e. the transform ation that maxim izes the single-clone delity) is in fact non-Gaussian, though the gain in delity is tiny. Nevertheless, it should be stressed that, while this non-Gaussian cloner is optimal in terms of delity, it adds more noise to the clones (as m easured by the quadrature variances) than the optim al Gaussian cloner. In potential applications of cloning such as eavesdropping on QKD protocols with coherent states and hom odyne detection [32, 33], one is often interested in m inim izing the quadrature variance. In such a case, the Gaussian cloning turns out to be the most dangerous attack [34]. Finding the multipartite generalization of asym m etric G aussian cloning is therefore a very interesting question.




FIG.1: Optim alGaussian N  $\, !\,$  M fully asymmetric cloning of coherent states. See text for details.

As we will prove in Section V, the optim al Gaussian cloning machine has the simple structure depicted in Fig. 1, which is a direct generalization of the 1 ! 2 asymmetric cloner [24]. The signal contained in N input replicas of the coherent state j i is rst collected into a 1 unbalanced beam splitsinglem ode by an array of N ters [23, 24]. A fter this, a single mode a carries all the signal, and is in a coherent state  $j \overline{N}$  i. This mode is sent on an unbalanced beam splitter BS with am plitude transmittance t and re ectance r, which divides the signal into two modes a and  $b_1$ . Mode a is then amplied in a phase-insensitive amplier (NOPA) with amplitude gain g. The modes a and  $b_1$  together with M 2 auxiliary modes  $b_j$ , with j = 2; ...; M1, are combined in a passive linear M -port interferom eter IF whose output modes contain the M clones. The interferom eter is designed in such a way that that the coherent component in each output mode is equal to . In the Heisenberg picture, the overall input-output transform ation describing the cloner depicted in Fig. 1 reads

where  $c^{y}$  is the creation operator of the idler port of the ampli er and  $b_{k}$  are the annihilation operators of the M 1 auxiliary modes, initially in the vacuum state. Here,  $n_{j}$  represents the amount of noise added to the j-th clone, and the  $_{jk}$  coe cients are chosen in such a way that the canonical commutation relations are conserved.

It follows from the canonical transform ations (1) that each clone is in a mixed G aussian state with coherent amplitude and added thermal noise characterized by a mean number of thermal photons  $n_j$ . The Husim iQ – function of the j-th clone reads,

The delity of the j-th clone is proportional to the value of the Husim iQ-function at =, and is therefore a monotonic function of the added therm allows,

The cloning is covariant and isotropic, i.e., the delity does not depend on the input state j i and the added noise is the same for each quadrature. These are natural conditions that the optim al cloning machine should satisfy.

The shot-noise limited amplication is governed by the transform ation

and the totalm ean number of therm alphotons produced during the amplication is  $n_{tot} = g^2$  1. Since the linear interferom eter does not add any noise, we have

where  $n_{tot} = {P \atop j=1}^{M} n_j$ . The total intensity of the coherent signal after ampli cation is N  $(r^2 + g^2t^2)jf$ , which

should be equal to M j f if we require the coherent com – ponent of each clone to be equal to  $\cdot$ . From this, we can determ ine the transm ittance of BS, namely

The multiplets of  $n_j$  cannot be arbitrary. Indeed, the M – port interferom eter IF in Fig.1 is described by a unitary matrix V, such that  $a_j = \prod_{j=1}^{P} v_{jk} b_k + v_{jM} a_{out}$ . The unitarity of V in poses a constraint on  $n_j$  which can be expressed as

This form ula provides a simple analytical param etrization of the set of optimalN ! M multipartite asymmetric G aussian cloning machines for coherent states.

In the special case of a 1 ! 2 asym m etnic G aussian cloner, Eq. (7) reduces to

which coincides with the no-cloning uncertainty relation that was displayed in [22, 24]. (Note that 1/2 corresponds here to one shot-noise unit.) Interestingly, if we consider a 1 ! 3 cloner and assign to the rst two clones the delity of the optim all! 2 sym metric cloner, that is,  $n_1 = n_2 = 1=2$ , we obtain by solving Eq. (7) that the noise of the third clone is not in nite,  $n_3 = 2$ . As noticed in [18], this means that some quantum information remains available beyond the one contained in the two clones (it actually corresponds to the inform ation hidden in the anticlone). In the case where N = 1 but M is arbitrary, we recover the expression that was derived by Ferraro and Paris [30]. Finally, note that if one clone is perfect, e.g.,  $n_M = 0$ , then Eq. (7) is transformed into the same equation but for a (N 1)! (M 1) cloner, which means that one of the input replicas is simply redirected to the perfect clone while the cloning of the N 1 remaining input replicas into the M 1 other clones is simply governed by the same relation.

### III. OPTIMALASYMMETRIC CLONING VIA MEASUREMENTAND FEEDFORWARD

In the experimental demonstration of the optimal cloning of coherent states of light carried out in [28], the ampli cation in a phase-insensitive ampli er was replaced by a clever combination of a partial measurement and feedforward that e ectively simulates the ampli cation process. Since an ampli er of arbitrary gain g can be implemented in this way [35], the scheme shown in Fig. 1 can be straightforwardly transformed into a setup which involves only passive linear optics, balanced hom odyne




FIG. 2: Setup for the multipartite asymmetric Gaussian cloning of coherent states using hom odyne detection and feed-forward.

detection and coherent displacem ent of the beam s proportional to the measurem ent outcom es. The resulting con guration is illustrated in Fig. 2.

W e assum e that all available signal has been collected igto a single mode a which is thus in the coherent state j N i. The beam is divided into two parts on a beam splitter BSq with amplitude transmittance t and reectance r. The re ected part is fed into a heterodyne detector consisting of a balanced beam splitter whose auxiliary input port c is in the vacuum state and two balanced hom odyne detectors BHD m easuring the x and p quadratures, respectively. This detector e ectively measures the operator o = ra+tb+c<sup>y</sup>. The portion of the beam transm itted through  $BS_{q}$ , characterized by ta rb, is divided into M modes a<sub>i</sub> by an array of M 1 beam splitters with rejectances  $r_k$ . Each mode  $a_k$  is then coherently displaced by amount  $g_j o$ , where  $g_j$  is the electronic gain of the corresponding feed forward. The added therm al noise in the output mode  $a_i$  reads  $n_i = g_i^2$ , which im m ediately xes all electronic gains,

As shown in [35], the optical ampli cation gain g is obtained in the feed-forw and equivalent scheme if the beam is split on a beam splitter with re ectance  $1 \quad 1=g^2$ , and the re ected part is heterodyne measured. Since in the scheme of Fig. 1 only an (amplitude) fraction t of the input beam a is actually amplied, we see that by replacing the amplier with a beam splitter of reectance  $1 \quad 1=g^2$ , the fraction of the beam that is sent to the heterodyne detector is  $t \quad 1 \quad 1=g^2$ . Thus, in Fig. 2, the re ectance of the beam splitter BS<sub>g</sub> m ust be  $r = t \quad 1 \quad 1=g^2$ , which yields

It remains to determ ine the relectances  $r_k$  of the nal array of beam splitters. They are xed by the condition that the coherent amplitude of each clone is . After some algebra we indicate that

From this form ula, all  $r_k$ 's can be calculated in an iterative way, starting from  $r_1$  [which is given by Eq. (11) for j = 1 with the product over k replaced by 1].

## IV . OPT IM AL CLON ING AND OPT IM AL PARTIAL EST IM AT ION OF COHERENT STATES

There is a close relationship between optim al cloning and optimal state estimation. An interesting scenario that recently attracted a lot of attention consists in the partial estimation of a state, which yields the classical estimate of the state as well as the perturbed quantum state [37, 38, 39, 40, 41, 42]. A coording to the fact that in the limit of an in nite number of copies, the optimal cloning becom es equivalent to optim al state estim ation [36], this optimal partial estimation can be viewed as a limiting case of an asymmetric cloning producing one (quantum) copy with delity F and in nitely many (classical) copies with delity G [17]. From the analytical formula (7), we can thus rigorously derive the optimal trade-o between the delities F and G in the partial Gaussian estimation of coherent states. We set  $n_1 = n_F$ ,  $n_2$  =  $n_3$  = :::=  $n_M$  =  $n_G$  and take the lim it M  $\ ! \ 1$  , which results in

In the limit of an undisturbed quantum copy ( $n_F = 0$ ), we have an in nitely noisy state estimation, as expected. We also note that  $n_F = n_G = 1$  is a solution of Eq. (12), which corresponds to the optim al (full) estimation of coherent states. Equation (12) also translates in the following relation between the delities,

This agrees with the trade-o derived in [37] which conms that the experimentally demonstrated partial measurement of coherent states in that work was indeed optimal among all Gaussian strategies. Note that using a non-Gaussian protocola slightly better trade-o between F and G could be achieved [43].

#### V. PROOF OF OPTIM ALITY

In what follows, we will prove the optimality of the asymmetric cloner de ned in Secs. II and III. Let us rst

note that the delities are monotonic functions of  $n_j$ , so that instead of maximizing the delities  $F_j$  we can equivalently minimize the added thermal noise  $n_j$ . The design of the optimal cloner can be thus rephrased as the minimization of a cost function [17]

which is a linear convex mixture of  $n_j$ ,  $x_j > 0$ . The ratios of the coe cients x  $_j$  control the asym m etry of the cloning m achine.

The most general Gaussian operation is a tracepreserving Gaussian completely positive (CP) map [21], and we have to m inim ize (14) over all such m aps. At the level of covariance m atrices , the Gaussian CP m ap acts as

The covariance matrix of N modes is de ned as  $_{jk} = h r_j r_k + r_k r_j i$ , where  $r = (x_1; :::; x_N; p_1 :::; p_N)$  is the vector of quadrature operators,  $[x_j; p_k] = i_{jk}$ . The rst m on ents transform under the G aussian CP m ap according to  $hr_{out}i = Shr_{in}i$ .

The matrices S and G must satisfy the complete positivity constraint

com prises the com m utators of the quadrature operators, while I denotes the identity m atrix of dim ension M , and M <sub>in</sub> and M <sub>out</sub> are the num ber of input and output m odes, respectively. The cloning m achine of interest has e ectively only a single input m ode a (as we collect the N input signals into a single m ode) and M output m odes, so that M <sub>in</sub> = 1 and M <sub>out</sub> = M . The M 2 m atrix S is xed by the condition that the rst m om ents should be preserved by cloning. W e get

W e have to m inim ize C  $(n_j)$  over the set of all G aussian completely positivem aps (15) with the matrix S given by (18), that is, we have to optim ize over all G's satisfying (16). C learly, if G<sub>1</sub> and G<sub>2</sub> satisfy (16), then any convex combination pG<sub>1</sub> + (1 p)G<sub>2</sub> with p 2 [0;1] also does. Thus, we have a convex optim ization problem . M oreover, since  $n_j = (G_{jj} + G_{M+jM+j} + 2=N 2)=4$ , the cost function (14) is linear in them atrix elements of G. Hence, the problem amounts to minimizing

under the constraints (16), which is an instance of a linear sem ide nite program [44]. We shall now prove the optimality of (1) by deriving a lower bound on C (G) which is saturated by (1).

The specic feature of the transform ation (1) is that only a single creation operator  $c^{y}$  is admixed to the annihilation operators. This operator is responsible for the added noise in cloning. Since all modes are initially in coherent states, the norm ally ordered moments of the operators  $a_{j}$  for the clones can be easily calculated,

The covariance matrix of the M  $\,$  clones is then fully determ ined by the added noises  $n_{\,\rm j}$  ,

where F is a symmetric M M matrix with elements  $F_{jk} = \frac{P}{n_j n_k}$ . Since the matrix S is xed and the input state of the cloner is a coherent state with covariance matrix  $_{in} = I$ , the matrix  $G_{opt}$  corresponding to transformation (1) can be determined from Eq. (15). This yields

where H is a matrix whose elements are all equal to one, H  $_{ik} = 1$ .

Since the transform ation (1) can be associated with a CP map, the matrix  $G_{opt}$  must satisfy the inequality (16). For the particular S matrix (18), this gives

We can transform the matrix  $A_{opt}$  to a block-diagonal form with the help of the unitary matrix

which gives  $UA_{opt}U^{Y} = diag(2F + 2I - 2H = N; 2F)$ , so that there remains to prove that F + I = M0 and 0. The matrices F and H both have rank one, F and can be written in Dirac notation as F = fihf jwhere  $fi = \int_{j=1}^{P} \frac{p}{n_j} \frac{p}{jji}$ , and H = fihhj where  $hi = \int_{j=1}^{P} M_{j=1}$  jji. The condition F 0 is satis ed by de nition, while solving F + I = N0 yields the nontrivial constraint on n<sub>i</sub>'s. A ctually, it is su cient to check the latter positivity condition in the two-dimensional subspace spanned by the (un-norm alized) vectors jfi and hi, and one can prove that it is indeed satis ed provided that Eq. (7) holds.

We now derive a tight lower bound on  $\mathbb{C}$  (G), which is saturated by (1). Suppose that we nd a positive sem idefinite matrix Z 0 such that it satis as the conditions

where  $iK = iJ_M$  is  $J_1S^T$ . Then, the Gaussian CP m ap with matrix  $G_{opt}$  is the optim alone that minimizes C(G). Since for every admissible G we have G + iK = 0, it follows from Z = 0 that Tr[Z(G + iK)] = 0, which im plies that C(G) = iTr[ZK], 8G. Equation (25) im plies that this lower bound is saturated by  $G_{opt}$ , which is therefore optim al.

The matrix Z can be determined from Eqs. (24) and (25). We not that

where  $X = \text{diag}(x_1; :::; x_M)$  is xed by Eq. (24), while Y is a real symmetric matrix that satis es

as a consequence of Eq. (25). Note that X > 0 by definition because  $x_j > 0$ . Since the matrix I N <sup>1</sup>H is invertible, we can express the matrix Y in terms of X using the rst condition of (27),

The second condition of (27) is then satis ed for any X provided that (7) holds.

In order to further simplify the matrix Y, we need to establish the relationship between  $x_j$  and  $n_j$ . W ithout loss of generality, we can restrict ourselves to the cloning machines that satisfy (7), and minimize the cost C  $(n_j)$  under the constraint (7). Using the standard method of Lagrange multipliers, we obtain the extrem al equations for the optim  $aln_j$ 's for a given set of  $x_j$ 's,

with being the Lagrange multiplier. With the help of these formulas, we can show that

The matrix X F X is symmetric, hence  $Y = Y^{T}$  as required.

The last step of the proof is to show that the matrix Z is positive sem ide nite. We ist apply a transformation that preserves the positive sem ide niteness,  $Z = V Z V^{\gamma}$ , where V = diag (X <sup>1=2</sup>; X <sup>1=2</sup>),

where we made use of Eq. (7). Since F is proportional to rank one projector the norm alization (32) in – plies that  $X^{1=2}FX^{1=2} = j$  ih j , where j i is a norm alized real vector, h j i = 1. We can convert Z to block diagonal form with the unitary (23),  $UZU^{Y} = \text{diag}(2; 2I 2)$ , which is obviously positive semide nite. This concludes the proof of optim ality of the cloning machine (1).

#### VI. CONCLUSIONS

In sum m ary, we have proposed a multipartite asymm etric G aussian cloning m achine for coherent states. The

machine produces M approximate copies of a coherent state from N replicas of this state in such a way that each copy can have a dierent delity. A simple analytical form ula characterizing the set of optim al Gaussian asymmetric cloning machines has been derived, and it was shown that the asymmetric cloning can be realized by amplifying of a part of the input signal followed by mixing the amplied signal and the bypass signal together with auxiliary vacuum modes on an array of beam splitters with carefully chosen transmittances. An alternate in plem entation is also described, where the am plier is replaced by a passive optical circuit supplem ented with feedforward.Wehope that our study of multipartite asymmetric cloning will trigger further investigations of optim alquantum inform ation distribution in continuousvariable quantum communication networks.
