N onexponential decay via tunneling to a continuum of nite width

A simple quantum mechanical model consisting of a discrete level resonantly coupled to a continuum of nite width, where the coupling can be varied from perturbative to strong, is considered. The particle is initially localized at the discrete level, and the time dependence of the amplitude to nd the particle at the discrete level is calculated without resorting to perturbation theory and using only elementary methods. The deviations from the exponential decay law, predicted by the Ferm i's G olden Rule, are discussed.

The transition of a quantum particle from an initial discrete state of energy into continuum of nal states is considered in any textbook on quantum mechanics. It is well known that perturbation theory approach, when used to solve the problem, leads to Ferm i's Golden Rule (FGR), which predicts the exponential decrease of the probability to nd the particle in the discrete state. It is also well known that, even for a weak coupling between the discreet state and the continuum, this result (exponential decrease of probability) has a nite range of applicability, and is not valid either for very sm all or for very large time (see e.g. Cohen-Tannoudjiet. al. [1]). This complies with the theorem proved 50 years ago, and stating that for quantum system whose energy is bounded from below, i.e., (0;1) the exponential decay law cannot hold in the full time interval [2, 3, 4]. The same statem ent rem ains valid when the discrete state is coupled to the continuum bounded both from below and above, the model we presently consider. Fortunately, the model is exactly solvable; the solution in the frequency representation obtained within the Green's functions (GF) formalism is presented in [5], where the model is called the Fano-Anderson model). In this paper we solve the problem of tunneling in the fram ework of Quantum mechanics proper W e concentrate on the calculation of the time dependent non-decay am plitude, the stage which is typically not given proper attention to within the GF formalism [5]. We analyze the relation between the exact results and those given by the FGR.

The system consists of the continuum band, the states bearing index k, and the discrete state d. The H am iltonian of the problem is

where jki is the band state and jdi is the state localized at site d; h.c. stands for H erm itian conjugate. The wavefunction can be presented as

with the initial conditions a(0) = 1, b(k;0) = 0.

Schroedinger Equation for the model considered takes the form

Making Fourier transformation (Im ! > 0)

we obtain

For the amplitude to nd electron at the discrete level, straightforward algebra gives

and integration in Eq. (6) is along any in nite straight line parallel to real axis in the upper half plane of the com plex ! plane. Notice that if, in addition, we de ne g(t) = 0 for t < 0, then g(t) is just the (single particle in an empty band) GF in time representation, and g(!) is the same GF in frequency representation. The quantity

(!) in the GF form alism is called self-energy (or mass operator).

For tunneling into continuum, the sum in Eq. (8) should be considered as an integral, and Eq. (8) takes the form

where and the lim it of integration are the band bottom E_b and the top of the band E_t . We would like to calculate integral (6) closing the integration contour by a sem icircle of an in nite radius in the lower half-plane. Thus we need to continue analytically the function g(!) which was de ned initially in the upper half plane (excluding real axis) to the whole com plex plane. We can do it quit sim ply, by considering Eqs. (7) and (9) as de ning propagator in the whole com plex plane, save an interval of real axis between the points E_b and E_t , where Eq. (9) is undetermined. (P ropagator analytically continued in such a way we'll call the standard propagator.) Thus the integral is determined by the integral of the sides of the branch cut between the points E_b and E_t . The real part




FIG.1: C ontour used to evaluate integral (6). R adius of the arc goes to in nity.

of the self-energy 0 is continuous across the cut, and the imaginary part 00 changes sign

So the integral along the branch cut is

In the perturbative regime $j^{0}()jj^{0}()j$ E_b;E_t them ain contribution to the integral 12) comes from the region E . Hence the integral can be presented as

and easily calculated to give the well known Ferm i's golden rule (FGR)

However, even in perturbative regine, the FGR has a limited time-domain of applicability [1]. For large t the survival probability is determined by the contribution to the integral (12) coming from the end points. This contribution can be evaluated even without assuming that the coupling is perturbative. Let near the band bottom (the contribution from the other end point is similar) (E) (E $E_{\rm b}$), where > 0. Then for large t

The similar contribution comes from the top of the band. If there can exist poles of locator (7), we should add

to the integral (12) the residues

where the index j enum erates all the real poles E $_{\rm j}$ of the integrand, and

N otice, that the poles correspond to the energies of bound states which can possibly occur for $E < E_b$ or $E > E_t$, and which are given by the Equation

If we take into account that norm alized bound states are

then the residue can be easily interpreted as the am plitude of the bound state in the initial state jdi, times the evolution operator of the bound state times the am plitude of the state jdi in the bound state

If the locator has one real pole at E_1 , from Eq. (19) we see that the survival probability $p(t) ! R_1 f$ when t ! 1. If there are several poles, this equation gives Rabioscillations.

Notice that Eq. (19) is just the well known result [5]

is the spectral density function. The rst term in Eq. (19) is the contribution from the continuous spectrum, and the second term is the contribution from the discrete states.

B efore proceeding further, consider two sim plem odels. F irst model is a site coupled to a sem i-in nite lattice. The system is described by the tight-banding H am iltonian

where jni is the state localized at the n-th site of the lattice. The band (lattice) states are described by the Ham iltonian

where $j_{ki} = \frac{p}{2} \frac{P}{n} \sin (kn)$ jni. Hence we regain Ham iltonian (1) with $V_k = \frac{p}{2} \sqrt{2} V \sin k$; also

where $_0 = 2V^2$. If we consider the case = 0 and $V^2=2 < 1$ the locator does not have real poles, so Eq. (12) after substitution of the results of Eq. (28) gives the am plitude of the non-decay am plitude [6]:

For numerical calculations we consider the second model:

The units and zero of energy we'll chose such that E $_{\rm b}$ = 1;Et = 1; thus we get




FIG.3: Survival probability as a function of time for $_0 = :1$.

For the sake of de niteness we'll chose = .4. For $_0 = .02$ (see Fig. 2) we observe the FGR regime, say, up to t = 9. For = .1 (see Fig. 3) the FGR regime

is seen up to t = 3. For $_0 = 2$ (see Fig. 4) the FGR




FIG. 5: Survival probability for $_0 = :02$ (beginning of the process of tunneling).

regime is absent. The Rabi oscillations we see already at Fig.3 and still more vividly at Fig.4. The FGR is not valid for small teither. (From Eq. (3) it is obvious that the expansion of g(t) is $g(t) = 1 + kt^2 + \dots$, which gives quadratic decrease of the non-decay probability at small t.) The region of small t, shown at Fig. 5, clearly demonstrates quadratic decrease of p with time.

Let us continue the discussion of what seem s to be the (alm ost) trivial result: FGR at perturbative regime. In fact, in this regime Eq. (16) we could obtain directly

from Eq. (6), changing exact G reen function (7) to an approximate one, which may be called the FGR locator

$$g_{FGR}(!) = \frac{1}{!} \qquad (34)$$

(N otice, that whichever approximation we use for (!), the property a(t = 0) = 1 is protected, provided does not have singularities in the upper half-plane.) Thus approximated, locator has a simple pole ! = + (), and the residue gives Eq. (16). However, the locator which is used to obtain Eq. (25) and the FGR locator have totally di erent singularities. So the fact that the locators give the same survival probability (even in nite time interval) dem ands explanation.




FIG. 6: A Itemative way to analytically continue the propagator into the lower half-plane. The arrows show the curves of analytical continuation in between the cuts and outside. R adius of the big arc and length of the cuts go to in nity.

Let us return to the issue of the analytical continuation of the propagator. The exam pless we considered show that E_b and E_t are the (!) branch points. Hence propagator is a multi-valued function and it's value in the lower half-plane depends upon the curve along which we continue the function from the upper half-plane [7]. The analytic continuation we used previously, corresponded to continuing (!) along the curves which circum vent the right branch point clockw ise and the and the left branch point anti-clockw ise. On the other hand, we could use a dierent continuation, making the curves from the branch points

to in nity and continuing the function between the cuts along the curves passing through the part of real axis between E_b and E_t , and outside as we did it previously. This way to make analytic continuation, and hence to calculate the integral (6) is presented on Fig. 6. (O f course, the value of the integral does not depend upon the analytic continuation we use.) (The treatment of

tunneling from the discrete level into a sem i-bound continuum presented in the paper by Onley and Kum ar [8], corresponds, in fact, to an analytic continuation sim ilar in spirit, to that presented on Fig. 6.) Notice, that because of the exponential decrease as a function oft of the integrand in the cut integrals appearing in this analytic continuation, in contrast to oscillatory behavior of the real axis cut integral, such analytic continuation is more convenient for the num erical calculations of the large t behavior of the non-decay am plitude.

For example, for the model with constant (E), thus continued self energy is

where log is de ned as having the cuts [1; 1 i1) and [1;1 i1), and the phase at the real axis between

1 and 1. For the model of the sem i-in nite chain the relevant self energy sheet is

$$(!) = {}_{0} ! {}^{p} \frac{1}{!^{2}} 1;$$

where the square root is de ned as having the phase =2 at the real axis between 1 and 1. In both cases the result for g(t) would include the integrals along the cuts presented at Fig. 6.

We can easily understand why the complex pole is present on the sheet of the propagator presented on Fig. 6, but not on that presented on Fig. 1. Consider for $\sin - p$ licity the perturbative regime. In the lower half-plane in the vicinity of ! = the standard propagator is

$$g(!) = \frac{1}{!} (37)$$

and the propagator continued according to Fig. 6 is

$$g(!) = \frac{1}{!} (38)$$

Thus only the second propagator has (in a perturbative regime) a FGR pole.

CONCLUSIONS

In this paper we solve the problem of tunneling from a discrete level into continuum . W e show, how the basic notion of the GF form alism, like frequency dependent discrete level propagator, self energy and spectral density, appearwithin the basic quantum mechanics. We concentrate on the calculation of the time dependent non-decay am plitude, the stage which is typically not given proper attention to within the GF form alism [5]. We show that the exponential time dependence of the non-decay probability given by the FGR is an approximation valid in perturbative regim e and only for interm ediate tim es. The large time dependence of the non-decay probability depends crucially upon the details of the band structure and hybridization interaction. We also look closely at those analytic properties of the propagator in the complex ! plane, which often pass unnoticed.

APPENDIX

To generalize Eq. (19) to the case of non-interacting Ferm i gas at nite temperatures, let us present the Ham iltonian (1) using second quantization

where c_k^y (q_k) and d^y (d) are creation (annihilation) operators of band states and discrete state respectively. The

tunneling of either the electron or the hole from the discrete level into continuum is described by G reen's functions $G^{>}$ and $G^{<}$ respectively [5]

 $G^{<}(t) = d^{y}(t)d(0)$: (40)

where the averaging is with respect to the grand canonical ensemble, and d(t) or $d^{y}(t)$ is the annihilation or the creation operator in H eisenberg representation. B oth G reen's functions are simply connected with the spectral density function [5]

where $n_F(!) = e^{(!)} + 1^{-1}$ is the Ferm idistribution function (is the chem ical potential and is the inverse tem perature). Thus we obtain
