Stability and entanglement in optical-atom ic amplication of trapped atoms: the role of atom ic collisions

A tom ic collisions are included in an interacting system of optical elds and trapped atoms allowing eld amplication. We study the elects of collisions on the system stability. Also a study of the degree of entanglement between atomic and optical elds is made. We found that, for an atomic eld initially in a vacuum state and optical eld in a coherent state, the degree of entanglement does not depend on the optical eld intensity or phase. We show that in conditions of exponential instability the system presents at long times two distinct stationary degree of entanglement with collisions a ecting only one of them.

#### I. INTRODUCTION

Bose-E instein condensation of trapped atom ic gases [1, 2, 3] has produced a fantastic advance in atom optics. Particularly, the interaction of condensates with single mode quantized light elds has been a fascinating topic [4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17], allowing for instance light and matter wave amplication [12, 13, 14], optical control of atom ic statistical properties [15, 16], and potential applications in quantum information technology [17].

It is known that the trap environm ent can modify the properties of ultra-cold atom s, such as its critical tem perature [18, 19]. Then it is expected that trap environment also in uences the interaction between ultra-cold atoms and optical elds. In Ref. [20], the trap environment effects on the Condensate Collective Atom ic-Recoil Laser (CARL) [21, 22] was considered by expanding them atterwave eld in the trap matter-wave modes. Such a situation was called Cavity Atom Optics (CAO), in analogy with the Cavity Quantum Electrodynamics (CQE) where the spontaneous em ission is modied by the presence of the cavity. The model obtained presents interesting properties such as two regimes of exponential instability [20] and statistical properties that depend on intensity and phase of the optical eld [23]. However, neither atom ic collisions was taken into account nor a detailed study of the degree of entanglem ent between atom ic and optical elds was done. Entanglement, one of the most notable characteristics of quantum mechanics [24], has been object of intense study, both in systems involving light and matter [25, 26] and in solids [27, 28], due to its im portant role for quantum -inform ation processing [29]. Therefore, inclusion of collisions and characterization of entanglement are important in order to turn the model more realistic and potentially useful for applications in the context of quantum information theory.

This paper deals with the extension of the model of atom-optical parametric amplier considered in Refs. [20, 23] by including collisions between atoms. A study of the changes due collisions on the thresholds of exponential instability as well as in grow thrate of the elds amplitudes is presented. Also a characterization of the degree of entanglement between atomic and optical elds is done. We show that in conditions of exponential instability the system presents at long times two distinct stationary degree of entanglement with collisions a ecting only one of them.

The article is organized as follows: In Section II we derive the elective ham iltonian describing the system studied. In Section III we present an analysis of the system stability. In Section IV we consider the atom-photon degree of entanglement in the regime of eld amplication. Finally, in Section V we present the conclusion.

# II. M ODEL

We consider a Schrodinger eld of bosonic two-level atoms, with transition frequency, interacting via two-body collisions and coupled by electric-dipole interaction to two single-mode running wave optical elds of frequencies! and! and! and a classical eld, respectively. Both optical elds are assumed being far o resonant from any electronic transition. Thus, although the atom's internal state remains unchanged, the center-of-mass motion may change due the atom ic recoil induced by two-photon virtual transitions. In the far o resonance regime the excited state population is small, and therefore spontaneous emission as well as col-

lisions between excited state atom s, and between ground state and excited states atom s, m ay be neglected. In this regime the excited state can be adiabatically eliminated and the ground state atom ic eld evolves coherently under the elective H am iltonian

m is the atom ic mass, V (r) is the trap potential, is the detuning between atoms and the classical optical eld,  $g_1$  and  $g_2$  are the optical elds coupling coe cients,  $K = k_1 k_2$  is the dierence between their wavevectors, and  $= !_1$  is the detuning between them . The operator  $\boldsymbol{\hat{a}}_1$  is the photon annihilation operator for the quantized optical eld, taken in the fram e rotating at the classical eld frequency ! 2. The optical eld treated classically is assumed to remain undepleted, so that  $a_2$  is simply a constant related to its intensity. Term s corresponding to the spatially independent light shift potential were neglected, so that the index of refraction of the atom ic sample was assumed the same of the vacuum. Two-body collisions were included in the swave scattering lim it by the second term inside brackets in the Hamiltonian (1), where

and a is the s-wave scattering length, which depending on the repulsive or attractive character of the interaction can assume positive or negative values, respectively. We consider only positive values of scattering length, which are suitable for the creation of large condensates, and correspond to a situation more consistent with the approximations in this paper.

We assume that the atom iceld is initially a Bose-Einstein condensate with mean number of condensed atoms N , and that this condensate is well described by a number state so its initial state is described by

where Di is the vacuum state, and

is the creation operator for atom s in the condensate state  $^{\prime}$   $_{0}$  (r). D ue to the presence of collisions the condensate wave function  $^{\prime}$   $_{0}$  (r) satis es the G ross-P itaevskii equation [30, 31]

where is the chemical potential.

Now we expand the atom ic eld operator in terms of the trap eigenmodes f'  $_{\rm n}$  (r)g according to

Therefore, in the linear regime, by inserting expansion (7) and taking into account the Gross-Pitaevskii equation (Eq. (6)), the Hamiltonian (1) reduces to

is the pollision modi ed energy of the nth trap level,  $_{n}=NA_{0n}$   $jg_{1}jjg_{2}jja_{2}j=jj$  is the e ective coupling constant between the condensate and the quantum optical eld,  $\hat{a}=(g_{1}g_{2}a_{2}=jg_{1}jjg_{2}jja_{2}jj)\hat{a}_{1}$  is the optical eld operatorm ultiplied by a phase factor that is related to the classical optical eld phase,

are the collision param eter and the elem ent ofm atrix for the optical transition, respectively, both assumed being real numbers. The phase factors e  $^{\rm i}$  t were included in the operators  $c_{\rm n}$  and  $c_{\rm n}^{\rm v}$ .

For sim plicity, we assume that the overlap-integral in the collision parameter given by Eq. (12) has a signicant contribution for a given n=1=m and the matrix for optical transition  $A_{0n}$  is sharply peaked for n=m [37]. In this case we can neglect all excited trap modes except the m-mode in the Hamiltonian (10), and the following elective Hamiltonian is obtained

Term s like  $\hat{a}^y c_m^y$  in H am iltonian (14) correspond to the generation of correlated atom -photon pair. These term s are analogous to the N ondegenerated O ptical P aram etric A m pli er [32]. Inclusion of collisions introduces term s like  $c_m^{y/2}$ , which are responsible by creation of an atom ic pair, and are analogous to the D egenerated O ptical P aram etric A m pli er [32]. The H eisenberg equations of motion for the eld operators obtained from H am iltonian (14) result the following 4 4 linear system of equations

where the index m was dropped in order to simplify notation, and we introduced the dimensionless parameters  $t=\,!_m\,t$ ,  $=\,-l_m$ ,  $=\,-l_m$ , and  $=\,-m=!_m$ .

### III. STABILITY

The solution of the linear system (15) can be written as

where we de ned  $\hat{\mathbf{x}}_1 = \hat{\mathbf{p}}, \hat{\mathbf{x}}_2 = \hat{\mathbf{c}}^y, \hat{\mathbf{x}}_3 = \hat{\mathbf{a}}$  and  $\hat{\mathbf{x}}_4 = \mathbf{a}^y$  for convenience,  $\mathbf{G}_{ij}$  (t) =  $\mathbf{E}_{k=1}^4 \mathbb{U}_{ik} \mathbb{U}_{ik} \mathbb{U}^{-1}_{kj} \mathbf{e}^{i!_k t}$ ,  $\mathbb{U}_{ik}$  is the ith component of the kth eigenvector of the matrix at RHS of Eq. (15), and  $\mathbf{E}_k$  are the system eigenfrequencies.

Stability analysis shows two regimes of exponential instability: (i) For > 0 and  $^2 > (1 + )=4$  there are two purely real and two purely imaginary eigenfrequencies of the form  $f!_1 = ;!_2 = ;!_3 = i;!_4 =$ where and are both real quantities. There is only one exponentially growing solution at the imaginary frequency  $!_4$  and the system is unstable. < 0 and <sup>2</sup> > (1) $^{2})^{2}=16 \text{ j j}(1$ ) the eigenfrequencies are complex numbers of the form  $f!_1 = +i;!_2 = +i;!_3 =$ i;! 4 = This case presents two exponentially growing solutions,  $!_3$  and  $!_4$ , which grow at the same rate , but rotate at equal and opposite frequencies , producing a beating in the exponential growth of the elds intensities. O therw ise the eigenfrequencies are real and the system is stable.




FIG. 1: Instability domains. Points inside region I correspond to one exponentially growing solution, whereas for points inside region II there are two counter-rotating exponentially growing solutions. The full line dene the threshold in the absence of collisions ( = 0.0). Change in the threshold due collisions correspond to the dashed ( = 0.4) and dotted lines ( = 0.8). The parameters are dimensionless.

In Fig. 1 we plot in the  $$^2$$  plane the values of param eters de ning the threshold between stable and unstable solutions. Points inside region I correspond to one exponentially growing solution, whereas for points inside region II there are two counter-rotating exponentially growing solutions. The full line indicates the threshold in the absence of collisions whereas dashed and dotted lines shows the change due collisions, which have the elect of reducing the unstable regions. In addition, for small the region II is centered around  $=\frac{1}{1}$  and at asymptotically large detunings its threshold grows as  $^2>$   $^3=16 \ (1)$ 

In order to illustrate the e ects pf collisions on the elds intensities  $I_i(t) = \hat{x}_i^y(t) \hat{x}_i(t)$ , with i=1;3, we consider that the atom icm ode begins in a vacuum state  $\hat{\mathcal{D}}i$  whereas the light eld is initially in a coherent state j i. Then, with the help of Eq. (16), we found

Figs. 2-(a) and 2-(b) shows the logarithm ic plot of the optical eld intensity  $I_3$  (t) as a function of time for parameters lying in the regions I and II of instability, respectively. The intensity of the atom ic mode has a simular behavior. We see that collisions reduce the rate of exponential growing and change the beating frequency of oscillation of the eld intensity. The change in the density distribution of atoms in the condensate mode due to collisions reduces the scattering of photons into the optical eld, as well as the scattering of atoms by the

optical eld into the atom ic mode, in opposition to eld amplication.

## IV. ENTANGLEMENT

Now we turn to analyze the atom-photon degree of entanglem ent for the exponential growing regimes of elds amplitudes. It is known that for a two-component system in a pure state the degree of entanglement can be characterized by the entropy or purity of one of the system components [34, 35]. Such entanglement measures require the calculation of the time-dependent quantum state for the system, which may not be an easy task. Instead, we consider a recently proposed entanglement coe cient in terms of cross-covariances of the elds operators de ned by [36]

with the notation  $\overline{x_ix_j}=hx_ix_ji$   $hx_iihx_ji$  for the unsym etrized centered second-orderm om ents of the opera-

tors. Since we know the time dependent solutions for the elds am plitudes the parameter Y is easily calculated for the system considered in this paper.

The coe cient Y satis es the inequality 0 Y < 1, where at the maximum value of Y the system is maximally entangled and was introduced taking into account that for two systems with operators  $\hat{A}$  and  $\hat{B}$ , if any of the cross-covariances with these operators diers from zero, then the modes are entangled. For the excited trap




FIG. 2: Logarithm ic plot of the light eld intensity as function of time. (a) for parameters lying over the region I of the instability domains. (b) for parameters lying over the region II of the instability domains. Full line corresponds to absence of collisions ( = 0:0) while dashed and doted lines corresponds to inclusion of collisions with = 0:4 and = 0:8, respectively. We set = 1 and = 2. The parameters are dimensionless.

m ode starting in a vacuum state and the light eld in a coherent state, we obtain,




FIG. 3: Plot of the entanglem ent coe cient as a function of time in absence of collisions for several values of detuning . We set = 1. The parameters are dimensionless.

Eq. (19) shows that the degree of entanglement do not depend on the optical eld intensity or phase. Furthermore, in the regime of exponential instability the parameter Y attains at long times a stationary value thats is dependent on the signal of the detuning. To see that, in Fig. 3 the parameter Y is plotted as a function of time for several values of detunings in the absence of collisions. We observe that for > 0 (one exponentially growing solution) the system attains at long times the maximum degree of entanglement, while for < 0 (two exponentially growing counter-rotating solutions) the long time degree of entanglement attains an oscillating stationary value far below the maximum one.




FIG. 4: Plot of the entanglement coe cient as a function of time. (a) for parameters lying over the region I of the instability domains. (b) for parameters lying over the region II of the instability domains. Full line corresponds to absence of collisions ( = 0.0) while dashed and doted lines corresponds to inclusion of collisions with = 0.4 and = 0.8, respectively. We set = 1.1 The parameters are dimensionless.

The e ects of collisions are presented in Figures 4-(a) and 4-(b) that show the entanglement coe cient as a function of time for values of parameters lying in regions of one and two exponential growing solutions, respectively, and considering dierent values for the collision parameter . We see in Fig. 4-(a) that collisions do not a ect at long times the degree of entanglement for > 0; which always tend to the maximum value. However, for < 0 (Fig. 4-(b)) collisions strongly a ects the long time degree of entanglement by changing the amplitude of oscillations of its stationary value.

### V. CONCLUSION

In conclusion, in this work we have included atom ic collisions in a model of an atom-optical parametric ampli er of trapped atoms. Analyzing the system stability in the regime of eld amplication, we found that atom ic

collisions reduce the growth rate of the elds am plitudes. For an atomic eld initially in a vacuum state and optical eld in a coherent state, we have veried that the degree

of entanglement between atom ic and optical elds does not depend on the optical eld intensity or phase. Furthermore, in conditions of eld amplication the degree of entanglement attains at long time a stationary value dependent on the regime of exponential instability, being maximum only in the case of one exponentially growing solution. Finally, atom ic collisions only a ect the long time degree of entanglement in the case of two exponentially growing solutions.
