A b-initio path integral techniques for molecules

Path integral Monte Carlowith Green's function analysis allows the sampling of quantum mechanical properties of m olecules at nite tem perature. W hile a high-precision com putation of the energy of the Born-Oppenheim er surface from path integral Monte Carlo is quite costly, we can extract m any properties without explicitly calculating the electronic energies. We demonstrate how physically relevant quantities, such as bond-length, vibrational spectra, and polarizabilities of molecules m ay be sam pled directly from the path integral simulation using M atsubura (tem perature) G reen's functions (im aginary-tim e correlation functions). These calculations on the hydrogen molecule (H_2) are a proof-of-concept, designed to motivate new work on xed-node path-integral calculations for m olecules.

I. INTRODUCTION

The quantum Monte Carlo (QMC) method has been extensively used as a powerful technique for calculating som e physical properties of many-body systems [1], such asmolecules [2, 3], solids [4], and nanostructures [5]. For molecules, it has been reported that the diusion QMC method can achieve near chemical accuracy within the xed-node approximation [6, 7].

W hile variational and di usion QMC algorithm susually sample only electrons at zero temperature, path integral Monte Carlo (PIMC) can sample both the ions and electrons simultaneously at nite temperature. This is a promising approach to calculate thermal e ects in the molecular systems. Additionally, PIMC includes the zero-point motion of the ions, yeilding the correct quantum statistical treatment of the motion of light ions at alltem peratures.

We note that another approach, coupled electron-ionic Monte Carlo (CEIMC) [8, 9], has been demonstrated in which electrons and ions are sampled in two independent but coupled M onte Carlo algorithms. For the molecule we study in this paper, a comparable CEIMC simulation would have a ground-state variational or di usion QMC simulation of the electrons that determines the Born-Oppenheim er energy surface. These QMC electron energies would then be used in a path integral simulation for the protons. Because the QMC estimates of ground-state electronic energies have statistical error bars, a penaltymethod [8] would be used to partially compensate for non-linear biases when these energies are fed into the ionic path integral M onte Carlo. U Ltim ately, the CEIM C m ethod requires a fairly accurate determ ination of total energies at many points on the Born-Oppenheim er surface form any dierent con gurations of the ion positions.

In this paper we address the following issue: by treating electrons and ions in the same path integral sim-

ulation (avoiding the explicit calculation of the Bom-Oppenheim er energy surface), can we extract properties of a molecule, such as bond-lengths, vibrational frequencies, and polarizability? These properties are often calculated directly from the Born-Openheim er surface, i.e. bond-lengths and vibrational frequencies come from localm in im a and curvature of the energy surface. Here we treat these properties as expectation values of the electron-ion therm aldensity matrix. That is, we do not m ake the Bom-Oppenheim er approximation, instead, we sample the electron and ion coordinates in a single path integral. The calculations presented here are a proofof-concept, dem onstrating how to extract physical properties from the PIMC simulations. The question of the relative e ciencies of this approach and CEIMC will have to be left to future calculations on larger system s, most likely requiring some kind of a path-integral xed-node approximation [10].

In PIMC simulations we can collect various correlation function of the system in imaginary time. These functions, known as nite temperature Matsubura Green's functions, can be transformed from the imaginary-time dom ain into the imaginary-frequencies through the fast Fourier transform (FFT). Since we want to calculate the physical properties of the system s, the correlation function at real frequency need to be obtained from the im aginary-frequency function. It is possible through the analytic continuation techniques to obtain real-time correlation function from imaginary-time correlation function, since a time-ordered correlation function is an analytic function of the time variable in the complex plane [11]. In other words, the time-correlation function calculated along the imaginary axis can be uniquely analytically continued to the real-time axis.

For the case of the simple and closed correlation function, the analytic continuation of imaginary-frequency correlation function is simply the replacement of i! n with ! + i . But for realistic correlation functions in m olecules it is hard to not the closed form of imaginary-frequency correlation function. Therefore analytic continuations need to be perform ed with num erical methods.

However, the analytic continuation of numerically evaluated correlation functions often leads to grossly am pli-

ed statistical errors in the realtim e correlation function. Some num erical methods have been proposed for reducing the statistical errors, such as using Pade approximations [12] or least-squares thing [13], minimizing a suitably de ned potential [14], maximum-entropy [15, 16], and singular value decomposition (SVD) methods [17]. It has been reported that the rotational constant of a molecule can be obtained by thing imaginary-time correlation function from PIMC data to analytic models of correlation function [18].

In this paper we show that some properties of molecules can be sampled directly from path integrals in ulations using M atsubura G reen's functions. For an accurate treatment of the Coulomb interactions between particles we use a new method to tabulate of the Coulomb density matrix that we have developed. Using correlation functions sampled with the accurate Coulomb propagator, we demonstrate PIMC calculations of the bond length, vibrational frequency, and polarizability of a hydrogen molecule. This calculations are important benchmarks for future calculations on more complicated systems. In particular, we have chosen a simple system without a fermion sign-problem so that we can separate the analysis of correlation functions from questions about the xed-node approximation.

II. M ONTE CARLO SAM PLING OF PATH INTEGRALS

A. M onte Carlo Sam pling

In them all equilibrium, the average value of any physical quantity can be calculated from the density matrix. In the coordinate representation, the thermaldensity matrix of N particles is dened by

where = $1=k_BT$ is the inverse temperature, R = $(r_1; N_i)$ rare the particle coordinates, r_i is the position of the i-th particle, and Z = $(R_i; R_i; N_i)$ dR is the partition function.

The average value of any physical quantity 0 can be w ritten

In the path-integral form u.l., in N $\,$ slices, we expand the density m atrix [19],

where m is the mass of the particle and the time step is = = N. In our molecule simulations $= 0.01~{\rm H\,a}^{-1}$. We estimate this high dimensional integral with Metropolis Monte Carlo algorithm, with an ecient multilevel sampling method. For a detailed discussion of P IM C methods, see reference [20].

B. A ccurate C oulom b A ction

The prim itive approximation to the path integral, Eq. (3), is not correct for attractive Coulomb interactions. Instead, we use an improved quantum action U (R;R 0) in place of the bare Coulomb potential V (R). The use of improved actions is discussed in reference [20].

In order to m ore accurately describe the C oulom b interactions we have developed a new technique for tabulation of imaginary-time C oulomb G reen's function [21], from which we extract the C oulomb action. The G reen's function, $G(r;r^0)$ for two particles in N-dimensional space satis es the equation,

The initial condition is G $^{(N)}$ (r; $r^0;0)={}^N$ (r ${}^{r^0})$ and r and r^0 refer to the relative separation of two particles with reduced m ass , and z is the product of the charges. There are several ways to numerically evaluate G reen's function, see reference [21]. But each methods has its particular limitation and numerical errors are often more than one percent.

Since the Coulomb potential, $V(r) = \frac{1}{r}$, has the symmetry properties, without a partial wave expansion we are able to simple, fast, and highly accurate numerical evaluation of $G(r;r^0;)$ using one-dimensional FFT's. The technique relies on Hostler's recursion relation [22, 23], which relates the N-dimensional Green's function to the 1-dimensional function. The use of an accurate Coulomb action is especially important in chemistry. An analogy can be drawn to the use of accurate integration schemes in molecular dynamics. In the current work, we not that quantities, such as the molecular binding energy and electrical polarizability are especially sensitive to the quality of the tabulated Coulomb action.

III. EST IM ATORS

A. Energy and the Virial Estim ator

There are several estim ators to obtain the total therm all energy of a system . The most widely used energy estim ator is the therm odynam ic energy estim ator, which is obtained by differentiating the partition function with respect to $\ ,$

where Z is the partition function and U_i is the action. In other words, the therm alenergy is an average value of the imaginary-time derivative of the action.

For the calculation of molecules we used the virial energy estimator. The virial estimator of the energy is

where $_{\rm i}$ is the deviation of the i-th particle from its average position, and F $_{\rm i}$ is a generalization of the classical force,

Form ore detailed derivation, see references [20] and [24].

B. Static polarization

The general description of the static polarization of molecules is P = E, where E is the applied electric eld, is the static polarizability tensor of the molecule, and and denote vector directions. For diatom ic molecules, symmetry reduces the polarizability tensor to reduced into two components, the parallel ($_k$) and perpendicular ($_2$) polarizability.

U sing the polarization estim ator

we calculate the static polarizability of the molecules given the electric eld. Here X (i) is the position of the i-th particle in the direction of , and E is the magnitude of the the electric eld in the direction.

C. The M atsubura G reen's function m ethod

The M atsubura G reen's function m ethod is a very useful technique for calculating the physical properties of m any-body systems at nite temperature [25]. The general de nition of temperature G reen's function is

where T is the time-ordering operator, represent the imaginary time, and A and B are operators. The bracket means the thermal average value at the inverse temperature = $1=k_B$ T. If the Ham iltonian of the system is independent of time, G reen's function becomes only a function of the time dierence 0, so it also can be written G () = hT A ()B (0)i.

A Fourier transform gives the frequency dependence of G reen's function for bosonic quantities, such as molecular vibrations and polarizabilities,

where $!_n=2n=$ and n=0; 1; 2; . In the linear response theory, the linear response of the system to a small perturbation can be written in terms of the G reen's function.

Asm entioned in the introduction section, through analytical continuation, M atsubura G reen's function of com plex frequencies, i! $_{\rm n}$, can be analytically continued to real, tim e-ordered correlation functions, which determ ine physical properties of the dynamic system. However, in num erical analytic continuation even small noise on im aginary-time correlation can make big statistical errors in real time dynamics of the system [17]. Instead of that, we analyze directly the imaginary-time correlation function calculated by path integral M onte Carlo m ethod in order to obtain som e properties of molecules. To calculate bond-length and vibrational frequency, we use displacement-displacement imaginary-time correlation functions and their Fourier transform s. For polarizability of molecules we use polarization-polarization correlation function.

1. Bond-length and vibrational frequency

For calculating of the bond-length and vibrational frequencies of molecules we use the displacement-displacement correlation function. The displacement correlation function of a harmonic oscillator, with V (x) = $\frac{1}{2}$ m! $_{SHO}$ x², in the imaginary-time domain at the inverse temperature can be written

where x() refers to the displacement of the oscillator from equilibrium. For > 0, this correlation function is [26],

where N = 1=($e^{! \text{ SHO}}$ 1) is the distribution function at the tem perature, $k_B T = 1$ = and we set ~ = 1.

For the hydrogen m olecule, the displacement x () represents the deviation from the equilibrium separation distance between two protons. The mass, m is the reduced mass of two protons. At low temperature, we assume that the molecule is in harm onic motion, so we compare our results with the simple harm onic oscillator.

We are able to extract the bond length from im aginarytime displacement-displacement correlation function, Eq. (11). The function $G() = h\kappa()\kappa(0)i$ can measure the uctuation in the quantity κ . At = 0, the initial value of G(0) is the equilibrium average $h\kappa^2i$. As time goes on, the correlation function shows the time decay which measure how $\kappa()$ and $\kappa(0)$ are correlated each other. In the long time lim it, the correlation function becomes totally uncorrelated so that the correlation function can be written as,

At = = 2, G (= 2) is approxim ately hD i², where D is the bond length of the molecule at low temperature. Since the bond length can be directly computed as a time-independent average, this limit is an important sanity check on our imaginary-time data.

To obtain the vibrational frequency of molecules we use imaginary-frequency correlation function. Using Eq. (10), we can obtain the correlation function of the simple harmonic oscillator in the imaginary-frequency space,

Once we have the correlation function, we can calculate the vibrational frequency $!_{SHO}$ at $i!_n = 0$,

A nother way to nd the frequency is to directly use the correlation function. Since the correlation function $G(i!_n)$ form sa Lorentzian in the imaginary axis of complex G reen's function, the full width at half maximum (FW HM) of the correlation function is equal to the frequency of the harm onic oscillator. Therefore we can compare to these frequencies using two methods.

2. Polarization

We use the polarization-polarization correlation function to calculate the polarizability of molecules. The imaginary-time correlation function can be written

where P () = ex (). Once we have obtained the imaginary-time correlation function, by Fourier transform Eq. (10) we can calculated the dynamic polarizability.

Sim ilar to the bond-length calculation, rst we calculate the polarizability for a simple harmonic oscillator. Note that this oscillator is a model for our polarization analysis and is not related to molecular vibrations.) From linear responses theory the static susceptibility, due to the smallelectric eld perturbation exE, can be written with the rst order perturbation theory,

It is clear that the polarizability depends on the con nement potential of the harm onic oscillator, $!_{\,\rm SHO}$.

We can also obtain the polarizability from the imaginary-frequency polarization-polarization correlation function. The correlation function for the simple

harm onic oscillator is

Sim ilar to bond length estim ator, we assume that the molecules are in the harmonic motion. Once we obtain (i! $_{\rm n}$), the polarizability (0) is the value at i! $_{\rm n}$ = 0. Note that for molecules the polarizations P are to be added for all particles in the molecule.

IV. RESULTS

In this section we report the results of our tests on an $\rm H_2$ molecule. Simulations were performed in serial and in parallel jobs with up to eight processors using our open-source pi code available online at http://phy.asu.edu/shum.way/codes/pi.html. We use a time step of = 0.01 Ha 1 , which leads to a discretization of the path integral into 100,000 slices at the lowest temperature (when = 10^3 Ha 1 for T 300 K).

A. Born-Oppenheim er energy surface




FIG. 1: Born-Oppenheim er surface of $\rm H_2$ molecule. Solid line is the accurate potential energy curve from the reference [27] and data points are P IM C results using the virial energy estim ator.

To check the accuracy of our discretized path integral, we calculate the potential energy surface of the ground state $\rm H_2$ m olecule with the internuclear separation from $0.5\,a_0$ to $4.5\,a_0$. For this calculation we xed the proton's position of the $\rm H_2$ m olecule, then calculate the thermal energy using the virial energy estimator. Figure 1 shows a very good agreement with the accurate potential energy curve (solid line) [27]. Note that we do not use this energy surface for any of the subsequent calculations. We only present the calculation here to verify that we can get the correct detailed energy surface if we so desire. All following results are directly sampled from the electronion density matrix.

B. Vibrational frequency of a H $_{\rm 2}$ m olecule




FIG. 2: The displacem ent-displacem ent correlation functions of im aginary-frequency for a hydrogen molecule at three different temperatures. The lines are the correlation functions of imaginary-frequency of harmonic oscillator at each temperatures and points represent our results before thing the vibrational frequency into the correlation function.

By sampling the displacement-displacement correlation function in imaginary time, we have calculated the vibration frequencies of a hydrogen molecule ($\rm H_2$) at three dierent inverse temperatures, = 200;500, and 1000 Ha 1 , corresponding to T 1500K, 600K, and 300K. Figure 2 shows the correlation function in imaginary-frequency domain for a hydrogen molecule. The solid lines are the displacement-displacement correlation functions of imaginary-frequency for the simple harmonic oscillator at each temperatures and the points represent our data points for the Hydrogen molecule. As described in Sec. IIIC 1, we extract the frequency using two dierent approaches: (i) a t to a simple harmonic

oscillator and (ii) the full-width at half-maximum of the frequency response. The results are summarized in Table I.

The exact ground state vibrational frequency of $\rm H_2$ is 0.02005 in atom ic units (= 4401.21 cm $^{-1}$) [28]. Due to the anham onic properties of the hydrogen m olecule's potential surface, the di erence between the ground state and the rst excite state level is 0.01895 hartree (4161.14 cm $^{-1}$) [29]. The time correlation functions measure this physical energy di erence, not the unphysical exact ground state frequency.

It is shown that the frequency is not sensitive to the temperatures. Because the thermal energy is so small, it just a ects the rotational levels. Since we doesn't x the protons in the space, there are rotational e ects to the calculation of frequency. The analytical results (solid lines in Fig. 2) are based on the harm onic oscillator without rotational motion.

C. Bond-length of a H 2 m olecule




FIG. 3: The displacement-displacement correlation function of imaginary time for a hydrogen molecule at three dierent temperatures. The solid lines are analytical correlation function of simple harmonic oscillator and the points are PIMC results at each temperatures.

N ext, we calculate the bond length of the H $_2$ m olecule from imaginary-time correlation function. Figure 3 shows

the displacem ent-displacem ent correlation functions of imaginary time at three temperatures. At room temprature, Fig. 3 (c), we could oberve the at in the middle of the imaginary time, which shows the correlation function is fully uncorrelated.

The exact bond length of a ground state hydrogen molecule is 1.401 in atom ic units [28]. With bond-length estimator we directly calculate two average values of the internuclear distance, hD i and hD 2 i. Table II shows the summary of two bond length averages from the estimator and the correlation function of a hydrogen molecule in atom ic units. It shows the two dierent methods agree very well.

The therm ale ects on the bond-length of a m olecule can be calculated from the Boltzmann factor (2J + 1)e $^{\rm E}$ $^{\rm J}$ with 2J + 1-fold degeneracy due to the rotational motion, where J is the total angular mom entum . The energy is E $_{\rm J}$ = BJ(J+1), where B is the rotational constants of a hydrogen molecule, B = 60.853 cm $^{\rm 1}$. At tem perature, $k_{\rm B}$ T = 1= , the number of molecules N $_{\rm J}$ in the rotational level J can be calculated by

W ith the number of distribution with respect to the temperature, we can calculate the elective potential due to the rotationalmotion in explicit method using Morse potential. We observed that the bond-length has changed the factor of 10 2 .

D. Polarization

M any-body perturbation m ethods are usually used for calculating the polarizability of m olecules. In the case of the hydrogen m olecule, the wavefunctions are very well known so that the variational perturbation m ethods of




FIG. 4: The polarization-polarization correlation function for simple harm onic oscillators with three di erent harm onic strength, $!_{\,\text{SHO}}=0.5;1;2$. At $i!_{\,n}=0$, the arrows show the polarizability for each oscillators.

the polarizability of the molecule agree very well with the experimental results [30, 31]. With the samement ethod the polarizability have been calculated of the dependence on rotation and vibration states [32] and of the function of internuclear separation [33].

We have calculated the polarizability of a hydrogen molecule in P IM C using two dierent approaches. The rst method is to use the polarization estimator as we explained in the estimator section, see Eq. (8). By applying a small electric eld through the z-axis to a xed molecule, we have calculated the polarizability at room temperature, for the parallel direction $_{\rm k}=6.12$ (50), and for perpendicular $_{\rm c}=4.92$ (26) in atom ic units. The exact value is $_{\rm k}=6.380$ and $_{\rm c}=4.577$ [31].

A nother way to calculate the polarizability is to use the polarization correlation function. We calculate the polarizability of the simple harmonic oscillator for three dierent oscillator strength $!_{\,\mathrm{SHO}}=0.5;1;2$ for the test of the correlation function method. As we mention in the estimator section, the static polarizability can be obtained at i! $_{n}=0$ of (i! $_{n}$). As the harmonic strength increase, the polarizability becomes smaller, see the equation (18). Figure 4 shows that the values of polarizability for the dierent harmonic strengths exactly follow Eq. (18). The polarizabilities for each oscillators are for $!_{\,\mathrm{SHO}}=1,~=1,~\mathrm{for}~!_{\,\mathrm{SHO}}=0.5,~=4$ and for $!_{\,\mathrm{SHO}}=2,~=0.25$ respectively at i! $_{n}=0.$

We can also estim ate the possible dipole transition energy levels (~! $_{SHO}$) from the values of the full width at half maximum (FW HM) of correlation function. With the analytic continuation we can obtain retarded G reen's function (G R (!)) of real frequency (!) from the imaginary-frequency correlation function (G $(i!_n)$). The retarded G reen's function is also related the spectral density func-




FIG.5: The polarization-polarization correlation function of a hydrogen atom . Ati! $_{\rm n}=0$, the arrow shows the polarizability of a hydrogen atom , 4.51 (3). The exact value is 4.5 in atom ic units.

tion (A(!)) for the harm onic oscillator at ! > 0,


At the poles ! = $!_{SHO}$, the spectral function is a delta function and imaginary-frequency correlation function form a Lorentian with FW HM of $!_{SHO}$. Since the harmonic oscillator has one possible transition, the values of FW HM are exactly the same as the harmonic strengths. But for a atom and molecule the FW HM doesn't represent the possible transition levels, because the levels are not equivalent.

Next we test the correlation function method for calculating the polarizability of a hydrogen atom. We found that the polarization-polarization correlation function has the same form whether the proton of the atom is xed or not. Figure 5 shows the correlation function at $=1000~{\rm H\,a^{-1}}$. We have obtained the polarizability is 4.51 (3) in atom ic units, while the exact value is 4.5.

For the hydrogen molecule, we xed the positions of two protons at the z-axis, so that the rotation e ect doesn't need to be considered for the polarization of the molecule and thus the correlation function is independent of the tem perature.




FIG. 6: The polarizability of a hydrogen molecule at = 1000. The protons are xed on the z-axis for the upper panel and un xed at the lower panel. The x, y components and the z component of polarizability represent $_{?}$ and $_{k}$ respectively.

Figure 6 shows the imginary-frequency correlation function of a hydrogen molecule when the protons are xed (a) and un xed (b). For the perpendicular ($_{?}$) and parallel ($_{k}$) polarizability we need to calculate x,y and z components of the displacement of particles (two electrons and two protons) respectively. We have obtained the perpendicular $_{?}$ = 4:56(17) and parallel $_{k}$ = 6:40(15) polarizability.

The value of FW HM is 0.596 for the perpendicular ($_{?}$) and 0.534 for the parallel ($_{\rm k}$) of the correlation

function. The polarizability of a molecule is a physical quantity how the molecule induced by an electric eld. For a diatom ic mole possible dipole transition energy levels for ($_2$) is bigger than ($_k$) because of the molecule structure.

We also have calculated the correlation function with un xed protons, allowing rotational and vibrational motion of the molecule. Since the trace of the polarizability tensor is invariant, the average polarizability, $= \frac{1}{3} (2_? + _k), \text{ should be identical with dierent conguration, see Fig. 6 (b). The exact average polarizability is 5.4139 in atom ic units [31]. This is the same value of non xed protons. Table III shows the sum mary of the polarizability for the simple harmonic oscillators, the hydrogen atom and the hydrogen molecule.$

V. CONCLUSIONS

We have demonstrated analysis techniques for path integral M onte C arlo simulations of molecules. The aim of these calculations is to show how important physical properties of molecules energies, bond lengths, vibrational frequencies, and polarizability can be computed directly from a path integral simulation without an explicit calculation of energies on the Born-O penheim er surface. This paper has focused on the analysis of M atsubura G reen's functions for bond length and electrical dipole operators. We have \lim ited this analysis to the H_2 molecule to avoid complications from xed-node approximations. Future calculations will need to properly treat fermions, most likely with a xed-node approximation, if these techniques are to have use in practical molecular simulations. The results presented here are benchmarks

that validate continued developm ent of the P ${\rm I\!M}$ C technique.

We have two main ndings: (1) displacement-displacement Green's functions can give accurate estimates of the energy splitting ~! between the ground and rst-excited vibrational states, and (2) dipole-dipole Green's functions provide accurate estimates of the electrical polarizability of atoms and molecules. Implicit in these results is the demonstration of very high accuracy of the discretized path integral through the use of a carefully tabulated coulomb action.

It is important to the computational strategy we are advocating in these calculations: rather than using costly m any-body techniques to calculate individual points on the Bom-Oppenheim er surface, we are including the quantum and thermal average of ionic positions in the many-body electronic calculation. This approach may lead to better algorithm ice ciency for systems that have signi cant therm alor zero-point ionic motion, including systems with strong polaronic e ects. The merits of this approach relative to other QMC techniques, such as CEIMC, cannot be measured until we treat larger m olecular system s. M ore complicated molecules will also lead to more complicated Green's functions that encode information on the normal modes. Nevertheless, the benchmark calculations presented here are a necessary rst step towards future calculations on more interesting m olecules.
