# Functional integral treatm ent of som e quantum nondem olition system s

#### Abstract

In the schem e of a quantum nondem olition (QND) m easurem ent, an observable is $m$ easured w ithout perturbing its evolution. In the context of studies of decoherence in quantum com puting, we exam ine the bpen' quantum system of a two-level atom, or equivalently, a spin-1/2 system, in interaction $w$ ith quantum reservoirs of either oscillators or spins, under the Q ND condition of the H am iltonian of the system com muting with the system reservoir interaction. For com pleteness, we also exam ine the well-known non-Q ND spin B ose problem. For all these $m$ any-body system $s$, we use the $m$ ethods of functional integration to work out the propagators. $T$ he propagators for the Q ND H am iltonians are show $n$ to be analogous to the squeezing and rotation operators, respectively, for the two kinds ofbaths considered. Squeezing and rotation being both phase space area-preserving canonical transform ations, this brings out an interesting connection betw een the energy-preserving Q ND H am iltonians and the hom ogeneous linear canonical transform ations.

## 1. Introduction

In the schem e of a quantum nondem olition (QND) m easurem ent, an observable is m easured w ithout perturbing its free $m$ otion. Such a schem e was originally introduced in the context of the detection of gravitational waves [1]. It was to counter the quantum $m$ echanical unpredictability that in general would disturb the system being measured. The dynam ical evolution of a system im $m$ ediately follow ing a $m$ easurem ent lim its the class of observables that $m$ ay be $m$ easured repeatedly $w$ ith arbitrary precision, $w$ th the in uence of the $m$ easurem ent apparatus on the system being con ned strictly to the conjugate observables. Observables having this feature are called QND or back-action evasion observables [2, 3, 4]. In addition to its relevance in ultrasensitive measurem ents, a QND scheme provides a way to prepare quantum $m$ echanical states which $m$ ay otherw ise be di cult to create, such as Fock states with a speci c number of particles. One of the original proposals for a quantum optical QND schemewas that involving the $K$ err $m$ edium [5], which changes its refractive index as a function of the num ber of photons in the signal pump laser. T he advent of experim ental $m$ ethods for producing B ose $\pm$ instein condensation (BEC) enables us to $m$ ake progress in the $m$ atter-w ave analogue of the optical $Q N D$ experim ents. In the context of research into BEC, QND schem es with atom s are particularly valuable, for instance, in engineering entangled states or Schrodinger's cat states. A state preparation w ith BEC has recently been perform ed in the form of squeezed state creation in an optical lattice [6]. In a di erent context, it has been shown that the accuracy of atom ic interferom etry can be im proved by using QND $m$ easurem ents of the atom ic populations at the inputs to the interferom eter [7].

N o system of interest, except the entire universe, can be thought of as an isolated system \{ all subsets of the universe are in fact bpen' system $s$, each surrounded by a larger system constituting its environm ent. The theory of open quantum system sprovides a naturalroute for reconciliation ofdissipation and decoherence w th the process of quantization. In this picture, friction or dam ping com es about by the transfer of energy from the sm all system (the system of interest) to the large' environm ent. The energy, once transferred, disappears into the environm ent and is not given back within any tim e ofphysical relevance. Ford, K ac and M azur [8] suggested the rst $m$ icroscopic $m$ odeldescribing dissipative e ects in which the system was assum ed to be coupled to a reservoir of an in nite num ber of harm on ic oscillators. Interest in quantum dissipation, using the system -environm ent approach, was intensi ed by the works of C aldeira and Leggett [9], and Zurek [10] am ong others. The path-integral approach, developed by Feynm an and Vemon [11], w as used by C aldeira and Leggett [9], and the reduced dynam ics of the system of interest was followed taking into account the in uence of its environm ent, quanti ed by the in uence functional. In the $m$ odel of the uctuating or $\backslash \mathrm{B}$ rownian" m otion of a quantum particle studied by C aldeira and Leggett [9], the coordinate of the particle was coupled linearly to the ham onic oscillator reservoir, and it was also assum ed that the system and the environm ent were initially factorized. The treatm ent of the quantum B row nian m otion has since been generalized to the physically reasonable initial condition of a $m$ ixed state of the system and its environm ent by H akim and Am begaokar [12], Sm th and C aldeira [13], G rabert, Schram $m$ and Ingold [14], and by us for the case of a system in a Stem-G erlach potential [15], and also for the quantum $B$ row nian $m$ otion $w$ ith nonlinear system -environm ent couplings [16].

An open system $H$ am iltonian is of the QND type if the $H$ am iltonian $H_{s}$ of the system com $m$ utes with the Ham iltonian $H_{S R}$ describing the system reservoir interaction, i.e., $H_{S R}$ is a constant of $m$ otion generated by $\mathrm{H}_{\mathrm{s}}$. Interestingly, such a system m ay still undergo decoherence or dephasing without any dissipation of energy [17, [18].

In this paper, we study such QND bpen system ' H am iltonians of particular interest in the
context of decoherence in quantum com puting, and obtain the propagators of the com posite system $s$ explicitly using path integral $m$ ethods, for two di erent $m$ odels of the environm ent. $T$ he aim is to shed some light on the problem of $Q N D$ m easurem ent schem es. $C$ an one draw upon any fam iliar sym $m$ etries to connect with the tim e-evolution operation of these QND system s of im $m$ ense physical im portance?

We take our system to be a two-level atom, or equivalently, a spin-1/2 system. We consider two types of environm ent, describable as baths of either oscillators or spins. O ne cannot in generalm ap a spin-bath to an oscillator-bath (or vioe versa); they constitute distinct universality classes of quantum environm ent [19]. The rst case of oscillator-bath models (originated by Feynm an and Vemon [11]) describes delocalized environm entalm odes. For the spin-bath, on the other hand, the nite $H$ ilbert space of each spin $m$ akes it appropriate for describing the low energy dynam ics of a set of localized environm ental m odes. A di culty associated $w$ th handling path integrals for spins com es from the discrete $m$ atrix nature of the spin $H$ am iltonians. This di culty is overcom e by bosonizing the $H$ am iltonian by representing the spin angularm om entum operators in term sofboson operators follow ing Schw inger's theory of angular $m$ om entum [20].

We then use the Bargm ann representation [21] for all the boson operators. The Schrodinger representation of quantum states diagonalizes the position operator, expressing pure states as wave functions, whereas the $B$ argm ann representation diagonalizes the creation operator $b^{\text {y }}$, and expresses each state vector $j$ i in the $H$ ilbert state $H$ as an entire analytic function $f($ ) of a complex variable. The association $j i \quad!f()$ can be written conveniently in term s of the nom alized coherent states $j i$ which are the right eigenstates of the annihilation operator b:

W e obtain the explicit propagators for these $m$ any-body system $s$ from those of the expanded bosonized form s by appropriate projection.

The propagators for the QND Ham iltonians with an oscillator bath and a spin bath are show $n$ to be analogous to the squeezing and rotation operators, respectively, which are both phase space area-preserving canonical transform ations. This suggests an interesting connection between the energy-preserving QND Ham iltonians and the hom ogeneous linear canonical transform ations, which would need further system atic probing.

The plan of the paper is as follow s. In section 2 we take up the case of a QND type of open system H am iltonian where the bath is a bosonic one of harm on ic oscillators. In section 2.1 we consider a case, which is a variant of the previous one, wherein we include an extemal $m$ ode in resonance $w$ ith the atom ic transition and obtain its propagator. In section 2.2 we discuss the non-QND variant of the Ham iltonian which usually occurs in the literature in discussions of the spin Bose problem [22, 23]. In section 3 we treat the case of a QND -type of open system Ham iltonian where the bath is com posed of two-level system s or spins. The structure of the propagators in the two cases of the oscillator and spin baths is discussed in section 4, and in section 5 we present our conclusions.

## 2. B ath of harm onic oscillators

W e rst take the case where the system is a two-level atom interacting w ith a bosonic bath of harm onic oscillators w th a Q ND type of coupling. Such a m odelhas been studied [24, 25, 26] in the context of the in uence of decoherence in quantum computation. T he total system evolves under the H am iltonian,

$H$ ere $H_{S} ; H_{R}$ and $H_{S R}$ stand for the $H$ am iltonians of the system, reservoir, and system reservoir interaction, respectively. W e have $m$ ade use of the equivalence of a tw o-levelatom and a spin-1/2 system, $x ; z$ denote the standard $P$ auli spin $m$ atriges and are related to the spin-
ipping (or atom ic raising and low ering) operators $S_{+}$and $S: x=S_{+}+S, z=2 S_{+} S \quad 1$. In (1) $b_{k}^{y} ; b_{k}$ denote the Bose creation and annihilation operators for the $M$ oscillators of frequency $!_{k}$ representing the reservoir, $g_{k}$ stands for the coupling constant (assum ed real) for the interaction of the eld w th the spin. Since $\left.\mathbb{H}_{S} ; H_{S R}\right]=0$, the $H$ am iltonian (1) is of Q ND type.

The explicit propagator $\exp \left(\frac{i H t}{h}\right)$ for the $H$ am iltonian (1) is obtained by using functional integration and bosonization [22,27]. In order to express the spin angularm om entum operators in term $s$ of boson operators, we em ploy Schw inger's theory of angular $m$ om entum [20] by which any angular m om entum can be represented in term $s$ of a pair ofboson operators $w$ ith the usual commutation rules. The spin operators $z$ and $x$ can be written in term $s$ of the boson operators a , $a^{y}$ and $a, a^{y}$ as

Here we associate the values with time $t$ and ${ }^{0}$ with time $t=0$ as is also evident from (8). The sim ple form of the last term on the right-hand side of (23) reveals the Q ND nature of the system reservoir coupling. Since we are considering the unitary dynam ics of the com plete H am iltonian (1) there is no decoherence, and the propagator (23) does not have any o -diagonal term s . In a treatm ent of the system alone, i.e., an open system analysis of Eq. (1) after the tracing over the reservoir degrees of freedom, it has been show n [25] that the population, i.e., the diagonalelem ents of the reduced density $m$ atrix of the system rem ain constant in tim ew hile the o -diagonalelem ents that are a signature of the quantum coherences decay due to decoherence, as expected.
$N$ ote that though the com $m$ only used coordinate-coupling $m$ odeldescribing a free particle in a bosonic bath, explicitly solved by H akim and Am begaokar [12], w ith

### 2.2. N on-Q ND spin-B ose problem

In this subsection we consider a Ham iltonian that is a variant of the spin Bose problem [22, 27, 23]. This addresses a num ber of problem s of im portance such as the interaction of the electrom agnetic eld m odes $w$ th a two-level atom [30, 31]. A nother variant of the spin-B ose problem has been used for treating problem s of phase transitions [32, 33] and also to the tunnelling through a barrier in a potential well [34]. O ur H am iltonian is

$T$ his could describe, for exam ple, the interaction ofM modes of the electrom agnetic eld with a tw o-level atom via a dipole interaction. This has a form sim ilar to Eq. (1) except that here the system -environm ent coupling is via $x$ rather than $z$. This makes the H am iltonian (36) a non-Q ND variant of the H am iltonian (1). We proceed as in Section II w ith $\mathrm{H}_{\mathrm{N}_{1}}$ (17) now given by

This agrees w th the results obtained in [22, 27]. T hem atrix on the right-hand side ofE q. (40) contains diagonal as well as o -diagonal term $s$ in contrast to the $m$ atrix on the right-hand side of Eq. (23) in which only diagonal elem ents are present. This is due to the non-Q ND nature of the system toath interaction of the H am iltonian described by Eq. (36) whose propagator is given by Eq. (40), whereas Eq. (23) is the propagator of the H am iltonian given by Eq. (1) where the system boath interaction is of the QND type. The simpler form of the structure of the propagator (23) com pared to the non-Q ND propagator (40) re ects on the sim pli cation in the dynam ics due to the QND nature of the coupling.

## 3. B ath of spins

N ow we consider the case where the reservoir is com posed of spin-half or tw o-level system s , as has been dealt w ith by Shao and collaborators in the context of Q ND system s [18] and also quantum com putation [35], and for a nanom agnet coupled to nuclear and param agnetic spins [19]. T he total H am iltonian is taken as

The above equations have only diagonal elem ents. W e can see from the above equations that there are 16 am plitudes of the propagator for each $m$ ode $k$ of the reservoir out of $w$ hich only the energy-conserving term s are present due to the Q ND nature of the system reservoir coupling.

## 4. D iscussions

W e look closely at the form s of the propagators (23) and (61) of the Q ND type H am iltonians (1) and (43), respectively. In the rst case with an oscillator bath, Eq. (23) involves the $m$ atrix

It can be easily seen from the right-hand side of the Eq. (72) that the determ inant of the transform ation of the spin vectors brought about by the $n$-odd $m$ atrix (71) has the value unity. It is well known that the determ inant of a rotation $m$ atrix is unity [39]. T hus we see that the above transform ation has the form of a rotation. Speci cally, it can be seen that

Here $T$ stands for the transpose operation. From the above it is seen that the $m$ atrix (68) has the form of the operation of rotation', whidh is also a phase space areapreserving canonical transform ation [36] and com es out as an artifact of hom ogeneous linear canonical transform ations [37]. A ny elem ent of the group of hom ogeneous linear canonical transform ations can bew rilten as a product of a unitary and a positive transform ation [40, 41], which in tum can be shown to have unitary representations (in the Fock space) of rotation and squeezing operations, respectively [37]. It is interesting that the propagators for the H am iltonians given by Eqs. (1) and (43), one involving a tw o-level system coupled to a bath of harm onic oscillators and the other with a bath of two-level system $s$, are analogous to the squeezing and rotation operations, respectively.

## 5. C onclusions

In this paper we have investigated the form s of the propagators of som e Q ND H am iltonians comm only used in the literature, for example, for the study of decoherence in quantum com puters. W e have evaluated the propagators using the functional integral treatm ent relying on coherent state path integration. W e have treated the cases of a tw o-level system interacting with a bosonic bath of harm onic oscillators (section 2), and a spin bath of two-level system s
(section 3). In each case the system -bath interaction is taken to be of the QND type, i.e., the H am iltonian of the system com $m$ utes w ith the H am iltonian describing the system -bath interaction. $W$ e have show $n$ the com $m$ only occuring free-particle coordinate coupling $m$ odel to be unitarily equivalent to the free-particle velocity coupling $m$ odel which is of the QND type. For the variants of the $m$ odel in section 2 , we have exam ined (a) the case where the two-level system in addition to interacting with the bosonic bath of harm onic oscillators is also acted upon by an extemalm ode in resonance with the atom ic transition (section 2.1), and (b) the non-QND spin-Bose problem (section 22), which could be used to describe the spin - ose problem of the interaction of a two-levelatom $w$ ith the electrom agnetic eld $m$ odes in a cavity via a dipole interaction.

The evaluation of the exact propagators of these $m$ any body system $s$ could, apart from their technical relevance, also shed some light onto the structure of QND system s . We have found an interesting analogue of the propagators of these $m$ any boody $H$ am iltonians to squeezing and to rotation, for the bosonic and spin baths, respectively. Every hom ogeneous linear canonical transform ation can be factored into the rotation and squeezing operations and these cannot in general be $m$ apped from one to the other $\{$ just as one cannot in general map a spin bath to an oscillator bath (or vice versa) \{ but together they span the class of hom ogeneous linear canonical transform ations and are universal'. Squeezing and rotation, being artifacts of hom ogeneous linear canonical transform ations, are both phasespace area-preserving transform ations, and thus this im plies a curious analogy between the energy-preserving QND H am iltonians and the hom ogeneous linear canonical transform ations. $T$ his insight into the structure of the Q ND system swould hopefilly lead to fiuture studies into this dom ain.
