H om ological invariants of stabilizer states

W e propose a new kind of invariant of multi-party stabilizer states with respect to local C li ord equivalence. These hom obgical invariants are discrete entities de ned in term s of the entanglem ent a state enjoys with respect to arbitrary groupings of the parties, and they m ay be thought of as re ecting entanglem ent in a qualitative way. W e investigate basic properties of the invariants and link them with known results on the extraction of G H Z states.

I. IN TRODUCTION

A. O verview

In quantum information theory states that are jointly held by several parties play a central role, and are at the heart of the notion of entanglement. Correspondingly the problem of classifying such states has attracted a bt of interest, the correct notion of equivalence being that of local unitary (LU) equivalence of states, which allow s each party to apply arbitrary local unitary operators. W hile classi cation has been successful in special cases involving few parties it is quite unreasonable to expect a m eaningfulanswer to the classi cation problem in general.

Among all quantum states the so-called stabilizer states form a subclass which is easier to investigate since much of the multilinear structure of stabilizer states is re-

ected in the additive structure of the corresponding stabilizer group. On the other hand m any in portant states like GHZ states can be realised as stabilizer states, and furtherm ore it has been found [1] that LU equivalence between su ciently entangled stabilizer states tends to coincide with local Cli ord (LC) equivalence, a fact that by and large reduces the classi cation of stabilizer states to that of stabilizer groups. Though conceptually easier the latter problem still is far too general to have a useful answer. It therefore appears reasonable to look for and study invariants of states which are intrinsically coarse in the sense that m any non-equivalent states are expected to share the sam e invariants | provided of course that at least som e essential features of a state are still re ected in its invariants.

In this paper we propose and construct such a set of invariants. In the case we have in m ind as the most im portant one we consider a nite set P of parties, each of which controls a state space H_p with some (nite) number of qubits. To each pure stabilizer state j i we will assign a sequence of nite dimensional vector spaces H^0 (j i);:::; H^{pj} (j i) which are invariant with respect to LC equivalences acting on j i, and also with respect to permutations of the parties. Our stain in the construction of these invariants is to capture the entanglement that is present in j i with respect to all possible subdivisions of P. It appears that the notion of sheaf, which was introduced and developed in great generality by the French school of algebraic geom eters since the 1940s, is perfectly suited to accommodate the desired data in a single object, which we call a partition sheaf. In a second step we intentionally reduce the am ount of inform ation by applying cohom ology to that sheaf | a process whose form alproperties are well understood and which in algebraic geom eters and eters are super – cial inform ation.

By its very nature the hom obgical invariants of a state are a qualitative rather than quantitative measure of entanglement, and more speci cally of entanglement expressible by linear data (rather than multilinear like the Schmidt measure introduced in [2]). Hom obgical invariants are easily and e ciently computed from their definition in terms of standard linear algebra. A lso, their behaviour under standard processes like coarsening the distribution of the quantum system among the parties, or joining quantum systems is, at least in part, computable.

A closer investigation of hom obgical invariants reveals the presence of a duality which eventually comes from the symplectic structure on the stabilizer groups, and the principal part of Section III is dedicated to the investigation of this duality.

For m any states we have explicitly calculated the homeological invariants, and we present some of the results in Section IV. Interestingly, duality of homeological invariants seems to be an important m athematical them e underlying the work of [3] on extraction of GHZ states, where it has appeared in an ad hoc way in some of the proofs. We therefore show how to recover and complement results of the cited work, giving proofs which are conceptual in terms of the invariants.

B. Stabilizer states

The stabilizer form alism was introduced in [4] in the context of error-correcting quantum codes, and since has been explained and widely used in varying degree of gen-

erality [5, 6, 7, 8, 9]. The purpose of the following very brief account is to x the term inology and notation used below.

The notion of stabilizer state is based on the m athem atical one of H eisenberg group, see [10]. Here we consider but a restricted class of such groups, built from data comprising a nite dimensional vector space G over a - nite eld $F = F_p = Z = p$ of prime order, and a sym plectic form $!:G \quad G \; ! \; F \; | \;$ that is, a skew -sym metric bilinear ! that induces an isom orphism G 3 g 7 ! in the sense that $e(q;h) = q h q^{-1} h^{-1}$ is the commutator of any two group elements representing g and h. By the theorem of Stone, von Neum ann, and Mackey (SNM) every Heisenberg group has a unique irreducible unitary representation space H on which the subgroup S^1 acts by scalars in the natural way. In the basic case where p = 2and $G = F_2$ F_2 carries the canonical symplectic form this representation may be realised sending the nonzero vectors of G to the Pauli matrices x, y, and z with their action on one qubit. M ore generally, taking G as a nite orthogonal sum of l copies of F_2 F_2 the resulting SNM representation H is an l-qubit space with one set of Pauli operators acting on each qubit. Therefore physicists usually consider the Heisenberg group G as a subgroup of the unitary group U (H) and call it a Pauli group.

Let now L G be an isotropic subspace: !(g;h) = 0for all g;h 2 L. Then the natural projection G ! G adm its a section s:L ! G over L, so that s(L) G is an abelian subgroup. Its xed space

is a stabilizer state corresponding to L. It is a vector subspace of H of dimension $2^{\dim G} 2^{\dim L}$, and therefore a mixed state in general while a pure state occurs if and only if L G has the maximal dimension $\frac{1}{2}$ dim G: such L are called Lagrangian subspaces of G.

A utom orphism s of the Heisenberg group G are | by de nition | required to restrict to the identity on S¹, and they form a group AutG which is an extension of the dualHom (G;S¹) = G by the group Sp(G) of sym plectic autom orphism s of G. Every element of AutG gives rise to a unitary transformation of H, called a C li ord autom orphism. As to the classi cation of stabilizer states, the autom orphism s from G just permute the dierent sections s over L G, so that the C li ord classi cation of states reduces to the sym plectic classi cation of the isotropic subspaces L G. An interesting classi cation problem only arises if som e additional structure is given, like a nite direct decomposition of $G = p_{2P} G_p$ which is orthogonal with respect to !. Then the local sym plectic group

acts on G in such a way as to restrict each party's control to the subspace owned by it, and the analogously de ned local C li ord equivalence of stabilizer states in H = $_{p2P} H_p$ corresponds to exactly this local sym - plectic equivalence of isotropic subspaces.

For the m ere construction of hom ological invariants no explicit reference to stabilizer states is needed nor even appropriate since the vector space G, its direct sum decomposition $G = \int_{p2p}^{p} G_p$, and the subspace L G is all the data required. Neither any assumption on the base eld F willbern ade, and the sym plectic form ! only com es in at a later stage.

II. THE CONSTRUCTION

A. Partition spaces

Let P be a nite set; the elements of P will be referred to as parties. In this subsection we will assign to P its partition space X = X (P). The partition space is a topological space that violates the Hausdor separation axiom since distinct points of X cannot be separated by neighbourhoods, and one should think of it not as a geom etric but rather a form al object that in spite of its simplicity serves as a useful organizing tool. In fact it is simply modelled on the two point topological space f0;1g in which the point 0, or m ore precisely the subset f0g is closed while flg is not a closed subset of X : thus;, flg, X is the complete collection of open subsets of X. The underlying idea, borrowed from algebraic geometry, is to think of 0 as the unique special, and of 1 as the general point of f0;1g | though we do not require these notions in a form alway.

The partition space

is de ned as the cartesian power of the topological space f0;1g just described, thus an element of X is a word $(x_p)_{p2P}$ whose letters x_p are zero or one and are labelled by p 2 P. For a subset of parties S P we write

B. Sheaves on partition spaces

A presheaf F on a topological space X assigns to each open subset U X a set F (U), whose elements are called

sections over U, and to each inclusion of open subsets U V a mapping F_{UV} : F(V)! F(U) called the restriction such that the relation F_{UV} $F_{VW} = F_{UW}$ holds whenever U V W. Presheaves offen carry additional algebraic structures, and all presheaves considered here will be presheaves of vector spaces over a xed eld F, that is, all F(U) will be vector spaces and all restriction m aps, linear hom on orphism s.

A sheaf on X is a presheaf that satis es two extra conditions:

If U X is open, U = $\sum_{i2I}^{S} V_i$ a covering of U by open sets, and f 2 F (U) then F_{V_iU} (f) = 0 for all i2 I in plues f = 0.

If U X is open, U = $\frac{S}{_{i2I}V_i}$ a covering of U by open sets, and $f_i \ge F(V_i)$ are given such that $F_{V_i \setminus V_j;V_i} = F_{V_i \setminus V_j;V_j} = 0$ for all i; j 2 I then there exists a section f 2 F (U) with $F_{U \setminus V_iU}$ (f) = f_i for all i 2 I.

Thus the property that characterises sheaves among presheaves is that sections over U m ay be described by local sections that are compatible on intersections. From every presheaf F on X a well-de ned sheaf m ay be constructed essentially by enforcing the two extra conditions.

Rather than by their spaces of sections sheaves may also be characterised by their stalks. In general the stalk of the sheaf F at the point x 2 X is de ned as $\lim_{x \to 0} F(U)$ where the direct lim it is taken over the system of all open neighbourhoods of x in X. For the partition spaces X = X (P) that we consider here this system contains the set U_{fp2P} $_{jx_p=1g}$ as its greatest element (that is, sm allest with respect to inclusion of sets): thus form ing the direct lim it is perfectly unnecessary, and the stalk F (x) = F (U_{fp2P} $_{jx_p=1g}$) reduces to a particular space of sections of F.

The standard notions of linear algebra also m ake sense for sheaves if applied to the latters' stalks. In particular there are the notions of direct sum, of sub and quotient sheaves, of sheaf hom om orphisms giving rise to kernel and in age subsheaves, and of exact sequences

of sheaves on X (exactness at F m eaning that in age f = kerg). A short exact sequence

is a means of stating that F is an extension of E by G.

The simplest presheaves on a topological space X are constant and assign to each open U X the same vector space, say L. By abuse of language the corresponding constant sheaf is also written L; to every open U X it assigns the cartesian product L $^{(U)} = ^{(U)}$ L where (U) is the set of connected components of U. In particular one has L (U) = L for all non-empty connected open U X while L (;) = 0 is the zero space.

M ore usefulare the sheaves on X which we callelem entary. Such a sheaf is based on data comprising a vector space L and an open subset V X. W riting the inclusion as j:V ,! X the corresponding elementary sheaf is j!L, the extension of the constant sheaf L from V to X by zero. It has the properties

By a quasi-elementary sheaf on X we mean one that can be obtained by successive extension of elementary sheaves.

M ost important in our context are sheaves of the following kind. Suppose that we are given a set P of parties and for each party p 2 P a nite dimensional vector space G_p over the xed eld F.W e write

C. Cohomology

Let F be a sheaf of vector spaces on a topological space X. Associated with any such sheaf is the sequence H 0 (X ;F), H 1 (X ;F) ...of cohomology groups (traditionally referred to as groups even if they are, in fact, vector spaces over the same eld as F)[11, 12]. It is often convenient to combine all groups from the sequence into the single graded vector space

H (X;F) :=

Apart from H 0 (X ;F) = F (X), the space of global sections of F, these groups have no simple direct interpretation and in no case of interest it is possible to com – pute them directly. Nevertheless in many instances cohom ology of sheaves is highly computable by m ethods

that rely on the form alproperties of cohom ology rather than one particular de nition. Am ong the most prom inent of these properties is the fact that every hom om orphism F ! G of sheaves over X induces linear mappings Hⁱ(X;F)! Hⁱ(X;G) in a functorial way (that is, com patible with composition of maps), and that every exact sequence of sheaves

A sheaf F on X is called acyclic if H i (X ;L) = 0 for all i > 0.

C ech cohom ology does depend on the covering U, and even if this dependence is elim inated by passing to the lim it of arbitrarily ne coverings the result in general does not give the correct sheaf cohom ology. For quasielem entary sheaves things are much simpler as in fact quite a small covering is su cient:

Note that as a consequence of the theorem H^j(W;F) must be the zero group if j \mathcal{P} j in fact this is a special case of a general property of sheaves on nite dimensional topological spaces.

D. Local cohom ology

The many known variants of cohom ology of a sheaf F on a space X include that of H (X; F), cohom ology with support in a given closed subset X.

Fix a set of parties P and for each party p 2 P a – nite dimensional symplectic vector space $(G_p;!_p)$ over the eld F. Furtherm ore the stabilizer states in H correspond to the isotropic subspaces L $G = G_P$, a state being pure if and only if L is lagrangian, that is, of half the dimension of G. LC

equivalence of these states is the sam e as local sym plectic equivalence of the corresponding isotropic subspaces.

To each isotropic subspace L $\ \ \mbox{G}$ we associate the F vector spaces

as its hom obgical invariants. In case of a prime eld F we also refer to the H ^{ij} (L) as the hom obgical invariants of the stabilizer states in H that correspond to L and write H ^{ij} (j i) in the most important case where L is lagrangian and that state is j i 2 H. The hom obgical invariant H ^{ij} (L) vanishes at least if i > dim L or if j > \mathcal{P} j and since presently ourm ain interest lies with i = 1 we introduce the further abbreviation H ^j(L) := H ^{1j}(L). W hile of course already the sheaf F L is an invariant of L the hom obgy H (L) is a more com pact object in which essential inform ation on L is concentrated. On the other hand F L has the advantage that the e ect of standard operations is immediately determined.

It is useful to be able to describe the duality pairing explicitly in terms of C ech cohom ology. To this end we may return to the more general situation where L and M are arbitrary linear subspaces of G that are orthogonal with respect to !. As before we write $G = F G = F G_P$; also recall the notations W = X nf g, and k for the inclusion of $_{p2P} U_p U_p$ in X, as well as $= f; \notin S + T P + P jS \ T = ;g$. The extensive diagram which involves the relevant mappings is displayed as F ig. 7. A n essential aspect of the form ula of P roposition 19 is that it treats both factors in $\(x;y)$ on an equal footing. Thus $\$ m ight as well have been de ned using F L and G=F M in the same way as we have used G=F L and F M . A part from being interesting in its own right this fact has further consequences if ! enjoys sym metry properties. For the sake of sim plicity we state but the case of characteristic two.

Theorem 20. A ssume that the characteristic of the base eld F is two, and that for each p 2 P the bilinear form $!_{\,\rm p}$ on $G_{\,\rm p}$ is alternating. If the linear subspace L~~G is isotropic for ! then

also alternates.

Proof. The form ula of Proposition 19 shows that for hom ogeneous x; y 2 H (X; FL) we have (x; y) + (y; x) =0: just swap S and T. Therefore it su ces to know that (x; x) = 0 for all x 2 Hⁱ(X; FL) with 2i = p j+ 2. But this also follows from the form ula.

C orollary 21. A ssum e charF = 2, that all $!_p$ are sym – plectic form s, and that L G is a lagrangian subspace: $L = L^2$. Then

Proof. C om bine Theorem 15 and Theorem 20. \Box

IV. EXAMPLES AND APPLICATIONS

In order to illustrate hom ological invariants we have calculated, using [16], a variety of exam ples including all pure stabilizer states in up to seven parties controlling a single qubit each. The base eld here is F_2 , and for each $p \ge P$ one has $G_p = F_2^2 = F_2 e$ $F_2 f$ with the standard symplectic form : $!_p$ (e; f) = 1. As is well known under these assumptions all lagrangian subspaces of $G = G_P$ are equivalent, under local sym plectic transform ations, to standard form s that m ay be described by sim ple graphs on the vertex set P. Though this description does not play an immediate role in the present context we make use of the classi cation in [17] of lagrangians in terms of graphs, retaining the labelling used in that work for the sake of convenient reference. We show the complete result for up to ve parties in Table I, and just the inform ation on $H^{j}(L) = H^{1j}(L)$ in the case of six or seven parties in Table II.

Note that H^{0j}(L) = 0 for all j as soon as P is non-empty, and that the hom ological invariants of any tensor products of the listed states may be calculated by Theorem 11. In particular for products with more than one factor | those which de ne decom posable lagrangians and stabilizer states | the rst order invariants H^j(L) = H^{1j}(L) vanish by C orollary 12.

In the case of parties controlling just one qubit every indecom posable state autom atically is irreducible in the sense that it cannot, in a non-trivial way, be written as a tensor product of stabilizer states distributed over the sam e set of parties. In term s of lagrangians this notion of irreducibility m eans that there is no way to write the lagrangian as an internal direct sum of sm aller lagrangians. In view of this the fact that H¹ (L) vanishes in all cases of the lists is no coincidence but a consequence of: Proposition 22. Let $L = G = \begin{bmatrix} L \\ p^{2P} & G_p \text{ be an isotropic} \end{bmatrix}$ subspace and assume that $L^0 \coloneqq L \setminus G_p$ is non-zero for some party p 2 P. Then L splits o a summand in G_p : there is an orthogonal splitting $G = G^0 = G^0 \text{ with} \\ 0 \notin G^0 = G_p$ such that $L = L^0 = L^\infty \text{ with } L^\infty \coloneqq L \setminus G^\infty$.

Proof. Since L^0 G_p is isotropic we may pick a subspace G^0 G_p of dimension 2 dim L^0 which contains L^0 and to which $!_p$ restricts as a symplectic form. We de ne G^0 G as the orthogonal complement of G^0 in G and have $G = G^0$ G^0 as claimed. The inclusion L^0 L^0 L is clear, and equality follows from a comparison of dimensions:

The rst order invariants H j (L) for j 2 shown in the tables nicely illustrate the duality properties described in Theorem 15 and C orollary 21.

We do not know whether there exist undecomposable stabilizer states with trivial rst order invariants but such states must involve at least four parties. We rst make a technical but more general statem ent and give a proof which is adapted from that of [3] Theorem 5.

We claim that if $(g_{st};h) = 0$ for all $h \ge L \setminus G_{P^{\circ}}$ then $(g_{st}) = 0$. Indeed, if Q P is a subset with P⁰6 Q, say with p 2 P⁰nQ then trivially $(g_{st};h) = !(f_{p};h) = 0$. Thus if $(g_{st};h) = 0$ holds for all $h \ge L \setminus G_{P^{\circ}}$ then it even holds for all $h \ge L$, in view of the hypothesis of the proposition. Since L is lagrangian it follows that $f_s \ge L \setminus G_s$, and therefore that f_s and a fortiori all g_{st} vanish.

Now pick any cocycle $(g_{st} = f_s \ f_t)$ and let $h \ge L \setminus G_P \circ$ be an element such that $(g_{st};h) = 1$. For each $s \ge P^O$ let $G_s^O \ G_s$ be the subspace spanned by f_s and the component of h in G_E : thus each G_s^O is a symplectic plane. Putting $G^O = {}_{s\ge P \circ} G_s^O$ the intersection $L \setminus G^O$ is spanned by the f_s and h, and the conclusion of the proposition is readily veried.

C orallary 24. Let P be a set of three parties and let L G = $_{p2P} G_p$ be a lagrangian subspace with H (L) = 0 Then L is decomposable.

Proof. If $L \setminus G_p$ is non-zero for som e p then L splits of a sum m and in G_p , by P roposition 22. We thus may assume $L \setminus G_p = 0$ for all p. If for some two-party set P⁰ P we have H² ($L \setminus G_{P^0}$) $\leftarrow 0$ we may apply proposition 23 since the assumption H³ (L) = 0 im plies $p_{p^2} \leq L \setminus P_Q$ = L. Thus in that case L splits o an EPR state. There remains the case where H² ($L \setminus G_{P^0}$) = 0 for all P⁰ P with P j = 2. Explicitly this condition m eans $L \setminus G_{P^0} = 0$ for all such P⁰; since H³ (L) = 0 on the ether hand m eans that the coboundary hom om orphism $p_{p^0 p_2} L \setminus G_{P^0}$! L is surjective we conclude that L = 0which of course is doom posable too.

One of the main results of β] is a formula for for the number of GHZ states that can be extracted from a multiparty stabilizer state by LC operations. We here state and reprove this result in terms of hom ological invariants.

Theorem 25. Let L $G = \begin{bmatrix} L \\ p^{2P} & G_p \end{bmatrix}$ be a lagrangian subspace. The num ber of lagrangians of all-party GHZ states that can be split o from L is

(which coincides with dim H 2 (L) = dim H $^{\mathcal{P}}$ ^j(L) as soon as \mathcal{P} j> 2).

Proof. It su ces to show that such a lagrangian can be split o if and only if H 2 (L) \notin 0. We put l = 2 j. The condition is necessary by Lemma 9 since the GHZ state has the non-trivial rst order invariants H 2 (L) and

 $H^{1}(L)$, each of dimension one unless l = 2 when they merge in a single space of dimension two.

Now assume that $H^{2}(L)$ is non-trivial. Put X = X (P), W = X nf g, and G = FG as usual. By Theorem 15 the pairing $: H^{2}(X;G=FL) + H^{1}(X;FL)$! F is perfect, so we may pick cocycles

with $(f_s; h_P) = 1$. Represent h_P by any vector $h = (h_s)_{s2P} 2 L$. Then for each s 2 P the vectors f_s and h_s span a sym plectic plane in G_s , and $L \setminus G^0$ is spanned by the f_s and h, and is a GHZ lagrangian.

The authors of $[\beta]$ construct an example of an irreducible four-party stabilizer state j iwhich is not a GHZ state. This property can easily be read from the rst order hom ological invariants of j i, which have dimensions $h^2 = 0, h^3 = 4, and h^4 = 0, as follows: Two of the four parties own one qubit, and the others two qubits each. If the lagrangian of j i were an internal direct sum, one sum – m and would have to involve all parties since <math>h^3 \notin 0$, and the complementary sum m and would have trivial invariants. But by the classication indecom posable four-party states in four or ve qubits with $h^3 = 4$ do not exist.

Scanning the classi cation lists we found m any m ore six- and seven-party states that by suitable coarsening lead to a four-party state with $h^3 = 4$; they include the states No.14, 17, 18, 30, 33, 35, and 37{45. Am usingly, the six-party state No.19 from which [3]'s example is constructed in fact gives a four-party state with $h^3 = 4$ whichever coarsening is chosen, as long as two of the new parties are given two qubits each.

V. CONCLUSION

In this paper we have introduced hom ological invariants of a system of vector spaces which is partitioned over a nite set of parties, and thereby LC invariants of multi-party stabilizer states. We have investigated som e basic properties of these invariants, in particular their duality. In the simplest cases we have explicitly calculated the invariants, and we have shown their connection with known results on the extraction of GHZ states from stabilizer states.

W e believe that the potential of hom obgical invariants in fact reaches much further, and wish to suggest several ways in which we believe the present work can be continued.

As mentioned in the introduction LC equivalence of stabilizer seems to be little stricter than LU equivalence, the conceptually more important notion. While hom ological invariants refer to LC equivalence by de nition it is nevertheless possible that they in fact are LU invariants. The most satisfactory positive answer to that question would, of course, involve an extension of our construction from stabilizer to all quantum states.

H om ological invariants do not, nor are intended to separate all the di erent LC classes of states. Yet it may be true, for an arbitrary number of parties, that the rst order invariant H (j i) vanishes only if j i is decomposable. Quite generally it would be worthwhile to obtain a global view of the hom ological classic cation of states, including asymptotic information on the size of the equivalence classes for large sets of parties, or with respect to large (but nite) eld extensions. For instance this might give a way to re-interpret and extend the results of [18] which show that stabilizer states from which many GHZ states can be extracted | that is, those with large H 2 (j i) | are exceptional rather than the rule.

O ur main result, the D uality Theorem 15, has so far been used in quite a limited way, relating H² and H^{Pj}. It would be reasonable to expect that a more system atic application will lead to an improved qualitative understanding of multi-party entanglem ent of stabilizer states, completing the picture for up to four or ve parties at least. System atic use of hom ological invariants probably will take advantage of the fact that rather than being m ere numbers they are algebraic structures with a well-de ned functorial behaviour, some of which we have explained in Section IIE. This pertains even m ore to the higher order invariants H^{ij}(L) | so far unused at all | which combine to form the algebra H (L) = $_{ij}$ H^{ij}(L) and thus carry a multiplication as an additional structure.
