M in im um -energy pulses for quantum logic cannot be shared

We show that if an electrom agnetic energy pulse with average photon number n is used to carry out the same quantum logical operation on a set of N atoms, either simultaneously or sequentially, the overall error probability in the worst case scenario (i.e., maximized over all the possible initial atom ic states) scales as N 2 =n. This means that in order to keep the error probability bounded by N, with l=n, one needs to use N n photons, or equivalently N separate \minimum -energy" pulses: in this sense the pulses cannot, in general, be shared. The origin for this phenomenon is found in atom - eld entanglement. These results may have important consequences for quantum logic and, in particular, for large-scale quantum computation.

There is by now a substantial amount of evidence [1,2] that an elementary quantum logical operation on a qubit requires a minimum amount of energy which is inversely proportional to the acceptable error probability. This has been most extensively studied for atomic systems interacting with an electromagnetic pulse controleld [3, 4, 5, 6] with the generic result that the error probability scales as the inverse of the number of photons in the (quantized) pulse.

A question that has not so far been addressed is whether this minimum energy must truly be dedicated to each qubit and each operation, or whether it could be shared by two or more qubits on which one wanted to perform a given operation, either sequentially or simultaneously. Intuitively, one would expect the latter to be the case: if a pulse of light containing, say, 10^5 photons has just interacted with an atom that may at most add or subtract one photon to the eld, one would not expect this very small change to make a substantial di erence if the same pulse is used later to act on another atom. Also, it is a fact (and this point will be elaborated on later) that, for an atom or ion in free space, the most im portant consequence of eld quantization is spontaneous em ission [7, 8, 9]; from this perspective, all that should matter is to have a su ciently large electric eld at the location of the atom, so as to complete the operation before it can decay, and there appears to be no reason why two orm one atoms should not be able to share this eld, for a su ciently long or wide pulse, without an appreciable increase in the error rate.

In contrast to these very reasonable expectations, we show here that a m inim um energy pulse cannot, in general, be shared as described above: speci cally, the result to be proven is that if the same pulse, with average photon number n, is used to carry out the same quantum logical operation on a set of N identical atoms, either simultaneously or sequentially, the overall error probability in the worst case scenario (i.e., maxim ized over all the possible initial atom ic states) scales, not as N = n, as

one would expect for N independent processes, but as N 2 =n. This means that in order to keep the maximum errorprobability bounded by N , with 1=n, one needs to use a total of N = photons, that is to say, the energy equivalent to N separate \m inimum energy pulses."

The most general proof of this result makes use of the methods of [6, 10] and applies to a system of N atoms interacting with an arbitrary set of quantized eld modes via a Hamiltonian of the form

Here the g_k are coupling constants and the $U_{k,i}$ are arbitrary mode functions, evaluated at the positions (indexed by i) of the respective atom s. We use the convention $_{iz} \not = i_{i,i} = j_{i,i}$, where $j_{i,i} = j_{i,i}$ is the excited state of the i-th two-level atom . The model (1) is extremely general, and it can easily be further generalized to cover multilevel atom s and R am an-type processes (see [6] for details); in particular, it includes spontaneous emission implicitly, by the presence of quantized vacuum modes.

The key property of the Hamiltonian (1) is that it has a conserved quantity, namely

where L_1 is an atom ic operator and L_2 a eld operator. Suppose we want to use the Ham iltonian (1) to implement a certain quantum logical operation so that, after a time T (om itted below for simplicity) the evolution operator U is as close as possible to some desired U_{ideal} . We can get an idea of how successful the procedure is by looking at how an atom ic operator A is transformed, and specically at the dierence D U^YAU $U_{ideal}^YAU_{ideal}$. If we choose A so that it commutes with L_1 , the methods of [6] can be used to show that one must have

Consider the case in which U_{ideal} corresponds to a collective =2 pulse, which is a Hadam and gate up to an overall bit ip. Specically,

Then choosing $A = \frac{Q_N}{i=10} \frac{iz}{2}$, and the initial atom ic state $j i= (j0i^N + ijli^N) = \frac{iz}{2}$, one im m ediately obtains

To relate the error hD^2i in the operator A to a more familiar error measure, such as the overall delity, one can follow a procedure similar to the one in Appendix A of [6]. With the above choices for A and j i

However, with Noeven, the ideal operation (3) when acting on the state ((j)i Norm jli Norm) = $\overline{2}$ produces a superposition of states with only odd numbers of ones, which means that the rest term in (6) is $2(1-F^2)$, where F^2 is the delity for that initial state. Similarly, the second term is $2(1-F^2_+)$, where F^2_+ is the delity for the initial state ((j)i Norm + jli Norm)= $\overline{2}$. Both of these in delities must be smaller than the in delity $(1-F^2)_{max}$, maximized over all initial atom is states, and therefore one concludes

The same result for N odd can be established along \sin - ilar lines.

While the above method is very powerful, it does not provide much insight on the origin of the N² scaling, and it has also proven hard to generalize it to other operations such as bit ips (pulses). Hence it is worthwhile to explore a much simpler model for the interaction which was shown in [6] to capture the essence of the constraints arising from the conservation of (2). This is a single-mode model where the creation and annihilation operators are replaced by e i^, where ^ is a \phase operator":

A lthough a Herm itian phase operator, strictly speaking, does not exist in the full Fock space, reasonable approximations can be de ned [11] with the desired properties, namely, e^{-i} ji=j 1i. As also shown in 6], the following manipulations will be accurate enough provided the weight of the vacuum in the initial eld state ji is vanishingly small, which is always the case for a coherent state with a high excitation number. The model (8) removes the nonessential (in this context) complication of the eld amplitude uctuations, and captures the basic requirement expressed by the conservation of (2), namely, that the photon number must increase or decrease by 1 when any of the atom smakes a transition.

Integration of (8) is trivial. Assuming each atom interacts with the eld for a total time T (it does not matter whether simultaneously or sequentially), the evolution operator is

When T==4 (the =2-pulse condition) (9) would reduce to (3) provided $\hat{}=0$. In what follows, it will be assumed that $\hat{}h=0$ and $\hat{}h^2i=(\hat{})^2$ is small. Taking again the initial atom is state to be of the form ($\hat{}Di^N+i\hat{}Ii^N=0$), which would be transformed by U_{ideal} into $(\hat{}j+xi^N+(-1)^N)^2$ $xi^N=0$, a direct calculation using (9) yields the delity

For a coherent state we have $\ (\)^2$ ' 1=4n, and hence the result

The right-hand side of (11) is always greater than that of (7), as it should, and, in fact, the two expressions agree up to term s of the order of $(N^2=n)^2$.

In spite of its sim plicity, there are several reasons to expect that the single-m ode approach provides a universally valid lower bound to the in delity. First, because adding more modes generally only adds more avenues for decoherence (a point that will be elaborated on later), and second, because it has been shown by Silberfarb and Deutsch [12] that the atom - eld entanglement predicted by single-mode models (specically, the Jaynes-Cummings model) is actually a good approximation to the actual entanglement obtained from multimode, free-space calculations, as long as the total probability for spontaneous emission over the duration of the gate remains small (which is the regime in which one would want to operate in any case).

The bit—ip example is especially helpful to show how the e ect described arises from atom—eld entanglement. In an N-atom bit—ip, the initial states \mathfrak{I} i $^{\mathrm{N}}$ j i and $^{\mathrm{N}}$ j i would have to become $^{\mathrm{N}}$ j i=N $_{\mathrm{I}}$ and $^{\mathrm{N}}$ j i=N $_{\mathrm{I}}$, respectively (where N $_{\mathrm{I}}$ and N $_{\mathrm{I}}$ are appropriate normalization constants), and therefore the coherent superposition ($^{\mathrm{N}}$ i $^{\mathrm{N}}$ + $^{\mathrm{I}}$ i $^{\mathrm{N}}$) = $^{\mathrm{N}}$ 2, which ideally should be left invariant by the operation, is instead transformed into

This superposition diers from the intended result because the atom ic and eld states are entangled, since the eld states a^N j i=N $_1$ and a^{y^N} j i=N $_2$ are dierent in general. In fact, the in delity of the state (13) is simply proportional to the \lack of overlap" between the two eld states:

Now, one might think that for a very \classical" state j i, with a large average photon number, the di erence between the state resulting from the creation of N photons and the one resulting from the annihilation of N photons would be very small, and it is but, somewhat surprisingly, it turns out to be quadratic, rather than linear, in N. Specically, for a coherent state j i, with j $j^2 = n$, the only nontrivial expectation value appearing in (14)

is $N_2 = (h j a^N a^{y^N} j i)^{1=2}$, for which one has (see [13])

and using this in (14) one obtains 1 $F^2 = N^2 = 4n + O((N^2 = n)^2)$ in agreement with (12).

This derivation suggests the kinds of situations when one may expect the N 2 terms in the in delity to be significant: when (as in (13)) the nalstate wavefunction contains at least two terms, with reasonably large weights, that dier from each other by the action of a number of creation operators of the order of N .

At this point it may be thought that a way to avoid this kind of diculty in quantum logical operations would be to use an encoding such as $\Re i_L = \Re i_L = \Re i_L = \Re i_L$ [14, 15], where each logical qubit is represented by two physical qubits, and the numbers of ones and zeros in the states $0i_L$ and $1i_L$ are the same. It is also known that such an encoding makes the logical qubit insensitive to collective phase uctuations, such as those in Eq. (8) [16]. However, since the Hamiltonian (1) does not couple directly the states 101i and 110i, a meaningful discussion of what can or cannot be done with encoded qubits requires a careful look at the \e ective H am iltonians" that describe the action of the control elds on the encoded states. For example, in the proposal [16] to use the above encoding in an ion trap, in conjunction with the S rensen-M Im ergate [17], one obtains, in e ect, an evolution operator of the form $U = cos(gnt) + isin(gnt)_X$, where x is the encoded bit- ip operator, and \hat{n} is a photon number operator (or a sum of such operators). But then one can show explicitly that the N 2 =n scaling must hold, for certain initial states, for arbitrary operations.

To exhibit this for a collective bit— ip, let j X i be the (two-qubit) encoded eigenstates of $_{\rm X}$. Then U j X ij i = e $^{\rm ight}$ j X ij i. Separating \hat{n} into average n and uctuations \hat{n} , where, for a bit ip operation, gnT = =2, and making U $^{\rm N}$ act on a superposition 2 $^{\rm 1=2}$ (j+ X i $^{\rm N}$ + j X i $^{\rm N}$) j i, the result is (up to a global phase)

This is to be compared to the action of U $_{\rm ideal}^{\rm N}$ $\stackrel{\rm N}{}_{\rm X}$ $\stackrel{\rm N}{}_{\rm X}$, which yields the same state except for the e $_{\rm igN}^{\rm N}$ $_{\rm nT}^{\rm N}$ terms. The in delity is then easily calculated to be 1 F² = hsin² (gN nT)i' $_{\rm N}^{\rm 2}$ (n)²=4n² = $_{\rm N}^{\rm 2}$ 24n for a coherent state.

The above derivation, concerning what is arguably the most popular proposal for encoded logic in an atom ic system, is enough to make us skeptical that one might get around the N $^2\!=\!n$ scaling using these approaches. Nonetheless, other encodings and gate mechanisms certainly exist, and we do intend to look into as many of

them as possible in the future.

Finally, we would like to supplement our single-mode calculations by considering brie y their possible relevance for a collection of atoms or ions in free space, where spontaneous emission is the leading quantized-eld source of decoherence. Let the laser beam (possibly including refocusing in between atoms) be taken to de ne an e ective single mode, all the other modes being then in the vacuum state. Every atom has a probability p to em it a photon in the course of the interaction, and if the beam waist at the location of the atom is w_0 then the probability that the photon goes into the laser mode is of the order of 3 2 = 8 2 w $_0^2$ 2 =A, where the area A is of the order of the cross-section of the beam (see Eq. (1) of [9]). Adopt a simple model in which a photon being em itted outside of the laser mode, by any atom, leads to the total failure of the operation. The overall failure probability of, e.g., a collective pulse can then be written (assuming pN

where the second term accounts for the result of the single-m ode analysis given above (Eq. (12)), in the case that all the photons are em itted into the laserpulse, with n being the number of photons in the pulse. Now, it was shown in [9] that for an operation such as a or =2 pulse, on resonance, p was of the order of 1=n times a geom etric factor of the order of 2 $^4\mathrm{w}_0^2$ =3 2 = $^2\mathrm{A}$ =4 2 , and so P_f becomes

This exhibits a scaling that is quadratic in N for succently large N, but is only linear in N if $^2A=^2$ N, However, the reason for this apparent \linearity" is that in this case, because of the suboptimal coupling between the atoms and the eld, one is already using many more photons than one would have to in the optimal, singlemode case. Indeed, in the singlemode treatment, the requirement to keep the overall failure probability smaller than N is n > N=4, whereas from [18] one requires n > ($^2A=4$)=, which is N=4 in this limit.

In conclusion, we have shown that, in general, the m inim um—eld energy needed to carry out a quantum—logical operation on a set of N—atom ic qubits with a given overall error probability scales as N 2 ; or, equivalently, that in order to ensure a constant error rate per operation per qubit, (say,) one needs to use, at least, the total energy of N—\minim um—energy pulses, with n—1=. In this sense, m in im um—energy pulses cannot be shared.

O verall, these results will need to be taken into consideration when designing large-scale quantum computing devices, especially in the proposals that would rely on the simultaneous manipulation of many atoms by a single electrom agnetic pulse. Examples might include schemes for cluster state computation [18], and/or for quantum computing with atoms in optical lattices [19]. (Note also that the results presented here are not restricted to atom ic system s; they would apply equally well to, e.g., superconducting qubits manipulated by radiofrequency pulses.) \Bang-bang" schemes for decoherence suppression [20] m ay also envision the simultaneous ipping of many qubits by a single pulse; the results presented here clearly place a constraint on the minimum energy required to carry out such operations with an acceptable error rate.
