A tom ic detection in m icrowave cavity experim ents: a dynam ical model

Abstract

We construct a model for the detection of one atom maser in the context of cavity Quantum Electrodynamics (QED) used to study coherence properties of superpositions of electromagnetic modes. Analytic expressions for the atom ic ionization are obtained, considering the imperfections of the measurement process due to the probabilistic nature of the interactions between the ionization eld and the atoms. Limited eciency and false counting rates are considered in a dynamical context, and consequent results on the information about the state of the cavity modes are obtained.

I. INTRODUCTION

The quantum interaction between two level Rydberg atoms and one microwave mode inside a high quality factor (Q) cavity has been crucial for our understanding of dissipation and decoherence in quantum mechanics [1, 2]. Usually in cavity quantum electrodynamics (QED) experiments, Rydberg atoms cross an experimental array constituted of two Ramsey zones and a high Q cavity. Thereafter their nal state is detected in two stages. Firstly, they cross an electromagnetic eld which is built to ionize the highest state of the atom. The second detection zone is designed to detect the lower atom ic level.

M ost of the work available in literature about the detection process is based on statistical assumptions. The pumped atoms are statistically independent, so that their arrival times are subject to a Poissonian or other statistics $\beta\{5\}$. The basic idea is that atoms arrive at random and they are recorded at equally random times, so the only reproducible data are statistical. In this context one is lead to studying the statistic of detector clicks. There are numerical studies [6, 7] and also analytical results by Rempe and Walther [8] and also by Paul and Richter [9].

In the present contribution we propose (to our know ledge for the rst time) a dynamical model for the detection process. We assume that the atom undergoes the in uence of a classical electrical eld when it traverses the detection zones. The net elect of this eld is to couple one (in the case of intrinsically inelicient detectors) or two (in the case of detectors that register false countings) discrete atom is levels to the continuum. If the atom is ionized, a transition to the continuum has occurred and a classical signal { a \click " { is generated in the correspondent detector. However, if the atom remains in one of the two discrete levels, no click is registered by the detector.

Since the atom works as a probe to the eld stored in a high-Q cavity, the click or no-click registered by the detectors represents a gain of inform ation about the state of the compound system formed by the atom and by the high-Q cavity eld. Hence, the process of detection can be divided in two parts. First, the state of the compound system atom {high-Q cavity eld undergoes an unitary evolution during the passage of the atom through each detection zone. Next, the resultant state is projected into a proper subspace de ned as follows: if a click is registered, this subspace is formed by the set of the states that form the continuum; otherwise, this subspace corresponds to the states associated to the two discrete levels.

This paper is organized in the following way. In Sec. II, we treat a model for intrinsically ine cient detectors. The analytical form of our results are exactly the same as those in reference [10], whose derivation is based on statistical and physically plausible arguments. In Sec. III, we study the possibility of the detectors perform false countings. In this case, we found that the probability of a click depends on the \non-diagonal" terms of the state of the system atom {high-Q cavity eld. We calculate the delity of the eld states in high-Q cavity after the measurement process considering the two kinds of imperfections, limited e ciency and false detections. Sec. IV contains a summary of the results and conclusions.

II. MODEL FOR INEFFICIENT DETECTOR

The ionization process of an atom due to its interaction with an electromagnetic eld is considered in a quantum context. Therefore a nite probability of non-excitation will exist. That is what we call an intrinsic (i.e., quantum mechanical) ine ciency.

The Ham iltonian which describes the interaction between two level atoms and ionization eld on the rst detection zone, and takes into account only the intrinsic ineciency of the process is given by (the ham iltonian for the second detection zone can been obtained replacing the index e by g):

The rst and second terms in the Hamiltonian stand for the two discrete atomic levels jei and jgi, excited and ground state respectively, with energies $_{\rm e}$ and $_{\rm g}$. The third term represents its continuum spectrum. The last term accounts for the coupling between the highest discrete level and the continuum. The strength of this interaction is given by the parameter $v_{\rm e}$, assumed state independent for simplicity. This term is responsible for the ionization of the atom. Since we are dealing with a quantum mechanical process, which is intrinsically probabilistic, we will also have to consider the possibility of non-ionization of the atom.

Following Cohen [11], the evolution of the discrete state jei according to (1) is given by:

This probability de nes the detector's e ciency. Therefore the non-detection probability is given by 1 $p_e = \begin{bmatrix} R & e^{i e^{-i e^{-i}e^{-i e^{-i}e^{-i e^{-i}e^{-$

where is the transition rate from discrete to the continuum level, calculated from Ferm i's golden rule. is given by

where (E) is the level density per unity energy. In the limit where the atom ionization time can be considered to be in nite (in some experimental context) we will have a perfect detector.

A. An exem ple: cavity QED

As an exemple of applicability of the model, let us study the interactions between two level atoms and their detection through ionization elds in cavity QED experiments. The state of the system atom {high-Q cavity eld can be written as




FIG. 1: In wence of the eciency of the detector D $_{\rm e}$ (p_e) on the \normalized" probability of click in the detector D $_{\rm g}$ (p_{clickD g} =p_g), for dierent values of Tr $_{\rm C}$ ($_{\rm gg}$). The eciency of the detector D $_{\rm g}$ (p_g) just lim its them axim um value reached by p_{clickD g} and does not modify its qualitative behavior as function of p_e.

This state represents the most general state (in the system atom-cavity eld) immediately before the interaction between the atom and the detectors. The symbols $_{\rm ee}$, $_{\rm eg}$, $_{\rm ge}$ and $_{\rm qg}$ are operators in the cavity eld subsystem.

The interaction between the atom and the $\,$ rst detection zone ($D_{\rm e}$) can be separated in two steps. Firstly, a quantum unitary evolution governed by the H am iltonian H $_{\rm 1e}$ given by Eq. (1) during the time interval t_1 . The atom-cavity $\,$ eld state, after this process, is given by

Now, in the second step, at the time t_1 , a classical signal is generated. If the detector clicks, we will know that the atom was ionized, so $_{AC}(t_1)$ must be projected into the subspace fjkig. Although, if D_e does not click we know that the atom ic state must be projected into subspace spanned by the discrete levels fjei; jgig. The maximum value that t_1 can assume is t_1^0 which is the time taken by the atom to cross D_e completely. So, up to t_1^0 , we will certainly acquire information about the system. This revealed information plays an essencial role into $_{AC}$'s evolution. So we are aware that before the interaction with D_g , the state $_{AC}(t_1)$ must be projected into properly subspace.

W e can calculate the probability of a click in D $_{\rm e}$

where Tr_C is the partial trace on the cavity- eld subspace. This product can be interpreted as the e-ciency of D_e (p_e) times the probability of click on a perfect detector after the interaction with the state $_{AC}$ (0) (Tr_C ($_{ee}$)).

where N=1 $p_eTr_{c~ee}$. Note that if the e-ciency is equal to unity ($p_e=1$), the reduced state operator on atom ic subspace can be written as gg jgihgj. This result was expected, as we know, for perfect detectors a non-click in D_e would lead to the projection jgihgj A_C (0) jgihgj.

When the atom is not ionized on D_e , it continues the journey and passes through the second detection zone (D_g) . Let us set the interaction time between atom and the electromagnetic eld inside D_g by t_2 . The temporal evolution that models this interaction is again unitary:

Note that this probability depends on the eximination of the rist detector (p). Now let us exam ine some limits. For $p_e = 0$, this is equivalent to the situation where the rist detector is absent, so the atom interacts just with the second ionization zone D_g and the probability of click is $p_g Tr_c$ (g_g), as expected. If $p_e = 1$, the rist detector is perfect, therefore we know that when an atom crosses D_e without been detected, the system goes to the state g_g , as discussed before, and the probability of click is the exciency of D_g (p_g). If both detectors are perfect ($p_e = p_g = 1$), $p_{clickD_g} = 1$ because the second detector will not miss any atom prepared in g_g .

A more complete analysis of p_{clickD_g} for dierent $_{AC}$ (0) is shown in Fig. 1. The behavior of the curves associate to Tr_C ($_{gg}$) = 0.5 and Tr_C ($_{gg}$) = 0.01 refect that a non-click on a very excient D_e (p_e 1) raises the probability p_{clickD_g} , even if the atom is practically prepared in the state jeilej (Tr_C ($_{gg}$) = 0.01). On the other hand, if the atom is practically prepared in the state jeilej (Tr_C ($_{gg}$) = 0.99), p_e does not a ect p_{lickD_g} .

The probability of non-click in D $_{\rm g}$ is

When the atom crosses both detectors without being detected, it reduces the eld state inside the cavity to

Here, Tr_A stands for the trace in the atom ic variables. Now, using the de nition (4) we may write:

The form of this result is in complete agreement with the one in [10], where the authors used statistics arguments to derive the expression (18).

III. MODEL FOR FALSE DETECTIONS

In addition to the previous intrinsically ine cient detector we extend the model to include false detections. The ham iltonian for the $\$ rst detection zone $\$ D $_{\rm e}$ is given by (the ham iltonian

for the second detection zone can been obtained replacing the index e by g):

where w_e and w_g are real coupling constants. The second interaction term (the last one in the equation above) represents the coupling between jgi and the continuum, so it is responsible for wrong detections. On the other hand, the previous one is responsible for the correct ones.

For simplicity we are going to de ne the complex coe cient

where fj eig and f eg are the set of eigenvectors and eigenvalues of H $_{2e}$ respectively. a and b are indexes that m ay represent continuum and discrete eigenvectors. The explicit form of the coe cients inside the integral and relative discussions are in the appendix. The notation is as follows: the upper index indicates which detection zone the atom is passing through. The two lower indexes, a and b, represent its initial incoming state and its nal state after traversing the detector, respectively. One can notice that ${\rm R} {\rm R$

We can see, from (19), that the unitary evolution of this system allows for an indirect coupling between the two discrete levels. So we can take into account $j_{e,g}^{\rho} \hat{j}$ which is the probability of a transition between the two discrete levels. $j_{e,g}^{\rho} \hat{j}$ ($j_{g,g}^{\rho} \hat{j}$) is the probability of an atom prepared in $j_{e,g}^{\rho}$ ($j_{g,g}^{\rho}$) to interact with the electrom agnetic eld inside D_{e} and do not change level. We can also notice that $j_{e,g}^{\rho} \hat{j}$ ($j_{g,k}^{\rho} \hat{j}$) is the probability that an atom prepared in $j_{e,g}^{\rho}$ ($j_{g,g}^{\rho}$) to be ionized inside $D_{g,g}^{\rho}$.

A. An exam ple: cavity QED

As we did for the intrinsically ine-cient detectors, the interaction between atoms and false counting detectors can be separated in two processes: rstly, an unitary evolution of the initial state operator, generated by H $_{2e}$ (H $_{2g}$) where H $_{2e}$ (H $_{2g}$) have the form shown in

Eq. (19), and then a projection in a subspace, which represents the classical information, click or non-click, on the detector.

Starting from the initial state given by Eq. (7), and using the de $\,$ nitions in Eq. (20), the probability of click in D $_{\rm e}$ can be written as

This expression shows us that p_{clickD_e} is sensitive to interference terms ($_{\text{eg}}$) and ($_{\text{ge}}$). If we calculate the value of p_{clickD_e} for the initial state $_{\text{AC}}$ (0) = $_{\text{ee}}$ jeihej+ $_{\text{gg}}$ jgihgj the answer would be different from (21). However, if we do the same, but replacing the false counting detectors by inecient or perfect detectors, the calculated probability would be the same for the two difference terms. That is due to the fact that this case is insensitive to interference terms.

In order to compare the modications on the cavity eld due to atomic interaction with ine cient detectors and false counting detectors, we calculate the delity of the dierent state operators. Fidelity between the states $_{\rm A}$ and $_{\rm B}$ measures the overlap between them and is given by

Firstly, let us calcule the delity between state operators $_{\rm A}^{\rm e}$ (which describe the system after the atom ic ionization inside the rst detection zone of ine cient detectors), and $_{\rm B}^{\rm e}$ (which describe the system after the atom ic ionization inside the rst detection zone of false counting detectors). For simplicity, assume that the system atom {high-Q cavity eld is found in the following entangled state just before the atom reaches the detection zones:

Notice that if the wrong detection probability goes to zero ($\frac{R}{dk}$ $jq_{g,k}^e$ j ! 0), the delity goes to one, $F(_A^e;_B^e)$! 1, so $_A^e$ and $_B^e$ became identical.

Now, we are going to calcule the delity between state operators $_{A}^{g}$, which describes the system after the atom ic ionization inside the second detection zone of ine cient detectors, and $_{B}^{g}$, which describes the system the atom ic ionization inside the second detection zone of false counting detectors. The calculation follows as this: interaction of atom with the rst detection zone D_{e} , modeled by unitary evolution of the state given by Eq. (23) and projection on the discrete subspace. Then, the interaction with the second detection zone D_{g} , modeled again by unitary evolution of the resultant state and projection, but now on the continuum subspace. After this, we can write the delity as

As we are considering that any transition from a discrete state to the continuum generates a classical signal, we must not adm it the possibility of indirect coupling between jei and jgi mediated by the continuum. Therefore, we must assume that $jq_{ge}^{e}j^{2}=0$ and we may write:

IV. CONCLUSIONS

We have presented a dynamical model for the detection process of atomic levels on eldionization detectors. On the context of cavity QED, the model allows us to calculate the reduced state operator, for the eldinside the cavity, after the classical signal generated by the detectors.

The detailed analysis of the detection process also let us introduce naturally the e ects of realistic features of the detectores (e.g. e ciency and false counting rates) on the study

of m icrowave cavity experiments. For intrinsically ine cient detectors, we found that the probability of a click in the second detection zone is sensitive to the e ciency of the rst one. Besides, our results are in complete agreement with those obtained in Ref. [10] by dierent methods.

If one allows the detectors to register false countings, the probability of a click is sensitive to the \non-diagonal" or coherence terms of the state of the system atom {high-Q cavity eld. In fact, false countings are a consequence of the coupling between the two discrete atom ic levels to the continuum in each detection zone. As a result of this coupling, a click registered in any detector does not provide an unequivocal information about the atom ic state. The detectors acts as a \beam splitter", m ixing the two \paths" e and g, and, to some degree, these \paths" become undistinguishable.

In order to calculate the coe cients inside the integral in (20), let us write the eigenvalue equation for H $_{2e}$:
