# G eom etrical structure of entangled states and secant variety

#### A bstract

We show that the secant variety of the Segre variety gives useful information about the geometrical structure of an arbitrary multipartite quantum system. In particular, we investigate the relation between arbitrary bipartite and three-partite entangled states and this secant variety. We also discuss the geometry of an arbitrary general multipartite state.

#### 1 Introduction

Recently, the geometry and topology of entanglement has got more attention and we know more about the geometrical structure of pure multipartite entangled quantum states. We have also managed to construct some usefulm easures of entanglem ent based on these underlying geom etrical structures. However, we know less about the geom etrical structure of an arbitrary multipartite quantum state and there is a need for further investigation on these states. Concurrence is a measure of entanglement which is directly related to the entanglement of form ation [1]. Its geom etrical structure is hidden in a map called Segre embedding [2, 3, 4, 5]. The Segre variety is generated by the quadratic polynomials that correspond to the separable set of pure multipartite states. We can construct a measure of entanglement for bipartite and three-partite states based on the Segre variety [4]. We can also construct a measure of entanglement for general pure multipartite states based on a modication of the Segre variety by adding sim ilar quadratic polynom ials [5]. In this paper, we will establish a relation between the secant variety of the Segre variety and multipartite states. For example we show that the concurrence of arbitrary bipartite and threepartite entangled states are equivalent to the secant variety of the Segre variety. We also generalize our result for a measure of entanglement for an arbitrary multipartite state. In section 2, we will de ne the complex projective variety. W e also introduce the Segre embedding and the Segre variety for general pure multipartite states. In following section 3, we will de ne and discuss the secant variety of a projective variety. In section 4, we investigate the secant variety of the Segre variety, which is of central importance in this paper. Moreover, we investigate relation and relevance of the secant variety of the Segre variety as geom etrical structure of entangled and separable states. For example, we show that this variety de nes the space of the concurrence of a mixed state. Finally, in section 5, we expand our result to an arbitrary multipartite

where is an antilinear operator and satis es  $^2 = I$ . Moreover, the concurrence of a quantum system  $Q_2(N_1;N_2)$  is dened by

where the in mum is taken over all pure state decompositions. If we have a quantum system  $Q_2(2;2)$ , where is a tilde operation, then concurrence coincides with W ootter's formula for concurrence of two-qubit states.

### 2 C om plex projective variety

In this section, we review some basic de nition of complex projective variety. The general reference on projective algebraic geometry can be found in [7,8,9]. Let C [z] = C [z<sub>1</sub>;z<sub>2</sub>;:::;z<sub>n</sub>] denote the polynomial algebra in n variables with complex coecients. Then, given a set of q polynomials fh<sub>1</sub>;h<sub>2</sub>;:::;h<sub>q</sub>g with h<sub>i</sub> 2 C [z], we de neacomplex a nevariety as

where  $P=(a_1;a_2;\dots;a_n)$  is called a point of  $C^n$  and the  $a_i$  are called the coordinates of P. A complex projective space  $P^n$  is defined to be the set of lines through the origin in  $C^{n+1}$ , that is,  $P^n=C^{n+1}=0=$ , where the equivalence relation is defined as follow;  $(x_1;\dots;x_{n+1})=(y_1;\dots;y_{n+1})$  for  $2 \in C$ 0, where  $y_i=x_i$  for all 0 in i1. Given a set of homogeneous polynomials i2. The i3 with i4 and i5 are defined as follows.

As an important example of projective variety we will discuss the Segre variety. For a multipartite quantum system Q ( $N_1$ ;:::; $N_m$ ), let  $\overline{N}$  = ( $N_1$ 

1;:::; $N_m$  1) and  $V_1$ ; $V_2$ ;:::; $V_m$  be vector spaces over the eld of complex numbers C, where dim  $V_j = N_j$ . That is, we have  $P^{N_j-1} = P(V_j)$  for all j. Then we de nea Segre map by

Thus, we have  $P^{N-1}=P$  ( $V_1$ ;:::; $V_m$ ). The Segre variety  $S_{\overline{N}}=Im$  ( $S_{N_1,N_2}$ ;:::; $N_m$ ) is dended to be the image of the Segre embedding. By denition, the Segre variety is formed by the set of all classes of decomposable tensors in  $P^{N-1}$ . For a quantum system Q ( $N_1$ ;:::; $N_m$ ), the Segre variety is given by

W e can also partition the Segre embedding as follows:

where M  $_1$  = N  $_1$ N  $_2$  :::N  $_1$  1,M  $_2$  = N  $_{l+1}$ N  $_{l+2}$  :::N  $_m$  1 and (M  $_1$  + 1) (M  $_2$  + 1) = N  $_1$ N  $_2$  :::N  $_m$  . For the Segre variety, which is represented by a completely decomposable tensors, the above diagram commutate. Let X  $\,$  P  $^{\!N}$  . Then there are two important subsets of P  $^{\!N}$ ; the secant variety S ec(X), which is dened to be the closure of the set of point lying on secant  $\overline{x_1x_2}$ , where  $x_1$  and  $x_2$  are distinct points of X . The second one Tan(X) is the union of the projective tangent spaces. In the next section we will discuss the secant variety of a projective variety.

#### 3 Secant variety

The secant variety of a projective variety has been studied in algebraic geometry and some recent references include [10, 11]. The k-th secant variety S eq. (X) of  $P^M$  with dim X = d is dened to be the closure of the union of k-dimensional linear subspaces of  $P^M$  determined by general k+1 points on X

where for  $P_0$ ;  $P_1$ :::  $P_k$  2 X, we have  $P^k = hP_0$ ;  $P_1$ :::  $P_k$ i. M oreover, the dim ension of S eq. (X) satisfies

where M  $^{\circ}$  is the dimension of the linear subspace spanned by X . The subvariety X is called k-defect when dim S eq. (X) < m infM  $^{\circ}$ ; (k + 1) (d + 1) 1g. For example, the secant variety of Segre variety S eq. (S  $_{\overline{\rm N}}$ ) is the closure of the set of classes of those tensor products which can be written as the sum of at most k + 1 decomposable tensor products. Thus, the secant variety of Segre variety S eq. (S  $_{\overline{\rm N}}$ ) gives some useful information about the geometry of entangled and separable mixed multipartite states.

## 4 Secant variety of the Segre variety and concurrence

In this section, we investigate the secant variety of the Segre variety and show that the geometry of concurrence for mixed bipartite and three-partite states is given by this variety. In the next section, we will discuss the secant variety of variety for an arbitrary multipartite state. For bipartite quantum system Q ( $N_1$ ;  $N_2$ ), the Segre variety  $S_{\overline{N}}$  is the variety of  $N_1$   $N_2$  m atrices of rank 1. Thus the secant variety S eq. (S  $_{\rm N_1;N_2}$ ) is the matrices of rank less than k and k = N  $_1$  is the least integer for which S eq. (S  $_{N_1;N_2}$ ) = P  $^{N_1N_2}$   $^1$  . The Segre variety has two rulings by the families of linear spaces v P(W) and P(V) w for allv2V and w2W. The Segre variety can be seen as decomposable tensors in P(V) P(W). The k-fold secant plane to the Segre variety is given by the tensor of rank k. For example, a tensor which can be written as  $\sum_{i=1}^{k} v_i$   $w_i =$  $v_1 w_1 + v_2 w_2 + k + w_k$ : A san example, we will discuss the Secant variety of the Segre variety S eq. (S  $_{(3;3)}$ ) of quantum system Q  $_2$  (3;3). For this quantum system , the Segre variety is given by S  $_{(3;3)}=$   $^{1}$   $_{k_{1};l_{2};k_{2};l_{2}=1}$  V (  $_{k_{1};k_{2}}$   $_{l_{2};l_{2}}$  $k_1; l_2 = l_1; k_2$ ). M oreover, we have dim S eq. (S  $_{(3;3)}$ ) =  $(3+3)(1+1)(1+1)^2 = 1$  = 7, but the expected dimension was dim  $S ec_1(S_{(3;3)})$  m in fM ; (k + 1)(d +1)  $1g = m \inf 8$ ; (1 + 1)(4 + 1) 1g = 8. We have expected that the secant variety S eq. (S  $_{(3;3)})$  does  $\$ 11 the enveloping space and this is an example of a de cient Segre variety. For bipartite systems, if we assume that N  $_1$  < N  $_2$ , then for all 1  $k < N_1$  the secant variety  $S eq_k (S_{(N_1;N_2)})$  has dimension less than the expected dimension and the least k for which  $S eq_k(S_{(N_1;N_2)})$  lls its enveloping space is  $k = N_1$ . Next, we write the concurrence of a quantum system  $Q_2$  ( $N_1$ ;  $N_2$ ) as follows

where N is a normalization constant. From this expression we can see that the geometry of concurrence of arbitrary bipartite state is given by the secant variety of the Segre variety. Moreover, the geometry of arbitrary three-partite states can be given by this secant variety, since we can construct a measure for

three-partite states based on the Segre variety in the same way as we did for bipartite states. The generalized concurrence for such a state is given by

From this equation and the discussion about the concurrence of bipartite states, we have

We can also connect the secant variety of the Segre variety to the separable set ofm ultipartite states Q (N  $_1$ ; N  $_2$ ; :::; N  $_{\rm m}$ ) based on the relation between perfect codes and Secant variety of the Segre variety. The existence of perfect codes can be proved based on nite elds with qelements. The perfect code exist only for the following parameters: q is a prime power, t =  $\frac{q^1-1}{q-1}$  for 1-2 and k =  $q^{t-1}$ . Let us look at some examples of this kind. Let q=2, t =  $2^1-1$ , and k =  $q^{t-1}$ , where 1 is a positive number. Then for the Segre embedding

the secant variety of the corresponding Segre variety  $S \ eq_{k-1} \ (S_t) = P^{2^t-1} \ w$  hich ts exactly into its enveloping space. Thus, all  $S \ eq_{k-1} \ (S_t)$  have the expected dim ension. This secant variety coincide with the space of separable mixed multiqubits states  $Q \ (2;2;:::;2)$ .

Next, let q be a prime power. Then for any 1 1,  $t = \frac{q^1-1}{q-1}$ , and the Segre embedding

the secant variety of the Segre variety  $S \, eq_{k-1} \, (S_t) = P^{q^t-1}$  gives inform ation on the geom etry of the entangled and separable sets of an arbitrary quantum system  $Q \, (q;q;:::;q)$ .

## 5 Secant variety and arbitrary generalm ultipartite state

Recently, we have proposed a measure of entanglement for general pure multipartite states as [5]

where 2 Perm (u) denotes all possible sets of perm utations of indices for which  $k_1k_2:::k_m$  are replace by  $l_1l_2:::l_m$ , and u is the number of indices to perm ute. By construction this measure of entanglement vanishes on product states and it is also invariant under all possible permutations of indices. Note that the rst set of permutations denes the Segre variety, but there are also additional complex projective variety embedded in CP  $^{\rm N}$  which are dened by other sets of permutations of indices in equation (5.0.17). We can also apply the same procedure as in the case of the concurrence to dene a measure of entanglement for arbitrary multipartite states

Next, for a quantum system Q (N  $_1;:::;$ N  $_m$  ) we de ne the variety

which include the Segre variety. Now, based on our discussion about the concurrence of bipartite and three-partite states, we conclude that

This equivalence relation establish a relationes between the geometrical structure of a measure of entanglement for arbitrary general multipartite states and the secant variety S eq.  $(T_N^-)$ .

We have established a connection between pure mathematics and fundam ental quantum mechanics with some applications in the eld of quantum information and computing. We have introduced and discussed the secant variety of the Segre variety. But the secant varieties are still subject of research in algebraic geometry. For example, there are still many fundamental open questions about the secant variety of the Segre variety. However, we hope that this geometrical structure may give us some hint to how to solve the problem of quantifying entanglement of an arbitrary multipartite system.
