C oherent control of photon transm ission : slow ing light in coupled resonator waveguide doped with A tom s

In this paper, we propose and study a hybrid mechanism for coherent transm ission of photons in the coupled resonator optical waveguide (CROW) by incorporating the electrom agnetically induced transparency (EIT) e ect into the controllable band gap structure of the CROW. Here, the conguration setup of system consists of a CROW with hom ogeneous couplings and the arti cial atom s with -type three levels doped in each cavity. The roles of three levels are completely considered based on a mean eld approach where the collection of three-level atom s collectively behave as two-m ode spin waves. We show that the dynam ics of low excitations of atom ic ensemble can be e ectively described by an coupling boson m odel. The exactly solutions show that the light pulses can be stopped and stored coherently by adiabatically controlling the classical eld.

I. IN TRODUCTION

E lectrom agnetically induced transparency (E IT) is a phenom enon that usually occurs for atom ic ensemble as an active mechanism to slow down or stop laser pulse completely [1, 2, 3, 4]. U sually, the E IT e ect happens in the so-called -type atom ic system, which contains two lower states with separate couplings to an excited state via two electrom agnetic elds (probe and control light). W hen the absorption on both transitions is suppressed due to destructive interference between excitation pathways to the upper level, the medium becom estransparent with respect to the probe eld.

M ost recently, an EIT-like e ect has been displayed in the experiment via all optical on-chip setups with the coupled resonator optical waveguide (CROW) [5,6]. The bare CROW for photons behaves as the tight-binding lattice with band structure for electrons, thus the CROW forms a new type photonic crystal. It was discovered that, by coupling each resonator in the CROW to an extra cavity, the resonate spectral line is shift and the band width is compressed, thus the propagating of light pulses is stopped and the inform ation carried by light is stored [7, 8, 9]. The scheme of stopping, storing and releasing light is also theoretically proposed and analyzed for quantum -well B ragg structures which form a onedim ensional resonant photonic bandgap structures [10].

A ctually, with the help of modern nano-fabrication technology, the hybrid structure, i.e., an array of coupled

cavities with doping arti cial atom s can be im plem ented experim entally with a photonic crystalor other sem iconductor systems. By making use of such hybrid system [11, 12], M ott insulator and super uid state can emerge in di erent phases of the polaritons form ed by dressing the doping atom s with the gapped light eld. A lso the hybrid system of a two-dimensional array of coupled optical cavities in the photon-blockade regim e will undergo a characteristic M ott insulator (excitations localized on each site) to super uid (excitations delocalized across the lattice) quantum phase transition [13]. Such a coplanar hybrid structure based on superconducting circuit, has been proposed by us [14] for the coherent control of m icrowave - photons propagating in a coupled superconducting transmission line resonator (CTLR) waveguide [15, 16].

By making use of the two time G reen function approach, we studied the coherent control of photon transmission along the hom ogeneous CROW by doping twolevel atom s[17]. U sually, to realize the controllable and robust two-level system, a three-level atom is used to reduce an e ective two level structure through the stimulated R am an mechanism, which is two photon process decoupling the two direct transitions to upper energy level in the case with large detuning. Then the induced coupling between two lower energy levels can be obtained by the adiabatic elim ination of the upper energy level.

In this paper, we study the photon transm ission in a hom ogeneous CROW controlled coherently by doped three-level -type system s, where the upper energy level is not elim inated adiabatically. To consider the coherent roles of three energy levels directly, we use the m ean

eld approach to deal with the collective excitations of all spatial distributed -type atom s as two independent




FIG.1: (Color on line) Illustrative con guration for controlling light propagation in a coupled resonators waveguide by doping atom systems: (a) A schematic of the coupled resonator optical waveguide (CROW) doped by three level systems. The CROW can be realized as a array of periodic defects in the photonic bandgap materials, or a waveguide with coupled superconducting transmission line resonators; (b). The doping three level atoms interacting with quantized probe light and the classical couple light. The arti cial atoms can be realized as the quantum dot, or the charge and ux qubits.

bosonic modes of quasi-spin-waves [18]. These quasispin-waves due to interacting with the cavity modes in CROW can change the photonic band structure of CROW so that the dispersion relation exhibits som e exotic feature - a slow (and even zero velocity) light pulses can em erge by som e appropriate coherent controlof lightatom couplings.

This paper is organized as follow: In Sec. II, we describe our model - the hom ogeneous CROW with each cavity doping a -type three-level atom . By the mean eld approach in terms of spin wave excitations, in Sec.III, we derive down the e ective Ham iltonian for the hybrid structure. In Sec. IV, we diagonalize the e ective Ham iltonian to determ ine eigenfrequencies of this hybrid photon-atom system . The quasiparticles - polaritons are introduced to describe the excitations of this system . Then, in Sec. V, we discuss how the doping atom s m odify the band structure of the CROW , and show how to store the inform ation of incident pulse by adjusting the intensity of the control radiation in EIT. The absorption and dispersion of the atom ic medium to the slow light pulses are studied in Sec. VI. W e make our conclusion and give rem arks shortly in sec. V II.

II. MODEL SETUP AND MOTIVATIONS

The hybrid system that we considered is shown in Fig.1. This system consists of N single-mode cavities with hom ogeneous nearest-neighbor interaction, which form a one-dimensional array of cavities. Each single-mode cavity has the same resonance frequencies !0. There are three practical systems to implement such array of cavities [19]: 1) a periodic array of coupled Fabry-

Perot cavities; 2) the coupled m icrodisk orm icroring resonators; 3) the coupled defect modes in photonic crystals, where the bandgap cavities are form ed when the periodicity of photonic crystal is broken periodically [20, 21]. The intercavity photon hopping is due to the evanescent coupling pathways between the cavities. In the coupled Fabry-Perot cavities and the m icrodisk or m icroring resonators, the doped system can be the natural atom . For photonic crystals, the photonic bandgap m aterial is fabricated in diam ond, the doping system s can be realized as som e ion-in planted NV centers [13]. A nother prom ising candidate for electrom agnetically controlled quantum device is based on superconducting circuit [14], where the CROW is realized by the superconducting waveguide with coupled transmission line resonators [15, 16], while the doping system s are in plem ented by the biased Cooper pair boxes (CPBs) (or called charge qubits), or

G enerally, we use a_j^y (a_j) to denote its creation (annihilation) operator of the jth cavity. In each cavity, the two lower levels jbi and jci are excited to the upper level jfi by the quantized eld and the coupling eld respectively. The energy level spacing between the upper level jfi and the ground state jbi is denoted by $!_{fb} = !_f !_b$. This two-level atom is transition couples to quantized radiation m odes of the waveguide cavities with coupling constant g_1 . The energy di erence between the upper level jfi and the m etastable lower state jbi is denoted by $!_{fc} = !_f !_c$. Let J be the nearest-neighbor evanescent coupling constant of intercavity. The model H am iltonian H = $H_{C} + H_{A} + H_{AC}$ consists of three parts, the cavity part with intercavity photon hoppings,

Here, the quasi-spin operators $^{J} = j i_{j}h j (; = f;b;c)$ for f describe the atom ic transitions among the energy levels of jfi, jbi and jci. In practical experiments, coupling constants g_{i} and J depend on the positions of atom s. In this paper, we take uniform g and J for simplicity. A ctually, a small di erence of couplings is unavoidable in the practical in plan entation of




FIG.2: (Color on line) E lectrom agnetically induced transparency (EII) e ect in the coupled resonator optical waveguide (CROW) with photonic band structure: The problem is equivalent to that a multiment ode optical pulse with di erent color component couples between two energy levels nearresonantly. The strong light split the bare energy levels. The EII phenom enon emerges when the band structure can m atch these split. This mechanism can well controls light propagation in the CROW by doping a three-level system.

the present setup, but there should been no principle dif-

culty in modern fabrication technique to achieve quasi uniform coupling [23]. Theoretically, the small uctuations of coupling constants are innocuous and do not change the results of this paper qualitatively.

To illustrate our motivation using this complex hybrid structure, we may recall the fundam ental principle for the E IT phenom enon brie y. U sually, a absorption region occurs to a weak probe light when it passes through a medium, but in the presence of the control light, a transparency \w indow " appears in the probe absorption spectrum. Here the probe light is not of single color since the photon propagating in the CROW has a photonic band. To consider whether or not E IT phenom enon emerges in this band-gap structure, we should match the photonic band structure with the splits of the energy level spacing between jf i and jci (see the Fig.2).

As for this hybrid structure with EIT e ect, it is well known that, am ong varieties of theoretical treatments of EIT, an approach for EIT is the \dressed state" picture, wherein the Ham iltonian of the system plus the light eld is diagonalized rstly to give rise to a Autler-Townes like splitting [24] in the strong coupling lim it with the control

eld. Then the Fano like interference [25] between the dressed states results in E IT. Between the doublet peaks of the absorption line, a transparency window emerges as the quantum probability am plitudes for transitions to the two lower states interference. In the CROW, the emitted and absorbed photons can also be constrained by the photonic band structure. Here, the single and two photon resonances in E IT for a given Autler-Townes like splitting should be re-considered to m atch the band structure of the CROW. Particularly, we need to generalize the polariton approach to describe the stopped and stored light schemes. Here, the photons of the probe

beam only within the photonic band can be coherently \transform ed" into \dark state polaritons", which are the dressed excitations of atom ensemble.

III. COLLECTIVE EXCITATIONSW ITH ELECTROMAGNETICALLY INDUCED TRANSPARENCY EFFECT

In order to study the novelEIT e ect in the CROW, we use the mean eld approach that we developed for the collective excitation of an atom ic ensemble with a ordered initial state [26]. This approach for EIT can be understood as a fully-quantum theory, which not only gives these results about slow light propagation that can be given by sem i-classical approach, but also em phasizes the quantum states of photon and the atom ic collective excitations-quasi-spin waves, which are crucial for quantum inform ation processing, such as quantum mem ory or storage

This means the interaction H am iltonian possesses a intrinsic dynamic symmetry described by a large algebra containing SU (2) as subalgebra. Technologically this observation will help us to diagonalize the H am iltonian Eq.(17) as follows.

IV. DRESSED COLLECTIVE STATES: POLARITONS

In each cavity the strong couplings will coherently m ix the photon and the articical atom sto form dressed states. The collective e ect of these dressed states can m ake the collective excitations, which behave as bosons (called polaritons) in the low excitation limit. M athem atically we write the boson operator a_k , A_k and C_k as an operator-valued vector

Now we solve eigenvalue problem of the matrix M. Then $V_k\,$ can be diagonalized to construct the polariton operators, which is described by the linear combination of the quantized electrom agnetic eld operators and atom ic collective excitation operator of quasi-spin waves. W hen the detunings approximately satisfy the resonance transition condition so that $_{k} = 0$ for some k; the dark-state polariton can be constructed as an eigenstate with vanishing eigenvalue. For concreteness, we

rst consider the case with the detuning $_2 = _1 = 0$, which m eans that the probe light and the classical eld are resonant with the -type atom s in each cavity. The polariton operators at the band center $k = k_0 = = (2)$ can be constructed as

Here, $P_{k_0}^{[2]}$ is the dark-state polariton (DSP), which traps the electrom agnetic radiation from the excited state due to quantum interference cancelling; B_{k_0} is called the bright-state polariton [26].

For another case, we assume that, in each cavity, the frequency of the probe light $!_0$ has a nonzero detuning from the transition frequency $!_{ab}$, i.e. $_1 = 60$. By adjusting the frequency of the classical eld, $_2 =$ can be realized, and then the condition $_k = 0$ is satis ed at the band center. So the dark-state polariton exists. W ith the polariton operators

A ctually, for a probe light with nonzero detuning $_1$ and small band around $k = k_1$ ($k_1 \notin k_0$), by adjusting the detuning $_2$ to satisfy $_{k_1} = 0$, at the model $k = k_1$, we can also construct the polariton operators similar to those of Eq. (25) with $_2$ replacing and k_1 replacing k_0 .

V. BAND STRUCTURE OF POLARITONS

From the above discussion, it can be observed that the spectra of the hybrid system consists of three bands, and there exists gaps among these three bands for a non-vanishing G_1 and g_2 . Since the number of total excitations




FIG.3: (Cobr on line) The band structure at the rst excitation space. Here the eigenfrequency is plotted as a function of the wave vector k. We have set J = 1. The other param eter are set as follow, $_1 = 0$, (a) $_2 = 3jJj$, $G_1 = 0.1J$, $g_2 = 1.0jJj$, (b) $_2 = 3jJj$, $G_1 = 0.1J$, $g_2 = 1.0jJj$, (c) $_2 = 0$, $G_1 = 0.1JJj$, $g_2 = 3JJj$, (d) $_2 = 0$, $G_1 = JJj$, $g_2 = 0.1JJj$, The wave vector k is in unit of 1='.

com m utes with V_k , the number of excitation N_k is conserved, while the numbers $a_k^y a_k$, $A_k^y A_k$ and $C_k^y C_k$ of different type excitations are m utually convertible by adjusting some parameters. In Fig.3 we plot the eigenfrequencies as a function of the wave vector k in the one excitation subspace. It can be seen from Figs. 3(a) and (b) that the bandwidth can be tuned by adjusting the

detuning $_2$ and the coupling strength g_2 . For a xed coupling strength g_2 , when $_2$ jg j the lowest band (the red dash line) has a large bandwidth, which ensures to accommodate the bandwidth of entire pulse; when $jg_2 j$ the bandwidth of the lowest band W $_0$ 0. 2 Hence for a light pulse that is a superposition of many k-states, its distribution in the k -space can be entirely contained in the photonic band of the CROW by setjg j. By adiabatically tuning the detunting 2 ing from 2 jo₂jto ₂ $jg_2 j$ the light pulse can be stopped. Such kind approach to stoping light with all-optical process has been investigated theoretically by num erical simulations [7, 8, 9] and a similar all-optical schem e has already been realized in a recent experim ent [5].

W hen the light pulse enters the medium, photons and atom s combine to form excitations known as polaritons. Because the spin wave propagates together with the light pulse inside the medium, the group velocity of light pulse is reduced by a large order of magnitude. Thus by analyzing the contribution of photons to the polaritons, it can be well understood that how the group velocity of probe eld is stopped and revived. For the sake of sim – plify, rstly, we focus on the polaritons at the band center and consider the situation with the resonance transition. The operators of polaritons are the linear com bination of that of photons and atom s with the follow ing form

The contribution of photons to dark polaritons can be explicitly analyzed. It can be obtained that the dark polariton appears like photons with probability approxi- G_1 , that is, $P_{k_0}^{[2]}$ m ately to one when g_2 a_{k_0} . Thus G_1 , this means the middle band if we initial set g_2 can accomm odate many component of the input pulse. It is easy to nd that when g G_1 , the contribution of photons in the polariton becom es purely atom ic, that is, P _{k0} [2] C_{k_0} . Thus when the pulse is completely in the system, the adiabatical perform ance changes the dark polariton from photons to atom s and reverse. The sim ilar situation can be found at the second band under the two photon resonance from Eq. (25).




FIG. 4: (C obr on line) the contribution of photons and two spin waves in the polaritons d_{jk} as functions of k for the rst eigenfrequency ${2 \choose k}$ (a) and (b), the second eigenfrequency ${2 \choose k}$ (c) and (d), the third eigenfrequency ${3 \choose k}$ (e) and (f). 1 = 2 = 0, J = 1. For (a), (c) and (e), we set $G_1 = jJj$ and $g_2 = 0.1jJj$; For (b), (d) and (f), we set $G_1 = 0.1jJj$ and $g_2 = 3jJj$. The wave vector k is in unit of 1=

In order to give a general argument, we plot the coe - cients before a_k , A_k and C_k in the polaritons as functions of the momentum index k respectively in Fig.4. For the convenience of expression, we denote $d_{jk}^{[i]}$ (j = 1;2;3) as the coe cients before the operators a_k , A_k and C_k for di erent eigenvalues i = 1;2;3 respectively. From Eq. (21), the expression of $d_{ik}^{[i]}$ can be obtained

gure, the red dash line represents the magni-In each tude $d_{2k}^{[i]}$ of spin waves generated by the atom ic transition between joi and jf i; the blue solid line denotes the am plitude $d_{3k}^{[i]}$ of spin waves between \mbox{tri} and \mbox{tri} ; the black dash-dot line describes the magnitude $d_{1k}^{[i]}$ of photonic component. It can be observed that for the incident pulse with momentum distribution around k = = (2), photons make a large contribution to the polaritons at q_2 than at the condition G_1 G₁ g_2 . The contribution of photons in the polariton of the second band, shown in Fig. 4(c) and (d), is modi ed completely by the coupling strength of light and matter: spin waves C_k take large proportions when G_1 g_2 and photons a_k have large contributions when G_1 g_2 . Hence the second band can be used to convert the quantum inform ation originally carried by photons into long-lived spin states of atom s.

The characteristic of our hybrid system is that the \dark state"can be realized in a straightforward way. This gives rise to quasi-particles - the dark polariton, which re ects the crucial idea of the EIT - the coherent

population trapping for the quantized probe eld. A ctually, a D SP is an atom ic collective excitation (quasi-spin wave) dressed by the quantized probe light. This point can be seen directly from Eq.(25b). The contributions of light or atom s in DSP can be varied by adapting the am plitude of the classical eld, which has been discussed in the last paragraph. Thus, in our hybrid system, the DSP o ers a possible control scheme for slowing light. This accessible scheme can be observed from the change of bandwidth. In Fig. 3 (c) and (d), we plot the eigenfrequency as a function of the wave vector k in the rst excitation space for a given $_2$. It shows that, when g_2 G₁, the bandwidth of the middle band (the blue solid line) has a large bandwidth; when g_2 G_1 , the bandwidth of the middle are approximately to zero; The couplings also make the center of bands away from $!_0, !_{ab}$ and $!_{cb}$ respectively. This fact means that by tuning the coupling G_1 to g_2 strength from g₂ G_1 adiabatically, we can stop the input light pulse and then re-em it it. Thus via selecting a classical eld with a suitable frequency, the quantum state of an input pulse can be converted into the doped three-level atom s sim ply by switching o the driving eld, and then by turning on the driving eld, the stored information can be retrieved.

To give a concrete example, we consider the resonant transition with $_1 = _2 = 0$. In this case, the correspond-

ing group velocities at each band center are

It can be seen that, at the band center, when q_2 G 1, the lowest band (the red dash line in Fig.3(c) and (d)) and the highest band (the black dash-dot line in Fig. 3 (c) and (d)) exhibit zero group velocity and zero bandwidth, but the middle band (the blue solid one in Fig.3 (c) and (d)) exhibits a large group velocity and a large bandwidth; in reverse, when q_2 G_1 , the m iddle band exhibits zero group velocity and vanishing bandwidth, but the low est band and the highest band exhibit large group velocities and large bandwidths. Hence in this system, focusing on the middle band, a light pulse can be stopped by the following process: Initially setting g_2 G_1 , the m iddle band accomm odates the entire pulse. A fter the pulse is completely in this system, we vary the coupling strength until g₂ G_1 adiabatically. The lowest band also can be used to stop light by tuning g_2 from g_2 G 1 G_1 . to g₂

Finally, we give some estimation about the group velocity according to the realistic parameters, which are taken for the array of coupled toroidal microcavities[12, 22]. The distance `between the microcavities is 15:69 m [5], and the evanescent coupling between the cavities $J = 1:1 \quad 10^7 \text{s}^{-1}$. Within each cavity, the coupling strength between the atom and the quantum eld $g = 2:5 \quad 10^9 \text{s}^{-1}$. Rabi frequency $g_2 = 7:9 \quad 10^{10} \text{s}^{-1}$. W hen N = 10;000 atom same contained in each cavity, the group velocity of light at the second band center is estimated 31m = s.

VI. SUSCEPTIBILITY ANALYSIS FOR LIGHT PROPAGATION IN THE DOPED CROW

W hen a light beam incidents on an optically active medium, the medium will give a response to the control light. U sually, the index of refraction can reach high values near a transition resonance, but the high dispersion always accompanies with a high absorption in the resonance point. In EIT, the resonant transition or the two photon resonance renders a medium transparent over a narrow spectral range within the absorption line. A lso in this transparent w indow, the rapidly varying dispersion is created, which leads to very slow group velocity and zero group-velocity. In this section, we will investigate the dispersion and the absorption property of the gapped light in our hybrid system . W e use the dynam ic algebraic m ethod developed for the atom ic ensemble based quantum mem ory with EIT [26, 27].

We begin with the Hamiltonian (17) in the k-space representation. W hen the atom ic decay is considered, we w rite down the H eisenberg equations of operators a_k , A_k and C_k for each mode k

where we have phenom enologically introduced the dam ping rate of cavity , and the decay rate $_{\rm A}$, $_{\rm C}$ of the energy levels jfi and jci of the three-level system respectively. W e also assume that

To nd the steady-state solution for the above motion equations, it is convenient to rem ove the fast varying part of the light eld and the atom ic collective excitations by m aking a transform ation



The real part $\frac{r}{k}$ and in aginary part $\frac{i}{k}$ of the susceptibility correspond to the dispersion and absorption respectively.

In order to calculate the susceptibility, we rst nd the steady-state solution by letting $Q_t A_k = 0$ and $Q_t C_k = 0$



Since the susceptibility depends on k, in Fig. 5 the real and in aginary susceptibilities ${}^{\rm r}_k$, ${}^{\rm i}_k$ are plotted versus the detuning di erence = $_{2}$ _ 1 in units of A (A = 10^3 _C), where we assume that the central frequency of light pulse is at k = -4 '.

It is observed that, when the detuning 1, 2 satisfy k = 0, that is, the two photon resonance is satis ed,




FIG.6:Real (solid) and imaginary (dotted) parts of the linear susceptibility as a function of the inter-cavity coupling strength J. The parameters are set as $G_1 = 1$, ' = 1. (a) $g_2 = 0.5$, $_2 = 0$, = 1 and k = =4; (b) $g_2 = 2$, $_2 = 0$, = 1 and k = =4; (c)g₂ = 0:5, 2 = 1, = 1 and k = =4; $(d)g_2 = 0:5, 2 = 1,$ = 1 and k = =4; (e)g₂ = 0:5, 2 = 2, = 1 and k = =4; (f) $q_2 = 0.5$, 2 = 0, = 1 and k = =2. J is in units of A = 1.

both the real and im aginary susceptibilities vanish, the absorption is absent and the index of refraction is unity. Thus the whole system becomes transparent under the driving of the strong classical control eld. Through Eq. (18), we obtain that the momentum index k together with the nearest-neighbor evanescent coupling strength J determ ines the range where the transparency window occurs. The width of the transparency window depends on the control eld Rabi frequency q, which is shown by comparing Fig. 5 (a) with Fig. 5 (b).

F inally to consider the role of the inter-cavity coupling J, we plot the real (solid line) and the imaginary (dash line) part of the susceptibility as a function of the intercavity coupling strength J, shown in Fig. 6. It can be observed that: when the incident pulse is center at k =

=(2), the susceptibility is independent of J (see Fig. 6(f); for the input pulse centered at k = -(4), in the vicinity of a frequency corresponding to the two-photon

transparency with respect to the input pulse within the photonic band. By comparing Fig. 6(a) and (b), It can be found that the detuning di erence determ ines the position where the transparency window occurs, and the intensity of the control beam decides the width of the transparency window; it can also be observed from Fig. 5 and Fig. 6 that the larger the detuning $j_2 j_1$ is, the broader transparency window the spectra of this system has.

> V II. CONCLUSION AND REMARKS

We have studied a hybrid system, which consists of N hom ogeneously coupled resonators with three-level type atom s doped in each cavity. The electrom agnetically induced transparency (EIT) e ect can enhance the ability for coherent m an ipulations on the photon propagation in the CROW , namely, the photon transmission along the CROW can be well controlled by the amplitude of the driving eld. W ith these results, it is expected that the quantum information encoded in the input pulse can be stored and retrieved by adiabatically tuning g_2 from G_1 to g_2 G₁. g_2

A lso it can be seen that our hybrid architecture possesses m ore controllable param eters for transferring photons in an array of coupled cavities: two coupling strength g_1 , g_2 and two detunings. Typically, in two photon resonance, the light can be stopped only by controlling the amplitude of the classical eld. In comparison with our scheme, the alloptical architecture with the passive optical resonator [7] only has two controllable param eters, the coupling strength between the side-coupled cavity and each of the CROW and the detuning between resonance frequency of side-coupled cavity and that of cavity which constitute the CROW . In other hand, the standard E II approach only uses the single "cavity" and thus there is not a controllable photonic band structure. The on-chip periodic structure used here actually can implement the EIT manipulation for photonic storage in the periodic lattice xing atom s spatially 26].
