Selective entanglem ent breaking

We discuss the cases where local decoherence selectively degrades one type of entanglement more than other types. A typical case is called state ordering change, in which two input states with dierent amounts of entanglement undergoes a local decoherence and the state with the larger entanglement results in an output state with less entanglement than the other output state. We are also interested in a special case where the state with the larger entanglement evolves to a separable state while the other output state is still entangled, which we call selective entanglement breaking. For three-level or larger systems, it is easy to not examples of the state ordering change and the selective entanglement breaking, but for two-level systems it is not trivial whether such situations exist. We present a new strategy to construct examples of two-qubit states exhibiting the selective entanglement breaking regardless of entanglement measure. We also give a more striking example of the selective entanglement breaking in which the less entangled input state has only an in nitesimal amount of entanglement.

I. INTRODUCTION

Quantum entangled states on a composite system are vital resources for many quantum information protocols [1], and it is important to understand how various entangled states are a ected by decoherence when one of the local subsystems is interacted with the environment or is transferred over a noisy quantum channel. Here we focus on the cases in which the e ects of such a local quantum operation/channel are di erent on two di erent kinds of entanglement. In a typical situation, one input state has a large am ount of entanglem ent and the other one has very small entanglement, but after applying a local quantum channel on one of the system s, the entanglem ent in the form er state is com pletely destroyed while the latter state is still entangled. In other words, the less entangled state is robust against the noises of the quantum channel that severely degrades the other type of entanglem ent.

When the dimension of Hilbert space for the local system is more than two, namely, for a three-level or larger system, such an example is easy to nd [2]. Since two levels (a two-dimensional subspace) are enough to form entanglement to another system, and there are dierent pairs of levels to choose, it is easy to imagine a quantum channel which completely destroys the coherence between a specic pair of levels, while leaving the coherence between another pair intact. If, however, the system in

question is a qubit (a two-level system), the problem becomes nontrivial because any entanglement must use the whole two-dimensional space. Hence the phenomenon of \state ordering change" by local evolution has been sought after [2], in which the amount of entanglement E satis es

for input states ${}^{\circ}_{1}$; ${}^{\circ}_{2}$ and the output states ${}^{\circ}_{j}$ = E_{L} [${}^{\circ}_{j}$] (j = 1;2), where E_{L} = E I is a local quantum channel. Zim an and Buzek have found examples of such state ordering change for a particular measure E of entanglement [2].

At this point, one must recall that the ordering between two entangled states may depend on the choice of the entanglem ent m easure. E isert and P lenio showed that the condition, $E^{0}(?_{1}) < E^{0}(?_{2})$, $E^{0}(?_{1}) <$ $\mathbb{E}^{0}(?_{2})$, is not always satis ed from M onte Carlo simulation (E 0; E 00 are two di erent entanglem ent m easures) [3]. That is to say, there exists a pair of states with $\mathbb{E}^{0}(?_{1}) < \mathbb{E}^{0}(?_{2})$ and $\mathbb{E}^{0}(?_{1}) > \mathbb{E}^{0}(?_{2})$. M iranow icz and Grudka studied such an ambiguity in the ordering in two-qubit states for entanglem ent m easures including negativity, concurrence, and relative entropy of entanglem ent [4, 5]. Hence a measure-dependent example is not enough to ascertain the existence of the state ordering change in a local qubit channel. For a de nite answer, we need to show that Eq. (1) holds for any measure of entanglem ent E.

In this paper, we propose a general strategy to produce many examples of two-qubit states and a qubit channel showing the state ordering change for any measure

of entanglem ent. In these examples, the output state $\S^0_1=E_L\ [\S_1]$ is separable, namely, the qubit channel destroys the entanglem ent in state \S_1 completely but leaves behind part of the entanglem ent in state \S_2 , which we call selective entanglem ent breaking". We further show that a particular example constructed from the above strategy exhibits a more striking feature that the channel breaks entanglement in \S_1 selectively even when the input state \S_2 has an in nitesimal amount of entanglement.

The construction of the paper is as follows. In Sec. II, we give a trivial example of two-qutrit states and a qutrit channel show ing the selective entanglem ent breaking. We also give precise de nitions of the three relevant phenom ena: state ordering change, selective entanglem ent breaking, and strong selective entanglement breaking. In the main part of the paper, Sec. III, we present a strategy for nding examples of two-qubit states and a qubit channel showing the selective entanglement breaking. We also construct a specic example and show that it exhibits the strong selective entanglement breaking. In Sec. IV, we show there is no selective entanglement breaking for two-qubit pure states. In Sec. V, we consider a family of entanglem ent m easures for which the state ordering change can be discussed with a strict inequality. Finally Sec. V I concludes the paper.

II. TW O-QUTRIT STATE ORDER ING CHANGE

Let us consider the case where the local system is a qutrit, namely, the dimension of the Hilbert space is three. We can easily not an example of two-qutrit states and a qutrit channel showing the state ordering change. Consider two pure states j_1i= $\frac{1}{1-2}$ (jl1i+ ½2i) and j_2i= $\frac{p}{q}$ p0i+ $\frac{p}{1}$ qjl1i (0 < q < 1). Suppose that the local channel E applied to the rst system is represented by K raus operators (the operator-sum representation): E(^) = $\frac{1}{2}$ M j M j , where M 0 = j0ih0j+ jlihlj and M = ½ih2j. A fler applying $E_L = E$ I to the two input states, we obtain a separable state $\frac{1}{2}$ 0 = (jlihl1j+ ½2ih22j=2 for the rst input state, but the second input state remains unaltered, $\frac{1}{2}$ 0 = j 2ih 2j.

In this example, the input state j₁i can be transformed to j₂i by local operations and classical communication (LOCC). One of the parties applies a local liter described by K raus operators $\hat{A_0} = 0$ in0 j + $\frac{1}{1}$ qjlihlj + $\frac{p}{q}$ pih2j and $\hat{A_1} = \frac{p}{q}$ qjlihlj + $\frac{p}{1}$ qpih2j and classically communicate the outcome (0 or 1) to the other party. W e see that this trivial example shows the state ordering change regardless of the choice of entanglement measure, which we de ne formally as

Here we cannot dem and the strict inequality to hold for any measure, since the property (i) cannot exclude a trivial measure which is constant for any state whether it is entangled or not. If we are to require the strict inequality, we need to restrict the allowed entanglement measures, which will be discussed in Sec. V .

In the above example of two-qutrit state ordering change, the entanglement in the state $!_1$ is completely destroyed by the channel. In this paper, we de ne such cases as follows:

Selective entanglement breaking | The state ordering change occurs with one of the output states being separable.

M oreover, in the trivial example considered here, the entanglement in state j $_2$ i is preserved no matter how small its entanglement is. This implies that the quantum channel selectively destroys the type of entanglement held in a state $?_1$, while it does not completely destroy entanglement held in another state $?_2$ even when its entanglement of formation [6], $E_f(?_2)$, is in nitesimal. Here we will de ne such a phenomenon in the following way.

In the three-level system considered here or in larger systems, the existence of the state ordering change is trivial, and even the existence of the strong selective entanglement breaking is also trivial as shown above. The next section will deal with the nontrivial question for the case of a two-level system.

In this section, we show an example of the selective entanglem ent breaking where the local system is a qubit. For two-qutrit system, it was not dicult to nd the example of the strong selective entanglement breaking. This is because for three-level or larger systems we can preserve entanglement even if we apply a projector onto a two-dimensional subspace. But for a two-level input system, we cannot preserve entanglement by nontrivial projections. It is thus dicult to nd an example of two-qubit selective entanglement breaking along the line used in the previous section.

Our strategy to nd such an example is as follows. First we consider an entangled mixed state AB and a qubit channel E with a parameter representing the am ount of the noise introduced by the channel. A fter applying the local channel to the input state AB, we $I(^{AB})$ as calculate the negativity [7, 8] of state E a function of to not the value of = sep at which the state becomes separable.




FIG. 1: Strategy to nd examples of the selective entanglement breaking. We use negativity N ($^{\circ}$) as an entanglement measure, since it is easy to calculate. Slight decrease in the degree of entanglement (the arrow) is done by LOCC, and hence the order of the two input states is measure—independent. The order of the two output states is also measure—independent, since one of them is separable.

The success of our strategy rests on whether the critical value sep changes depending on the choice of the unitary \hat{U} . Once we not such a dependency, we can construct an example of the selective entanglement breaking as follows. Without loss of generality, we can assum e that there is a value of for which E is separable, while the negativity of state E is strictly positive. Then, we consider an LOCC operation E⁰ with parameter representing the strength of the noise ($\mathbb{E}_0^0 = \mathbb{I}$ I), and apply it to state AB to obtain AB $E^{0}(^{AB})$. If is small enough but nonzero, we have N $(^{AB})$ < N $(^{AB})$ = N $(^{AB})$ while the negativity of the new state E $\,\,\,$ I ($^{A\,B}$) should still be strictly pos- $I(^{AB})) > 0 = N (E$ itive, namely, N Œ Hence, for the negativity, the strict inequality (3) is satis ed (see Fig.1). On the other hand, we can convert $^{AB}_{II}$ to AB by LOCC (\hat{U}^{1} \hat{I} followed by E^{0}), and we can also convert E I (AB) to E I (AB) by LOCC since the latter is separable. Hence, from the monotonicity (i), the inequality (2) holds for any measure E.

Let us show a speci c example using the above strategy. First we consider a mixed entangled state,

As the local quantum channel applied to system A, we take a phase damping channel represented by two K raus operators

For an input two-qubit state ^in, the output of the phase damping channel is given by ^out = $(\hat{E}_0 \quad \hat{I})^{\text{in}} (\hat{E}_0^{\hat{Y}} \quad \hat{I}^{\hat{Y}}) + (\hat{E}_1 \quad \hat{I})^{\text{in}} (\hat{E}_1^{\hat{Y}} \quad \hat{I}^{\hat{Y}})$. For the two input states ^in and ^in , the output states are calculated as




FIG. 2: Exam ple of the selective entanglem ent breaking. The negativities of $^{\text{out}}_1$, $^{\text{out}}_2$, $^{\text{out}}_3$ (t = 1=3) are indicated by the dotted curve, the dashed curve, and the solid curve, respectively.

where $_{\rm min}$ is the minimum of the eigenvalues of the partial transpose of state ^ [7, 8]. For two-qubit states, it has the range from 0 (separable) to 1 (maximally entangled). The negativity of the two output states $_{1}^{\rm out}$ and $_{2}^{\rm out}$ are

which are shown in Fig. 2.

When the noise parameter of the quantum channel is = $_1$ 16+ $12_p \overline{2}$ 0.97, N ($_2^{\text{out}}$) = 0, and N ($_1^{\text{out}}$) $_{j=1}$ = 2(3 2 $\overline{2}$)=3 0.11 > 0. Then we decrease N ($_1^{\text{in}}$) using LOCC. Specically, we consider an operation in which the state is replaced by j00i with probability . Applying this operation to $_1^{\text{in}}$, we have

where t = 2(1) = 3 < 2=3. Calculating in a sim ilarway, we obtain the negativity of the output state as

The case with t = 1=3 is shown in Fig. 2.

As explained for the general strategy, E $\binom{\text{ain}}{3}$ E $\binom{\text{ain}}{2}$ and E $\binom{\text{aout}}{3}$ E $\binom{\text{aout}}{2}$ hold for any entanglement measure satisfying the monotonicity (i). On the other hand, N $\binom{\text{ain}}{3}$ < N $\binom{\text{ain}}{2}$ holds for t < 2=3 and N $\binom{\text{aout}}{3}$ >

N ($^{\text{out}}_2$) holds for t > 0. Hence the phase damping channel with = $_1$ and the states $^{\text{in}}_2$ and $^{\text{in}}_3$ with 0 < t < 2=3 exhibit the selective entanglement breaking.

In the lim it of t! 0, the state $^{'in}_{3}$ becom es separable. But as long as t > 0, the output state is still entangled, and the state ordering change occurs. Hence the particular example here exhibits not only the selective entanglement breaking, but also the strong selective entanglement breaking.

IV. NO SELECTIVE ENTANGLEMENT BREAKING EXISTS FOR TW O-QUBIT PURE STATES

In the previous section, we present a speci c exam ple of selective entanglem ent breaking in which the two input states are mixed states. In fact, we cannot nd pure-state exam ples by our strategy. The reason is closely related to the following general property of qubit channels: if a two-qubit pure entangled state becomes separable after one of the qubit passes through a qubit channel, then the channel is an entanglement breaking channel [9, 10], namely, the channel destroys the entanglement of any input state. We can prove it as follows.

Consider a two-qubit pure state $j_{in}i = 100i + 11i$, where $^2 + ^2 = 1$, and suppose that j in i becomes separable state 'sep after the application of a qubit channel. Im agine we further apply a local lter, which is described by the K raus operator $\hat{M}_0 = \hat{J} + \hat{J} +$ to the second qubit. Now notice that even if we apply the local Iter rst and then apply the one-qubit channel, the nal state should be the same because they are operations on di erent systems. In this case, the state after the successful Itering is a maximally entangled state 1=2 (100i+ 111i), which evolves into the separable state ^sep after the application of the qubit channel. Hence the channelm ust be an entanglem ent breaking channel.

For a system with dimension d larger than two, a straightforward extension of the above proof shows that a local channel is entanglement breaking if a pure entangled state with full local rank (the marginal density operator having rank d) is broken by the channel. This leaves the possibility of having the selective entanglement breaking of pure states with a small local rank, as in the trivial example shown in Sec. II.

V. STATE ORDERING CHANGE W ITH STRICT INEQUALITY

As discussed in Sec. II, not all of the entanglement measures satisfying the monotonicity (i) full lithe strict inequality (3). Here we show that, in the example in Sec. III, the strict inequality (3) holds for a wide range of measures specified by a set of additional conditions which are often considered to be desirable as a measure of entanglement. We consider the measures satisfying the following properties:

 $(^{\circ})$ M onotonicity under LOCC on average, if LOCC transforms AB into a state $^{AB}_{i}$ with probability p_{i} , the entanglement does not increase on average, i.e. E $(^{AB}_{i})$ $_{i}$ p_{i} E $(^{AB}_{i})$;

(ii) Vanishing on separable states, E (AB) = 0 if AB is separable;

It is shown that for any measure E satisfying the above set of conditions, the following inequality holds for any state $^{[1]}$:

where E_D (^) is the distillable entanglement [12] and E_C (^) is the entanglement cost [13]. Using this relation, we can easily see that E (^out) > E (^out) = 0 since ^out is entangled and any two-qubit entangled state is distillable [14], namely, $0 < E_D$ (^out) E (^out). We can also prove E (^in) < E (^in) for 0 < t < 0.495 as follows. From Eq. (15), we have

and hence what we need is an upper bound on E_C ($^{in}_3$) and a lower bound on E_D ($^{in}_2$).

The entanglem ent cost $E_{\rm C}$ (^) is upper-bounded [13] by the entanglem ent of form ation $E_{\rm f}$ (^) [6], which can be computed through the concurrence C (^) [15] as

where $_{\rm x}$ are the diagonal entries of the matrix form of ^ on a Bell basis. Since $_{\rm 2}^{\rm in}$ is rewritten on a Bell basis as

Hence for 0 < t < 0.495 , the strict inequality) (holds for the family of entanglement measures satisfying the properties (1^0) , (ii)-(vi).

VI. CONCLUSION

We have shown examples of a local qubit channel exhibiting the selective entanglement breaking and an example with the strong selective entanglement breaking. These results imply that even for the system as small as a qubit, a quantum channel/operation can have a preference over which kind of entanglement to break. In our examples, the ordering with respect to entanglement is determined by the transformability through LOCC operations, and hence is dened solely by the property of monotonicity. This makes our results independent of the choice of the entanglement measure. We have also shown that the ordering change with a strict inequality holds for a family of measures satisfying a set of plausible conditions.
