Exact Polynom ial Eigensolutions of the Schrodinger Equation for the P seudoharm onic Potential

Abstract

The polynom ial solution of the Schrodinger equation for the P seudoham onic potential is found for any arbitrary angular momentum 1. The exact bound-state energy eigenvalues and the corresponding eigen functions are analytically calculated. The energy states for several diatom ic molecular systems are calculated numerically for various principal and angular quantum numbers. By using a proper transformation, this problem can be also solved very simply using the known eigensolutions of anham onic oscillator potential.

I. INTRODUCTION

The three-dimensional (3D) anharm onic oscillators are of great importance in dierent physical phenomena with many applications in molecular physics [1]. The solutions of the Schrodinger equation for any 1-state for such potentials are also of much concern. Morse potential is commonly used for anharmonic oscillator. However, its wavefunction is not vanishing at the origin. On the other hand, the Mietype and also the Pseudoharmonic potentials do vanish. The Mietype potential has the general features of the true interaction energy [1], interatomic and intermolecular and dynamical properties in solid-state physics [2]. The Pseudoharmonic potential may be used for the energy spectrum of linear and non-linear systems [3]. The Pseudoharmonic and Mietype potentials [3,4] are two exactly solvable potentials other than the Coulombic and anharmonic oscillator.

The anharm onic oscillator and H-atom (Coulombic) problems have been thoroughly studied in N-dimensional space quantum mechanics for any angular momentum 1: These two problems are related together and hence the resulting second-order dierential equation has the normalized orthogonal polynomial function solution (cf. Ref.[5] and the references therein).

In this brief letter we will follow parallel solution to Refs.[6,7,8] and give a complete normalized polynomial solution of 3D Schrodinger equation with P seudoharmonic potential, anharmonic oscillator like potential with an additional centrifugal potential barrier, for any arbitrary 1-state. Further, by a proper transformation, we obtain the eigensolutions of this problem from the well-known eigensolutions of the anharmonic oscillator potential. As an application, we present some numerical results of the energy states of N₂; CO; NO and CH molecules [9].

The contents of this paper is as follows. In Section II, we give the eigensolutions of the 3D Schrodinger equation with P seudoharm onic potential and calculate numerically the energy levels for various diatomic molecular systems. We also obtain the eigensolutions of the P seudoharm onic potential from a known anharm onic eigensolutions using a proper transformation. Finally, in Section III, we give our results and conclusions.

II. SCHROD INGER EQUATION WITH PSEUDOHARMONIC POTENTIAL

We wish to solve the Schrodinger equation for a pseudoharm onic potential [3] given by

where D $_{0}$ is the dissociation energy between two atoms in a solid and r_{0} is the equilibrium intermolecular seperation.

For brevity, we write the radial part of the Schrodinger equation as

The behaviour of the solution at = 0; determined by the centrifugal term and its asymptotic behaviour, determined by the oscillator terms, suggests us to write:

with the numerator of \mathbf{x}^2 term equal to zero leads to

As q > 0; the above wavefunction vanishes at = 0; corresponding to the strong repulsion between the two atoms. It is reasonable to set Eq.(6) into Eq.(5) and then to use, instead of ; the variable:

At = 0; the second part of the solution so that $C_2 = 0$: This clearly dieres from the linear oscillator where no boundary condition exists at origin. A con uent series behaves asymptotically at large positive values of its argument as

leads us to write

which is exponentially divergent wavefunction. This divergence can be avoided, in cutting o the series in Eq.(10), by putting the parameter a = n; with n = 0; 1; 2; :::; thus transform ing the series into a polynomial of degree n: Hence

Thus, solving Eqs. (13) and (14) for the energy eigenvalues gives

and further from Eqs.(6), (10) and (13), we write the nal form of the wavefunction as

where N $_{n1}$ is a normalization constant to be determined from the normalization condition and Y $_{lm}$ (;') = sin^m P $_n^{(m,m)}$ (cos) exp (im') is the angular part of the wave function.

On the other hand, for the sake of simplicity, we can immediately obtain the energy eigenvalues and the corresponding wave functions of the P seudoharm onic potential by transforming Eq.(3) to another Schrodinger-like equation with L (L + 1) = $1(l+1) + \frac{2 D_0 r_0^2}{h^2}$;

At this point, we should report that Eq. (17) corresponds to the Schrödinger equation of anham onic oscillator potential, $V(r) = B^2 r^2$; with energy levels

Finally, in the light of transform ation (18), the eigenvalues (15) and the eigen functions (16) can be easily determined from the traditional formulas (19) and (20), respectively, with the Laguerre function being expressed in terms of Kummer's function, that is, $L_n^{()}(z) = 1$ $F_1(n; +1;z)$::

III. RESULTS AND CONCLUSIONS

In this work we have studied the analytical solution for a P seudoham onic potential. Considering this potential, the problem is reduced to a harm onic oscillator potential plus an additional centrifugal potential barrier of order $1=r^2$: The exact eigensolutions for this particular case have been obtained, in a similar way as the Hydrogenic solutions [5,8]. We have calculated the energy eigenvalues and the corresponding wave functions considering bound-states for any quantum-mechanical system of any angular momentum 1 bound by a pseudoharm onic potential. The present results for the potential parameters = 0 reduces to a Harm onic oscillator solution.

Finally, we calculate the binding energies of the P seudoharm onic potential for N_2 ; CO; NO and CH diatom ic molecules by means of Eq.(15) with the potential parameter values [9,10] given in Table 1. The explicit values of the energy for dierent values of n and lare shown in Table 2.
