Gaussian Decoherence and Gaussian Echo from Spin Environments

W e exam ine an exactly solvable m odel of decoherence { a spin-system interacting with a collection of environm ent spins. W e show that in this simple m odel (introduced some time ago to illustrate environm ent{induced superselection) generic assumptions about the coupling strengths typically lead to a non-M arkovian (G aussian) suppression of coherence between pointer states. W e explore the regime of validity of this result and discuss its relation to spectral features of the environm ent. W e also consider its relevance to Loschm idt echo experiments (which m easure, in e ect, the delity between the initial state and the state rst evolved forward with a H am iltonian H, and then \unevolved" with (approxim ately) H). In particular, we show that for partial reversals (e.g., when only a part of the total H am iltonian changes sign) delity m ay exhibit a G aussian dependence on the time of reversal that is independent of the details of the reversal procedure: It just depends on what part of the H am iltonian gets \ ipped" by the reversal. This puzzling behavior was observed in several NM R experiments. N atural candidates for such two environments (one of which is easily reversed, while the other is \inceversible") are suggested for the experiment involving ferrocene.

IN TRODUCTION

\It seems very important to us... that the idea and genesis of random ness can be made rigorously precise also if one rigorously follows the determ inism; the law of large numbers comes then not as a mystical principle and not as a purely empirical fact, but as a simple mathematical result..." wrote Marian Smoluchowski in his posthum ously published paper [1]. At that time determ inism meant classical determ inism { the underlying equations of motion that determ ined a trajectory of a classical particle. O ne could, however, develop simple stochastic models that encapsulated e ects of that exact dynam ics. That was the essence of the approach that led to the Smoluchowski equation (which is still widely used today, a century after it was derived using this strategy).

Quantum theory forces one to reassess the relation between determ in ism and random ness: Chance plays a different role in the quantum dom ain. According to Bohr and Born, quantum random ness is fundam ental: A m easurement on a quantum system { according to the C openhagen interpretation { necessarily involves a classical apparatus. The outcom e of the m easurem ent is random ly selected with probability given by the fam ous rule that connects probability to amplitude $(p_k = j_k f)$ conjectured by Max Born. The Copenhagen view of the quantum Universe was challenged by Everett, who half a century ago noted that it is possible to imagine that our Universe is all quantum, and that its global evolution is determ inistic. Random ness will appear only as a result of the local nature of subsystem s (such as an apparatus or an observer) [2, 3].

It is not our aim here to recapitulate this well known story, except to point out that it sheds a rather di erent light on the relation between determ inism and random ness than did classical physics. The key insight of Sm oluchow ski contained in the quote above is, how ever, still correct { perhaps even m ore deeply correct { in the quantum setting. Entanglem ent, the quintessential quantum phenom enon, which plays such an important role in the approach of Everett is central for its validity. W e illustrate here only one aspect of these connections { decoherence which is caused by entangling interactions between the system and the environm ent.

The story that will unfold makes one more connection with Smoluchowski: It touches on the debate about the origins and nature of irreversibility between his two formerprofessors { Boltzmann and Loschmidt { as the evolution responsible for the buildup of correlations which lead to decoherence can be (approximately) reversed in suitable settings, allowing for the study of \Loschmidt echo" [4, 5, 6, 7].

SPIN DECOHERENCE MODEL

A single spin{system S (with states fjli; jlig) interacting with an environm ent E of m any independent spins $(f_{i}, i; \#_{k}; k = 1:N)$ through the H am iltonian

m ay be the sim plest solvable m odel of decoherence. It was introduced some time ago [2] to show that relatively straightforward assumptions about the dynam ics can lead to the emergence of a preferred set of pointer states due to einselection (environm ent{induced superselection) [2, 8]. Such m odels have gained additional im portance in the past decade because of their relevance to quantum information processing [9].

The purpose of our paper is to show that { with a few additional natural and simple assumptions { one can evaluate the exact time dependence of the reduced density matrix, and dem onstrate that the o {diagonal com ponents display a Gaussian (rather than exponential) decay [10]. In e ect, we exhibit a simple soluble example of a situation where the usual Markovian [11] assumptions about the evolution of a quantum open system are not satis ed. A part from their in plications for decoherence, our results are also relevant to quantum error correction [12] where precise precise know ledge of the dynam ics is essential to select an e cient strategy. M oreover, while the model H am iltonian of Eq. (1) is very specic, it suggests generalizations that lead one to conclude that G aussian decay of polarization m ay be common, and specify when a reversal of the Ham iltonian evolution in a part of the spin environment naturally leads to a Gaussian dependence of the return signal on the time of reversal, a feature of Loschmidt echo observed in NMR experiments.

To demonstrate the G aussian time dependence of decoherence we rst write down a general solution for the model given by Eq. (1). Starting with:

The reduced density matrix of the system is then:

where the decoherence factor $r(t) = hE_1(t) \not E_0(t) i$ can be readily obtained:

It is straightforward to see that r(0) = 1, and that for t > 0 it will decay to zero, so that the typical uctuations of the o -diagonal terms of _S will be small for large environments, since:

Here h:::i denotes a long time average [2]. C learly, jr(t) j = 0, leaving s approximately diagonal in a mixture of the pointer states fjDi; jLig which retain preexisting classical correlations.

This much was known since [2]. The aim of this paper is to show that, for a fairly generic set of assumptions, the form of r(t) can be further evaluated and that { quite universally { it turns out to be approximately G aussian in time. Thus, the simple model of Ref. 2 predicts a universal (G aussian) form of the loss of quantum coherence, whenever the couplings g_k of Eq. (1) are su ciently concentrated near their average value so that their standard deviation $(g_k \ hg_k i)^2$ exists and is nite. When this condition is not fullled other sorts of time dependence become possible. In particular, r(t) may be exponential when the distribution of couplings is a Lorentzian.

We shall also consider in plications of the predicted time dependence of r(t) for echo experiments. In particular, the group of Levstein and Pastawski [4, 5, 6, 7], have carried out experiments that aim to implement time reversal of dynamics, as was suggested long time ago by Loschmidt [13], who used time reversal as a counterargument to Boltzmann's ideas about H-theorem and the origins of inteversibility. Boltzmann's reported (possibly apocryphal) reply \Go ahead and do it!", which may re ect his belief in the molecular disorder hypothesis [14], points to the origin of the di culty in implementing such reversal in practice for all of the relevant degrees of freedom. It is nevertheless possible in some settings to carry out \Loschmidt echo experiments" that approximate Loschmidt's original idea [13].

W hen the reversal is successful for only some of the relevant degrees of freedom $(E^{(0)})$ but does not encom pass all of the environm ent E (leaving behind \unreversed" $E^{(0)}$) the result is a partial Loschm idt echo (also dubbed \Boltzm ann echo" [15]). As in Ref. [16], we interpret the decay in the Loschm idt echo as the e ect of coupling to a second environm ent. We shall study the partial Loschm idt echo in the context of the sim plem odel of Eq. (1) and Ref. [2], and conclude that its basic in plicationsm ay generalize to a much broader range of dynam ics relevant to NMR experiments.

In our case the state of all the degrees of freedom after a partial reversal (that happens at $t = t_R$) is given by:

The echo signal measured in the experiments concerns only a part of the whole { the system S. It is given by:

This is in elect the delity of the state of S.We shallexpress (t) in terms of decoherence factors corresponding to E^0 and E^{00} : This follows from a straightforward generalization of Eqs. (5, 6) to the case of partial Loschmidt echo with two environments, only one of which gets reversed. Evaluating time dependence of the decoherence factors for E^0 and E^{00} is therefore our rst goal. To this end we carry out multiplication of Eq.(6), re{expressing r(t) as a sum :

Decoherence factor is then a sum of $2^{\mathbb{N}}$ complex contributions with xed absolute values and with phases that rotate at the rate given by the eigenvalues of the total H am iltonian.




FIG. 1: Decoherence factor r(t) decomposed as a sum of complex terms as in Eq. (9), for $j_k j^2 = j_k j^2 = 1=2$ and N = 8 spins in the environment with random couplings g_k from a uniform distribution. The times plotted are t = 0, (at \noon"), and t = 0.25, 0.5, 0.75, 1, 1.25, and 1.5 in a \clockwise direction": The coordinate of the complex plane is rotated clockwise by an angle 2 =7 for each r(t) (dashed lines), starting with a vertical axis for t = 0. Notice the random walk-like behavior of r(t). The dotted curve line is the envelope of the random walks { the net decoherence factor decaying with a Gaussian form in accord with our discussion.

Decay of r(t) can be understood (see [2]) as a progressive random ization of a walk in a complex plane: Att = 0 all of the phases are the same so all of the steps { all of the contributions to the decoherence factor { add up in phase yielding jr(t = 0) j = 1. However, as time goes on, these phases rotate at various rates so r(t) is a term inalpoint of what becomes in time a random walk (on a complex plane) where the directions of various steps are uncoordinated (see Fig. 1).

This view of the decay of r(t) is the rst instance where the random walk analogy is useful in our paper. The term inal point of this random walk determ ines decoherence factor. A nother random walk { this time in energy { can be invoked in computing eigenvalues of the total H am iltonian. These eigenvalues are responsible for the rotation rates of the individual steps that contribute to r(t). We shall now see that this random walk in energies is responsible for the (typically G aussian) decay of the decoherence factor.

To exhibit the G aussian nature of r(t) we start by noting that there are ${}^{N}_{0}$, ${}^{N}_{1}$, ${}^{N}_{2}$, ... etc. terms in the consecutive sums above. The binom ial pattern is clear, and can be made even more apparent by assuming that $_{k} =$ and $g_{k} = g$ for all k. Then,

i.e., r(t) is the binomial expansion of $r(t) = j f e^{igt} + j f e^{igt N}$.

We now note that, as follows from the Laplace-de Moivre theorem [17], for su ciently large N the coefcients of the binom ial expansion of Eq. (10) can be ap-

This limiting form of the distribution of the eigenenergies of the composite SE system immediately yields ourmain result:

So, r(t) is approximately Gaussian since it is a Fourier transform of an approximately Gaussian distribution of the eigenenergies of the total H am iltonian resulting from all the possible combinations of the couplings with the environment.

A few quick comments on the above form of the decoherence factor may be in order: We note that in the limit of large N g^2 it predicts \instantaneous" decay of quantum coherence. We also note that when = 0 the environment is incapable of decohering the system (as it is then in an eigenstate of the global H am iltonian, so the \m easurement-like evolution" that is at the heart of decoherence is in possible). Last but not least, we note that when the environment ism ixed, decoherence will proceed unimpeded, and that it will be most e cient when the mixture is perfect { when j $\hat{j} = j \hat{j} = \frac{1}{2}$.

LAW OF LARGE NUM BERS AND ENERGIES




FIG.2: The distribution of the energies obtains from the random walks with the steps given by the coupling size and in the direction (+ g_k or g_k) biased by the probabilities $j_k f$ and $j_k f$ as in Eq. (17) (although in these examples we set $j_k f = 1=2$). (a) W hen all the couplings have the same size $g_k = g$ (Eq. (10)), a simple N ewton's triangle leads to an approximate G aussian for the distribution of energies. (b) W hen the couplings random ly di er from step to step (Eq. (9)), the resulting distribution still approaches an approximately G aussian envelope for large N.

To yield a G aussian decay of jr(t) j the set of all the resulting eigenenergies of the total H am iltonian m ust have an (approxim ately) G aussian distribution. This behavior is generic, a result of the law of large num bers [17]: these energies can be thought of as the term inal points of an N (step random walk. The contribution of the k {th spin of the environment to the random energy is + g or g with probability $j \ f$ or $j \ f$ respectively (Fig. 2-a).

The same argument can be carried out in the more general case of Eq. (9). The \random walk" picture that yielded the distribution of the couplings remains valid (see Fig. 2-b). However, now the individual steps in the random walk are not all equal. Rather, they are given by the set fg_kg (see Eq. 1) with each step g_k taken just once in a given walk. There are 2^N such distinct random walks. This exponential proliferation of the contributing coupling energies allow s one to anticipate rapid convergence to the universalG aussian form of their distribution, and, therefore, of the decoherence factor r(t).

Indeed, we can regard eigenenergies resulting from the sum $sofg_k$'s as a random variables. Its probability distribution is given by products of the corresponding weights. That is, the typical term in Eq. (9) is of the form :

The resulting term inal energy is

and the cum ulative weight p_W is given by the corresponding product of $j_k \ j^2$ and $j_k \ j^2$. Each such speci c random walk W corresponding to a given combination of right (k 2 W $^+$) and left (k 2 W $_{\rm N}$) \steps" (see Figs. 1 and 2) contributes to the distribution of energies only once. The term inal points E_W may or may not be degenerate: As seen in Fig. 2, in the degenerate case, the whole collection of 2^N random walks \collapses" into N + 1 term inal energies. M ore typically, in the non-degenerate case (also displayed in Fig. 2), there are 2^N di erent term inal energies E_W . In both cases, the <code>\envelope"</code> of the distribution P (E_W) should be G aussian, as we shall show below .

In contrast to the usual classical random walk scenario (where each event corresponds to speci c random walk) in this quantum setting all of the random walks in the ensemble contribute simultaneously { evolution happens because the system is in a superposition of its energy eigenstates. The resulting decoherence factor r(t) can be viewed as the characteristic function [17] (i.e., the Fourier transform) of the distribution of eigenenergies E_W . Thus,

where the strength function (E), also known as the local density of states (LDOS) [18] is de ned in general as

Above j i are the eigenstates of the full H am iltonian and E its eigenenergies. In our particular model (Eq.1) the eigenstates are associated with all possible random walks in the set W , and therefore

Decoherence in our model is thus directly related to the characteristic function of the distribution of eigenenergies

(E). M oreover, since the E_W 's are sum s of g_k 's, r(t) is itself a product of characteristic functions of the distributions of the couplings $fg_k g$, as we have already seen in the example of Eq. (6). Thus, the distribution of E_W




FIG.3: (Left panels) A ssum ed distribution of the couplings g_k , from top to bottom : uniform, G aussian, and exponential. (Center panels) Resulting distribution of the eigenenergies E_W (center panels) for N=6 (E $_W<0$) and N=24 (E $_W>0$). In the case of j $_k \ f = 1=2$ this distribution is in e ect the <code>\strength</code> function" (local density of states). (R ight panels) D ecoherence factor r(t) for di erent initial conditions with N=6 (dashed lines), N=24 (thin solid lines) and the average (bold line) rapidly approaches a Gaussian whenever couplings have a nite variance.

belongs to the class of the so{called in nitely divisible distributions [17, 19].

The behavior of the decoherence factor r(t) { characteristic function of an in nitely divisible distribution { depends only on the average and variance of the distributions of couplings weighted by the initial state of the environment [17, 19]. The remaining task is to calculate

(E), which can be obtained through the statistical analysis of the random walk picture described above. If we denote x_k the random variable that takes the value + g_k or g_k with probability $j_k f$ or $j_k f$ respectively, then its mean value a_k and its variance b_k are

The behavior of the sum s of N random variables x_k (and thus, of their characteristic function) depends on whether the so{called Lindeberg condition holds [17]. It is expressed in term s of the cum ulative variances $B_N^2 = b_k^2$, and it is satis ed when the probability of the large individual steps is small; e.g.:

an expression in excellent agreement with numerical results already form odest values of N. This distribution of energies yields a corresponding approximately G aussian time (dependence of r(t), as seen in Fig. 3. Moreover, at least for short times of interest for, say, quantum error correction, r(t) is approximately G aussian already for relatively small values of N. This conclussion holds whenever the initial distribution of the couplings has a nite variance. The general form of r(t) after applying the Fourier transform of Eq. (15) is




FIG. 4: Same as Fig. 3 but for a Lorentzian distribution of the couplings g_k . In this case r(t) decays exponentially. The histogram and the dashed line in r(t) correspond to N = 20, the straight thin line is a particular case for N = 100 and the thick line is the average. We note that the convergence is slower than in the G aussian case of Fig. 2, because realizations of g_k are more likely to have one or two dom inant couplings. Therefore, although the average shows a clear exponential decay, uctuations are noticeable even for large N. N otice also that the logarithm ic scale con rm s the long time saturation of r(t) at $2^{N=2}$, Eq. (7).

It is also interesting to investigate cases when Lindeberg condition is not met. Here, the possible limit distributions are given by the stable (or Levy) laws [19]. One interesting case that yields an exponential decay of the decoherence factor is the Lorentzian distribution of couplings (see Fig. 4). It can be expected e.g. in the e ective dipolar couplings to a central spin in a crystal [25]. Further intriguing questions concern the robustness of our conclusion under the changes of the model. W e have begun to address this issue elsewhere [20] but, for the time being, we only note that the addition of a strong self(H am iltonian proportional to $_{\rm X}$ changes the nature of the time decay [20, 21]. On the other hand, sm all changes of the environm ent H am iltonians, like for instance truncated dipolar interactions,

seem to preserve the G aussian nature of r(t) [20]. This universality of G aussian decoherence extends beyond the short-tim e regim e where it was emphasized in R ef. 26. It arises as a consequence of the central lim it theorem that leads to G aussian distribution of the eigenenergies, a lim – iting behavior that can be expected for reasons pointed out above (see also [10]) under generic conditions in m any body system s [27].

PARTIAL REVERSAL AND GAUSSIAN ECHO

Let us now consider a Loschm idt echo { reversal of the sign of the H am iltonian { carried out at a tim $e t_R$. In our m odel it can be im plem ented by appropriate \ ipping"

of the spins in the environment. We rst note that the measured observable (t) signal can be readily related to the decoherence factor:

For a complete Loschm idt echo, the sign of the the whole H am iltonian would be reversed at $t = t_R$, so for $t > t_R$;

Hence, the decoherence factor is now $r(2t_R t)$, and the system will return to its initial state at $t = 2t_R$.

W e now suppose with Petitjean and Jacquod [15] that only a part of the H am iltonian is reversed (e.g., only som e of the spins { spins in E^{00} { get ipped). In our model, environments E^{0} and E^{00} do not interact. Thus, the net decoherence factor is a product of the decoherence factors com ing from each environment,

At the instant $t = 2t_R$ when the echo signal is usually acquired $r^0(2t_R) = 1$ and:

Thus, reversal is incomplete. The decit in the signal exhibits a G aussian dependence on the instant of reversal $t_{\rm R}$. This is the elect of the on-going decoherence due to E^0 { these spins in the environment that did not get reversed.




FIG. 5: Attenuation of the polarization echoes in a single crystal of ferrocene as a function of reversal time t_R : The data correspond to an orientation where the twom olecules per unit cellare m agnetically equivalent. The solid line corresponds to a Gaussian tting yielding a characteristic time $T = (400 \ 10)m$ s as the single free parameter. The inset shows in e ect ln ($(2t_0)$ (1)) vs t_0 in a log-log plot. The slope of the resulting line is 2:1 0:08, and is consistent with Eq. (30) (This illustration, Fig. 11 of Ref. [4], is reproduced here by perm ission of the authors.)

These equations exhibit the G aussian time dependence $(e.g., of the echo signal on the time of reversal t_R)$ for large values of t_R (i.e., beyond the initial quadratic regime) as was found in some of the Loschmidt echo experim ents carried out by Levstein and Pastawski [4] (see Fig. 5). Most importantly, the partial reversal provides an explanation of the surprising experim entally observed insensitivity of the Gaussian decay of polarization to the details of the pulse that initiates reversal: As noted in Ref. [6], one m ight have expected that reversal pulse w ith larger amplitude will \turn back" evolution in a larger fraction of the environment, but this does not seem to happen. Rather, independence of the \backwards evolution" of the pulse inducing reversal indicates that always the sam e subset of the environm ent is turned back. It is therefore tem pting to interpret their experim ental results using the \two environment" theory we have outlined above. We believe that such interpretation is basically correct, but that a more careful discussion should take into account di erences between the system investigated in Ref. [4] and our sim ple model.




FIG.6: Schem atic representation of a ferrocene (F $e(C_5H_5)_2$) m olecule. The hydrogens (white, on the outside) are coupled to the carbon atom s (light grey) which form a pentagon ring. The two rings are joined in the middle by an iron atom (dark grey). They can rotate with respect to each other and with respect to the solid matrix in which ferrocene is in bedded, which suggests natural division into the immediate environment that can be e ectively reversed and the more distant environment where the reversal is likely to fail.




FIG. 7: Evolution of the local spin polarization in a single crystal of ferrocene. The dots are the experim ental data for a 0 degree orientation of the crystal with respect to the external m agnetic eld. The thin solid line is the calculated evolution of the local polarization in a complete m olecule where the rings rotate independently in a staggered con guration. The dashed line is the ratio between the simulation to the experim ental data (up to 100 s), and the thick dotted line is a t to the ratio between experim ent and simulation. The characteristic decay times of the tted Gaussians are 90 s and 340 s respectively. This data is reproduced from Fig. 8 of R ef. [4] with permission from the authors.

This view of the above data seems especially appropriate since in ferrocene (F e (C $_5$ H $_5$)₂, the molecule used in Ref. [6]) there are (at least) two environments that are likely to respond di erently to the attem pted \Loschm idt reversal" of the dynamics. To point them out we need a bit more detailed description of the experiment. The ferrocene molecule (Fig. 6) consists of two rings, each with 5 hydrogen atom s attached to 5 carbon atom s. The Loschmidt echo experim ent starts when a rare 13 C atom (that appears in a small fraction of all the molecules) is polarized by the external eld that starts the experiment. This polarization is then transferred to its adjacent hydrogen. O noe it is there, it can easily \di use" to the other hydrogens within the ring (or possibly within the molecule). This process is rapid; a brief (100 s) approximately Gaussian decay leads to an ondulating plateau. The hydrogen ad poent to the ¹³C atom is about 20% polarized at this instant (see Fig. 7).

Up to that point, the agreem ent between the num ericalsimulation of quantum evolution in a single ferrocene molecule and the experiment is remarkable, suggesting that the only environment explored by the injected polarization is the \immediate neighborhood": hydrogens

within the original F e(C₅H₅)₂. Indeed, the value of the num erical plateau ($\frac{1}{5}$ of the original polarization) suggests that only the 5 hydrogens from the C₅H₅ \ring" that includes the rare ¹³C atom participate early on.

By contrast with this initial interval, there is a marked discrepancy between the experiment and the single molecule simulations afterwards: Experimental data indicate leakage of the polarization from the molecule, with the signal decaying with time below the single molecule num erical prediction (see Fig. 7). As time goes on, both the measured and the simulated polarizations ondulate (indicating partial \revivals", presum ably because of the nite size of the ferrocene molecule [23]) but the experim ental data also indicates persistent polarization leakage. Over the same time interval the simulation continues to hover just above 20% of the original signal, and exhibits at best only much slower system atic decay.

G iven the previous discussion, we have now reached the \eureka m om ent": The immediate environment { hydrogens in the ferrocene (and, possibly, in only one of the C_5H_5 rings) are responsible for short term approximately G aussian decay, and for the partial revivals, consistent with the behavior of such small quantum systems (as seen in Fig. 2). This is clearly a good candidate for our E^{0} { the \reversible" part of the whole environment.

By contrast, once the signal leaks out to more distant E^0 (which is responsible for the discrepancy between the single molecule simulations and the experimental data), \the cat is out of the bag", and it (e.g., the polarization which has leaked out of the molecule) m ight be very difcult to recapture. This view is supported by what is known about the structure of solid ferrocene: Individual molecule) motate on timescales short compared to these probed in the echo experiments. This dynam ics will be much more di cult to reverse in the echo experiment.

The reversal will then result in the desired echo only on subsystems in which the atom has xed neighbors (like the C_5H_5 ring), but is unlikely to succeed elsewhere. So, the environment of the ferrocene molecule (neighboring ferrocene molecules, and possibly even its other ring) constitute E^0 .

In closing this section we note that the tim escale on which the echo decays is consistent with a Gaussian t to the experim ental data of the decay of the local polarization divided by the num erical simulation of the isolated m olecule, see Fig. 7. The t is consistent with an echo decay tim escale of 4 tim es the initial scale for decay of the local polarization, i.e. 400 s (see Fig. 5 for com parison). This is an ecouraging observation. Further, this scale would not be a ected by a better reversal with the immediate environment $E^{(0)}$, consistent with the observed insensitivity of the echo to radiofrequency power [6].

DISCUSSION

The model we have proposed is suggestive, but it is not yet conclusive: It o ers only a rather simplied representation of the experiment. For instance, it is much more reasonable to say that the polarization rst diuses to the immediate \reversible" environment, and that the more remote environment decoheres all of this reversible $E^{(0)}$ (and not just the original system). Nevertheless, the split into two environments { our key assumption { ex-

plains the key features of the data in a way that naturally ts the physics of the system . However, it is useful to list at least som e of the approximations we have made, and to consider their in plications.

To begin with, interactions between the spins in Ref. [4] are dipolar, so the interaction H am iltonian does not have the simple structure of the Ising H am iltonian of Eq. (1). M oreover, spins of the real environm ent interact with each other. Furtherm ore, interaction and self-H am iltonians of the spins do not commute in general.

C onsequently, the straightforward manipulations that allow ed us to derive G aussian tim e dependence of the decoherence factor from rst principles within a few lines cannot be directly carried out for more realistic models of the experiment. Nevertheless, the central ingredient needed to establish the G aussian character of the echo does not seem to depend on these detailed assum ptions. Rather, it is { in essence { the (approximately) G aussian nature of the distribution of the eigenenergies of the total H am iltonian, which then leads to the G aussian tim e dependence of the decoherence factor. O ne can certainly believe that this very generic requirem ent is satis ed under conditions that are far more common than the speci c assumptions of the simple decoherence m odel we have analyzed. Indeed, this broad applicability is the very essence of the central limit theorem we (and others [27]) have invoked.

Even more convincing is the direct experimental evidence: Short time G aussian dependence of the signal before reversal in the experiments involving ferrocene has been established [7] (see Fig. 5). This is in elect the decoherence factor { the characteristic function of the distribution of the relevant eigenenergies of the underlying H am iltonian responsible for the evolution. And approximately G aussian r(t) in plies (by the arguments involving Fourier transform) G aussian eigenenergies.

Time evolution of the NMR polarization signal is in such settings often interpreted as di usion [25, 28]. This makes intuitive sense in the experiments that lead to Fig. 5, as only rare nuclei of C^{13} in a small fraction of ferrocene m olecules are initially polarized, so the decay of the polarization signal is caused by the spreading of that polarization over an increasingly larger environment. However, this e ective di usion must obviously re ect a reversible dynamical process generated by an underlying H am iltonian, as fundam entally di usive evolution could never be reversed. This is relected in the short tim e m esoscopic echoes observed in this \di usive" process [23] due to the sm all size of the rst environm ent. To account for the di usive character of the evolution the distribution of eigenenergies, (E) must be Gaussian in character. So, while specic assumptions we used in our simple model are not satis ed in the experimental setting, Gaussianity of the energy spectrum we were led to as a result of these assumptions may well turn out to be a fairly generic feature.

SUM MARY AND CONCLUSIONS

We have seen how { in the quantum setting of decoherence and Loschmidt echo { deterministic dynamics can lead to evolutions that have a distinctly stochastic G aussian character. W hile our model is rather simple and clearly too idealized to directly address experim ental situation of Refs. [4, 5, 6, 7], it also suggests that ourm ain results { Gaussian decay of the decoherence factor and Gaussian echo { will appear whenever the energy spectrum of the excitation corresponding to the initial state of the system is approximately Gaussian. As we have noted earlier, there is ample evidence of this in the existing experim ents involving ferrocene. Even more, we can reproduce the observed insensitivity to perturbations of the Gaussian echo decay. Qualitative { and even quantitative { com parisons between predictions of our m odel and the experim ental data are prom ising.
