# Generalized Lifshitz form ula for a cylindrical plasm a sheet in front of a plane beyond proximity force approximation

#### A bstract

We calculate the rst correction beyond proximity force approximation for a cylindrical graphene sheet in interaction with a at graphene sheet or a dielectric half space.

### 1 Introduction

The interaction of material bodies at distances in the micrometer and nanometer scale is of signicant actual interest in view of applications in nanotechnology and for precision measurements of the Casimir force. The basic method for the calculation of the interaction forces is the Lifshitz formula [1]. It holds for planar or stratied material bodies having permittivity. Permeability as well as frequency dispersion and nite temperature may be included too. The generalization to non planar geometry is more complicated in case the variables in the underlying wave equation do not separate and for the interaction of two material bodies one is bound to the case of plane parallel geometry. However, most force measurements are done with a sphere or lens in front of a plane and there is a demand for generalizations to non planar geometry.

The most frequently used method for non planar geometry is the proximity force approximation (PFA). Here the Casimir or van der W aals force known from planar geometry is taken at the local distance and then averaged over the surfaces. In this method the curvature of the surfaces in included in the sense of a rst correction. The method holds obviously for small deviation from the plane parallel geometry.

Its precision cannot be estimated since it is impossible to calculate higher order corrections by this method.

The method of PFA dates back to Derjaguin [2] and only recently it became possible to go beyond analytically. In [3] the rst correction beyond PFA was calculated for a cylinder in front of a plane with conductor boundary conditions. For the part containing D irichlet boundary conditions this was con rm ed num erically by the world line method [4]. The opposite case of large and medium separations is easier and more detailed results are available, see [5] and [6].

A nother line of generalizations of the Lifshitz formula is to consider the interaction between two graphene sheets [7] having in m ind applications to carbon nanotubes. The graphene sheets are described by the two dimensional plasm a shell model used in [8, 9]. For thin shells this model is more appropriate because the C asim ir or van der W aals forces vanish if the thickness of a dielectric layer goes to zero. In [7] the interaction between two such sheets was studied and in [10] this was generalized to the interaction of a material body with a strangeneral graphene sheet and, further, to a cylindrical graphene sheet in front of a plane in PFA.

In the present paper we derive the generalized Lifshitz formula in the rst approximation beyond PFA for a cylindrical graphene sheet in front of a at graphene sheet or a plane material body with permittivity (!). In both cases we consider two scalar problems corresponding to the TE and TM modes. Regrettably, in this con guration the polarizations of the electrom agnetic eld do not separate (in opposite to the case of a conducting wave guide). However for small separations the TM mode dom inates and for large separations the ideal conductor case is recovered.

The paper is organized as follows. In the next section we collect the basic formulas of the method of  $[\beta]$  and generalize them to sem itransparent boundaries. In section 3 we calculate the interaction energies in stapproximation beyond PFA. A fler the conclusions some appendixes follow with details of the calculations.

## 2 Functional integration and sem itransparent boundaries

In this section we start from the method of introducing boundary conditions into a functional integral by functional delta functions. The method was used in [11] for the calculation of radiative corrections to the Casim ir elect. Later it was rediscovered [12]. In [6] and  $\beta$ ] it was used to obtain a nite expression for the Casim ir interaction energy of a sphere or a cylinder with a plane for D irichlet and conductor boundary conditions. In [5] sim ilar results were achieved in a multiscattering approach. Here we follow the representation given in [3] and generalize it to sem itransparent boundaries.

Before entering the form alism of functional integration we form ulate the boundary conditions which are considered in this paper. There are two types, that on the surface of a dielectric body and that on an in nitely thin plasm a shell. We mention that both are in fact rather matching conditions relating the elds on both sides of the surface. These boundaries are sem itransparent in the sense that the corresponding relation and transmission coeccients take values somewhere in the interval from zero to unity. Both turn into Dirichlet resp. Neum ann boundary conditions in the limiting case of the frequency parameter going to in nity.

#### 1. Plasm a shell

Here we consider an in nitely thin sheet led with a charged uid in an oppositely charged in m obile neutralizing background. This is the two dimensionale limiting case of three dimensional plasm a used for example in the theory of m etals. It is aimed to describe the -electrons of a graphene sheet or a carbon nano tube. For details see [9] and papers cited therein. The interaction of such a sheet with the electrom agnetic eld can be reduced to m atching conditions across the sheet. For a at sheet the polarizations separate into TE and TM m odes and the m atching conditions read

is a parameter in parallel to the plasm a frequency  $!_{\rm p}$  in the second model. It depends on the parameters of the plasm a, the density n of the electrons, their charge e and mass m. The inverse, l=, is a length which is to be compared with the geometric sizes of the interacting bodies. For a carbon nano tube we note l= = 1.5 m (see [10], Eq.(11)), which is by two orders of magnitude lager that the corresponding value, say  $l=!_{\rm p}=$  0.02 m for gold, in the second model. The matching conditions for the TE polarization is just the same as for a delta function potential of strength for a scalar eld and up to some subtleties the conditions for the TM mode correspond to a potential with the derivative of a delta function. As shortcut we will use the subscripts  $_{\rm TE}$  and  $_{\rm TM}$ .

In addition to a at sheet we consider also a cylindrical one. In that case the polarizations do not separate (in opposite to a conducting wave guide). We de ne the analogous scalar problem s by the same matching conditions 1) as in the case of a <math>at boundary on the radial functions,

with polar coordinates (r; ') in the plane perpendicular the the axis of the cylinder,  $x_1 = r\cos'$ ,  $x_2 = r\sin'$ . The prime denotes then the radial derivative.

#### 2. D ielectric body

We consider a dielectric body with permittivity lling the half space x > 0,

In order to consider later the short separation lim it we need to include frequency dispersion. We take the plasm a model,

where  $!_p$  is the plasm a frequency. U sually, this model is used for metals.

Since the surface is at the polarizations of the electrom agnetic eld separate into transverse electric (TE) and transverse m agnetic (TM) m odes. The well known m atching conditions for the corresponding scalar functions (am plitudes)

where are the limiting values from the right and from the left of the plane and the prime denotes the derivative with respect to  $x_1$ . Here the Fourier transform in the translational invariant directions  $x_{jj} = (x_2; x_3)$ , i.e., in the directions parallel to the plane, is assumed,

In the following we use the shortcuts  $_{\rm TE}$  and  $_{\rm TM}$  to identify these models.

The method of implementing boundary or matching conditions in the functional integration rests on the restriction of the integration space in a functional integral

representing the generating functional Z (or the partition function) of a eld theory with a eld and some action S. Initially, the theory is completely arbitrary and it may contain interaction, background elds and boundaries. The functional delta function provides then the necessary restriction of the integration space to elds

ful lling additional boundary or matching conditions on a surface S. We assume that these conditions can be formulated in terms of a linear functional,

where H(z;x) is some integral kernel. For example, D irichlet boundary conditions are given by

where the function f(z) describes the surface S = fxjx = f(z)g and z provides a parameterization of the surface S. A sum ing the surface S is a plane parallel to the

The function H (z;x) for the upper line of the m atching conditions (1) reads

where  $Q_{n_+}$  is the norm all derivative on the right side of the surface  $(x_1 > a)$  and  $Q_n$  is that on the left side. The function H (z;x) for the lower line of the matching conditions (1) reads

Here f  $(z)_+$  assumes to take the limiting value if x approaches the surface from the right side. The norm alderivative can be taken on either side. Using these functions in Eq. (10) one obtains just the matching conditions (1) for a plane or, with the appropriate choice of z and f (z), for a cylinder.

It should be mentioned that this method is completely general and that it holds for any boundary or matching conditions which can be written in form of a linear functional like (10). A loo, it is not restricted to a scalar eld. O riginally it was used in [11] for the electrom agnetic eld.

However, there is also a limitation of this method. It cannot been used for the matching conditions (6) on the surface of a dielectric body since there are di erent speeds of light on both sides and the condition cannot be expressed in form of a delta function in the functional integral. W hether this limitation can be overcome is not known at the moment. There exists an attempt to incorporate a dielectric body into the functional integral [13] but it boks too com plicated and no nontrivial

example was given so far. A loo the recent approach of [14] cannot solve this problem since it cannot handle the TM mode.

W ith the formulation (10) of the boundary conditions the method follows exactly the steps given in section 2 of  $\beta$ . One arrives at a representation of the Casim ir energy in the form 7

where K has an integral kernel,

in the space of functions de ned on S and the trace is over such functions. D (x;y) is the propagator of the initial theory de ned by the action S in (0) and the transposition in H <sup>></sup> (y;z<sup>0</sup>) means that the derivatives in H act to the left. A di erence of this form ula as compared to Eq.(15) in [3] is that we already passed from time dependency to frequency dependent quantities by means of the corresponding Fourier transform. A lso, starting from here we work in the Euclidean version.

The conguration we are interested in is shown in Fig. 1 and we proceed as follows. We consider a free scalar eld in the presence of a dielectric halfspace at  $x_1 > a$  or a at plasma shell at  $x_1 = a$  given by the action S and the functional integral (9) without the functional delta function as the initial theory. Further we consider this initial theory to interact with a cylindrical plasma shell S with radius R. This interaction is incorporated in (9) as matching conditions (1) using the functional delta function. In this way we formulated two problems, the interaction between a cylindrical plasma sheet S and

1. a at plasm a sheet (shortcuts ( _{\rm T})_{\rm E} and ( _{\rm TM} ),

2. a dielectric halfspace (shortcuts ( $\frac{1}{2}$  and ( $\frac{1}{2}$  ).

In the following, to a large extend the formulas are the same for all considered problems. The shortcuts will be used for the quantities speci c for the considered problem.

In general, other combinations, for example the interaction of a cylindrical shell obeying TE conditions with a plane carrying a TM condition, can be considered too but we restrict ourselves here to the cases which appear in the physical applications.

To continue we have to specify the propagator D  $(x;x^0)$  of the initial theory, i.e., for a at plasm a shell and for a dielectric halfspace. These are well known expressions but we need them is a somewhat speci c representation, namely as a di erence

where the subscript ! indicates that the Fourier transform in the time variable was done. The st term in the r.h.s.,  $D^{(0)}(x = x^0)$ , is the free space propagator for a massless scalar eld,

which is the representation of the propagator in cylindrical coordinates in terms of modi ed Bessel functions.

In Eq.(16) the addendum  $D_{!}^{r}(x;x^{0})$  describes the boundary dependence of the propagator. For the at plasm a sheet we make use of the translational invariance in the directions parallel to the sheet and write down a representation in parallel to (18), z

Note that this representation holds for the arguments  $x_1$  and  $x_1^0$  on any side of the plane at  $x_1 = a$ . For both arguments to the left of the plane the expression simplifies,

Similar expressions can be found in [15] where the propagator for a delta function potential was considered.

For the TM matching condition (second line in (1)) we proceed in the same way and obtain

which can also be checked by applying the matching condition (note that we are here in the Euclidean version and  $!^2$  enters with the apposite sign as compared to Eq.(1)). We note that  $\hat{\alpha}_{!,k_{jj}}^{(\text{TM})}(x_1;x_1^0)$  has a jump if  $x_1$  passes through a whereas the derivative is continuous. To the left of the plane the representation simpli es too,

Now we need the corresponding formulas for the dielectric half space. These are standard and can be found in many places. For the TE mode it holds

Up to a comm on factor these are just the related scattering problem s.

Now with the explicite expressions for the propagator D  $(x;x^0)$  of the initial theory at hand we return to Eq.(14). The next step is to calculate the trace over K  $(z;z^0)$ . We chose a convenient basis for that, namely

W e m ention that  $K_{m,m^{0}}$  is an in nite dimensional matrix labeled by m and m<sup>0</sup> and that  $\ln K_{m,m^{0}}$  is another matrix and that the trace is over the latter matrix. In Eq.(35) the translational invariance along the axis of the cylinder was taken into account and  $E_{Cas}$ ,(35), is in fact the energy density per unit length of the cylinder.

W e proceed with dividing  $K_{m,m^{\circ}}$  into two parts according to the subdivision in Eq.(16) and (15),

## 3 Sm all separation and rst correction beyond PFA

In this section we generalize the sm all separation expansion of section IV in  $\beta$ ] to the sem itransparent boundaries of a plasm a sheet and a dielectric half space interacting with a cylindrical plasm a sheet. For the dielectric halfspace with dispersion (!) we restrict ourselves now to the plasm a model, i.e., to a perm ittivity given by Eq.(5). We start from the representation (64) of the interaction C asim ir energy with the matrix elements  $A_{m\,m\,0}^{TE}$  and  $A_{m\,m\,0}^{TM}$  given by Eqs. (65) and (67). The idea of the sm all separation expansion is is that only high momenta, i.e., large all, !, k<sub>3</sub>, m and m<sup>0</sup>, contribute and that one can use the asymptotic expansions of the matrix elements. Further, it is useful to expand the logarithm although at the end it needs to be sum m ed up again. We note that this asymptotic expansion is the same as done for hard boundary conditions in [3], however the expressions depend in addition on the parameters and !<sub>p</sub> and they are more involved.

The short separation expansion implies 1= << R and  $1=!_{p} << R$ . However, with respect to the separation L we assume them to be L. As a consequence we have to of the same order, i.e., 1= L and 1=!p  $_{\rm L}$  and  $!_{\rm p}R = !_{\rm p}L !_{\rm L}$  which will consider the combinations R =L appear in the following as being of order of one. The latter notations will be used in the interm ediate steps. In order to shorten the notations, in the following we will put R = 1. The correct dimension of the energy can be restored by  $E_{Cas}$  !  $E_{Cas}=R^2$ . In the nalexpressions, only the parameters L and  $!_L$  will appear and their dimensions are restored by  $_{\rm L}$  ! L and  $!_{\rm L}$  !  $!_{\rm p}$ L.

W e continue with the expansion of  $K_{m+m^{\circ}}$ . In the case of hard boundary conditions this was due to (59) simply the asymptotic expansion of the Bessel function. Here we have to consider the integral representation (58). However, since it is very close to a known integral representation of the Bessel function we can use standard m ethods, namely a saddle point expansion. This done in Appendix B where also the result is stated. It consists of a factor , Eqs.(B.9)-(B.11), which is dimensioned and factors which are the same as for hard boundary conditions in [3]. These factors are collected in , Eq.(B.13). W ith all these factors at hand we obtain for the functions  $A_{m+n,m+n^0}$  entering M , (70),

This expression for the Casim ir energy is to some extend the nal formula for the short separation expansion because the remaining integrations cannot be carried out in an explicit form (except for that over the  $n_i$ ). The function  $f^{()} \frac{!_{p}^{2L}}{!_{x}!_{0}}$  is shown in Fig.2. Its limiting values are  $f^{()}(x) = 1.62^{p} \frac{1}{x}$  and  $f^{()}(x) = 1.39$ .

The functions  $f_0$  for the ( )-case, i.e., for the interaction of the cylindrical plasma sheet with a at plasma sheet, are shown in Fig2. For large argument they go to unity which is the hard boundary limit. For smaller argument when the sheets become more transparent they decrease whereby the function for the TE case decreases faster. The behavior at the origin is given by the upper lines in Eqs.(89) and (90). The corresponding functions for the ( )-m odel depend on two

parameters. Their general behavior is similar to the ( )-case and as an example we show in Fig.4 the function  $f_0^{(-)_{\rm TM}}$  (L;!<sub>p</sub>L) for several values of the ratio of its arguments. Also for these function the limiting value for large arguments, i.e., for hard boundaries is unity and the limit for small arguments is given by the lower lines in Eqs.(89) and (90).

The rst contribution beyond PFA is given by the functions  $f_i$  in Eq.(86). These appear from the contributions proportional to  $P_{-}^{P_{-}}$  and to in the representation 64) of the energy with  $a_{n\pi^0}^{(1=2)}$  and  $a_{n\pi^0}^{(1)}$ , Eqs.(C.1) till (C.8), inserted into M<sup>as</sup>, (82). The next step is then to carry out the integrations over the  $n_i$ . These integrations are G aussian since the exponential  $_1$  is quadratic in the  $n_i$  and M<sup>as</sup> is polynom ial. As seen from the explicit form ulas,  $a_{n\pi^0}^{(1=2)}$  is odd in the  $n_i$  hence the contribution proportional to  $P_{-}^{-}$  vanishes. So we are left with the integrations of the term s proportional to . These integrations can be carried out in the same manner as in [3]. However, the results are too big as to be displayed here. A fter that form ula

(81) can be used since the appearing expressions are polynom ial in A gain, the integration over y remaining in (81) can be carried out trivially in the TE case but not in the TM case. The next step is to rewrite the summation over s in terms of polylogarithms. A fler that the expressions for the functions  $f_1$  become simpler. They are represented by formulas similar to that for the  $f_0$ , Eqs.(88), how ever m ore lengthy and for the ()-m odel the explicit expressions are displayed in Appendix D, Eq.(D 1).

It is interesting to note that the functions  $f_0$  and  $f_1$  are numerically quite close to each other. For the TE-mode in the ( )-model both functions are shown in Fig.(5). Only for small values of the argument L there is a signi cant di erence. It comes about because in this case it is impossible to expand the integrand for the function for  $f_1 \sin ply$  in powers of L. Instead one has to make a rescaling of the integration variable and the behavior comes out to be

This behavior is di erent from the corresponding one in PFA (upper line in Eq. (89)).

For the TM -m ode in the ( )-m odel both functions are shown in Fig.(6). Here the behavior for sm all argument is the same as in PFA and can be calculated by the same substitution. The result is

As a consequence, and as seen from the upper curve in Fig.(6), the ratio  $\frac{f_1^{(-)_{TE}}(L)}{f_0^{(-)_{TE}}(L)}$  of the two curves takes nite values for all L. We mention that like in PFA the TM mode dom inates at small separation.

Finally we discuss the results for the ( )-model. Again, the functions f are very close to the functions  $f_0$  in PFA. So we restrict us to show in Fig.7 the function

#### 4 Conclusions

In the forgoing sections we have derived the generalization of the Lifshitz form ula for the interaction of a cylindrical plasm a sheet with a at plasm a sheet (( )-m odel) and with a dielectric half space (( )-model) in PFA and in the rst approximation beyond. The limiting values for hard boundary conditions and for a separation sm all as compared with the plasm a wave lengths of the model (which corresponds to the nonretarded regime) are considered in detail. The previously known results were reproduced. The results in PFA and beyond are represented in form of functions  $f_0$ and  $f_1$  describing the deviation from the hard boundary limes, num erically computed and represented in a number of gures. In general words the outcom e is that these functions are very close to each other, i.e., the functions describing the ratios of the two functions  $f_1$  and  $f_0$  are close to unity. This allows a simpler representation of the result for the needs of practical calculations, namely as a pure superposition of PFA and the rst correction beyond (as calculated so far in 3) and [4]) and the reduction function taking care of the frequency dispersion (or transparency) of the boundaries which can be calculated for at boundaries. In terms of formulas that would imply in a representation like (86) simply to take the function  $f_0$  in place of the function  $f_1$ . It can be expected that this property holds also if one considers for example a dielectric medium with a dispersion given by optical data.

Open questions are still an extension of the method to a sphere in front of a plane and for accounting for the non separation of the modes of the electrom agnetic eld. However, for small separations the TM mode will prevail anyway and for large

separations which is equivalent to the hard boundary lim es both m odes are additive (for the wave guide geom etry). So it can be expected that for practical calculations the above results will be su cient at present time.

### Appendix A
