A Nano-Quantum Photonic Model for Justi cation of Dispersion in Single Crystal Film of NPP

Abstract

In this paper, we present a nano-quantum photonic model for justication of normal dispersion in a thin crystal lm of NPP. In this method, we assume a laser beam consists of a ow of energetic particles. By precise analyzing of photon interaction with -electron system of benzene ring in NPP crystal, we will attain refractive index (RI) in any wavelength and compare the results with experimental data.

Keywords: -electron system, photon-electron interaction, dispersion, NPP.

1 Introduction

Organic optical materials like MNA, NPP, MAP have a high gure of merit in optical properties in comparison with inorganic optical materials such as LiN bO₃, ADP, KDP and GaP [1]. Additionally N-(4-nitrophenyl)-Lprolinol (NPP) after MNA has the highest gure of m erit between organic nonlinear optical materials [2]. Thus it is used for electro-optic and nonlinear optic applications [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11]. It may say that refractive index (RI) is the most e ective element in optical phenom ena. Ledoux et al. rst proposed a Sellm eier set for RI of NPP, based on m easured refractive indices[3]. Ban, Datta and co-workers design a more accurate Sellmeier set for RI of NPP for nonlinear optical studies [4, 5, 6]; these data based on classic and macroscopic m easurem ents and approaches. Som e authors explain RI in molecular bases [12, 13, 14], although no data on realm aterial exist in this literature. Our purpose in this paper is the explanation of R I or dispersion e ect of a realm aterial, a single crystal lm of NPP, in an approach

that nam e nano-quantum photonic [15, 16, 17]. This approach is based on four elements: 1-quasi-quantum principle for justi cation of phenom enon in molecular scales, 2-K now ledge of crystal network and its space shape, 3-Short range intram olecular and interm olecular forces, 4-M onte-Carlo time dom ain simulation. We suppose a laser beam is a ow of photons when passes through single crystal lm, interacts with delocalization -electron system of NPP molecule and delays the photon in every layer. By precise calculation of these retardation in every layer, we obtain refractive index (RI) in speci c wavelength. The results obtained from this method are agreeable to experim ental data. Our previous work was about MNA arom atic crystal, with a simpler structure than NPP molecule, [17, 18]. By simulation on more complex crystal, NPP, and considering the agreement of simulation results with experimental and Sellmeier data, the validity of assumptions and simulations will be proved. Hence, rst we introduce crystal and m olecular structure of NPP and com parison to Benzene m olecule, after which we explain normal dispersion formula according to classical physics, electrom agnetism, quantum electrodynam ics and our m icroscopic m odel. In fourth section, we simulate and calculate the probability density function (PDF) of electron presence in benzene ring ofNPP molecule, approximately. In fth section, we express detailed calculation of R I. In sixth part, we clarify how to obtain RI for NPP crystal and com pare simulation results with experim ental and Sellm eier data.

2 Crystal and Molecular structure of NPP

O rganic m olecular units and conjugated polymer chains possessing -electron systems usually form as centrosymmetric structures and thus, in the electric dipole approximation, would not show any nonlinear second order optical properties. The necessary acentric may be provided by rst distorting the -electron system by in-

3 Classic and microscopic model for dispersion

Cauchy suggested an equation that perform s a relation between wavelength and RI in form [21]:

If we have three RI in three wavelength according to experimental data, then we have RI in any wavelength in transparent range of that substance. Ledoux et.al Bloroposed a Sellmeier formula for NPP crystal in the form :

and D atta et al. [5] dem onstrated a m ore accurate of it in the form :

that A,B,C,D and E is exerted from table 1. These formulas that derived from Sellm ier equation, gives no microscopic perspective of interactions of photon-electron when light passes through the material; additionally in sub-micron scales, RI loses its stabilization and these equations are not useful [15].

E lectrom agnetism have also a dispersion equation:

where there are N $_k$ electrons per unit of volum e, whose natural frequency is $!_k$ and whose damping factor is $_k$, [8].

Quantum Electrodynamics attains a famous dispersion relation in form of:

that introduce the notation:

for unit of the polarization of the incident and scattered light, and

for the electron momentum vector [22]. This formula is the simplest form in thermal equilibrium and is very complex in real world. This means that for attaining R I from quantum electrodynamics theory, we require to measure electron momentum vector and certainly, these elements can be calculated on the basis of sem iclassical arguments.

Now, we suggest a microscopicm odel for RI and wavelength relationship. In this pattern, average photon ux is related to classic electrom agnetic concepts like: intensity, power and energy. For example if we have a monochromatic laser beam with frequency and intensity I, then we may attain average photon ux from relation [23]:

now if we assume thin single crystal lm of NPP in "b" direction of crystal (or "z" axis) radiated by a He-Ne laser with: = 633 nm, average power=10m w and beam width= 20 m icrons, then from (4) average photon ux is equal to 10^{22} photons=(s cm²) that signiles in every second 10^{22} photons arrive to each centimeter square. M oreover from data of crystal in section (II) in every 36.5 (A²) in z direction, one NPP m olecule exists. Therefore in every second 36:5 10^6 photons interact with any m olecule or in other words in every 27ns, one photon interacts with any NPP m olecules. In each interaction between photon and electron in every layer of crystal, we suppose delay time equal to _i (ith layer of crystal). Total retardation time for m layers in crystal region is equal to:

Consequently required time for photon transmission in L length of crystal is equal to , achieved from relation:

where c_0 is velocity of light in vacuum. By using this relation, we can relate m acroscopic quantity n to m icroscopic quantity $_i$. A coording to (3) if, n = 3; L = 3, consequently is equal to 10 $^{14}\,\sec$. Because in b direction of crystal in 3 length, approximately 4024 m olecules exist, therefore the average quantity of :

is in order of 10¹⁸ sec. From this quantity and previous quantity that in every 27ns, one photon interacts with one NPP molecule, we conclude that in every moment, just one photon interacts with one molecule. Because NPP molecule has delocalization electrons, (or

-electron system), in benzene ring, that photon interacts with this electron type and it is annihilated [24]. W e call this photon, a successful photon, (that does not produce phonon). By this method, we are able to sim ulate m icroscopic perturbation of RI for NPP successfully. Equations (1), (2) and (3) use average quantities in frequency domain, but in (6), we utilize momentary quantities in time dom ain that perturb on average values. In our nano-quantum photonic model, we may estim ate photon-electron m utual actions in very short tim e, on the order of "attosecond"; (10¹⁸ s). We claim that our approach is applicable for opticalm aterial that their crystal structure is known, especially arom atic optical crystal. Because, they have a delocalization electron and successful photon interact with it. For inorganic optical material if we know active electron in optical phenom enon, we are able to use this method. In our approach, we do not have any measurement and we have simulation and estimation with an ideal observer. This is the rst time that we have focused on a realm aterial for approximating its constitutive parameters (like n;"; ;). Neither in classical nor in Q M . approach we only have typical material. In Q E D, we have not seen yet practical or predictable data for a realm aterial. Our approach is quasi-classic and is similar to the Compton e ect but in greater wavelengths. W e have used som e approximations for problem solution.

4 PDF calculation of -electron in benzene ring of NPP

To obtain -electron wavefunction for benzene m olecule the Schrodinger equation may be solved. Since this is very complex, this cannot be done exactly, an approxim ated procedure known as Huckle m ethod must be em – ployed. In this method, by using Huckle M olecular-O rbital (HMO) calculation, a wave function is form ulated that is a linear combination of the atom ic orbitals that have overlapped [20] (see Fig.3) (this method is often called the linear combination of atom ic orbitals); that is: χ

where the $_{\rm i}$ refers to atom ic orbitals of carbon atom s in the ring and the sum mation is over the six C atom s. The Schrödinger equation for a delocalized electron is:

that V_i is the atom ic potential of ith atom . Following the common approach in quantum mechanics, we multiply the above equation from the left by $_i$ and integrate over space. By solving this set of algebraic equations, the C_i coe cient, the $_i$ wavefunction and energy E will be obtained, (Fig. 3). Thus, the $j_{c,i}j_{i}$ is the probability of the -electron at ith atom. Thus:

In the case of Benzene molecule:

as followed from the symmetry of the ring [20, 25, 26]. But for NPP molecule there isn't such as Benzene molecule. NPP is a polar molecule. N itro (NO_2) is more powerful electronegative compound than prolinol and pulls -electron system; consequently, the probability of nding -electron system at various carbon atoms of main ring isn't same and the probability of nding -electrons near the N itro group is greater than near the prolinol group. Therefore there is no symmetry for NPP and electron cloud is spindly or oblong, (sim ilar to dom -bell) (Fig. 6). We estimate this form of electron cloud by an ellipse that our calculations would be uncom plicated. According to Bohr atom ic model, we assume -electron is rotating around the center of positive charge in agreement with K epler law. The positive

charge in this approximation is virtual.

For attaining probability of electron presence on an orbit (g. 7), we say, T time is required by radial vector to sweep total uv interior area of ellipse (u and v are sem in a pr and sem in inor axis of ellipse respectively), in t tim es, this radial vector sweeps

area of ellipse, (see g. 7). If t is the time, that electron sweeps radian of orbit then t is obtained from this relation [27]:

W here " is ellipse eccentricity. By using this relation, we attain the required time for electron to traverse from to + d (dt) and it is divided by total time T.By this approach, we can determ ine the PDF approximately. Fig. 8 and Fig. 9 show PDF and CDF (Cumulative Density function) respectively for presence probability of electron around the assumed orbit in g. 7. Such as shown in this gure the PDF in apogee (near the N itro group), is maximum and in perigee (near the prolinol group) is minimum.

5 Calculation

The angle between Y vector and charge transfer action (N_1-N_2) is 58.6 and X and Z axis is perpendicular to Y (Fig.10). We consider propagation along Z direction.

We spot a photon interacts with -electron of NPP in rst layer. A fter interaction, this photon gives its energy to electron and is annihilated. Electron absorbs energy and digresses in direction of photon m om entum . E lectron with photon energy, may not be unbounded and after arriving to apogee of digression, it returns back to main orbit, because the photon energy is equal to is frequency h = 1:96ev (h is P lanck's constant and of laser beam) whereas energy for ionization is greater than 5ev. W hen electron returns to main elliptical orbit one photon is produced. The time coming up and down is delay time. This photon after freedom goes to second layer in direction of annihilated photon (nonce, we assume the polarization doesn't change), in second layer this photon interacts with another delocalization

-electron certainly, because the elective range of photon is approximately equal to its wavelength and is very greater than the distance between molecules. This action is repeated for each layer. The location of photonelectron interaction is significant in every molecule and it is elective on quantity directly. We assume that interacting photon has a led in X direction and electron subject to virtual positive charge center. A coording to g.11 we have:

in e ective center of positive charge. Consequently the time required for electron to go up and down is equal to:

where is the elliptical eccentricity and u is the sem im a praxis of the ellipse. By performing $_x$ and $_y$ separately in every layer and using (6), we attain n_x and n_y separately.

6 Attaining of n_x and n_y for N P P crystal

We are now in a position to take up n_x and n_y by M onte-C arb m ethod, then we simulate random num – ber producer using M ATLAB program. This program produces PDF quantities explained in section (4) and relates each of them to every m olecule. These values are indexing -electron positions in each layer, by assum ption a reference point (see g. 7). Additionally we have used a M ATLAB program for M onte-C arb simulation. The inputs of this program are:

1. The wavelength of incident optical beam in which we want to obtain refractive index of NPP crystal;

2. h;m;q;k = $\frac{1}{4 : ::}$;c₀ that are P lanck's constant, electron rest m ass, elem entary charge, C oulom b constant and speed of light respectively.

3. Unit cellparam eters of NPP crystal: a, b, c, and its other param eters that have given in section 2.

We assume that in- And the outputs of MATLAB program are: n_x, n_y in has a eld in X direction and electron each wavelength and their related errors from experilpositive charge center. According to mental data.

> System calibration is done in this method that we obtain two refractive indexes in two wavelengths with (eccentricity), u (sem in a jor axis of ellipse) and Z (equivalent positive charge) in a way that refractive indexes in two wavelengths are very close to experim ental data. Then we would see that refractive index in other wavelengths with same , u and Z will be achieved. O f course these values, , u and Z would be close to experim ental structure of crystal, for example u would be greater than and smaller than minimum and maximum sizes of six lengths of benzene hexagonal respectively, or would be sm all and greater than zero. In other hand these values must be logical. From this method in our simulation we have obtained = 0.26; Z = 3.9; u = $1.4A^0$ that is very close to experim ental and structural data . Tables (2) and (3) compare the results of simulation with experim ental data. From these tables we perceive nx and

 n_y that we attained from simulation, have 5.8 percent maximum error and 0.23 percent minimum error. These values are acceptable measures. Figures 12 and 13 com – pare these data with Sellmeier data that are provided from [3, 5].

7 Conclusion

The suggested physicalm odel in this paper that is based on assumption of energetic particles could be a powerful tool for analyzing and explaining processes that happen in waveguides in microscopic sizes. From similar models we can explain optical events such as second harm onic generation and optical polarization in ber optic applications and optical communication. We will try to continue applying this method for justi cation of another phenomenon. Our approach is quasi-quantum and its advantages are:

1-W e m ay to obtain scienti c data of a realm aterial, 2-W e utilize m om entary quantities in tim e dom ain,

3-0 urm ethod m ay predict som e events in nanostruc-

turs and very short time by considering short-range interatom ic forces and its e ect on photons.
