A bstract

A new class of entanglement witnesses (EWs) called reduction type entanglement

witnesses is introduced, which can detect some multi-qudit entangeled states including

PPT ones with Hilbert space of dimension $d_1 d_2 \cdots d_n$. The novelty of this work

com es from the fact that the feasible regions turn out to be convex polygons, hence the

m anipulation of these EW s reduces to linear program m ing which can be solved exactly

by using $sim\ plex\ m\ ethod$. The decom posability and non-decom posability of these EW s

are studied and it is shown that it has a close connection with eigenvalues and optimality

of EW s. A lso using the Jam iolkowski isom orphism, the corresponding possible positive

m aps, including the generalized reduction m aps of Ref. [21], are obtained.

1 Introduction

Quantum entangled states lie at the heart of the rapidly developing eld of quantum inform ation science, which encompasses important potential applications such as quantum communication, quantum computation [1, 2, 3]. However, the fundamental nature of entangled states has tantalized physicists since the earliest days of quantum mechanics, and even today is by no means fully understood. One of the most basic problems is that how can one tell if a quantum state is entangled?, and how entangled is it still after some noisy quantum process.

Here we will deal with the states of nite dimensional Hilbert space $H = H_{d_1}$::: H_{d_n} . A density matrix is called unentangled or separable if it can be written as a convex combination of pure product states as ji=j⁽¹⁾i ::: j⁽ⁿ⁾i. If no such convex linear combination exists for a given , then the state is called entangled. A Ithough, in the case of pure states of bipartite systems it is to check whether a given state is, or is not entangled, the question is yet an open problem in the case of mixed states (see the recent good review s[4, 5, 6, 7]). There have been m any e orts in recent years to analyze the separability and quantitative character of quantum entanglement. The Bell inequalities satised by a separable system give the rst necessary condition for separability [8]. In 1996, Peres made an important step towards proving that, for a separable state, the partial transposition with respect to one subsystem of a bipartite density matrix is positive, TA 0 [9]. By establishing a close connection between positive m ap theory and separability, Horodecki et al. promptly showed that this is su cient condition for separability for bipartite systems of 2 2 and 2 3 [10]. Regarding the quantitative character of entanglement, Wootters succeeded in giving an elegant formula to compute the entanglement of formation [11] of 2 mixtures, thus giving also a separability criterion [12]. An alternative m ethod to detect entanglem ent is to construct so-called entanglem ent w itnesses [10, 13, 14, 15] and positive maps [16]. Entanglement witnesses are physical observables that can detect the presence of entanglem ent. Recently m any attempts have been m ade to use the

convex optim ization methods as a robust tools in most quantum information areas including construction of EW s [17, 18, 19, 14, 15].

The main motivation for the present investigation is the remarkable fact that there is no evidence that when and where the manipulation of the EW s reduces to LP which can be solved exactly. For example, the rst author and his collaborators have found certain examples of Bell diagonal EW s and generalized d d Choi entanglement witnesses [14, 15], by approxim ate LP m ethod. Indeed in most cases determ ining feasible regions needs to use num erical calculation and consequently the problem is solved approximately. Therefore to gure out the problem swhich can be easily solved exactly in a optimal way and also can be generalized to an arbitrary number of particles with dierent Hilbert spaces is the main purpose of this paper. To this aim we introduce a new class of (d, d, ::: d,)-multi-qudit EW s called reduction type entanglement witnesses (REWs) and show that the computational diculty in solving such problem s reduces to LP which can be solved by sim plex m ethod [20]. In these cases the feasible regions are simplexes and the minimum value of optimization problem is achieved on their apexes. On the other hand we show that the EW s corresponding to hyperplanes surrounding feasible regions are optimal. Another advantage of this work is the fact that all REW s can be written in terms of some positive operators and optimal EW s. Also in most cases the decomposability of REW s is rather determined, where two of their eigenvalues plays an important role in this issue. A nother important consequences of such EW s are the positive maps including the generalized reduction map [21], which can be obtained from these EW s or their tensor product, via Jam iolkowski isom orphism. Finally a class of entangled density matrix including PPTES are provided which can be detected by such REW sand consequently they determ ine the non-decomposability of REW s. At the end we carry out in detail some particular cases such as multi-qubit and 2 3 4 and generalized reduction EW.

The paper organized as follows: In section 2 we give a brief review of EWs. In section 3 we explain the general scheme of linear program ming. In section 4, we introduce a new class of

EW s which can be put in the realm of LP, since their feasible regions are convex polygons (indeed simplexes) which can be exactly determined. In section 5, we show that all EW s corresponding to hyperplanes surrounding the feasible regions are optimal. Section 6 is devoted to some interesting examples such as: multi-qubit REW s, (dd::: d) multi-qudit REW s and 2 3 4 REW. Section 7 deals with two examples of LP type, where the rst one can be solved exactly by the prescription of this paper. In section 8 we introduce some entangled and PPT states which can be detected by REW s and the decomposability of REW s is discussed. In section 9 by using Jam iolkowski isomorphism, the relation between REW s and positive maps is explained. The paper is ended with a brief conclusion and three appendices.

2 Entanglement witness

A sm entioned above in the introduction, one of the pragm atic approach to detect entanglement is to construct entanglement witnesses. Let us brie y recall what these operators are.

De nition 1. A Herm itian operator W is called an entanglement witness detecting the entangled state $_{\rm e}$ if Tr(W $_{\rm e}$) < 0 and Tr(W $_{\rm s}$) 0 for all separable state $_{\rm s}$.

So, if we have a state and we measure Tr(W) < 0, we can be sure that is entangled. This de nition has a clear geometrical meaning. The expectation value of an observable depends linearly on the state. Thus, the set of states where Tr(W) = 0 holds is a hyperplane in the set of all states, cutting this set into two parts. In the part with Tr(W) > 0 lies the set of all separable states, the other part (with Tr(W) < 0) is the set of state detected by W. From this geometrical interpretation it follows that all entangled states can be detected by witness. Indeed for each entangled state e there exist an entanglement witness detecting e [10].

De nition 2. An EW is decomposable (d-EW) i there exists operators P; Q_i with

where partial transpose taken with respect to some subsystems and it is non-decomposable if it can not be put in this form [19].

Only non-decomposable EW s can detect PPT entangled states that is those density matrices which have positive partial transposition with respect to each subsystem s[22].

3 Manipulating EW sby LP method

This section deals with basic de nitions of linear program ming (LP) and general scheme to construct EW s by an exact LP method.

To this aim st we consider a Herm itian operator W with some negative eigenvalues

where $_{i}$ are positive operators, with 0 Tr($_{i}$ s) 1 for every separable states $_{s}$. Note that, the condition 0 Tr($_{i}$ s) 1 is not always required. It is used here only to simplify analyzing the problem and pave the way to generalize the prescription to multi-qudits with arbitrary higher dimensions as will be discussed in the following.

where D_{prod} denotes the set of product states. Thus we need to nd the pure product state $j_{min}i$ which minimize Tr(W j ih j). This is not all circum stances. An important and dicult task

is to nd the convex region (called feasible region) inside this hypercube which comes from $F_w := Tr(W_s)$ as s varies on D_{sep} , where D_{sep} denotes the set of separable states. Here in this work we are interested in the EW s with the feasible regions of simplexes (or at most convex polygons) types, such that the manipulating these EW s amounts to

where c_{ij} ; d_i i;j=1;2;::: are parameters of hyper-planes surrounding the feasible regions. Therefore, the corresponding boundary points of feasible region will minimize exactly F_w , thus the required task reduces to LP problem which can be solved by the well-known simplex method [20].

4 $(d_1 \ d_2 \ \dots \ d_n)$ m ulti-qudit reduction type EW s

In this section we consider n Particles with arbitrary dimensions. Without loss of generality particles can be arranged so that $d_1 \ d_2 \ \cdots \ d_n$. The discussion of some special cases is postponed to Section 6. We introduce and parameterize the multi-qudit reduction-type entangled witnesses (REW s) labeled by subscript R as

We introduce the new more convenient parameters $a_1 = b_1 = b_1$, $a_s = b_s + \frac{P}{s_0 s_s} b_{s_0}$, instead of b_s 's. In order to turn the observable (4.5) to an EW, we need to choose its parameters in such a way that it becomes a non-positive operator with positive expectation values in any pure product state $j i = j^{(1)}i$::: $j^{(n)}i$:

Now it is the time to reduce the problem to LP one. In order to determ ine the feasible region, we need to know the apexes, namely the extremum points, to construct the hyperplanes surrounding the feasible regions. Regarding the above consideration, we are now ready to state the feasible region.

To this aim we rst prove that, $2^{n-1} + m$ extrem um points obtained above form the apexes of $(2^{n-1} + m)$ -simplex in Euclidean space of dimension $N = 2^{n-1} + m$. To this purpose we consider the convex hull of theses points, i.e. draw N + 1 hyperplanes passing through each combination of N points out of N + 1 ones ($C_N^{N+1} = N + 1$). Now, we get a bounded region formed from their intersection which is the required feasible region of $M_R^{(n)}$ and it is obviously a $(2^{n-1} + m)$ -simplex. It is strait forward to show that the feasible region can be obtained by taking the expectation values of

in pure product states (see appendix II). Now, in order that W $_{_{\rm R}}^{^{\rm (n)}}$ to be an EW , the following expectation values

Putting the coordinates of apexes in Eq.(4.10) yields all $a_s=0$ and $a_s+a_s^0=0$. As we stated in previous section, all P_S and P_S^0 lie in the closed interval [0;1]. Now, F is a linear function of P_S and P_S^0 and if we require it to be positive on the apexes (which are extremum points), then it will be positive in the whole feasible region.

At the end we need to know all eigenvalues of W $_{R}^{(n)}$ which consist of a_{s} ; $a_{s} + a_{s}^{0}$; $l_{1} = a_{N^{0}}$ b $b_{N^{0}}$ and $l_{2} = d_{1}a_{N^{0}}$ (d l_{1}). Since a_{s} ; $a_{s} + a_{s}^{0}$ 0, then one of the remaining eigenvalues: l_{1} and l_{2} must be negative to guarantee W $_{R}^{(n)}$ to be an EW .

5 Optimality of (S)W (n)

A fler determ in ing the feasible regions, one needs to know whether the boundary of EW s is formed by optimal EW S.An EW is optimal if a positive operator P is subtracted from that then it will be no longer an EW [13].

Note that the EW s corresponding to hyperplanes surrounding feasible regions of $W_R^{(n)}$ are optimal since they cover the simplex feasible region in an optimal way (see appendix III). Thus, the structure of the optimal EW s $^{(S)}W_{opt}^{(n)}$ characterizes the boundary of REW s $W_R^{(n)}$. In fact, from the results of this Section it will become clear that we can restrict ourselves to the structure of the optimal EW s corresponding to hyperplanes surrounding feasible regions. In other words optimal EW s $^{(S)}W_{opt}^{(n)}$ are tangent to the boundary between separable and non-separable states.

A nother advantage of $^{(S)}W$ $^{(n)}_{opt}$ is that one can rewrite the W $^{(n)}_{R}$ in terms of positive operators $^{0}_{s}$; j $_{00::::0}$ ih $_{00::::0}$ j and some optimal EW s, i.e.,

6 Som e special cases of W (n)

In this section we discuss some special cases of REW s to enlighten the subject.

6.1 Multi-qubit reduction type EW s

It is important both theoretically and experimentally to study multi-qubit entanglement and to provide EW s to verify that in a given multi-qubit state, entanglement is really present. The Eq. (4.5) for system of n-qubits reduces to

As we see the number of P_S is three, while the number of optimal points is four. Therefore, there are four hyperplanes surrounding the feasible region, where the hyperplanes pass through each combination of three points out of four ones. (see Fig.1). Thus the problem can be reduced to

Where for $a_2 = 0$ it reduces to the well-known reduction EW (the term "reduction-type EW s" for general W $_{R}^{(n)}$ is inspired from this particular case). In this case we have only P_2 which can takes values between 0 and 1. So the feasible region is just the line segment 0 P_2 1. Putting 0 and 1 in F $(P_2) = a_1 + (a_2 - a_1)P_2$ yields $a_1 = 0$ and $a_2 = 0$ respectively. The eigenvalues are a_1 and $a_2 = 0$ where the second one must be negative to ensure detecting some entangled states.

6.3 Three particles (2 3 4)

As a particular example of REW swith dierent dimension let us discuss three particles with 2 3 4 dimensions



In general it is hard to not the BDEW swith feasible region of simplex type or even polygon type, namely those which can manipulated by LP method. Here we give two examples which are both set in LP problem, where only one of them (the rst example) can be solved exactly by the prescription of this paper.

8 Detecting som e entangled states by W $_{\rm R}^{\rm (n)}$

This section is devoted to some entangled states which can be detected by general W $_{R}^{(n)}$ and three-qubit REW W $_{R}^{(3)}$. First we consider some Bell states. All of the Bell states j $_{i \ 0::::0}$ i can

The above requirem ent makes $_{0,0,\dots,0}$ a class of PPT entangled state which can be detected by W $_{\text{R}}^{\text{(n)}}$. But to detect the other $_{i,0,\dots,0}$ we must have ! $_{1}$ < \$ which is impossible. This is in

agreement with the discussion made in section 5. Now, combining thus obtained results with those of Eq. (5.12) which implies that $W_R^{(n)}$ is decomposable provided that $!_2$ is positive, one can rather determine the decomposability and non-decomposability of REW s (see Fig.4).

Furtherm ore one can construct some entangled states which can be detected by particular REW s. As an example consider entangled density matrices

These examples show that one can construct more positive maps by making tensor product of EW sW $_{\rm R}^{(n)}$ in arbitrary way provided that the dimensionality condition d_i d_i^0 is satisfed.

10 Conclusion

The generalized reduction type entanglement witnesses with simplex feasible regions are introduced, where the EW s corresponding to hyperplanes surrounding the feasible regions are

optim al. These REW s are of types that their manipulation is reduced to LP problem and can be solved exactly by using the simplex method. As it shown above, the REW s are decomposable in cases if their second eigenvalue, namely! becomes positive while for negative values of !, the decomposability or non-decomposability of REW s is still open for debate. Also various other interesting issues remain unsolved, such as keeping the REW s in realm of LP problems despite of adding some other operators or entangled states to them.








