On the maximal violation of the Collins-Gisin-Linden-Massar-Popescu inequality for in nite dimensional states

We present a much simplied version of the CGLMP inequality for the 2 2 d Bell scenario. Numericalmaxim ization of the violation of this inequality over all states and measurements suggests that the optimal state is far from maximally entangled, while the best measurements are the same as conjectured best measurements for the maximally entangled state. For very large values of d the inequality seems to reach its minimal value given by the probability constraints. This gives numerical evidence for a tight quantum Bell inequality (or generalized C sirelson inequality) for the 2 2 1 scenario.

The violation of B ell inequalities [1] by certain quantum correlations can be seen as a nonclassical property of those correlations. This \quantum nonclassicality" has its roots in quantum entanglem ent. There are several ways to quantify entanglem ent of which one is the so-called entanglem ent entropy of a quantum state [2]. Q uantum states with maximalentanglem ent entropy, socalled maximally entangled states, play an important role in quantum information science [3]. It was long believed that the maximally entangled state must also be the \m ost nonclassical" state in the sense of maximal violation of B ell inequalities. A lthough this is true for the CH SH inequality [4], it was given evidence in [5, 6] that this is not true for the more com plex CG LM P inequality [7], as also exposed in [8].

In the following, we investigate maxim al nonclassicality in the context of the CGLMP.We present a new sim pli ed version of the CGLMP inequality. As in \$, 6] num erical analysis suggests that the optim al state for each num ber of outcom es above d= 2 is not m axim ally entangled, where we mainly work with the assumption that the dimension of the Hilbert space D is equal to the number of outcom es d as in [5, 6], but also investigate the case of d < D and the validity of this assumption. We give num erical evidence that the best m easurem ents are the well-known (conjectured) best measurements with the maximally entangled state. The simple form of our new version of CGLMP enables us to e ectively extend the num erical search to a num ber of measurem ent outcom es and dimension of the Hilbert spaces of the order of 10^6 . W e observe that for these large values of d the new version of CGLMP seems to reach its absolute bound at the boundary of the polytope of all probability vectors. This gives num erical evidence for the tightness of a quantum Bell inequality (or generalized C sirelson inequality) for the 2 2 1 scenario.

The 2 2 d Bell scenario and a new version of the CGLMP inequality: Let us consider the standard scenario of the CGLMP inequality [7] which consists of two

spacelike separated parties, A lice and B ob. B oth share a copy of a pure state j $i 2 C^{D} C^{D}$ on the composite system. Let A lice and B ob have a choice of performing two di erent projective measurements which each can have d possible outcomes, where d D.We call this a 2 2 d scenario.

Let A_a^i , a = 1;2 and i = 0;:::d 1 denote the positive operators corresponding to A lice's measurement a with outcome i and sim ilar for Bob, B_b^j . They satisfy $P_{j=0}^{d-1} A_a^i = 1$. The probability predicted by quantum mechanics (QM) that A lice obtains the outcome i and that Bob obtains the outcom e j conditioned on A lice has chosen measurement a and B ob measurement b then reads

Let us on the other hand consider the fram ework of local realistic (LR) theories, where the joint probability distribution can be written as

m eaning that conditioned on their mutual past the probability distributions of A lice and B ob are uncorrelated.

As already mentioned, QM is nonclassical in the sense that there exist joint probability distributions P_Q (i; j;;b) arising from QM which do not admit a local realistic representation in the form of (2). Bell [1] was the state representation in the form of a testable form in terms of an inequality which is violated for nonclassical probability distributions.

We now give a new Bell inequality for the 2 2 d Bell scenario:

$$P_{L} (A_{2} < B_{2}) + P_{L} (B_{2} < A_{1}) + P_{L} (A_{1} < B_{1}) + P_{L} (B_{1} - A_{2}) > 1; (3)$$
where $P_{L} (A_{a} < B_{b}) = P_{i < j} P_{L} (i; j; j; b).$

This inequality can be easily proven. Let us start with the following obvious statement $fA_2 = B_2g \setminus fB_2$ $A_1g \setminus fA_1 = B_1g = fA_2 = B_1g$. Taking the complement we get $fA_2 < B_1g = fA_2 < B_2g = fB_2 < A_1g = fA_1 < B_1g$. This implies for the probabilities that $P_L (A_2 < B_1) = 1 = P_L (A_2 = B_1) = P_L (A_2 < B_2) + P_L (B_2 < A_1) + P_L (A_1 < B_1)$ which completes the proof.

The new version (3) of the CGLMP inequality has apart from its simple form several advantages over previous versions. One advantage is that the inequality does not depend on the actual values of the m easurem ent outcom es, only their relative order on the real line m atters. For the case of m easurem ents with outcom es 0; ...;d 1 this inequality in plies another sim pli ed version of the CGLMP inequality presented in [5], as well as the original CGLMP inequality. A nother advantage is that inequality (3) reads the same for all values of d. Further, the way the new inequality is derived m ight be interesting for

nding new, simpler inequalities for other Bell settings, such as the 2 $\,$ 3 $\,$ 2 Bell setting.

In the following section we will investigate them axis al violation of inequality (3) by QM for large values of the number of outcomes and dimension of the H ilbert space.

V iolation of the CGLMP inequality for the maxim ally entangled state: In the following we will assume that the dimension of the Hilbert space D is equal to the number of outcomes d which we abbreviate as dimension d. We will comment on this assumption at the end of this letter, where we also present numerical evidence for the validity of this assumption. For the maxim ally entangled state, $j \ i = \int_{i=0}^{d-1} jiii= d$, it has long been conjectured that the measurements which maxim ally violate the CGLMP inequality are described by operators A_a and B_b with the following eigenvectors [7, 9],

where the phases read 1 = 0, 2 = 1=2, 1 = 1=4 and 2 = 1=4, here i = 1 is the imaginary number.

We evaluate the left-hand-side of inequality (3) for the joint probabilities arising from QM in the case of the maxim ally entangled state and the just described measurem ents. For later purposes we will leave the Schm idt

coe cients unspeci eq throughout this calculation and only equate them to 1 = d at the end. We use (1), where the $A_a^i = jia_{i,a}hij_{i,a}$ are the projectors on the corresponding eigenspaces de ned in (4) { (5) and similarly for B_b^j . We obtain

where the d d-matrix M can be simplied to

Putting $_{i} = 1 = d$, i.e., boking at the maximally entangled state, we obtain for d = 2, $A_{2}() = (3 2)=2$ 0:79289 which corresponds to the maximal violation of the CHSH inequality know from C sirelson's inequality [13].

It is also interesting to bok at the conjectured (it is not known that these are the best measurements) maximal violation of (3) with the in nite dimensional maximally entangled state. We get $\lim_{d! = 1} A_d() = 2$ 16C at² = ² 0:515 where C at is C atalan's constant, reproducing the result obtained in [7] for the original version of the CGLMP inequality.

In this section we described what are believed to be the best m easurements for the CGLMP inequality with the maxim ally entangled state. Though it is often thought that the maxim ally entangled state j i represents the most nonclassical quantum state, evidence has been given in [6] and [5] that the states which maxim ally violate inequality (3) are not maxim ally entangled. In the following section we provide further evidence for this and investigate several properties of the optim al state especially in the case of very large values of d.

On the maximal violation of the CGLMP inequality: In the previous section we described the measurements which in the case of them axim ally entangled state appear to give the maximal violation of inequality (3). However, as mentioned above, it has already been given evidence that in the case of d 3 the state which causes the maximum violation of the inequality is actually not the maxim ally entangled state [5, 6].

In the following we want to optimize the left-handside of inequality (3) over all possible measurements and states. For this purpose we assume that the state of A lice's and B ob's composite system is a pure state j i 2 C^d C^d and that the measurements A_a and B_b describing A lice's and B ob's measurement are projective and nondegenerate as also considered above.

For small values of d we can numerically perform the optimization. The results for the rst values are summarized in Table I. Shown are the minimal values of the left-hand-side of inequality (3), denoted by m in A_d (; A_a ; B_b), and the Schmidt coe cients of the optimal state for which A_d (; A_a ; B_b) reaches its m inimum.

O ne observes that for d 3 the optim al state is not m axim ally entangled. M ore precisely, as we will see later the entanglem ent entropy decreases as d becomes bigger. The optim al states arising from the numerical optim ization over A_d (; A_a ; B_b) agree with results obtained in [6], but dier from the results in \$]. That is because in [5] the quantity to be optimized was not the CGLM P inequality, but the Kullback-Leibler divergence (relative entropy) which contrary to common belief is not equivalent to the concept of maxim alviolation of B ell inequalities [11].

C beer analysis of the optim alm easurements A_a^i and B_b^j shows that even though the optim al state is not the maxim ally entangled state the best measurements seem to be the best measurements (4) and (5) of the previous case. Further numerical optimizations for higher values of d give strong evidence that this true in general.

If we assume that (4) and (5) are the best measurements for all values of d we can further simplify the optimization. We have already derived in Eq. (6) that in the case of the measurements (4) and (5) we can write $A_d() = P_{i=0}^{d-1} P_{j=0}^{d-1} M_{ij-i}$, where $j = P_{i=0}^{d-1} P_{i=0}^{d-1} M_{ij-i}$.

Hence under this assumption, nding the maximal violation of (3) reduces to nding the smallest eigenvalue of the matrix M. The corresponding eigenvector f $_{i}g_{i=0}^{d-1}$ gives us the optimal state.

For d = 2;3 we obtain minA₂ = (3 $p = \frac{1}{2}$)=2, with ~ = (1;1)^T = $p = \frac{1}{2}$, and minA₃ = (12 $p = \frac{12}{3}$)=9, with ~ = (1; ;1)^T = ($2 + \frac{1}{2}$), and = ($11 - \frac{11}{3}$)=2, agreeing with results presented in [6] where violations of the originalCGLM P inequality were investigated.

M ore interesting becomes the search for eigenvectors with minimal eigenvalue for a large number of possible measurement outcomes. Numerical search for those eigensystems is feasible for very large values of d by use of A moldi iteration.




FIG.1: M inim al value of the left-hand-side of inequality (3) as a function of the dimension d: (i) for the maximally entangled state and (ii) for the optimal state. Inside: Entanglement entropy $E = \log d$ of the optimal state as a function of the dimension d.

The results of the num erical optim izations are sum m arized in Fig.1. Shown is them in in altarget value, $A_{\rm d}$ (), as a function of the dimension d for a range from 2 to 10^6 both for the case of the maximally entangled state and the optimal state. In the case of the maximally entangled state, $A_{\rm d}$ () approaches very quickly the asymptotic value $A_{\rm l}$ () 0:515 derived above.

In the case of the optim alstate it is interesting that the m axim alviolation of (3) does not approach an asymptote very quickly. In fact, for very large d it falls o slower than logarithm ically with the dimension. The numerical data shown in Fig. 1 do suggest that the m inim al value of A_d () approaches zero as d tends to in nity. This is very interesting since zero is the absolute m inim um of A_d () on the boundary of the polytope of all probability

vectors. If one could show analytically that there exists a optim all state which actually causes A_d () to approach zero as d tends to in nity, one would have proven a new tight quantum Bell inequality for the 2 2 1 scenario (see conjecture at the end of this section).




FIG.2: The typical shape of a optim al state for d 3. Shown are the Schm idt coe cients $_{i}$ of the optim al state for d = 10000 as a function of the index i.

Let us now investigate further properties of the optim al states causing the maximal violation of inequality (3). Fig.2 shows the typical shape of a optimal state ford 3, namely in the case of d = 10000. P botted are the Schmidt coe cients $_{i}$ as a function of the index i. The rejection symmetry around (d 1)=2 can be easily derived from the speci c form of the symmetric kernelM_{ij}. As d increases the Schmidt coe cient get more and more peaked at i= 0 and i = d 1.

It is also interesting to look at the entanglem ent entropy of the optim al state. W hereas for the maximally entangled state E ()=logd = 1 for all values of d, in the case of the optim al state the entanglem ent entropy decreases with the dimension. As in the case of the minimal value of A_d () the entanglem ent entropy decreases slower than logarithm ically, but we are not able to give an asymptotic bound for it. This is contrary to work presented in [5], where the entanglem ent entropy seem ed to approach the asymptotic value $\lim_{d \le 1} E$ () = lnd 0:69 logd. Again, the disagreem ent is due to the fact that in the latter the quantity to be optimized was not the CGLMP inequality, but rather the Kullback-Leibler divergence.

From the insights gained in this section we state the following conjecture:

C on jecture (Q uantum Bell inequality). For d ! 1 the minimal value of P_Q ($A_2 < B_2$) + P_Q ($B_2 < A_1$) +

 P_Q ($A_1 < B_1$) + P_Q ($B_1 \quad A_2$) converges to zero, where the best m easurem ents for each d are the ones presented above, (4) and (5), and the optim alstates are of the form shown in Fig. 2. Hence,

$$P_Q (A_2 < B_2) + P_Q (B_2 < A_1) + P_Q (A_1 < B_1) + P_Q (B_1 - A_2) > 0$$

is a tight quantum Bell inequality for the 2 2 1 Bell setting.

The fact that the inequality seems to reach its minimalvalue given by the probability constraints as d! 1 also relates to recent results derived in [12] for a chained version of the CGLMP inequality.

Conclusion: A new version of the CGLMP inequality for the 2 2 d Bell scenario has been presented. Num erically, under the assumption that the num ber of outcom es is equal to the dimension of the H ilbert space D, the optim al states are not maxim ally entangled for d 3, though the best measurements with respect to those states are the same as for the maxim ally entangled state.

We investigated the maximal violation of this new inequality forvery large numbers of measurement outcomes and dimension of the Hilbert space. We analysed the speci c form of the best states and their entanglement entropy. It turned out that for increasing dimension the entanglement entropy of the optimal state decreases, agreeing with the observations made in [5, 6]. Interestingly, the numerics indicate that the maximal violation of the inequality tends, as the number of measurement outcomes and dimension of the Hilbert space tends to in nity, to the absolute bound imposed by the polytope of probability vectors. We conjectured from this a tight quantum Bell inequality for the 2 2 1 Bell scenario. An analytical proof of the tightness of this inequality is work in progress which will hopefully appear soon. 4

To justify the above assumption that the dimension of the Hilbert space D is equal to the number of possible outcom es d we also num erically analyzed the case of d < D. In particular, we obtained the minimal target value optimized over Schmidt coe cients and all possible com binations of degenerate m easurem ents $A_1; A_2; B_1; B_2$ for d= 2;3;4 with D = 5 and over random ly selected degenerate m easurem ents for d = 2;3;4;5 with D = 20. In all cases the sm allest obtained target values agreed with the corresponding m in in al target values obtained under the assumption that D = d as summarized in Table I up to an error of 10^{-3} . This gives strong evidence for the validity of the assumption that D = d and suggests that the m inim al target values obtained under this assum ption are also valid for the case of degenerate projective m easurements and POVM measurements which can always be realized as projective measurements on a higher-dimensional Hilbert space due to Naimark's theorem . Further, it strengthens the evidence that the optim al state for d > 2 is not maxim ally entangled beyond the analysis of [5, 6].
