#### Abstract

It is shown that the full unknown state of a spin $\frac{1}{2}$ system, $S$, which, with in B om's statistical interpretation, is $m$ eant as the state of an ensem ble of identically prepared system $s$ and is described by its density $m$ atrix, can be determ ined $w$ ith a sim ultaneous $m$ easurem ent $w$ ith the help of an \assistant" system $A$ whose in itial state is known. $T$ he idea is to let $S$ and $A$ interact w ith each other in a known way during a proper interaction time, to measure sim ultaneously two observables, one of $S$ and one of $A$ and their correlation. O ne thus determ ines the three unknown com ponents of the polarization vector of $S$ by $m$ eans of repeated experim ents using a unique setting. In this w ay one can $m$ easure sim ultaneously all the non-com m utative observables of $S$, which $m$ ight seem prohibited in quantum $m$ echanics.

## 1. Introduction

The determ ination of the unknow $n$ state of quantum system is one of the $m$ ost $i m$ portant issues in the eld of quantum inform ation. ${ }^{1,2} \mathrm{~T}$ his determ ination involves a m easurem ent process in which a m acroscopic system, apparatus, is coupled to the quantum system; during this process the state of both the apparatus and the system is $m$ odi ed. ${ }^{3}$ For instance, as currently described in $m$ any textbooks, the $z$-com ponent of the polarization vector of a spin $-\frac{1}{2}$ system, $S$, can statistically be determ ined by m eans of a repeated Stem-G erlach experim ent. In this process, the $x$ - and $y$-com ponent of the polarization vector are destroyed as a consequence of the non-com $m$ utation of the spin operator in the transversal directions. O ther experim ental settings seem therefore necessary to $m$ easure the unknow $n$ polarization vector of $S$. Its three com ponents are represented by incom patible observables, the $P$ auli operators, and their direct determ ination requires three $m$ acroscopic apparatuses, di ering by a change of orientation of the $m$ agnets and detectors. Likew ise, the state of any two-level system, represented by a $2 \quad 2$ density $m$ atrix ^ can be fully determ ined only through $m$ easurem ent of three linearly independent observ$a b l e s w h i c h ~ d o ~ n o t ~ c o m ~ m u t e ~ a n d ~ c a n n o t ~ b e ~ s i m ~ u l t a n e o u s l y ~ m ~ e a s u r e d . ~$ $N$ evertheless, wew illprove that the whole unknow $n$ density $m$ atrix of such a system
$S$, in particular the full polarization vector of a spin $-\frac{1}{2}$ system, can be determ ined indirectly by $m$ eans of a set of $m$ easurem ents perform ed sim ultaneously on $S$ and an auxiliary system, A, which we term the assistant. T he strategy is the follow ing: initially $S$ is in the unknown state that we wish to determ ine, while the assistant A is in som e known state. D uring som e tim e interval $S$ and $A$ interact in a known fashion. T heir joint state is m odi ed, involves correlations and keeps m em ory of the initial state of S.A sim ultaneousm easurem ent of one of the observables of S and A is then perform ed. Repeating this process provides then three statistical data: the expectation values of these observables and their correlation. W e w ill show that one can infer the three com ponents of the initialpolarization vector of $S$ from the three data.
There are tw o approaches to this problem. E ther using another tw o-level assistant, for solid state applications ${ }^{5}$ or using an electrom agnetic eld as an assistant, for quantum optics applications.
A fter de ning the general problem, we ilhustrate, in section 3, the rst approach, i.e. using another spin- $-\frac{1}{2}$ system as an assistant in a known pure state to determ ine the initial state of S. Then, in section 4, we show that it is also possible to use an electrom agnetic eld in a coherent state to determ ine the whole elem ents of the unknown density m atrix of $S$.

## 2. Statem ent of the $P$ roblem

The idea of $m$ apping the state ${ }^{\wedge}$ of an unknown spin $\frac{1}{2}$ system, $S$, onto a single observable of S+A system by using another system in a known state $\hat{R}, A$, was rst proposed by D 'A riano. ${ }^{4}$ It w as explicitly im plem ented in a dynam ic form in Ref. 5.

The state of the com posite system $S+A$, which is tested, is

where the initial state of $S+A$ is $\hat{R_{0}}=\hat{R} \quad \wedge$ and the evolution operator is $\hat{U}=e^{i \hat{H}}$. Therefore, the dynam ics of the system yields the required mixing of ${ }^{\wedge}$ and $\hat{R}$ and the sim plest possible non-degenerate observable of the com posite system S+A, ^, can be chosen as a factorized quantity
where the observable $\uparrow$ and $\delta$ pertain to $S$ and $A$ respectively. Then the spectral decom position of $\hat{\wedge}$ and $\delta$ can be used to construct the pro jection operator $\hat{P^{\wedge}}$ of ${ }^{\wedge}$

where $\hat{R}$ is de ned in (Eq. [1). In fact the num bers $P$ are the diagonal elem ents $\operatorname{of~}^{\mathrm{U}}{ }^{\mathrm{Y}}(\wedge \hat{R}) \hat{U}$ in the factorized basis which diagonalizes $\hat{\wedge}$ and $\theta$.
The whole elem ents of the density $m$ atrix $\wedge$ can be determ ined by the $m$ apping $\wedge!~ P$. Like the idea of nding a universal observable, ${ }^{4}$ if $\hat{H}$ couples $S$ and $A$ properly, this $m$ apping $w$ ill be expected to be invertible for $n m . W e$ shall see that even simple interactions can achieve this condition. For given observables $\uparrow$. of $S$ and $\delta$ ofA and for a know $n$ initialstate $\hat{R}$, the precision of this procedure relies on the ratio betw een the experim ental uncertainty of $P$ and the resulting uncertainty on $\wedge$, which can be characterized by the determ inant, , of the transform ation (5). For $=0$ it is im possible to determ ine ${ }^{\wedge}$ from $P$. This $m$ eans, the system is unstable $w$ ith respect to $s m$ allerrorsm ade during experim entaldeterm ination ofp or equivalently $\left(h^{\wedge}{ }_{z} i ; h \hat{S}_{z} i ; h \hat{S}_{z}{ }_{z} i\right)$. Therefore, the $H$ am iltonian $\hat{H}$ and tim e interval
should be chosen so as to $m$ axim ize j jover allpossible unitary transform ations.
3. Spin $-\frac{1}{2}$ A ssistant in a K now n P ure State

In this section we illustrate the above ideas by studying a two-level system $S$, nam ely, an spin $-\frac{1}{2}$ system in a known pure state. The density $m$ atrix of a spin $-\frac{1}{2}$ can be represented w th the help of $P$ aulim atrices. T he determ ination of ${ }^{\wedge}$ corresponds to determ ination of the elem ents of the polarization vector, ~. we let $S$ and $A$ interact during the tim e interval. The observables $\uparrow$ and $\delta$ to be $m$ easured are the $z$-com ponents of spin of $S$ and $A$ and are determ ined by ${ }_{z}$ and $s_{z}$ respectively. The projection operators are

If the unitary evolution operator $\hat{U}$ is such that vectors $N$ are not coplanar, the transform ation (Eq.7) is invertible and one can determ ine ~ from the set of $P$. A ltematively, ${ }^{\wedge}$ is deduced from $h \wedge_{z} i, h \hat{s}_{z} i$ and $h s_{z} \wedge_{z} i$ at time. The notation $\hat{S}_{2} \wedge_{z}$ is used for simplicity instead of $S_{z} \quad \hat{\mathrm{~A}}_{\mathrm{z}}$ which lives in the com $m$ on $H$ ibert space of $S$ and $A .{ }_{z}, S_{z}$ and $S_{z} \wedge_{z}$ can be sim ultaneously $m$ easured and are in one to one correspondence $w$ ith the set of probabilities $P$.
W e rst look for the upper bound of the determ inant of transform ation (Eq.7), $j$ jimplied by the conditions (Eq. 9). First we note that $j j$ increases $w i$ ith $j$ jfor each .W e therefore $m$ axim ize ${ }^{2}$ under the constraints

which gives directly the whole elem ents of the density $m$ atrix, ^, in term $s$ of the expectation values and the correlation of the commuting observables $\wedge_{z}$ and $s_{z}$ in the nalstate.
N ext step is to nd out the interaction Ham iltonian and the interaction tim e
which give such a description of the tested system, $S$.
This correspondence can be achieved under the action of the H am iltonian

The rst term in (Eq. 18) describes, in the spin language, an Ising coupling, while the second term represents a transverse $m$ agnetic eld acting on the assistant A.

## 4. A ssistant System as a C oherent State of Light

In this section we discuss the possibility of using light as an assistant to determ ine the elem ents of the density $m$ atrix of a spin $-\frac{1}{2}$ system. $W$ e show that in case ofusing an electrom agnetic eld in coherent state, one can determ ine the state of $S$ from the com $m$ utative $m$ easurem ents on $S$ and $A$.
To describe this physical situation we choose the Jaynes-C um mings model ${ }^{6,7}$ a $w$ idely accepted $m$ odeldescribing the interaction ofm atter (tw o-levelatom or spin$\frac{1}{2}$ system) and a single $m$ ode of radiation. This $m$ odel is exactly solvable but still rather non-trivial and it nds direct experim ental realization in quantum optics. The H am iltonian reads: ${ }^{6}$

the coupling constant. It can be easily checked that the interaction operator, $\hat{V}$, and the total num ber of excitations, $\hat{N}$ :

W e study the case in which the electrom agnetic eld is in a coherent state, a condition that coincides $w$ th the com $m$ on experim ental situation of a resonant laser $m$ ode interacting $w$ th a spin $-\frac{1}{2}$ system. A ssum ing initial factorization betw een $S$ and $A$, the density $m$ atrix of the total system $S+A$ at tim et=0, is:

A direct evaluation show sthat only the second choice produces a set of independent equations relating the $m$ easurem ents of the chosen com $m$ utating observables at tim et>0, after tuming on the interaction, and the state of the system $S$ at tim $e t=0.0$ nly in this case then, a reconstruction of the state of the spin $-\frac{1}{2}$ system at tim et=0 is possible. W e report here the details of the calculation only for this relevant choice of observables. W e have to calculate the expectation values of these three observables at tim et. In order to perform this calculation, we willm ake use of the eigenfunctions of the $\hat{V}$ operator, which are:

evaluated at a generic tim e t, to the variables $h^{\wedge}{ }_{x}(0) i ; h_{y}(0) i ; h_{z}(0) i$, i.e. to the density $m$ atrix of the spin $-\frac{1}{2}$ system at tim et=0. In order to assess if this system of equations has solutions, we have to evaluate the determ inant of the $m$ atrix $\hat{M}$ $m$ ade up by the coe cients of $h^{\wedge}{ }_{x}(0) i ; h^{\wedge}{ }_{y}(0) i ; h^{\wedge}(0) i$ appearing in the system of equations determ ined by the evaluation of (29). In order to achieve this goal, it is convenient to de ne $\hat{M}_{i j}=P_{n=0}^{1} \frac{e^{j j^{2} j j^{2 n}}}{n!} M_{i j}(n)$ and then determ ine the coe cients $M_{i j}(n) . N a m e A_{i j}(n)$ the sam e type of coe cients but relative to the $m$ atrix $\hat{A} m$ ade up by the coe cients $m$ ultiplying the variables $1 ; 2 ; 2$ in the system of equations (27). By replacing the de nitions of $f_{n} ; g_{n} ; S_{n}$ and then simplifying, one gets:

W e evaluate this determ inant num erically. C onvergence within the seventh signi cant gure is reached by keeping in each of the three sum s the rst 30 term swhen j f 9.For larger values of j f convergence tums out to be m uch slow er. In Fig. 1 the tem poral evolution of the determ inant is shown. W e see that as $j$ j increases, i.e. for larger average num ber of photons, the determ inant has uctuations of larger
am plitude, so that a tim ewith a large enough determ inant can be chosen to solve for the initial state of the spin $-\frac{1}{2}$ system. W hen the $m$ atrix elem ents are determ ined w ith som e experim ental uncertainty such a choice is a sensible one that allow s a $m$ ore accurate determ ination of the initial state of the spin $-\frac{1}{2}$ system and avoids cases of ill-conditioned $m$ atrix inversion.

## 5. C onclusions

W e have illustrated a procedure which allow s to reconstruct the state of a spin $\frac{1}{2}$ system w ith a sim ultaneous $m$ easurem ent of the expectation values of three com m uting observables, by coupling the system to an assistant. W e have also illustrated how the procedure works in the sim ple case of a spin $-\frac{1}{2}$ system coupled to a coherent laser eld.W e have show $n$ that in this case, after a proper choice of the com $m$ uting observables, it is alw ays possible to reconstruct the in itialstate of the spin $-\frac{1}{2}$ system . A radiation source w th a large average num ber of photons allow s to im plem ent the procedure in an experim entally reliable condition, i.e. w th a large absolute value of the determ inant of the $m$ atrix connecting the expectation values of the com $m$ uting observables at tim e $t$ to the initial state of the spin $-\frac{1}{2}$ system .
