SIM ULTANEOUS MEASUREMENT OF NON-COMMUTING OBSERVABLES

It is shown that the full unknown state of a spin $\frac{1}{2}$ system, S, which, within Born's statistical interpretation, is meant as the state of an ensemble of identically prepared systems and is described by its density matrix, can be determ ined with a simultaneous measurement with the help of an \assistant" system A whose initial state is known. The idea is to let S and A interact with each other in a known way during a proper interaction time , to measure simultaneously two observables, one of S and one of A and their correlation. One thus determ ines the three unknown components of the polarization vector of S by means of repeated experiments using a unique setting. In this way one can measure simultaneously all the non-commutative observables of S, which might seem prohibited in quantum mechanics.

1. Introduction

The determ ination of the unknown state of a quantum system is one of the most im portant issues in the eld of quantum information.^{1,2} This determ ination involves a measurement process in which a macroscopic system, apparatus, is coupled to the quantum system; during this process the state of both the apparatus and the system is modied.³ For instance, as currently described in many textbooks, the z-component of the polarization vector of a spin $\frac{1}{2}$ system, S, can statistically be determ ined by means of a repeated Stern-Gerlach experiment. In this process, the x- and y-component of the polarization vector are destroyed as a consequence of the non-commutation of the spin operator in the transversal directions. O ther experim ental settings seem therefore necessary to measure the unknown polarization vector of S. Its three components are represented by incompatible observables, the Pauli operators, and their direct determ ination requires three m acroscopic apparatuses, di ering by a change of orientation of the magnets and detectors. Likewise, the state of any two-level system, represented by a 2 2 density matrix ^ can be fully determ ined only through m easurem ent of three linearly independent observables which do not commute and cannot be simultaneously measured.

N evertheless, we will prove that the whole unknown density matrix of such a system

S, in particular the full polarization vector of a spin $\frac{1}{2}$ system, can be determined indirectly by means of a set of measurements performed simultaneously on S and an auxiliary system, A, which we term the assistant. The strategy is the following: initially S is in the unknown state that we wish to determine, while the assistant A is in some known state. During some time interval S and A interact in a known fashion. Their joint state is modied, involves correlations and keeps mem ory of the initial state of S.A simultaneous measurement of one of the observables of S and A is then performed. Repeating this process provides then three statistical data: the expectation values of these observables and their correlation. W e will show that one can infer the three components of the initial polarization vector of S from the three data.

There are two approaches to this problem . Either using another two-level assistant, for solid state applications⁵ or using an electrom agnetic eld as an assistant, for quantum optics applications.

A fter de ning the general problem, we illustrate, in section 3, the rst approach, i.e. using another $spin-\frac{1}{2}$ system as an assistant in a known pure state to determ ine the initial state of S. Then, in section 4, we show that it is also possible to use an electrom agnetic eld in a coherent state to determ ine the whole elements of the unknown density matrix of S.

2. Statem ent of the P roblem

The idea of mapping the state $^{\circ}$ of an unknown spin $\frac{1}{2}$ system, S, onto a single observable of S+A system by using another system in a known state \hat{R} , A, was not proposed by D'A riano.⁴ It was explicitly in plemented in a dynamic form in Ref. 5.

The state of the composite system S + A, which is tested, is

where the initial state of S + A is $\hat{R_0} = \hat{R}$ ^ and the evolution operator is $\hat{U} = e^{-i\hat{H}}$. Therefore, the dynamics of the system yields the required m ixing of ^ and \hat{R} and the sim plest possible non-degenerate observable of the composite system S+A, ^, can be chosen as a factorized quantity

where the observable \uparrow and \Diamond pertain to S and A respectively. Then the spectral decomposition of \uparrow and \Diamond can be used to construct the projection operator P^{\uparrow} of \uparrow

where \hat{p}_a and $\hat{}_i$ are eigen projectors of the observables $\hat{\sigma}$ and $\hat{}$ respectively. Therefore, projection operator \hat{P} with (i; a) takes the form

where \hat{R} is defined in (Eq. 1). In fact the numbers P are the diagonal elements of \hat{U}^{γ} (^ \hat{R}) \hat{U} in the factorized basis which diagonalizes \uparrow and \hat{O} .

The whole elements of the density matrix ^ can be determined by the mapping ^ ! P . Like the idea of nding a universal observable,⁴ if \hat{H} couples S and A properly, this mapping will be expected to be invertible for n m.We shall see that even simple interactions can achieve this condition. For given observables ? of S and ô of A and for a known initial state \hat{K} , the precision of this procedure relies on the ratio between the experimental uncertainty of P and the resulting uncertainty on ^, which can be characterized by the determinant, , of the transformation (5). For = 0 it is impossible to determine ^ from P . This means, the system is unstable with respect to smallerrorsmade during experimental determination of P or equivalently ($n_z^{-1};hs_z^{-1};hs_z^{-1};n$). 3. Spin $\frac{1}{2}$ A ssistant in a K now n P ure State

In this section we illustrate the above ideas by studying a two-level system S, namely, an spin- $\frac{1}{2}$ system in a known pure state. The density matrix of a spin- $\frac{1}{2}$ can be represented with the help of Paulim atrices. The determination of ^ corresponds to determination of the elements of the polarization vector, ~.we let S and A interact during the time interval . The observables \uparrow and \diamond to be measured are the z-components of spin of S and A and are determined by $^{2}_{z}$ and s_{z} respectively. The projection operators are

If the unitary evolution operator \hat{U} is such that vectors v are not coplanar, the transformation (Eq. 7) is invertible and one can determine ~ from the set of P . A lternatively, ^ is deduced from h^_i, hs_zi and hs_z^_i i at time . The notation f_z^{a} is used for simplicity instead of f_z^{a} ^_ which lives in the common H ilbert space of S and A . ^_z, s_z and s_z^z can be simultaneously measured and are in one to one correspondence with the set of probabilities P .

We rst look for the upper bound of the determ inant of transform ation (Eq. 7), jjim plied by the conditions (Eq. 9). First we note that jjincreases with $\frac{1}{2}$ jfor each .We therefore maximize ² under the constraints

Having a non-zero determ inant for the proposed procedure, ensures its feasibility. One simple choice for vectors \mathbf{v} is

of \hat{H} can be obtained by a rotation of \hat{S} and also achieves an optim alm apping ^ ! P , provided \hat{s}_z ! $\hat{s}_x \sin + \hat{s}_z \cos$ both in the measured projections $\hat{p}_a = 1=2(1 \quad \hat{s}_z)$ and in the initial state $\hat{R} = \hat{p}_+$. The rst term in (Eq. 18) describes, in the spin language, an Ising coupling, while the second term represents a transverse magnetic eld acting on the assistant A.

4. A ssistant System as a Coherent State of Light

In this section we discuss the possibility of using light as an assistant to determ ine the elements of the density matrix of a spin $\frac{1}{2}$ system .We show that in case of using an electrom agnetic eld in coherent state, one can determ ine the state of S from the commutative measurements on S and A.

To describe this physical situation we choose the Jaynes-Cummings model^{6,7} a widely accepted model describing the interaction of matter (two-level atom or spin- $\frac{1}{2}$ system) and a single mode of radiation. This model is exactly solvable but still rather non-trivial and it nds direct experimental realization in quantum optics. The H am iltonian reads:⁶

where \hat{A}^{y} and \hat{a} are the standard photon creation and annihilation operators of the eld (the assistant A), with commutation relation $[\hat{a}; \hat{a}^{y}] = 1$, \hat{a}_{i} are the standard Paulim atrices for the spin of the two level system S. The total H am iltonian (19) is the sum of the H am iltonian of the eld \hat{H}_{A} , the H am iltonian \hat{H}_{S} of the two level system S and the interaction H am iltonian \hat{H}_{SA} which can be written as \hat{V} , with

the coupling constant. It can be easily checked that the interaction operator, \hat{V} , and the total num ber of excitations, $\hat{N:}$

are two constants of motion. \hat{V} and \hat{N} also commute with each other since $\hat{V}^2 = \hat{N}$.

One can then calculate exactly the relevant observables at time t using the Heisenberg equations of motion:

W e will brie y outline the result. The exact solution of the above set of equations reads:

We study the case in which the electrom agnetic eld is in a coherent state, a condition that coincides with the common experimental situation of a resonant laser mode interacting with a spin $\frac{1}{2}$ system. A ssum ing initial factorization between S and A, the density matrix of the total system S+A at time t = 0, is:

where jki denotes the ket for the photon quanta and j f is the average photon number in the coherent state.

W e consider as possible triplets of com muting observables the following:

but others com binations are possible. A direct evaluation shows that only the second choice produces a set of independent equations relating the m easurements of the chosen commutating observables at time t > 0, after turning on the interaction, and the state of the system S at time t = 0.0 nly in this case then, a reconstruction of the state of the spin $\frac{1}{2}$ system at time t = 0 is possible. We report here the details of the calculation only for this relevant choice of observables. We have to calculate the expectation values of these three observables at time t. In order to perform this calculation, we will make use of the eigenfunctions of the \hat{V} operator, which are:

evaluated at a generic time t, to the variables $h_x(0)i;h_y(0)i;h_z(0)i$, i.e. to the density matrix of the spin- $\frac{1}{2}$ system at time t = 0. In order to assess if this system of equations has solutions, we have to evaluate the determ inant of the matrix \hat{M} made up by the coe cients of $h_x(0)i;h_y(0)i;h_z(0)i$ appearing in the system of equations determ ined by the evaluation of (29). In order to achieve this goal, it is convenient to de ne $\hat{M}_{ij} = \prod_{n=0}^{P} \prod_{n=0}^{1} \frac{e^{j \cdot j^2 j \cdot j^{2n}}}{n!} M_{ij}(n)$ and then determ ine the coe – cients $M_{ij}(n)$. Name $A_{ij}(n)$ the same type of coe cients but relative to the matrix \hat{A} made up by the coe cients multiplying the variables __1; _2; __2 in the system of equations (27). We evaluate this determ inant num erically. Convergence within the seventh signi – cant gure is reached by keeping in each of the three sums the rst 30 term s when $j \neq 0$. For larger values of $j \neq 0$ convergence turns out to be much slower. In Fig. 1 the tem poral evolution of the determ inant is shown. We see that as $j \neq 1$ increases, i.e. for larger average num ber of photons, the determ inant has uctuations of larger

am plitude, so that a time with a large enough determ inant can be chosen to solve for the initial state of the spin $\frac{1}{2}$ system .W hen the matrix elements are determined with some experimental uncertainty such a choice is a sensible one that allows a more accurate determination of the initial state of the spin $\frac{1}{2}$ system and avoids cases of ill-conditioned matrix inversion.

5. Conclusions

We have illustrated a procedure which allows to reconstruct the state of a spin $\frac{1}{2}$ system with a simultaneous measurement of the expectation values of three commuting observables, by coupling the system to an assistant. We have also illustrated how the procedure works in the simple case of a spin $\frac{1}{2}$ system coupled to a coherent laser eld. We have shown that in this case, after a proper choice of the commuting observables, it is always possible to reconstruct the initial state of the spin $\frac{1}{2}$ system. A radiation source with a large average number of photons allows to implement the procedure in an experimentally reliable condition, i.e. with a large absolute value of the determinant of the matrix connecting the expectation values of the commuting observables at time t to the initial state of the spin $\frac{1}{2}$ system.
