# P hase C ontrolled C ontinuously Entangled Two-P hoton Laser with D ouble Schem e

#### Abstract

W e show that an absolute coherent phase of a laser can be used to $m$ anipulate the entanglem ent of photon pairs of two-photon laser. Our focus is on the generation of a continuous source of entangled photon pairs in the double (or Ram an) schem e. W e study the dependence of steady state entanglem ent on the phase and laser param eters. W e obtain a relationship between entanglem ent and two-photon correlation. W e derive conditions that give steady state entanglem ent for the Ram an EIT scheme and use it to identify region of steady state $m$ acroscopic entanglem ent. N o entanglem ent is found for the double resonant $R$ am an schem $e$ for any laser param eters.

## I. IN TRODUCTION

E ntangled photon pairs is an integralasset to quantum com $m$ unication technology with continuous variables [1]. A bright source ofentangled photon pairs could be useful also forquantum lithography [2]. Transient entanglem ent of a large num ber of photon pairs has been show $n$ to exist for cascade schem e [3], [4], and double $R$ am an schem e [5]. The transient regim e does not provide a continuous source of entangled photon pairs that could be as useful and practical as typical lasers in c. w. operation. O ne $m$ ight w onder whether the entanglem ent still survives in the long time lim it.

In this paper, we use the coherent phase of the controlling lasers to generate a large num ber ( $m$ acroscopic) of entangled photon pairs in the steady state. This also shows the possibility of coherently controlling entangle$m$ ent in the steady state. $W$ e focus on the $R$ am an E IT schem e ( F ig. [1]) that has been show $n$ to produce nonclassically correlated photon pairs in single atom and $m$ any atom $s$ cases.

F irst, we discuss the physics of a tw o-photon em ission laser using the $m$ aster equation in Section II. The physical signi cance of each term in the $m$ aster equation is elaborated and related to the quantities of interests (in Section III) such as two-photon correlation and Duan's [6] entanglem ent $m$ easure. In Section $\mathbb{I V}$, we show the im portance of laser phase for acquiring entanglem ent. In Section $V$, the steady state solutions for the photon num bers and correlation betw een photon pairs are given. W e show that the laser phase provides a usefulknob for controlling entanglem ent. W e then use the results to derive a condition for entanglem ent in the double Ram an schem e. By using proper values of cavity dam ping and laser param eters based on analysis of the condition, we obtain $m$ acroscopic num ber of entangled photon pairs in the steady state. W e also analyze the double resonant Ram an schem ebut nd no entanglem ent.

## II. PHYSICSOFTWOPHOTON LASER

For sim plicity, we consider single atom localized in the doubly resonant cavity. U sing the usual approach [7] we obtain the $m$ aster equation

$N$ ote that Eq. (11) generalizes the $m$ aster equation for the cascade schem e [8] in which $C_{3}=C_{\text {gain } 2}=0$, and $\mathrm{C}_{\text {lossj }}=$ j.

The $C_{\text {gain }}$ are due to the em issions processes of the atom in the excited levels and $R$ am an process via the laser elds which provide gain. On the other hand, the $\mathrm{C}_{\text {lossj }}$ are due to cavity dissipation $j$ and absonption processes of the atom in the ground levels which create loss. $T$ he $C_{k}$ coe cients correspond to squeezing. Each term gives the coherence betw een $n_{j}$ and $n_{j} \quad 1$ such that the di erence between the total photon number in the bra and in the ket is alw ays 2. Figure 1] ilhustrates in twodim ensional photon num ber space the essence of each diagonalterm in Eq. (1).

The consequence of this relation is that for large number of photons $n_{j} \gg 1$, the coherences due to $\hat{a}_{2} \wedge \hat{a}_{1} ; \wedge \hat{a}_{1} \hat{a}_{2} ; \hat{a}_{1} \wedge \mathrm{a}_{2} ; \hat{a}_{1} \hat{a}_{2} \wedge$ and their adjoint are approxi$m$ ately equal. H ence, the contribution of the o-diagonal term $s$ vanish and the $m$ aster equation reduces to the rate equation. Since the o-diagonal term $s$ give rise to entanglem ent (as we show below), we can understand that there $w$ ill be no entanglem ent for very large $n_{j}$.
III. RELATION BETWEEN ENTANGLEMENT AND TWOPHOTON CORRELATION

Two-photon correlation for Ram an em ission doublet (RED) (large detuning and weak pum p) version of the double Ram an schem e for single atom [9] and extended m edium [10], [1]] show nonclassicalproperties such as antibunching and violation of $C$ auchy-Schw arz inequality.

It is usefult to show how the nonclassical correlation relates to entanglem ent. T he norm alized two-photon correlation at zero tim e delay is

W e shallconsider the vacuum state, in which they vanish. C learly, the presence of inseparability or entanglem ent is entirely determ ined by the phase 21 in Eq. (6). W e now nd the knob to control entanglem ent, i.e. cos 21 m ust be negative or $=2<21<3=2$.

The condition for inseparability or entanglem ent $0<(\hat{u})^{2}+(\hat{v})^{2}<2$ can be re-expressed in term $s$ of the phase and the two-photon correlation

N ote that for photon antibunching $g^{(2)} \& 1$ the entanglem ent $w$ indow for 21 can be quite large, provided $\mathrm{n}_{1} ; \mathrm{n}_{2}$ are sm all too.

In the lim it of large two-photon correlation (photon bunching) $\mathrm{g}^{(2)} \gg 1$ and large photon num bers $\mathrm{n}_{1} ; \mathrm{n}_{2} \gg 1$ the range for entanglem ent becom es quite restrictive. Here, cos 21 , $\mathrm{p} \frac{1}{\mathrm{~g}^{(2)} 1}$ becom es very sm all in $m$ agnitude (but negative) and from Eq. (6), D (t) . 2 the entanglem ent is $s m$ all. This explains the results in Fig. 2 where large transient correlation is accom panied by sm allentanglem ent.

In the long time lim it Fig. 2 shows that the correlation vanishes (corresponds to antibunching) and there
is entanglem ent, $\mathrm{D} \ll 2$. Thus, both the antibunching and entanglem ent are com patible quantum mechanical properties since they $m$ anifest in the sam e way. Duan's entanglem ent increases with time while the correlation decreases w ith tim e, thus both do not vary in the sam e way. This clearly show s that correlation should be discemed from entanglem ent. H ow ever, as expected, the decoherence bc tends to reduce the degree of entangle$m$ ent and the $m$ agnitude of correlation.

## IV. LASER PHASE FOR ENTANGLEMENT

Here, we show by using sim ple exam ple from the resonant cascolew ork off an et. al. [3] that the nonzero phase of the paired correlation $h \hat{a}_{1} \hat{a}_{2} i$ is necessary for entanglem ent. Let us analyze the transient equation (w ritten in their notations w th zero laser phase)

V. STEADY STATEENTANGLEMENT

The $m$ aster equation (1) is linear and do not include saturation. O nem ight w onder w hether steady state solutions. W e nd that there are steady state solutions w hen
the photon num bers $\mathrm{n}_{\mathrm{j}}$ do not increase inde nitely. $\mathrm{Pa-}$ ram eters that give non steady state solutions $m$ anifest as negative value of $D$ and should be disregarded. The study of entanglem ent via nonlinear theory will be published elsew here.

From Eq. (11), the necessary condition for entangle$m$ ent is $E e^{i}+E e^{i}<\left(n_{1}+n_{2}\right)$. If $E$ is realpositive there would be no entanglem ent in the region cos $>0$. Entanglem ent is still possible even if $=0$ provided realfe $\mathrm{g}<0$. Thus, the phase is not necessary for entanglem ent, but it provides an extra knob for controlling entanglem ent.

Let us search for entanglem ent conditions for the lim iting cases of $R$ am an EIT (REIT) schem ewhich produces nonclassically correlated photon pairs, and the double resonant $R$ am an ( $D R R$ ) schem e.

## A. Ram an EIT regim e

To obtain large entanglem ent, we tune the cavity dam ping such that $j$ a s $\quad C_{2} C_{2} j$ is sm all and $\sin t \quad 1$. $N$ ote that the sign of the detuning in Eq. (24) is im portant for entanglem ent generation. W e can arrange the signs of these quantities such that $E q_{p}(28)$ is satis ed.

Figure 3 is plotted using $a=s=\overline{1: 01\left(C_{2} C_{2}\right)}$ and $=40$ ac for $\mathrm{t} \quad 90^{\circ}$. We nd that the region c gives a large entanglem ent, but the photon num bers are m inim um. This prevents having a steady state m acroscopic entanglem ent. W e verify that if we change to a negative detuning $=40$ ac there is no entanglem ent. The region of $m$ axim um entanglem ent occur around
$=90^{\circ}$. Entanglem ent can occur at a wide range of large $c$. H ow ever, the photon num bers $n_{j}$ decrease $w$ ith the increase of $c$.

Figure 4 show s that it is possible to obtain a continuous bright source of entangled photons. $W$ e realize that the num ber of nonclassical photon pairs in RE IT schem e is lim ited by the weak pump eld. Thus, by increasing the pum $p$ eld we can generate $m$ ore Stokes photons ( F ig. 4a). At the sam e tim e, the detuning is increased as well to ensures that the scheme rem ain in the nonclassical $R$ am an E IT regim e. By applying the derived condition Eq. (28) we further obtained a larger num ber of entangled photon pairs (Fig. 4b).

## B. Resonant C ase

It seem $s$ that steady state entanglem ent in the double resonant $R$ am an case ( $c=p$; $c=p=0$ ) is hardly possible. In the follow ing, we investigate this analytically. In the weak eld regim e, the cavity dam ping has to be su ciently large to ensure the existence of steady state solutions, i.e. $>g^{2}=2$. If the cavity dam ping is $s m$ all $<g^{2}=2$, regions $w$ ith negative values of $D$ and $n_{j}$ would appear which re ect the non-steady state regim e.

Thus, we have show $n$ that there is no steady state entanglem ent for DRR scheme in both weak and strong elds regim es. This is com patible w ith its classical tw ophoton correlation $G{ }^{(2)}$ [13]. H ow ever, the REIT photon pairs, which are nonclassically correlated, are also entangled in the steady state.

## VI. CONCLUSION

W e have shown that two-photon laser can produce a continuous source of entangled photon pairs based on the steady state solutions and an entanglem ent criteria. W e have obtained a relationship betw een entangle$m$ ent and two-photon correlation, and nd that both do not vary w ith time in the sam e m anner. W e have derived a condition for steady state entanglem ent in the Ram an EIT (REIT) schem es and showed that steady state $m$ acroscopic entanglem ent is possible. W e nd that a large steady state entanglem ent occurs at the expense of $s m$ aller photon num bers. $W$ e show ed that the double resonant $R$ am an ( $D R R$ ) does not generate steady state entangled photon pairs for any laser param eters.
