# Phase Controlled Continuously Entangled Two-Photon Laser with Double Scheme

W e show that an absolute coherent phase of a laser can be used to manipulate the entanglem ent of photon pairs of two-photon laser. Our focus is on the generation of a continuous source of entangled photon pairs in the double (or R am an) scheme. We estudy the dependence of steady state entanglem ent on the phase and laser parameters. We obtain a relationship between entanglem ent and two-photon correlation. We derive conditions that give steady state entanglem ent for the R am an EIT scheme and use it to identify region of steady state macroscopic entanglem ent. N o entanglem ent is found for the double resonant R am an scheme for any laser parameters.

#### I. IN TRODUCTION

Entangled photon pairs is an integral asset to quantum communication technology with continuous variables [1]. A bright source of entangled photon pairs could be useful also for quantum lithography [2]. Transient entanglement of a large number of photon pairs has been shown to exist for cascade scheme [3], [4], and double R am an scheme [5]. The transient regime does not provide a continuous source of entangled photon pairs that could be as useful and practical as typical lasers in c. w. operation. One m ight wonder whether the entanglement still survives in the long time limit.

In this paper, we use the coherent phase of the controlling lasers to generate a large number (m acroscopic) of entangled photon pairs in the steady state. This also shows the possibility of coherently controlling entanglement in the steady state. We focus on the Ram an-EIT scheme (Fig. 1a) that has been shown to produce nonclassically correlated photon pairs in single atom and many atoms cases.

First, we discuss the physics of a two-photon em ission laser using the master equation in Section II. The physical signi cance of each term in the master equation is elaborated and related to the quantities of interests (in Section III) such as two-photon correlation and Duan's [6] entanglem ent measure. In Section IV, we show the im portance of laser phase for acquiring entanglem ent. In Section V, the steady state solutions for the photon num bers and correlation between photon pairs are given. We show that the laser phase provides a useful knob for controlling entanglement. We then use the results to derive a condition for entanglem ent in the double R am an scheme. By using proper values of cavity dam ping and laser parameters based on analysis of the condition, we obtain m acroscopic num ber of entangled photon pairs in the steady state. W e also analyze the double resonant Ram an scheme but nd no entanglem ent.

#### II. PHYSICS OF TW O-PHOTON LASER

For simplicity, we consider single atom localized in the doubly resonant cavity. Using the usual approach [7] we obtain the master equation

phase becomes  $'_t = _p + _c = .$  The explicit expressions for C<sub>lossj</sub>, C<sub>gainj</sub> and C<sub>k</sub> (where j=1,2 and k=1,2,3,4) are given in Appendix A.

Equation (1) already includes the cavity damping Liouvillean  $L^{+} = {}_{j}fa_{j}^{y}a_{j}^{+} + a_{j}^{y}a_{j}^{-} 2a_{j}^{+}a_{j}^{y}g$ . We  ${}_{j=1,2}^{j=1,2}$  nd that the relation holds

Note that Eq. (1) generalizes the master equation for the cascade scheme [8] in which  $C_3 = C_{gain2} = 0$ , and  $C_{lossj} = \frac{1}{2}$ .

The  $C_{gainj}$  are due to the emissions processes of the atom in the excited levels and Ram an process via the laser elds which provide gain. On the other hand, the  $C_{lossj}$  are due to cavity dissipation  $_j$  and absorption processes of the atom in the ground levels which create loss. The  $C_k$  coe cients correspond to squeezing. Each term gives the coherence between  $n_j$  and  $n_j$  1 such that the di erence between the total photon number in the bra and in the ket is always 2. Figure 1b illustrates in two-dimensional photon number space the essence of each diagonal term in Eq. (1).

The consequence of this relation is that for large number of photons  $n_j >> 1$ , the coherences due to  $a_2 \ a_1; \ a_1a_2; a_1 \ a_2; a_1a_2 \ and their adjoint are approximately equal. Hence, the contribution of the o -diagonal term s vanish and the master equation reduces to the rate equation. Since the o -diagonal term s give rise to entanglement (as we show below), we can understand that there will be no entanglement for very large <math>n_1$ .

# III. RELATION BETW EEN ENTANGLEMENT AND TWO-PHOTON CORRELATION

Two-photon correlation for Ram an emission doublet (RED) (large detuning and weak pump) version of the double Ram an scheme for single atom [9] and extended medium [10],[11] show nonclassical properties such as antibunching and violation of Cauchy-Schwarz inequality. It is useful to show how the nonclassical correlation relates to entanglem ent. The norm alized two-photon cor-

W e shall consider the vacuum state, in which they vanish. C learly, the presence of inseparability or entanglement is entirely determined by the phase  $_{21}$  in Eq. (6). We now not the knob to control entanglement, i.e.  $\cos_{21}$  must be negative or  $=2 < _{21} < 3 = 2$ .

The condition for inseparability or entanglement  $0 < (t)^2 + (t)^2 < 2$  can be re-expressed in terms of the phase and the two-photon correlation

where the lower limit corresponds to maximum entanglement. The midpoint value  $\cos_{21} = \frac{p_1^{n_1+n_2+1=2}}{2}$ gives D (t) = 1. When  $n_1 = n_2$ , we have  $\frac{p_1^{1+1=2n}}{q^{(2)} 1} < \cos_{21} < \frac{p_1^{1}}{q^{(2)} 1}$ . Note that for photon antibunching  $q^{(2)}$  & 1 the entanglement window for  $_{21}$  can be quite large, provided  $n_1; n_2$  are small too.

In the limit of large two-photon correlation (photon bunching)  $g^{(2)} >> 1$  and large photon numbers  $n_1;n_2 >> 1$  the range for entanglement becomes quite restrictive. Here, cos  $_{21}$  '  $\frac{p-1}{g^{(2)}-1}$  becomes very small in magnitude (but negative) and from Eq. (6), D (t) . 2 the entanglement is small. This explains the results in Fig. 2 where large transient correlation is accompanied by small entanglement.

In the long time limit Fig. 2 shows that the correlation vanishes (corresponds to antibunching) and there is entanglem ent, D << 2. Thus, both the antibunching and entanglem ent are compatible quantum mechanical properties since they manifest in the same way. Duan's entanglem ent increases with time while the correlation decreases with time, thus both do not vary in the same way. This clearly shows that correlation should be discerned from entanglem ent. However, as expected, the decoherence  $_{\rm bc}$  tends to reduce the degree of entanglem ent and the magnitude of correlation.

### IV. LASER PHASE FOR ENTANGLEMENT

Here, we show by using simple example from the resonant casedework of H an et. al. [3] that the nonzero phase of the paired correlation  $ha_1a_2$  is necessary for entanglement. Let us analyze the transient equation (written in their notations with zero laser phase)

which gives maximum entanglement when = = 2 or 3 = 2, and no entanglement when = 0.

### V. STEADY STATE ENTANGLEMENT

The master equation (1) is linear and do not include saturation. One m ight wonder whether steady state solutions. We nd that there are steady state solutions when the photon numbers  $n_j$  do not increase inde nitely. Param eters that give non steady state solutions manifest as negative value of D and should be disregarded. The study of entanglement via nonlinear theory will be published elsewhere.

From Eq. (11), the necessary condition for entanglem ent is  $Ee^i + Ee^i < (n_1 + n_2)$ . If E is realpositive there would be no entanglem ent in the region  $\cos > 0$ . Entanglem ent is still possible even if = 0 provided realf Eg< 0. Thus, the phase is not necessary for entanglem ent, but it provides an extra knob for controlling entanglem ent.

Let us search for entanglem ent conditions for the lim iting cases of R am an-E II (REII) scheme which produces nonclassically correlated photon pairs, and the double resonant R am an (D R R) scheme.

#### A. Raman-EIT regime

For negative detuning < 0, there are two possibilities: a) if  $a \le 2^2$  entanglement occurs in the region  $\frac{a \le 2}{(s + a)} 2 \sin t >$ , b) if  $a \le 2^2$  we have entanglement in  $\frac{a \le 2}{(s + a)} 2 \sin t <$ . Similarly, for positive detuning > 0: a) if  $a \le 2^2$  then we need >  $\frac{a \ s}{(s+a)} 2 \sin t$  and b) if  $a \ s$  > <sup>2</sup> then we need <  $\frac{a \ s}{(s+a)} 2 \sin t$ .

To obtain large entanglement, we tune the cavity damping such that  $j_{a} \ _{s} \ C_{2}C_{2}j$  is smalland sin t 1. Note that the sign of the detuning in Eq. (24) is important for entanglement generation. We can arrange the signs of these quantities such that Eq. (28) is satisfied.

Figure 3 is plotted using  $a = s = \frac{1}{1.01} (C_2 C_2)$  and  $= 40_{ac}$  for  $t = 90^{\circ}$ . We not that the region c gives a large entanglement, but the photon numbers are minimum. This prevents having a steady state m acroscopic entanglement. We verify that if we change to a negative detuning  $= 40_{ac}$  there is no entanglement.

The region of maximum entanglement occur around  $= 90^{0}$ . Entanglement can occur at a wide range of large c. However, the photon numbers  $n_{j}$  decrease with the increase of c.

Figure 4 shows that it is possible to obtain a continuous bright source of entangled photons. We realize that the num ber of nonclassical photon pairs in REIT scheme is limited by the weak pump eld. Thus, by increasing the pump eld we can generate more Stokes photons (Fig. 4a). At the same time, the detuning is increased as well to ensures that the scheme remain in the nonclassical Raman-EIT regime. By applying the derived condition Eq. (28) we further obtained a larger num ber of entangled photon pairs (Fig. 4b).

### B. Resonant Case

It seems that steady state entanglement in the double resonant Raman case ( $_{c} = _{p}$ ;  $_{c} = _{p} = 0$ ) is hardly possible. In the following, we investigate this analytically. Here, we nd  $C_{ac;ac}$ ;  $C_{ac;bc}$ ;  $C_{bd;ac}$ ;  $C_{bd;bd}$  are real and positive while  $C_{ac;ad}$ ;  $C_{ac;bc}$ ;  $C_{bd;ad}$ ;  $C_{bd;bc}$  are purely in aginary (positive or negative). Since  $p_{cd} =$

In order to determ ine whether Eq. (31) can be met we consider a simpler case where  $_{bc} = 0$ . For strong eld,  $p_{cc}$  '  $p_{aa} = 0.25$ . The steady solutions become  $n_1 = n_2 = \frac{q^2}{8}$ ,  $ha_1a_2i = \frac{q^2}{8}e^{i_t}$  and  $D = 2(1 + \frac{q^2}{2}\sin^2\frac{1}{2}t)$ , i.e. no entanglement.

For weak eld,  $p_{cc}$  ' 0.5;  $p_{aa}$  ' 0. The steady solutions are  $n_1 = n_2 = \frac{q^2}{4} - \frac{1}{\frac{q^2}{2}}$ ,  $ha_1 a_2 i = \frac{q^2}{4} - \frac{e^i t}{\frac{q^2}{2}}$  with  $> \frac{q^2}{2}$ and hence  $D = 2(1 + \frac{2q^2}{g^2} \sin^2 \frac{1}{2}t)$ , again no entanglement. In the weak eld regime, the cavity dam ping has to be su ciently large to ensure the existence of steady state solutions, i.e.  $> q^2=2$ . If the cavity dam ping is small  $< q^2=2$ , regions with negative values of D and  $n_j$  would appear which reject the non-steady state regime.

Thus, we have shown that there is no steady state entanglement for DRR scheme in both weak and strong elds regimes. This is compatible with its classical twophoton correlation G<sup>(2)</sup> [13]. However, the REIT photon pairs, which are nonclassically correlated, are also entangled in the steady state.

## VI. CONCLUSION

We have shown that two-photon laser can produce a continuous source of entangled photon pairs based on the steady state solutions and an entanglement criteria. We have obtained a relationship between entanglement and two-photon correlation, and nd that both do not vary with time in the same manner. We have derived a condition for steady state entanglement in the Raman-EIT (REII) schemes and showed that steady state macroscopic entanglement is possible. We nd that a large steady state entanglement occurs at the expense of sm aller photon num bers. We showed that the double resonant Raman (DRR) does not generate steady state entangled photon pairs for any laser parameters.
