W hat happens to spin during the SO (3) ! SE (2) contraction?

A $s$ is known, a Lie algebra of a little group of a tim elike four vector is not equal to so (3) unless spacelike com ponents of the vector vanish. In spite of th is fact the algebra can still be interpreted as the angular $m$ om entum algebra, as can be shown w ith the explicit exam ple of the $D$ irac equation. T he angularm om entum corresp onds to the even part of the $D$ irac spin operator. Its eigenvalues in directions penpendicular to m om entum decay to zero in the in nite m om entum $/ \mathrm{m}$ assless lim it. This explains physically why only extrem al helicities survive the $m$ assless lim it. The e ect can be treated as a result of a Lorentz contraction of an extended particle. A naturalm easure of this extension is introduced for $m$ assless particles of any spin. It is show $n$ that such particles can be interp reted as circular strings w hose classical lim it is described by Robinson congruence. Finally, as an application of the even spin, we form ulate the $E$ instein $P$ odolsky $R$ osen $-B$ ohm $G$ edankenexperim ent for $D$ irac electrons.

## I. IN TRODUCTION

It is know $n$ that the transition from the rotation group SO (3) to the group SE (2) of tw o-dim ensional E uclidean m otions can be obtained as a continuous Inonu-w igner contraction of respective $L$ ie algebras [1, 2, 3]. This contraction can be explained in physical tem s sim ply as an abstract counterpart of the relativistic Lorentz contraction of a m oving body and it can be also shown that the sam e e ect is obtained both in the massless ( $m$ ! 0) and in nite $m$ om entum (ipj! 1 ) lim its. This result is intuitively quite natural since a light cone is the largem om entum asym ptotics of any $\mathrm{m}>0 \mathrm{~m}$ ass hyperboloid. Still, even though the SO (3) ! SE (2) transition is now well understood from a mathem atical point of view, it seem $s$ that no de nite physical intenpretation of this fact is generally accepted.

W e know that the $L$ ie algebra so (3) corresponds physically to an angular momentum. On the other hand there exist at least two physical intenpretations of the translation subalgebra of $e(2)$. First, the generators of translations can be naturally associated $w$ ith the twocom ponent position operator for $m$ assless elds (2) مcalizing m assless particles in a plane perpendicular to
their $m$ om entum . Second, if one considers the action of a four-dim ensional nonunitary representation of SE (2) on the electrom agnetic four-potential, it can be shown that the \translation" operators generate gauge transfor$m$ ations 34$]$. Such results are rather confiusing as there is no clear explanation for the continuous deform ation of the angular $m$ om entum into position or a generator of gauge transform ations. O f course, it is possible that form assless elds various physically di erent observables $m$ ay satisfy the e (2) algebra since $m$ assless unitary representations of the $P$ oincare group are generated by a onedim ensional representations of $E$ (2) so that not $m u c h$ room is left for di erent possible algebraic structures.

W e would like to show in this paper that it is possible to intempret the contraction so (3) ! e(2) also as the continuous deform ation of the angular $m$ om entum of a relativistic particle. The Lie algebra corresponding to the interm ediate $m$ om entum $p$, with $0<j \dot{p}<1$, is neither so (3) nore (2) but, as we shall see, there is a natural w ay of treating it as the relativistically generalized angularm om entum algebra.

To m ake our analysis as explicit as possible we shall discus the $m$ entioned $\lim$ its in the context of the D irac equation. It $w$ ill be shown that relativistic spin can be naturally represented by an \even" spin operator which reduces to ordinary nonrelativistic spin for a particle at rest and whose com ponents in directions perpendicular to $m$ om entum decay to zero as the $m$ om entum increases. In the in nite-m om entum / m assless lim it the operator \points" in the m om entum direction. The three com ponents of the new spin com m ute $w$ ith the free H am ittonian so that one can consider projections of spin in any direction even for a particle $m$ oving $w$ ith som e well dened and nonvanishing m om entum . This property $w$ ill be used for deriving a relativistic version of the $E$ insteinP odolsky-R osen-B ohm paradox for two spin-1/2 particles. W e shall also discuss the relationship betw een the even spin operator and the P auli-Lubanskivector, show ing that the in nitem om entum and $m$ assless lim its are equivalent for the rst one but not for the latter.

W e begin our analysis $w$ ith a brief sum $m$ ary of properties of little algebras corresponding to any tim elike or null fourm om entum .

## II. LIT TLE ALGEBRAS FOR ANY P W IT H $P \quad P \quad 0$

Eqs. (6) and (7) $m$ ean that the $L$ ie algebra of the little group is param etrized by p. In the $m$ assive case $w e$, in general, do not obtain so (3); in fact this is the case only if $\dot{p j}=0$, that is $w$ hen we consider the little group of a rest fram e fourm om entum. Such a rest fram e alw ays exists form $>0$. Form $=0$ we have

and (G) is indeed the Lie algebra e (2). N ote also that $\frac{i^{p j}}{p_{0}}$ ! 1 in the in nite $m$ om entum lim it and, as expected, the algebra is again e (2). T he sam e conclusions
follow from the m ! 0 and $\mathfrak{p j}$ ! 1 contractions of (7). $T$ he two contractions are equivalent and the contracted algebra is e(2). A reader interested in a geom etrical interpretation of these contractions is refered to the book by K im and NOz (p. 200 in 3 B ).

The form (6) of the generators leads to a di culty in a direct physical interpretation, as $L_{1}$ and $L_{2}$ are not $H$ erm itian for nite dim ensional representations of $S L(2 ; C)$ and nonvanishing $P$. For photons represented by a four-potentialthese operators generate gauge transform ations. For the rest fram e fourm om entum of $m$ as sive particles such representations correspond to spin. H ow ever, what is a physicalm eaning of this algebra for particles that are not at rest? In order to answer this question we must nst understand in what way the spin operator enters relativistic quantum m echanics.

## III. SP IN OF THE ELECTRON AND THED IRAC EQUATION

The Uhlenbeck and G oudsm ith idea of an intemalangularm om entum of the electron was form ally introduced to quantum $m$ echanics by P auli in 1927 [6]. P auliadded a new interaction term to the Schrodinger equation in order to explain a behavior ofelectrons in a m agnetic eld. This approach w as successfulbut, in fact, no other justi cation of the concept of spin existed at that tim e. A year later $D$ irac form ulated his relativistic w ave equation 6]. He assum ed that the equation (1) has a Schrodinger form $i \varrho_{t}=H \quad w h e r e H$ does not contain tim e derivatives, (2) factorizes the K lein-G ordon equation, (3) is relativistically covariant, and found that no single-com ponent wave function can satisfy such requirem ents. T he additional degrees of freedom present in the multicom ponent w ave function could be interpreted physically by a non-relativistic approxim ation w here positive energy solutions of the $D$ irac equation were show $n$ to satisfy the equation postulated by P auli. T he P auli spin operator was found to be an \intemal" part of the generator of rotations restricted to \large" com ponents of a bispinor.

In this way the spin operator was identi ed, from a $m$ athem atical view point, w ith the spinor part of the generator of rotations.

The rst di culty $m$ et in relativistic intenpretation of this operator w as the fact that, contrary to the nonrelativistic case, the com ponents of spin were not constants ofm otion even for a free particle (unless in a rest fram e). In the $H$ eisenberg picture the spin operator of the free electron satis es the follow ing precession equation

where $t=2{ }^{5} p$ and only the projection of $S$ on the \precession axis" $p$, the helicity, is conserved. T he total angular $m$ om entum $\tau$ also com $m$ utes $w$ th the $D$ irac

Ham iltonian and the purely spin part of $J$ can be extracted by in $\mathcal{J}=\mathrm{q} \quad \mathrm{S}$, where $\mathrm{n}=\mathrm{p}=\mathrm{p} j$. The existence of the conserved helicity is su cient for representation classi cation purposes and physical applications in, for instance, the $C$ lebsh-G ordan coe cients problem. $T$ he com ponents of spin in directions other than r are rarely needed. In the last section of this paper we shall consider one such case, nam ely the E instein-P odolskyR osen-B ohm G edankenexperim ent and the Bell inequality for relativistic electrons.
$T$ he general theory of representations of the $P$ oincare group shows that the group possesses tw o C asim ir operators: the mass P $P$ and the square $W \quad W$ of the $P$ auli-Lubanskivector

where M are generators of SL (2;C). W commutes $w$ th $P$ for all hence, in particular, $w$ ith $P^{0}$. The Pauli-Lubanski vector appears naturally in the theory because it, in fact, generalizes the generators of the litthe group described in Sec. H. T he C asim ir W W has eigenvalues $m^{2} j(j+1)$ where $m$ and $j$ are, respectively, the rest $m$ ass and the $m$ odulus of helicity of the irreducible representation in question.

In standard approaches to relativistic eld theories it is often stated that $W$ is the covariant generalization of spin. Its square is de ned as the follow ing elem ent of the enveloping eld of the $P$ oincare Lie algebra

W e have, therefore, tw o possibilities of introducing the spin operator in $P$ oincare invariant theories. The P auliLubanski vector has the advantage of having four conserved com ponents and is closely related to the generators of the little group of a $m$ om entum four-vector. T he dim ension of $W$ is, how ever, energy tim es angular m om entum so its relationship to P auli's 1927 spin is not evident.

## IV. THE PAULI-LUBANSKIVECTORAND ELECTRON'S SPIN

In the follow ing discussion we willw ork in the m om entum representation and units are chosen in such a way that $\mathrm{c}=1=\mathrm{h}$. The bispinor parts of generators are $S \quad=\frac{i}{4}[$; $]$ and the generators of SL $(2 ; C)$ are

In order to understand the physical m eaning of the $P$ auli-Lubanskivector let usm ultiply (10) from the right by $H^{1}$ (this operator is well de ned for $m$ assive elds; for $m$ assless elds it exists in the subspace of nonzero mom enta). W e get

where is the sign ofenergy operator and $=\frac{1}{2}(1)$ pro ject on positive (+ ) or negative ( ) energy solutions. $T$ he operator $S_{p}$ is therefore the so-called even part of the generator ofrotations S. The decom position ofoperators into even and odd parts is well known in rst quantized approaches to the D irac equation [7, 8$]$. T he even parts of operators are ectively the parts that contribute to average values of observables calculated in states of a de nite sign ofenergy. The even spin operator occurs naturally in the context of $Z$ itterbew egung and the $m$ agnetic-m om ent operator of the D irac electron $[9,10]$.

All these facts suggest that the even spin operator, which is som ehow in between the two notions discussed above, $m$ ight be the correct candidate for the electron's spin. A $l l$ the three components of $S_{p}$ com $m$ ute $w$ th $H$ so a projection of $S_{p}$ in any direction is a constant of m otion.

The explicit form of $S_{p}$ for free electrons $m$ oving $w$ ith $m$ om entum $p$ is the follow ing

$T$ he transition from $\dot{p j}=0$ to $p j=1$ deform $s$ continuously su (2) into e(2) and the spin operator $S_{p}$ becom es parallel to the m om entum direction. The latter phenom enon can be deduced from either (12) and (13) or the discussed lim its of (15).
$T$ he above lim its $m$ ust be understood in term $s$ of $L$ ie algebra contractions. Physically the in nite m om entum lim it is $m$ ore reasonable than $m$ ! 0 . It m eans that the greater velocity of a particle, the less \fuzzy" are the com ponents of spin in directions perpendicular to mo m entum. Intuitively, the particle becom es attened by the Lorentz contraction so that contributions to the intrinsic angular $m$ om entum from rotations around directions perpendicular to $p$ becom e $s m$ aller the greater is the attenning.

For $m$ equals exactly zero, two of the three com ponents of spin vanish which agrees w th the fact that the only self-adjoint nite dim ensionalrepresentations ofe (2) are one dim ensional. Physically this e ect can be again explained by the Lorentz contraction: A massless particle is com pletely attenned and its \intrinsic" angular m om entum can result only from rotations in the plane penpendicular to $p$.

Equations 11) and 15) im ply that the eigenvalues of a $W$ are

It follow s that the $P$ auli-Lubanskivector, as opposed to $S_{p}$, cannot be used for a uni ed treatm ent of spin in both $m$ assive and $m$ assless cases. The sam e concems the seem ingly natural and covariant choice of ( $\mathrm{W} 0=\mathrm{m} ; \tilde{W}=\mathrm{m}$ ) as the relativistic spin four-vector. This property of $W$ explains the follow ing apparent paradox. 16) is identical to the expression for the density $m$ atrix of the D irac neutrino. H ow ever, for supenpositions of different helicities $\sim 0$ which seem $s$ to suggest that even in the in nite $m$ om entum lim it som e \rem ains" of spin's com ponents in directions perpendicular to the m om entum $m$ ay be found. Still, there is no contradiction $w$ ith our analysis if we treat $S_{p}$ and not $W$ as the relativistic spin operator. $T$ he rem ains are those of $W$ and not of $S_{p}$. The \transverse polarization" vector ? has to be treated as a m easure of supenposition of the tw o helicites.

## V. LORENTZCONTRACTION... OFWHAT?

The decom position of operators into even and odd parts can be used for rew riting the D irac $H$ am iltonian in a form which is rather unusualbut especially suitable for investigation of its ultra-relativistic and $m$ assless lim its. Let us consider the angular velocity operator $!$ dened by (9). Form $\& 0$ and $p \in 0 \downarrow$ does not com $m$ ute w ith H . Its even part, commuting w ith H , is given (in ordinary units with $c$ 1) by

It is rem arkable that this radius occurs also naturally in the tw istor form alism [12]. A tw istor is a kind of a \square root" of generators of the Poincare group on a light cone and belongs to a carrier space of a representation of the conform al group. It is known that although spin -0 tw istors can be represented geom etrically by null straight lines, this does not hold for $\operatorname{spin}-s, s \in 0$, tw istors [12]. Instead of the straight line we get a congruence of tw isting, null, shear-free w orld lines, the so-called Robinson congruence. A three-dim ensionalprojection of this congruence consits of circles, whose radii are given exactly by our formula 23) (cf. the footnote at p. 62 in 12]). The circles propagate $w$ ith velocity of light in the m om entum direction and rotate in the right- or lefthanded sense depending on the sign of helicity.

The R obinson congruence picture is typical of classical tw istors. It suggests that classicalm assless elds $m$ ay be related naturally to classical strings whose radii would have to be di erent for di erent inertial observers. T he quantized tw istor form alism does not have such a pictorial representation since even for a spin-0 particle whose m om entum is given no w orld line exists, but additionally because of the di culties $w$ th the relativistic position operator.

The string-like picture ofm assless elds resulting from them om ent of inertia form ulas and from their agreem ent w ith the classical R obinson congruence is a physical indication that a fundam ental role should be played in this context by the conform al group. Indeed, a transition from one inertial reference frame to another not only transform $s$ the particle's fourm om entum, but sim ultaneously rescales the radius $r_{s}$ of the congruence.
$F$ inally, the fact that the $m$ assive $D$ irac $H$ am iltonian w ritten in term sofeven operators has the \energy ofpreœession" form 17) suggests that som e kind ofan extended structure can be associated also $w$ ith $m$ assive spinning particles. Structures of this type were constructed explicitly by B anut and collaborators [13,14,15].

in the helicity basis is given by the $m$ atrix
where 1 is the 44 identity $m$ atrix and $p_{0}$ is the energy of one of the particles. Its eigenvalues are: $1+\frac{\mathrm{m}^{2}}{\mathrm{p}_{0}^{2}}, 2 \frac{\mathrm{~m}^{2}}{\mathrm{p}_{0}^{2}}$ and 0 . The rst tw o correspond to the non-relativistic triplet state and the third one to the singlet (degeneracies of the eigenvalues are, respectively, 8, 4 and 4). An im portant property of the de nition (25), is the usage of squared even operators (this is not the same as the even part of the ordinary squared two-particle spin operator).

where the symbols $k$ and ? denote projections on, respectively, the m om entum direction and the plane perpendicular to it. For a and $\check{b}$ perpendicular to $p_{1}$ (26) equals a $\check{\mathfrak{D}}$, the form ula known from the nonrelativistic quantum $m$ echanics, and the $B$ ell theorem can be form ulated. For other directions the form ula 26) di ens from the nonrelativistic one so m ight be used for an experi$m$ ental veri cation of the even spin conœept 17].

## V II. C O N C LU SIO N S

W e have show $n$ that the algebra of a little group of any physical four $m$ om entum is isom orphic to the algebra of the even spin operator. This result explains qualitatively the fact that $m$ assless elds can exist only in extrem al helicity states since eigenvalues of the even spin's com ponents perpendicular to m om entum tend to zero in both in nite m om entum and m assless lim its. A physical origin of this phenom enon can be explained by the Lorentz attenning of the $D$ irac particle provided the particle is extended. For massless elds (or ultra-relativistic electrons) the attenned picture can be naturally associated w th the classicalR obinson congruence ofnullw orldlines, leading to a string-like classical lim it of spinning particles. In this way we have retumed to the old problem of localization of spinning particles $1,8,18$,19] and have found another argum ent for their extended structure and usage of noncom $m$ uting position operators.
