# Q uantum E lectrodynam ics at Large D istances III: <br> Veri cation of Pole Factorization and the C orresp ondence Principle [

#### Abstract

In two com panion papers it was shown how to separate out from a scattering function in quantum electrodynam ics a distinguished part that $m$ eets the correspondence-principle and pole-factorization requirem ents. The integrals that de ne the term $s$ of the rem ainder are here shown to have singularities on the pertinent Landau singularity surface that are w eaker than those of the distinguished part. T hese rem ainder term stherefore vanish, relative to the distinguished term, in the appropriate $m$ acroscopic lim its. This show S, in each order of the perturbative expansion, that quantum electrodynam ics does indeed satisfy the pole-factorization and correspondence-principle requirem ents in the case treated here. It also dem onstrates the e cacy of the com putational techniques developed here to calculate the consequences of the principles of quantum electrodynam ics in the $m$ acroscopic and $m$ esoscopic regim es.

## 1. Introduction

In papers $\mathrm{I}^{1}$ and $\mathrm{II}^{2}$ we exam ined the functions $F(g)$ associated $w$ th the innite set of graphs fgg obtained by dressing a sim ple triangle graph G w ith soft photons in all possible ways. A distinguished set of contribution to these functions F ( $g$ ) was singled out and called \dom inant" because these contributions were expected to dom inate the $m$ acroscopic behaviour of the scattering functions. Each of these distinguished parts was shown to be well de ned, and to have a singularity of the form $\mathrm{log}^{\prime}$ on the (Landau N akanishi) triangle-diagram singularity surface ${ }^{\prime}=0$. This form $\mathrm{log}^{\prime}$ agrees $w$ th the form of the singularity of the originalFeynm an function $F(G)$ on ${ }^{\prime}=0$, and it produces the sam e kind of large-distance fallo . M oreover, these dom inant contributions yield (exactly once) every term in the perturbative expansion of the triangle-diagram version of the pole-factorization property

The left-hand side of this equation represents value at ' $=0$ ofthe discontinuity across the surface' $=0$ of the function $\mathrm{F}^{0}$ that is obtained by om itting the contributions from the \classical" photons. These latter contributions are supplied by the unitary operator $U(L) \mid$ after the transform ation to coordinate space. C onsequently, the discontinuity form ula given above entails that the contributions from these \dom inant" terms give just the classical-type large-distance behaviour dem anded by the correspondence principle: the rate of fallo at large distances is exactly what follow s from the classical concept of three stable charged particles, each moving from one scattering region to another, and the electrom agnetic eld generated by $U(L)$ is exactly the quantum analog of the classical electrom agnetic eld generated by the $m$ otions of these three charged particles. In the present article we shall show that, in each order of the perturbation expansion, the term s of the rem ainder give no contributions to the discontinuity de ned above. C onsequently, these \non-dom inant" term s give no contribution to the leading term in the the asym ptotic large-distance behaviour, and hence the correspondence-principle requirem ent is satis ed.

In section 2 we exam ine the sim plest exam ple, nam ely the triangle graph $G$ dressed w ith one intemal soft photon. T he rem ainder part is separated into a sum of term s . For som $e$ term $s$ the weakening of the singularity on the surface
' = 0 is associated $w$ ith the topologicalcom plexity of the graph that represents this term, nam ely its non-separability: cutting the graph at the three lines associated w ith the three Feynm an-denom inator poles does not separate the graph into three disjoint parts. This $m$ eans that the integration over the $m$ om enta of the intemal photons tends to shift the position of the singularity, and hence weaken it. For the rem aining term $s$ the weakening of the singularity on ${ }^{\prime}=0$ is due to the replacem ent of one orm ore of the three pole singularities $\left(p_{s}^{2} \quad \mathrm{~m}^{2}\right)^{1}$ of the integrand by a pair of logarithm ic singularities: this replacem ent of the pole singularities in the integrand by logarithm ic singularities likew ise leads to a weakening of the singularity of the integral on ${ }^{\prime}=0$.

O ur problem s here are rst to show that these reductions in the degree of the singularity on ' $=0$, which em erge easily w ithin our form alism in this sim ple one-photon exam ple, hold for every $g$ obtained by dressing the triangle graph G w ith soft photons, and second to show that the weakening of the singularity is, in every case, a weakening by at least one fullpower of', up to a prescribed nite number of powers of log' that increases linearly with the number of photons, and hence with powers of the coupling constant. This strong result $m$ eans that the validity of the correspondence\{principle in the large\{scale lim it, which is established here at each order of the perturbative expansion, cannot be upset by an accum ulation of powers of ( $\left.\mathrm{log}{ }^{\prime}\right)^{\mathrm{n}}$ that leads to a singularity of the form ', where is of the order of the ne-structure constant ( $1=137$ ). A ccum ulations of this kind occur often in eld theories. The appearance of the
ne-structure constant in the exponent arises from the fact that usually, just as in our case, the num ber of pow ers of log' is linearly tied to the num ber of pow ers of the ne-structure constant. W e have not studied, in our case, the num erical factors that multiply the term s of the rem ainder, except to show that they are all nite. H ence we can $m$ ake here no claim pertaining to $m$ eaningfulness of the in nite sum in our case: we plan to exam ine this question later.

To establish our general conclusions we need two auxiliarly results. The rst is a geom etric property conceming the structure of the Landau- N akanishi surface. It is proved in section 3. The second pertains to several singular integrals. The needed com putation is perform ed in section 4. The required properties of the various intergrals are then proved in sections 5, 6, and 7.
2. Exam ination of non-dom inant singularities for the one-photon case.

Let us consider the contributions associated $w$ th the graph $g$ show $n$ in F igure 1 .

In references 1 and 2 we showed how to separate the contribution represented by the graph of Fig . 1 into a m erom onphic part consisting of a sum of the four term $s$ represented by the the four graphs of $F$ igure $[2$, plus a \non-m erom onphic" part.

T he term associated w ith the graph a off igure 2 is separable, and is classi ed as dom inant. The associated function $F_{a}$ is given by (4.1) and (4.3) of Ref. 1, and has a logarithm ic singularity along the Landau surface' $=0$. W e also claim ed there that the other three term $s$ in the $m$ erom onphic part are are infrared nite, and have weaker singularities along the Landau surface' $=0$. In the follow ing subsection we verify this claim for the case of the function $\mathrm{F}_{\mathrm{b}}$ associated $w$ th graph (b) of Fig. 2. T he other two cases, $c$ and $d$, can be treated sim ilarly.

Figure 1: A graph $g$ representing a soft-photon correction to a hard-photon triangle-diagram process $G$. The letters $Q$ near the ends of the $w i g g l y$ line that represents the soft photon indicate that this particle is coupled to the charged particle through the \quantum " part of the fullquantum -electrodynam ical coupling.

2.i. The contribution from a one-photon nonseparable m erom orphic part.

It was shown in Ref. 2 that we can distort the -contour so that Im ${ }^{2}>0$ at
${ }^{2}=0$, and $\operatorname{Im} p_{j}>0(j=1 ; 2)$ at $p_{j}=0$. Then, except for three polefactors $p^{2} m^{2} ;\left(p_{1}+r\right)^{2} m^{2}$ and $p_{2}^{2} \quad m^{2}$, each denom inator of the integrand of $\mathrm{F}_{\mathrm{b}}$ is di erent from zero.

C om bining this singularity, instead of the ordinary pole $1=\left(p_{1}^{2} \quad \mathrm{~m}^{2}\right)$, w ith the other tw o poles, i.e., $1=\left(\begin{array}{ll}p^{2} & m^{2}\end{array}\right)$ and $1=\left(p_{2}^{2} \quad m^{2}\right)$, we perform the p-integration and nd a singularity A ( $q ;)^{\prime}\left(q^{f}\right) \log { }^{\prime}(q)$, w ith A being analytic. E ssentially the sam e argum ent covers the case where one of the two $m$ ero$m$ onphic parts is due to a C-coupling. T hen the factor rdr becom es sim ply dr , and the singularity becom es ' log'.

By deform ing the -oontour, in them anner speci ed in ref. 2 , so that Im ${ }^{2}>0$ and $\operatorname{Im} p_{j}>0(j=1 ; 2)\left[w\right.$ th $\left.p_{1}=q_{1}+p_{3} ; p_{2}=p_{3} \quad q_{3}\right]$, we nd the singularity of this integral near ${ }^{\prime}\left(q_{1} ; q_{3}\right)=0$ is ${ }^{\prime} \log \left({ }^{\prime}+i 0\right)$, as there is no potentially divergent factor $1=r$.

If the $m$ erom onphic part is replaced by a $C$-term, then the dom inant singularity is given by an integral sim ilar to (2.iii.1) but with the replacem ent of the residue factor $\left.1=\left(\begin{array}{ll}\left(p_{3}\right. & q_{3}\end{array}\right)+r{ }^{2}\right)$ by $1=r\left(\begin{array}{ll}\left(p_{3}\right. & q_{3}\end{array}\right)$. H ence a potentially divergent factor $1=r$ arises. But this problem is circum vented by combining the singularity originating from $\log \left(\left(q_{1}+p_{3}+r\right)^{2} m^{2}+i 0\right)$ and that from $\log \left(\left(q_{1}+p_{3}\right)^{2} m^{2}+i 0\right)$; the results in $x 4$ show, with a reasoning sim ilar to (but sim pler than) that in x 2 .ii, that the resulting singularity is ${ }^{\prime}(\log (r+i 0))^{2}$.
3. A norm alization of the function de $n$ ing a Landau surface.

The punpose of this section is to prove the follow ing lem $m a$, which is an adaptation of the im plicit function theorem (or the $W$ eierstrass preparation theorem in the theory of holom orphic fiunctions of several variables) to the Landau surface shifted by a vector determ ined by photons that bridge star lines. (cfix 11. of $R$ ef. 1.). H ere and in what follow $S,\left(r_{1} ;:: ; r_{n}\right)$ denotes a nested set of polar coordinates introduced in Ref. 1, x5.

Lem ma 3.1 Let' (q) denote a de ning function of the Landau surface for the triangle diagram and let of be a point on the surface. Let ibe the sm allest j such that $j$ identi es a bridge photon line. (A bridge photon line is a photon line that has m erom orphic couplings on both ends and that com pletes $\mid$ via the rules de ned below Eqn. (2)of ref. $2 \mid$ to a closed photon loop that passes along at least one star line.) Then on a su ciently sm all neighborhood of $\mathrm{q}_{\mathrm{p}}$ and for su ciently $s m$ all $i=r_{1} \quad i$ there exist non-vanishing holom onphic functions B ( $q ;{ }_{i} ; k^{0}={ }_{i}$ ) and C ( $q ; k^{0}={ }_{i}$ ) such that

4. Som e auxiliary integrals.

The purpose of this section is to nd an explicit form of the singularities of several integrals that we encounter in dealing w ith infrared problem s. The sim plest exam ple of this sort is the follow ing integral I ( t ):

Speci cally, let e be an end-point of the photon line $i$, and let $s$ be the side of the triangle on which e lies. At the end-point of $s^{0}$ that coincides $w$ ith a vertex $v_{i}$ of the triangle diagram, run $L\left(k_{i}\right)$ out along the extemal line $q_{j}(j=1 ; 2$ or 3$)$. D o the sam e for the other end-point of the line $i$. Include on $L\left(k_{i}\right)$ also the segm ent $i$ itself. This produces a continuous ow line. Orient it so that it agrees w ith the orientation of the line $i$. This oriented line is the ow line $L\left(k_{1}\right)$. Then for each extemal line $q_{j}$ along which $L\left(k_{i}\right)$ nuns add to the vector $q_{j}$ either $+k_{i}$ or

6. C om putation for the N onm erom orph ic C ase

T he com putation in the nonm erom onphic case is sim ilar to the com putation for the $m$ erom onphic case described in section 5 w th the help of section 3 . Let the special index ibe now the sm allest integer such that photon line is either a bridge line or a photon line w ith a nonm erom orphic coupling on at least one end.

If line $i$ is a bridge line (and hence, by de nition, has a m erom onphic coupling on each end, and bridges across a -segm ent) then the argum ent used for the $m$ erom onphic case continues to work. This is because the condition (5.1) of section 5 continues to hold, and each variable jassociated w ith a nonm erom orphic coupling acts just like a variable $r_{j}(j>i)$ of sections 3 and 5 .

If, on the other hand, the index i labels a line w ith a nonm erom onphic coupling on at least one end then (5.1) m ay fail, because in this case the variable $k_{i} m$ ay enter into only in the form $i_{i} k_{i}$ (or ${ }_{i}^{0} k_{i}$ ). For example, if the photon line i runs between two di erent sides, $s$ and $s$, and has a nonm erom onphic coupling on both ends then, according to (10.8b) of ref. 1 , the vector $k_{i}$ enters into only in the combinations $i_{i} k_{i}$ or ${ }_{i}^{0} k_{i}$, where $i$ and ${ }_{i}^{0}$ are the variables associated w ith the two di erent nonm erom onphic couplings of line i. H ence the derivative on occurring in (5.7) will introduce a factor i or into each $k_{i}$-dependent contribution to (5.7). Since $i$ and $i_{i}$ vanish in the dom ain of integration, and all other contributions have factors $r_{j}(j>i)$, whidh can vanish, the property (5.1) can fail.

Sim ilarly, if only one end of line i is coupled nonm erom ophically, say into the side $s$, but the closed loop i does not pass through the star line for either of the other two sides $s^{0} s, s$, then again (5.1) can fail, for essentially the sam e reason.

These faitures of (5.1) cannot be avoided by sim ply using $\begin{array}{l}0 \\ i\end{array}$ i i (or $\left.\begin{array}{ll}0 & i\end{array}\right)$ in place of ${ }_{i}$, because the condition in (3.1) on $k={ }_{i}$ fails if $i_{i}$ is replaced by ${ }_{i}$.

In this section the \selfenergy" photons that couple nonm erom onphically on both ends onto the sam e side s w illbe ignored: they are treated in section 7 .

where $P$ is as de ned above. O ne sees im mediately that $f(\varsigma)$ is bounded, and tends to zero $w$ ith $r_{0}$.

To begin the study of the general form off $\left(r_{0}\right)$ let us consider a case slightly $m$ ore com plicated than (6.14):

A function ofone variable $x$ having, in $0<x<1$, the form ${ }^{P} C_{n m} x^{n}(\log x)^{m}$, and bounded in $0 \quad x \quad 1$, with some nite number ofnonzero coe cients $C_{n m}$, w ill be said to have form $F$. Thus the functions $f\left(r_{0}\right)$ speci ed in (6:14) and (6:16) both have form F.

In fact, the general function $f\left(r_{0}\right)$ of the form speci ed in (6:15) has form F. To see this note rst that if we replace the factor $H(h)=(\operatorname{logh})$ in (6.16) by any function $H(h)$ of form $F$ then $f\left(r_{0}\right)$ has form $F$ :

(N ote that every term in ${ }^{R_{x^{0}}}$ dhH (h) has a factor $x^{0}$, and hence the denom inator $\left(x^{0}\right)^{2}$ is reduced to $x^{0}$.) So our problem is to show that $f\left(r_{0}\right)$ can be reduced to the form (6.16) w ith $H(h)$ having the form $F$.

Repeated application of this result show $s$ that if $P=x_{1} x_{2}:: x_{p}$ then $f\left(r_{0}\right)$ has form $F$. O ne rst combines $x_{1} x_{p}$ into $h_{p}$, then combines $x_{p}{ }_{2} h_{p}$ into $h_{p}$, etc.. At each stage the functions $I$ and $H$ have form $F$, and hence one nally gets (6.16) with $H(h)$ having form $F$, as required.

The general form of $P$ is not just a single product $r_{i+1}:: r_{j}:$ it is a sum of such term $s w$ th di erent values of $j$, som $e$ of which can be multiplied by $j$ or ${ }_{j}^{0}$. H ow ever, these other term s can be brought into the required form by a generalization of the operator technique used above.

The two im portant points are: (1), that the integral operator that reduces a sum $t+g$ to a single $h$, just like the operator that reduces a product tg to $h$, preserves form F ; and (2), the extra part $\mathrm{h}>1$ does not disnupt the argum ent: it adds only a term $r_{0}$ const.

By taking combinations of these two kinds of operators, and a third kind w ith $t$ xed at unity, rather than being integrated over, one can reduce any one
 F. Thus all functions $f\left(r_{0}\right)$ of the kind (6:15) will be of the form $F$, provided we $m$ ake the simple assignm ents $1=a=A=p_{s}{ }_{j}=e_{j}+1$. The rem aining task is to show that essentially the sam e result follows even when we do not $m$ ake these sim ple assignm ents. O ne other problem also needs to be addressed: we have com puted the integrals on the variables $r_{j}$ under the assum ption that the variables $j$ are held xed, whereas the distortions in the variables $j$ can depend on the $r_{j}$.

By follow ing through the argum ents just given, but w ith the $e_{j}$ now allowed to be nonnegative integers, one nds that the conclusions are not dismupted: the positive power $n$ of $r_{0}$ in $f\left(r_{0}\right)$ can be increased, and the positive power $m$ of $\log r_{0}$ can be decreased, but changes in the opposite direction do not occur. $H$ ence the singularities are at $m$ ost w eakened.

To deal sim ultaneously w ith the problem s of the dependence ofA ( $q$; ;r;x) upon ( $r ; x$ ), and the dependence of the distortion in upon ( $r ; x$ ), we introduce a su ciently sm all number $=1=\mathrm{N}>0$, and divide the dom ain of integration $0<x<1$ in each of the variables $x_{j}$ and $r_{j}$ into a sum of $N$ intervals of length , such that (1), the distortion of the set of variables can be held xed over each separate product interval, and (2), for any subset of the set of variables $r_{j}$ and $x_{j}$, and for the corresponding space $S$ form ed by the product over of the corresponding set of leading intervals $0<\left(r_{j} ; x_{j}\right)<$, the dependence of A on these variables can be represented by a pow er series that converges $w$ ithin $S$ for each point in the space form ed by the product over the com plem entary set of variables of the nonleading intervals $<\mathrm{x}<1$. (Sœ Rem ark 4.3 (ii).) The variables can then be re-scaled so that the original integration dom ains run from 0 to N , and the leading intervals (form erly from 0 to ) now run from from 0
to 1. The earlier argum ents can then be applied to the re-scaled problem, w ith the concept Yorm $F^{\prime}$ replaced by Yorm $F^{0}$ : a function of one variable $x$ is said to have form $\mathrm{F}^{0}$ if and only if it is bounded in the interval $0 \mathrm{x} \quad 1$, and in $0<x<1$ can be written in the form

where the sum is over a nite set of integers $m$, and each $A_{n}(x)$ is analytic on $0<x<1$. The contributions from the integrations over the nonleading dom ains $1<\mathrm{x}<\mathrm{N}$ do not disnupt the argum ents, and form ula (4:8) show $s$ that extra factors $n+1$ are introduced into the denom inators at each integration, so that convergence at the level of the integral is, if anything, im proved over the original convergence at the levelof the integrand. This takes care of these tw o problem s.

The nalstep is to rem ove the assum ption that the coe cients ofthe various term $s$ ofP are unity: these coe cients are actually the quantities $p_{s} j$.

There is no problem in allow ing these coe cients to be strictly-positive -dependent functions: the constants $\mathrm{C}_{\mathrm{nm}}$, or the functions $\mathrm{A}_{\mathrm{m}}$, then sim ply becom e analytic functions of the variables $p_{s} j$ over these strictly-positive do$m$ ains. In fact, these coe cients can be continued into the complex dom ain without a ecting the character of the singularity at $f=0$ provided we keep each coe cient aw ay from the cut along the negative real axis in that variable, and keep the point $C$ in the space of the collection of these coe cients away from all points where $a+P\left(C ; x_{j} ; r_{j}\right)=0$ for some point in the product of the open dom ains of integration $0 \ll 1$, and (for all $j$ ) $0<x_{j}<1$ and $0<r_{j}<1$. Here $a=p_{s i}$.

The points in the dom ain of integration over the variables $r_{j} ; x_{j} ; j$ that contribute to the singularity at ${ }^{\prime}=0$ are points where each of the three starline factors is evaluated at, or very close to, the associated pole. T he argum ents in ref. 2 show that in this region the rst of the variables $\mathrm{p}_{\mathrm{j}}$, nam ely $\mathrm{p}_{\mathrm{s}} \mathrm{i}=\mathrm{a}$ can be shifted into upper-half plane Im a > 0, and the collection of contours C can be distorted so that a +P is shifted into the upper-half-plane provided $0 \ll 1$ and, for all $j, 0<r_{j}<1$ and $0<x_{j}<1$. This is exactly the condition that is needed to justify the extension of the results obtained above for positive realcoe cients to the com plex points of interest.

The dependence of the distortion of the contour on needs to be described. W hen one introduces the nonm erom orphic couplings, and hence the ${ }^{R} d$, into the formula, the Landau m atrix acquires a new colum $n$, the $d$ column. However, the param eter enters in an alm ost trivial way: the pole residues associated $w$ ith the side $s$ of the triangle into which the vertex associated $w$ ith is coupled are changed from $p_{s}\left(j_{j}+::\right.$ ) into $\left(p_{s}+{ }_{i} k_{i}\right)\left(j_{j}+:::\right)$, and the pole denom inator $\left(p_{s}\right)^{2} \quad m^{2}$ is changed to $\left(p_{s}+{ }_{i} k_{i}\right)^{2} m^{2}$. The new set of Landau equations can be satis ed at each of the two end points $i_{i}=1$ and ${ }_{i}=0$. $T$ hese tw o solutions correspond to diagram $s$ in which the vertex associated $w$ ith $i$ is placed at one end or the other of the side s of the triangle. B oth solutions to the triangle-diagram equations exist, and, because of the null contributions in alld ${ }_{j}$ Colum ns, the two solutions yield two di erent ways of distorting the ${ }_{j}$ contours, 1 and 0 , the rst corresponding to ${ }_{i}=1$, the second corresponding to $i=0$. An allowed distortion that gives these two cases and sm oothly interpolates to the interm ediate values of $i_{i}$ is $i_{1}+\left(\begin{array}{ll}1 & i\end{array}\right)$. It keeps the im aginary part of the pole denom inator strictly positive (near the zero of the realpart) for all values of $i$ in the dom ain 0 i 1 . This distortion, or som e approxim ation to it, can be used in the argum ent given above.

For the rem aining integrations on the $d r_{j}(j \quad i)$ one uses P ropositions 4.4 (ii) and 4.5 , and $R e m$ ark 4.3 (ii). This gives for the singular part of $F$ (q) at q a function of form $F^{0}$, in som e appropriately scaled variable' (q), multiplied by an analytic function of $q$.
7. C om putation for Selfe nergy C ase.

C ontributions from photon lines j coupled nonm erom orphically on both ends into the sam e side s of the triangle were excluded from the discussion in section 6 . For these values of $j$ one can, in order to exclude double counting, im pose the condition $j{ }_{j}$, where $j$ is the -param eter associated w th the nonm erom orphic coupling on the tailofphoton line $j$, and ${ }_{j}^{0}$ is the -param eter associated with the nonm erom orphic coupling on the head of line $j$. $M$ om entum $k_{j}$ ow salong line $j$ from its tail to its head, according to our conventions.

The form ulas of section 2 of Ref. 1 refer to $m$ om entum $k_{j}$ ow ing out of the charged-particle line at the tail of the photon line $j$. The coupling at the head can be treated like the coupling at the tail, but w ith a reversal of the sign of $k_{j}$. Then the ect of the two couplings into the sam e side $s$ is to replace $p_{3}$ by $\mathrm{p}_{\mathrm{s}}+\left(\begin{array}{cc}j & 0\end{array}\right) \mathrm{k}_{j}$, and to integrate on j from zero to one and on ${ }_{j}^{0}$ from zero to $j$. The condition $I m p_{s}>0$ then retains its usual from. The reduction of the dom ain of integration does not upset the argum ents of section 6 .

To bring this case into accord w ith section 6 we use the follow ing transfor$m$ ations:


T he variable h plays the role played by in section 6 .
