Husim i Param etric O scillator in Frame of Symplectic Group and Q-oscillators

A bstract

Time (dependent integrals of motion which are linear forms in position and momentum are discussed for Husimi parametric forced oscillator. Generalization of these integrals of motion for q(oscillator is presented. Squeezing and quadrature correlation phenomena are discussed on the base of Schrodinger uncertainty relation. The properties of the generalized correlated states, squeezed states, even and odd coherent states (the Schrodinger cat states) are reviewed. The relation of the constructed nonclassical states to representations of the symplectic symmetry group and nite symmetry groups is discussed.

1 Q -invariant of P aram etric O scillator

Husim i [1] has considered forced param etric oscillator described by the Schrodinger equation

where we take h = m = ! (0) = 1. In the references the Gaussian packets and analogs of oscillator number states have been found as well as Green function and transition amplitudes between the energy levels in a form of series. In [2], [3] the integrals of motion which are linear forms in position and momentum operators have been found and used to rederive the Husim isolutions. The review of the approach has been given in [4], [5].

In this talk for the Husim i param etric oscillator we nd integrals of motion which satisfy the commutation relations of q{oscillator [6], [7], i.e. the quantum Heisenberg{Weyl group is shown to be the dynamical group of this oscillator. In [8], [9] the possibilities to interprete the q{oscillator as nonlinear oscillator with special exponential dependence of its frequency on the amplitude has been suggested. Using the construction of even and odd coherent states [10] interpreted in quantum optics as Schrodinger cat states [11] we discuss the properties of these states for the Husim i parametric oscillator.

For sym plicity of presentation we take f(t) = 0. Then the time {dependent operator

is the integral of motion [3] satisfying the commutation relation

One can easily check that the time (dependent operator

where $= \ln q$, is the integral of motion of the parameteric oscillator satisfying the commutation relation

It m eans that operators A_q ($A_q y$) corresponding to q{oscillators due to these com m utation relations determ ine the dynam ical sym m etry of the parametric oscillator and all the states of the oscillator are the basis of the irreducible representation of q{deformed Heisenberg{Weylqroup.}

2 Correlated and Squeezed State

It was shown in β] that some Husim ipacket solutions may be interpreted as coherent states [12] since they are eigenstates of the operator A (2) of the form

is analog of the ground state of the oscillator and is a complex number. The variances of the position and momentum of the parametric oscillator in the state (8) are

and the correlation coe cient of the position and momentum has the value corresponding to minimization of the Schrodinger uncertainty relation [13]

Due to this the state (7) is a correlated coherent state introduced in [14]. For dierent dependences of frequency on time there may appear phenomenon of squeezing, i.e.

are eigenstates og the integral of m otion AyA. For the H usim i oscillator the q{coherent states [6] m ay be easily constructed as norm alized eigenstates of the integral of the m otion $A_{\rm q}$ (5) in the form

The function (13) satis es the Schrodinger equation (1), and it is eigenfunction of the q{ oscillator operator A_q . In [8], [9] it was shown that if the q{oscillator describes a nonlinearity of classical electrom agnetic eld vibrations (q{nonlinearity}) at high am plitudes the blue shift e ect must exist. It is the e ect of shifting the light frequency versus the light intensity which may serve for evaluating an upper lim it for the parameter of nonlinearity :

3 Squeezed Schrodinger Cats

A nother normalized solution to the Schrodinger equation (1)

is the even coherent state [10] (the Schrodinger cat m ale state). The odd coherent state of the param etric oscillator (Schrodinger cat fem ale state)

satis es the Schrodinger equation (1) and is the eigenstate of the integral of motion A² (as well as the even coherent state) with the eigenvalue ²: The even and odd coherent states are ortogonal each to other. A multimode generalization of the even and odd coherent states has been introduced in [15]. The properties of multimode Schrodinger cat states, the coherent components of which are subjected to parametric excitation, are discussed in [16]. The even and odd coherent states are the partial case of a set of nonclassical states discussed in [17]. They may be used as alternative to squeezed vacuum states in gravitational wave antenna to improve its sensitivity [18].

The multim ode generalization of the Husim i parametric oscillator has been considered in [19]. The linear in position and momentum integrals of motion have been constducted

and generalized correlated states [20] in the form of Gaussian packets have been found explicitly. It is interesting to note that for multidimensional parametric oscillator the linear integrals of motion of the type A (2) and their quadratic forms constitute the Lie algebra of the inhomogeneous symplectic group. Thus, the solutions to Schrodinger equation for the multimode parametric oscillator form the basis for irreducible representation of this symplectic group. The remark made for one mode case on the existence of q deformed dynamical algebra may be extended to the multimode parametric oscillator, too. Thus, the solutions of the Schrodinger equation for multimode parametric oscillator may be also considered as a basis of the irreducible representation for a q deformed symplectic group.

The construction of the even and odd coherent states made in [10] used the representation of the inversion group for which even states realize the symmetric irreducible representation and odd states realize the antisymmetric one. Generalization of this construction to higher crystallographic groups for introducing the crystallized Schrodinger cat states is done in [21].

The multivariable Herm ite polynom ials describe the photon distribution function for the multim ode mixed and pure correlated light [22], [23], [24]. The nonclassical state of the light may be created due to nonstationary C asim ir e ect [25], and the multim ode Husim i oscillator is the model to describe the behaviour of the squeezed and correlated photons.
