#### Abstract

We show that a set of gates that consists of all one-bit quantum gates (U (2)) and the two-bit exclusive-or gate (that m aps Boolean values (x;y) to (x;x y)) is universal in the sense that all unitary operations on arbitrarily m any bits n (U (2<sup>n</sup>)) can be expressed as compositions of these gates. We investigate the number of the above gates required to implement other gates, such as generalized D eutsch-To oligates, that apply a speci c U (2) transformation to one input bit if and only if the logical AND of all remaining input bits is satis ed. These gates play a central role in m any proposed constructions of quantum com – putational networks. We derive upper and low er bounds on the exact number of elementary gates required to build up a variety of two- and three-bit quantum gates, the asymptotic number required for n-bit D eutsch-To oligates, and m ake som e observations about the number required for arbitrary n-bit unitary operations.

### 1 Background

It has recently been recognized, after fly years of using the paradigm s of classical physics (as embodied in the Turing machine) to build a theory of computation, that quantum physics provides another paradigm with clearly di erent and possibly much more powerful features than established computational theory. In quantum computation, the state of the computer is described by a state vector , which is a complex linear superposition of all binary states of the bits  $x_m \ 2 \ f0;lg:$

The state's evolution in the course of time t is described by a unitary operator U on this vector space, i.e., a linear transform ation which is bijective and length-preserving. This unitary evolution on a norm alized state vector is known to be the correct physical description of an isolated system evolving in time according to the laws of quantum mechanics[1].

H istorically, the idea that the quantum mechanics of isolated systems should be studied as a new form all system for computation arose from the recognition twenty years ago that computation could be made reversible within the paradigm of classical physics. It is possible to perform any computation in a way that is reversible both logically | i.e., the computation is a sequence of bijective transformations | and therm odynam ically | the computation could in principle be performed by a physical apparatus dissipating arbitrarily little energy [2]. A formalism for constructing reversible Turing machines and reversible gate arrays (i.e., reversible combinational logic) was developed. Fredkin and To oli[3] showed that there exists a 3-bit \universal quark is a gate array, could be used to simulate any arbitrary reversible computation. (Two-bit gates like NAND which are universal for ordinary computation are not reversible.) To oli's version [4] of the universal reversible gate will gure prominently in the body of this paper.

Quantum physics is also reversible, because the reverse-time evolution specified by the unitary operator U<sup>-1</sup> = U<sup>Y</sup> always exists; as a consequence, several workers recognized that reversible computation could be executed within a quantum -m echanical system. Quantum -m echanical Turing m achines [5, 6], gate arrays [7], and cellular autom ata [8] have been discussed, and physical realizations of To oli's[9, 10, 11] and Fredkin's[12, 13, 14] universal three-bit gates within various quantum -m echanical physical system s have been proposed.

W hile reversible computation is contained within quantum mechanics, it is a small subset: the time evolution of a classical reversible computer is described by unitary operators whose matrix elements are only zero or one | arbitrary complex numbers are not allowed. Unitary time evolution can of course be simulated by a classical computer (e.g., an analog optical computer governed by M axwell's equations) [15], but the dimension of the unitary operator thus attainable is bounded by the number of classical degrees of freedom | i.e., roughly proportional to the size of the apparatus. By contrast a quantum computer with m physical bits (see de nition of the state above) can perform unitary operations in a space of  $2^m$  dimensions, exponentially larger than its physical size.

Deutsch [16] introduced a quantum Turing machine intended to generate and operate on arbitrary superpositions of states, and proposed that, aside from simulating the evolution of quantum systems more economically than known classical methods, it might also be able to solve certain classical problems | i.e., problems with a classical input and output | faster than on any classical Turing machine. In a series of articial settings, with appropriately chosen oracles, quantum computers were shown to be qualitatively stronger than classical ones [17, 18, 19, 20], culminating in Shor's [21, 22] discovery of quantum polynomial time algorithms for two important natural problems, viz. factoring and discrete logarithm, for which no polynomial-time classical algorithm was known. The search for other such problems, and the physical question of the feasibility of building a quantum computer, are major topics of

investigation today [23].

The form alism we use for quantum computation, which we call a quantum \gate array" was introduced by Deutsch [24], who showed that a simple generalization of the To oligate (the three-bit gate  $^{2}(\mathbb{R}_{x})$ , in the language introduced later in this paper) su ces as a universal gate for quantum computing. The quantum gate array is the natural quantum generalization of acyclic combinational logic \circuits" studied in conventional computational complexity theory. It consists of quantum \gates", interconnected without fanout or feedback by quantum \wires". The gates have the sam e num ber of inputs as outputs, and a gate of n inputs carries a unitary operation of the group U  $(2^n)$ , i.e., a generalized rotation in a H ilbert space of dimension  $2^n$ . Each wire represents a quantum bit, or qubit [25, 26], i.e., a quantum system with a 2-dimensional Hilbert space, capable of existing in a superposition of Boolean states and of being entangled with the states of other qubits. W here there is no danger of confusion, we will use the term \bit" in either the classical or quantum sense. Just as classical bit strings can represent the discrete states of arbitrary nite dimensionality, so a string of n qubits can be used to represent quantum states in any H ilbert space of dimensionality up to 2<sup>n</sup>. The analysis of quantum Turing machines [20] is complicated by the fact that not only the data but also the control variables, e.g., head position, can exist in a superposition of classical states. Fortunately, Yao has shown [27] that acyclic quantum gate arrays can simulate quantum Turing machines. Gate arrays are easier to think about, since the control variables, i.e., the wiring diagram itself and the number of steps of computation executed so far, can be thought of as classical, with only the data in the wires being quantum.

Here we derive a series of results which provide new tools for the building-up of unitary transform ations from simple gates. We build on other recent results which simplify and extend Deutsch's original discovery [24] of a three-bit universal quantum logic gate. As a consequence of the greater power of quantum computing as a form al system, there are many more choices for the universal gate than in classical reversible

computing. In particular, D iV incenzo [28] showed that two-bit universal quantum gates are also possible; Barenco [29] extended this to show than almost any two-bit gate (within a certain restricted class) is universal, and L byd [30] and D eutsch et al.[31] have shown that in fact almost any two-bit or n-bit (n 2) gate is also universal. A closely related construction for the Fredkin gate has been given [32]. In the present paper we take a som ewhat di erent tack, showing that a non-universal, classical two-bit gate, in conjunction with quantum one-bit gates, is also universal; we believe that the present work along with the preceding ones cover the full range of possible repertoires for quantum gate array construction.

W ith our universal-gate repertoire, we also exhibit a number of e cient schemes for building up certain classes of n-bit operations with these gates. A variety of strategies for constructing gate arrays e ciently will surely be very in portant for understanding the full power of quantum mechanics for computation; construction of such e cient schemes have already proved very useful for understanding the scaling of Shor's prime factorization [33]. In the present work we in part build upon the strategy introduced by Sleator and W einfurter[9], who exhibited a scheme for obtaining the To oligate with a sequence of exactly ve two-bit gates. We nd that their approach can be generalized and extended in a number of ways to obtain more general e cient gate constructions. Some of the results presented here have no obvious connection with previous gate-assembly schemes.

W e will not touch at all on the great di culties attendant on the actual physical realization of a quantum computer | the problems of error correction [34] and quantum coherence [35, 36] are very serious ones. W e refer the reader to [37] for a comprehensive discussion of these di culties.

## 2 Introduction


We begin by introducing some basic ideas and notation. For any unitary


As shown by one of us [31, 29], alm ost any" single  $^{1}$  (U) gate is universal in the sense that: by successive application of this gate to pairs of bits in an n-bit network, any unitary transform ation m ay be approximated with arbitrary accuracy. (It su ces for U to be specified by Euler angles which are not a rational multiple of .)

We show that in some sense this result can be made even simpler, in that any unitary transformation in a network can always be constructed out of only the \classical" two-bit gate  $^{1}_{1}$   $^{0}_{1}$   $^{1}_{1}$  along with a set of one-bit operations (of the form  $^{0}_{0}$  (U)). This is a remarkable result from the perspective of classical reversible computation because it is well known that the classical analogue of this assertion | which is that all invertible boolean functions can be implemented with  $^{1}_{1}$   $^{0}_{1}$   $^{1}_{0}$  and  $^{0}_{0}$   $^{1}_{1}$  gates[38] | is false. In fact, it is well known that only a tiny fraction of Boolean functions (those which are linear with respect to modulo 2 arithmetic) can be generated with these gates[39].

We will also exhibit a number of explicit constructions of  $\uparrow_m$  (U) using  $\uparrow_1$  (U), which can all be made polynomial in m. It is well known [4] that the analogous family of constructions in classical reversible logic which involve building  $\uparrow_m = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$  from the three-bit To oligate  $\uparrow_2 = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$ , is also polynomial in m. We will exhibit one important dierence between the classical and the quantum constructions, however; To olishowed [4] that the classical  $\uparrow_m$  's could not be built without the presence of som e \work bits" to store intermediate results of the calculation. By contrast, we show that the quantum logic gates can always be constructed with the use of no workspace whatsoever. Similar computations in the classical setting (that use very few or no work bits) appeared in the work of C leve [40] and Ben-Or and C leve [41]. Still, the presence of a workspace plays an important role in the quantum gate constructions | we nd that to implement a family of  $\uparrow_m$  gates exactly, the time required for our implementation can be reduced from  $(m^2)$  to (m) merely by the introduction of one bit for workspace.

#### 3 N otation

W e adopt a version of Feynm an 's[7] notation to denote  $^{m}$  (U) gates and To oligates in quantum networks as follows.



In all the gate-array diagram s shown in this paper, time proceeds from left to right T he rst network contains a 2 (U) gate and the second one contains a 3-bit To oligate [42]. The third and fourth networks contain a 0 (U) and a 2-bit reversible exclusive-or (simply called XOR henceforth) gate, respectively. The XOR gate is introduced as the m easurement gate" in [24], and will play a very prominent role in many of the constructions we describe below. Throughout this paper, when we refer to a basic operation, we mean either a 0 (U) gate or this 2-bit XOR gate.

In all the gate-array diagram s shown in this paper, we use the usual convention that time advances from left to right, so that the left-m ost gate operates rst, etc.



### 5 Two-Bit Networks

#### 5.1 Simulation of General $^{1}$ (U) G ates

Lem m a 5.1: For a unitary 2  $2 \mod W$ , a  $^{1}(W)$  gate can be simulated by a network of the form



where A, B, and C 2 SU (2), if and only if W 2 SU (2).

Proof: For the \if" part, let A, B, and C be as in Lemma 4.3. If the value of the rst (top) bit is 0 then A B C = I is applied to the second bit. If the value of the rst bit is 1 then A  $_{x}$  B  $_{x}$  C = W is applied to the second bit.

Clearly,  $^{1}(S)$  composed with  $^{1}(W)$  yields  $^{1}(S W)$ . Thus, by noting that any unitary matrix U is of the form U = S W, where S = Ph() (for some) and W is 2 SU (2), we obtain the following.

C orollary 5.3: For any unitary 2 2 m atrix U, a  $^{1}$  (U) gate can be simulated by at most six basic gates: four 1-bit gates ( $^{0}$ ), and two XOR gates ( $^{1}$  ( $_{x}$ )).

#### 5.2 Special Cases


In Section 5.1, we have established a general simulation of a  $^{1}(U)$  gate for an arbitrary unitary U. For special cases of U that may be of interest, a more e cient

construction than that of C orollary 5.3 is possible. C learly, Lemma 5.1 immediately yields a more e cient simulation for all special unitary matrices. For example, the x-axis rotation matrix" (to use the language suggested by the mapping between SU (2) and SO (3), the group of rigid-body rotations[43])



Examples of matrices of the form of Lemma 5.4 are  $R_y()$  itself, as well as  $R_z() = R_z(\overline{2}) = R_y(0) = R_y(\overline{2})$ . However,  $R_x()$  is not of this form.



C orollary 5.6: For any unitary 2 2 matrix U, a  $^{1}$  (U) gate can be simulated by at most six basic gates: four 1-bit gates ( $^{0}$ ), and two gates ( $^{1}$  (V)), where V is of the form V = R<sub>z</sub>() R<sub>y</sub>() R<sub>j</sub>() x.


A particular feature of the  $^{1}(_{z})$  gates is that they are symmetric with respect to their input bits. In view of this, as well as for future reference, we introduce the following special notation for  $^{1}(_{z})$  gates.



### 6 Three-Bit Networks

#### 6.1 Simulation of General $^{2}(U)$ Gates

Lem m a 6.1: For any unitary 2 2 matrix U, a  $^{2}(U)$  gate can be simulated by a network of the form



where V is unitary.

Proof: Let V be such that  $V^2 = U$ . If the rst bit or the second bit are 0 then the transform ation applied to the third bit is either I or V V = I. If the rst two bits are both 1 then the transform ation applied to the third is V V = U 2

Some of the intuition behind the construction in the above Lemma is that, when the rst two input bits are  $x_1$  and  $x_2$ , the sequence of operations performed on the third

bit is: V i  $x_1 = 1$ , V i  $x_2 = 1$ , and V<sup>Y</sup> i  $x_1$   $x_2 = 1$ . Since

$$x_1 + x_2$$
  $(x_1 - x_2) = 2$   $(x ^ x_2)$ 

(where  $+ ", \ ", and \ "$  are the ordinary arithm etic operations), the above sequence of operations is equivalent to perform ing V<sup>2</sup> on the third bit i  $x_1 \wedge x_2 = 1$ , which is the  $^2$  (V<sup>2</sup>) gate. (This approach generalizes to produce a simulation of  $^m$  (V<sup>2<sup>m</sup> 1</sup>), for m > 2, which is considered in Section 7.)

We can now combine Lemma 6.1 with Corollary 5.3 to obtain a simulation of  $^{2}$  (U) using only basic gates ( $^{1}$  ( $_{x}$ ) and  $^{0}$ ). The number of these gates is reduced when it is recognized that a number of the one-bit gates can be merged and eliminated. In particular, the  $^{0}$  (C) from the end of the simulation of the rst  $^{1}$  (V) gate, and the  $^{0}$  (C<sup>Y</sup>) from the  $^{1}$  (V<sup>Y</sup>) gate combine to form the identity and are eliminated entirely. This same sort of merging occurs to eliminate a  $^{0}$  (A) gate and a  $^{0}$  (A<sup>Y</sup>) gate. We arrive at the follow ing count:

C orollary 6.2: For any unitary 2 2 m atrix U, a  $^{2}$  (U) gate can be simulated by at most sixteen basic gates: eight 1-bit gates ( $^{0}$ ) and eight XOR gates ( $^{1}$  ( $_{x}$ )).

A noteworthy case is when U = x, where we obtain a simulation of the 3-bit To oli gate  $^{2}(x)$ , which is the primitive gate for classical reversible logic [4]. Later we will use the fact that because  $^{2}(x)$  is its own inverse, either the simulation of Lemma 6.1 or the time-reversed simulation (in which the order of the gates is reversed, and each unitary operator is replaced by its Hermitian conjugate) may be used.


#### 6.2 Three-bit gates congruent to $^{2}(U)$

We now show that more e cient simulations of three-bit gates are possible if phase shifts of the quantum states other than zero are permitted. If we de ne the matrix W as '

$$W = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}^{1} = Ph(\frac{1}{2}) y;$$


then the gates  $^{2}$  (W) and  $^{2}$  ( $_{x}$ ) can be regarded as being \congruent m odulo phase shifts", because the latter gate di ers only in that it m aps jllli to jll0i (instead of jll0i). This is perfectly acceptable if the gate is part of an operation which m erely m in ics classical reversible computation, or if the gate is paired with another sim ilar one to cancel out the extra phase, as is sometimes the case in reversible gate arrangements (see C orollary 7.4); however, this phase di erence is dangerous in general if non-classical unitary operations appear in the computation. G ates congruent to  $^{2}$  ( $_{x}$ ) m odulo phase shifts have been previously investigated in [44].

The following is a more e cient simulation of a gate congruent to  $^{2}(x)$  modulo phase shifts:



where  $A = R_y(\frac{1}{4})$ . In the above, the  $\ = "$  indicates that the networks are not identical, but di er at most in the phases of their am plitudes, which are all 1 (the phase of the jl01i state is reversed in this case).


An alternative simulation of a gate congruent to  $^{2}(x)$  modulo phase shifts (whose phase shifts are identical to the previous one) is given by



where  $B = R_y(\frac{3}{4})$ .

### 7 n-Bit Networks

The technique for simulating  $^{2}(U)$  gates in Lemma 6.1 generalizes to  $^{m}(U)$  gates for m > 2. For example, to simulate a  $^{3}(U)$  gate for any unitary U, set V so that  $V^{4} = U$  and then construct a network as follows.



The intuition behind this construction is similar to that behind the construction of Lemma 6.1. If the set three input bits are  $x_1$ ,  $x_2$ , and  $x_3$  then the sequence of operations performed on the fourth bit is:

V	i	$x_1 = 1$	(100)
VУ	i	$x_1 x_2 = 1$	(110)
V	i	$x_2 = 1$	(010)
VУ	i	$x_2 x_3 = 1$	(011)
V	i	$x_1 x_2 x_3 = 1$	(111)

V	i	$x_{3} = 1$	(001).

The strings on the right encode the condition for the operation V or V<sup>y</sup> at each step | the \1"'s indicate which input bits are involved in the condition. For an e cient im plem entation of  $^{3}$  (U), these strings form a grey code sequence. Note also that the parity of each bit string determ ines whether to apply V or V<sup>y</sup>. By comparing this sequence of operations with the term s in the equation

 $x_1 + x_2 + x_3$  ( $x_1 \quad x_2$ ) ( $x_1 \quad x_3$ ) ( $x_2 \quad x_3$ ) + ( $x_1 \quad x_2 \quad x_3$ ) = 4 ( $x^{\land} x_2^{\land} x_3$ ); it can be veri ed that the above sequence of operations is equivalent to perform ing  $V^4$  on the fourth bit i  $x_1^{\land} x_2^{\land} x_3 = 1$ , which is the  $^3 (V^4)$  gate.

The foregoing can be generalized to simulate  $n_m$  (U) for larger values of m. Lem m a 7.1: For any n 3 and any unitary 2 2 matrix U, a  $n_{1}$  (U) gate can be simulated by an n-bit network consisting of  $2^{n-1} = 1 n_1$  (V) and  $n_1$  (V) gates and


#### $2^{n-1}$ $2^{n-1}$ (x) gates, where V is unitary.

W e om it the proof of Lemma 7.1, but point out that it is a generalization of the n = 4 case above and based on setting V so that  $V^{2^{n-2}} = U$  and im plementing" the identity

with a grey-code sequence of operations.

For some speci c sm all values of n (for n = 3, 4, 5, 6, 7, and 8), this is the most e cient technique that we are aware of for simulating arbitrary  $n_{n-1}(U)$  gates as well as  $n_{n-1}(x)$  gates; taking account of mergers (see Corollary 6.2), the simulation requires 3  $2^{1} 4^{1}(x)$ 's and 2  $2^{1} n_{0}$ 's. However, since this number is ( $2^{n}$ ), the simulation is very ine cient for large values of n. For the remainder of this section, we focus on the asymptotic grow th rate of the simulations with respect to n, and show that this can be quadratic in the general case and linear in many cases of interest.

7.1 Linear Simulation of  $^{n}_{n}_{2}$  ( $_{x}$ ) G ates on n-B it N etworks Lemma 7.2: If n 5 and m 2 f3;:::; $d_{2}^{n}$ eg then a  $^{n}_{m}$  ( $_{x}$ ) gate can be simulated by a network consisting of 4 (m 2)  $^{2}_{2}$  ( $_{x}$ ) gates that is of the form




(illustrated for n = 9 and m = 5).

Proof: Consider the group of the st 7 gates in the above network. The sixth bit (from the top) is negated i the st two bits are 1, the seventh bit is negated i the st three bits are 1, the eighth bit is negated i the st four bits are 1, and the ninth bit is negated i the st ve bits are 1. Thus, the last bit is correctly set, but the three preceding bits are altered. The last 5 gates in the network reset the values of these three preceding bits 2

Note that in this construction and in the ones following, although many of the bits not involved in the gate are operated upon, the gate operation is performed correctly independent of the initial state of the bits (i.e., they do not have to be \cleared" to 0 rst), and they are reset to their initial values after the operations of the gate (as in the computations which occur in [41] and [40]). This fact makes constructions like the following possible.

Lem m a 7.3: For any n 5, and m 2 f2;:::; n  $3ga_{n}(x)$  gate can be simulated by a network consisting of two  $n_m(x)$  gates and two  $n_m(x)$  gates which is of the form



(illustrated for n = 9 and m = 5).

Proof: By inspection 2


C orollary 7.4: O n an n-bit network (where n 7),  $a_{n-2}(x)$  gate can be simulated by 8 (n 5)  $_{2}(x)$  gates (3-bit To oligates), as well as by 48n 204 basic operations. P roof: First apply Lemma 7.2 with  $m_{1} = d_{2}^{n}e$  and  $m_{2} = n - m_{1} - 1$  to simulate  $a_{m_{1}}(x)$  and  $a_{m_{2}}(x)$  gates. Then combine these by Lemma 7.3 to simulate the  $a_{n-2}(x)$  gate. Then, each  $a_{2}(x)$  gate in the above simulation may be simulated by a set of basic operations (as in Corollary 6.2). We not that almost all of these To oli gates need only to be simulated modulo phase factors as in Sec. 6.2; in particular, only 4 of the To oligates, the ones which involve the last bit in the diagram above, need to be simulated exactly according to the construction of Corollary 6.2. Thus these 4 gates are simulated by 16 basic operations. A careful accounting of the mergers of  $a_{0}$  gates which are then possible leads to the total count of basic operations given above. 2

The above constructions, though asymptotically e cient, requires at least one \extra " bit, in that an n-bit network is required to simulate the (n - 1)-bit gate  $n_{n-2}(x)$ . In

the next subsection, we shall show how to construct  $n_1$  (U) for an arbitrary unitary U using a quadratic number of basic operations on an n-bit network, which includes the n-bit To oligate  $n_1(x)$  as a special case.

### 7.2 Quadratic Simulation of General ^<sub>n 1</sub> (U) Gates on n-Bit Networks

Lem m a 7.5: For any unitary 2 2 matrix U, a  $n_{n-1}(U)$  gate can be simulated by a network of the form



(illustrated for n = 9), where V is unitary.

P roof: The proof is very similar to that of Lemma 6.1, setting V so that  $V^2 = U 2$ C orollary 7.6: For any unitary U, a  $n_1(U)$  gate can be simulated in terms of  $(n^2)$  basic operations.

P roof: This is a recursive application of Lemma 7.5. Let  $C_{n-1}$  denote the cost of simulating a  $^{n-1}(U)$  (for an arbitrary U). Consider the simulation in Lemma 7.5. The cost of simulating the  $^{n}(V)$  and  $^{n}(V^{Y})$  gates is (1) (by Corollary 5.3). The cost of simulating the two  $^{n-2}(x)$  gates is (n) (by Corollary 7.4). The cost of simulating the  $^{n-2}(V)$  gate (by a recursive application of Lemma 7.5) is  $C_{n-2}$ .

Therefore,  $C_{n-1}$  satis es a recurrence of the form

$$C_{n-1} = C_{n-2} + (n);$$

which implies that  $C_{n-1} 2$  (n<sup>2</sup>) 2

In fact, we nd that using the gate-counting mentioned in C orollary 7.4, the number of basic operations is  $48n^2 + 0$  (n).

A lthough C orollary 7.6 is signi cant in that it perm its any  $_{n-1}$  (U) to be simulated with \polynom ial complexity", the question remains as to whether a subquadratic simulation is possible. The following is an (n) lower bound on this complexity.

Lem m a 7.7: Any simulation of a nonscalar  $n_1$  (U) gate (i.e. where U  $\neq$  Ph() I) requires at least n 1 basic operations.

P roof: Consider any n-bit network with arbitrarily m any 1-bit gates and few er than  $n = 1 \uparrow_1(x)$  gates. Call two bits adjacent if there there is a  $\uparrow_1(x)$  gate between them, and connected if there is a sequence of consecutively adjacent bits between them. Since there are few er than  $n = 1 \uparrow_1(x)$  gates, it must be possible to partition the bits into two nonempty sets A and B such that no bit in A is connected to any bit in B. This in plies that the unitary transform ation associated with the network is of the form A = B, where A is  $2^{\frac{n}{2}}$ -dimensional and B is  $2^{\frac{n}{2}}$ -dimensional. Since the transform ation  $\uparrow_{n=1}^{-1}(U)$  is not of this form, the network cannot compute  $\uparrow_{n=1}^{-1}(U)$  2

It is conceivable that a linear size simulation of  $^{n-1}(U)$  gates is possible. A lthough we cannot show this presently, in the remaining subsections, we show that something \similar" (in a number of di erent senses) to a linear size simulation of  $^{n-1}(U)$  gates is possible.

### 7.3 Linear Approxim ate Sim ulation of General<sup>^</sup>n 1 (U) Gates on n-Bit Networks

De nition: We say that one network approximates another one within " if the distance (induced by the Euclidean vector norm ) between the unitary transformations

associated with the two networks is at most ".

This notion of approximation in the context of reducing the complexity of quantum computations was introduced by Coppersm ith [33], and is useful for the following reason. Suppose that two networks that are approximately the same (in the above sense) are executed with identical inputs and their outputs are observed. Then the probability distributions of the two outcom es will be approximately the same in the sense that, for any event, its probability will diver by at most 2" between the two networks.

Lem m a 7.8: For any unitary 2 2 matrix U and " > 0, a  $n_{n-1}$  (U) gate can be approximated within " by (n log  $(\frac{1}{n})$ ) basic operations.

P roof: The idea is to apply Lemma 7.5 recursively as in C orollary 7.6, but to observe that, with suitable choices for V, the recurrence can be term insted after  $(\log (\frac{1}{\pi}))$  levels.

Since U is unitary, there exist unitary matrices P and D, such that  $U = P^{y} D P$ and

$$D = \begin{array}{c} e^{id_1} & 0 \\ 0 & e^{id_2} \end{array}$$

where  $d_1$  and  $d_2$  are real.  $e^{id_1}$  and  $e^{id_2}$  are the eigenvalues of U. If  $V_k$  is the matrix used in the k<sup>th</sup> recursive application of Lemma 7.3 (k 2 f0;1;2;:::g) then it is su cient that  $V_{k+1}^2 = V_k$  for each k 2 f0;1;2;:::g. Thus, it su ces to set  $V_k = P^y \quad D_k \quad P$ , where

$$D_{k} = \begin{array}{c} e^{id_{1}=2^{k}} & 0 \\ 0 & e^{id_{2}=2^{k}} \end{array};$$


for each k 2 f0;1;2;::g. Note that then

$$kV_{k} Ik_{2} = kP^{y} D_{k} P I_{k}$$
$$= kP^{y} (D_{k} I) P_{k}$$
$$kP^{y}k_{2} kD_{k} Ik_{2} kP_{k}$$
$$= kD_{k} Ik_{2}$$

Therefore, if the recursion is term inated after  $k = dlog_2(\frac{1}{n})e$  steps then the discrepancy between what the resulting network computes and  $n_1(U)$  is an (n - k)-bit transform ation of the form  $n_{k-1}(V_k)$ . Since  $k n_{k-1}(V_k) - n_{k-1}(I)k_2 = kV_k$  Ik<sub>2</sub> = $2^{dlog_2(\frac{1}{n})e}$  ", the network approximates  $n_{k-1}(U)$  within "2

#### 7.4 Linear Simulation in Special Cases

Lem m a 7.9: For any SU (2) matrix W , a  $n_{n-1}$  (W ) gate can be simulated by a network of the form



where A, B, and C 2 SU (2).

P roof: The proof is very similar to that of Lemma 5.1, referring to Lemma 4.3.2 Combining Lemma 7.9 with Corollary 7.4, we obtain the following.

Corollary 7.10: For any W 2 SU (2), a  $n_{n-2}$  (W) gate can be simulated by (n) basic operations.


As in Section 5, a noteworthy example is when

$$W = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}^{!} = Ph(\frac{1}{2}) y^{!}$$

In this case, we obtain a linear simulation of a transformation congruent modulo phase shifts to the n-bit To oligate  $^{n}_{n-1}(x)$ .

7.5 Linear Simulation of General<sup>^</sup><sub>n 2</sub> (U) Gates on n-B it N etworks W ith One B it F ixed

Lem m a 7.11: For any unitary U, a  $^{n}_{n 2}$  (U) gate can be simulated by an n-bit network of the form



(illustrated for n = 9), where the initial value of one bit (the second to last) is xed at 0 (and it incurs no net change).

Proof: By inspection 2

Combining Lemma 7.11 with Corollary 7.4, we obtain the following.


C orollary 7.12: For any unitary U, a  $n_{n-2}$  (U) gate can be simulated by (n) basic operations in n-bit network, where the initial value of one bit is xed and incurs no net change.

Note that the <code>\extra</code>" bit above m ay be reused in the course of several simulations of  $\simes$  (U) gates.

### 8 E cient general gate constructions

In this nal discussion we will change the ground rules slightly by considering the \basic operation" to be any two-bit operation. This m ay or m ay not be a physically reasonable choice in various particular in plem entations of quantum computing, but for the m on ent this should be considered as just a m athem atical convenience which will perm it us to address som ewhat m ore general questions than the ones considered above. W hen the arbitrary two-bit gate is taken as the basic operation, then as we have seen, 5 operations su ce to produce the To oligate (recall Lem m a 6.1), 3 produce the To oligate m odulo phases (we perm it a m erging of the operations in the construction of Sec. 6.2), and 13 can be used to produce the 4-bit To oligate (see Lem m a 7.1). In no case do we have a proof that this is the m ost econom ical m ethod for producing each of these functions; however, for m ost of these exam ples we have com pelling evidence from num erical study that these are in fact m inim al[44].

In the course of doing these num erical investigations we discovered a num ber of interesting additional facts about two-bit gate constructions. It is natural to ask, how m any two-bit gates are required to perform any arbitrary three-bit unitary operation, if the two-bit gates were permitted to im plem ent any m ember of U (4)? The answer is six, as in the gate arrangem ent shown here.



We nd an interesting regularity in how the U (8) operation is built up by this sequence of gates, which is sum marized by the \dimensionalities" shown in the diagram. The rst U (4) operation has  $\hat{4} = 16$  free angle parameters; this is the dimensionality of the space accessible with a single gate, as indicated. W ith the second gate, this dimensionality increases only by 12, to 28. It does not double to 32, for two reasons. First, there is a single global phase shared by the two gates. Second, there is a set of operations acting only on the bit shared by the two gates, which accounts for the additional reduction of 3. Form ally, this is sum marized by noting that 12 is the dimension of the coset space SU (4)/SU (2). The action of the third gate increases the dimensionality by another  $9 = 16 \ 1 \ 3 \ 3.9$  is the dimension of the coset space SU (4)/SU (2). The further subtraction by 3 results from the duplication of one-bit operations on both bits of the added gate. At this point the dimensionality increases by nine for each succeeding gate, until the dimensionality reaches exactly 64, the dimension of U (8), at the sixth gate. In preliminary tests on four-bit operations, we found that the same nules for the increase of dimensionality applied. This permits us to make a conjecture, just based on dimension counting, of a lower bound on the number of two-bit gates required to produce an arbitrary n-bit unitary transform ations will be computationally uninteresting, since they will require exponentially many operations to implement.

Finally, we mention that by combining the quantum gate constructions introduced here with the decomposition form ulas for unitary matrices as used by Reck al.[15], an explicit, exact simulation of any unitary operator on n bits can be constructed using a nite number ( $(n^3 4^n)$ ) of two-bit gates, and using no work bits. In outline, the procedure is as follows: Reck et al.[15] note that a form ula exists for the decomposition of any unitary matrix into matrices only involving a U (2) operation acting in the space of pairs of states (not bits):

$$U = ( \sum_{x1;x22 \text{ f0; 1g}^{m}; x1>x2}^{Y} T (x1;x2) ) D :$$

T (x1;x2) perform sa U (2) rotation involving the two basis states x1 and x2, and leaves all other states unchanged; D is a diagonal matrix involving only phase factors, and thus can also be thought of as a product of  $2^{n-1}$  matrices which perform rotations in two-dimensional subspaces. U sing the methods introduced above, each T (x1;x2) can be simulated in polynomial time, as follows: write a grey code connecting x1 and x2; for example, if n = 8, x1 = 00111010, and x2 = 00100111:

- 1 00111010 x1
- 2 00111011
- 3 00111111
- 4 00110111
- 5 00100111 x2

O perations involving adjacent steps in this grey code require a simple modil cation of the  $n_{n-1}$  gates introduced earlier. The (n-1) control bits which remain unchanged are not all 1 as in our earlier constructions, but they can be made so temporarily by the appropriate use of NOT gates  $(n_0(x))$  before and after the application of the  $n_{n-1}$  operation. Now, the desired T (x1;x2) operation is constructed as follows: rst, permute states down through the grey code, performing the permutations (1,2), (2,3), (3,4), ... (m-2,m-1). These numbers refer to the grey code elements as in the table above, where m, the number of elements in the grey code, is 5 in the example. Each of these permutations is accomplished by a modil ed  $n_{n-1}(x)$ . Second, the desired U (2) rotation is performed by applying a modil ed  $n_{n-1}(U)$  involving the states (m-1) and (m). Third, the permutations are undone in reverse order: (m-2,m-1), (m-3,m-2), ... (2,3), (1,2).

The number of basic operations to perform all these steps may be easily estimated. Each T (x1;x2) involves  $2m = 3 \pmod{n}$  (modi ed)  $\hat{n}_{n-1}$  gates, each of which can be done in

 $(n^2)$  operations. Since m, the number of elements in the grey code sequence, cannot exceed n + 1, the number of operations to simulate T (x1;x2) is  $(n^3)$ . There are  $0 (4^n)$  T's in the product above, so the total number of basic operations to simulate any U  $(2^n)$  matrix exactly is  $(n^34^n)$ . (The number of steps to simulate the D matrix is smaller and does not a left the count.) So, we see that this strict upper bound di ers only by a polynom ial factor (which likely can be made better than  $n^3$ ) from the expected lower bound quoted earlier, so this Reck procedure is relatively \e cient" (if something which scales exponentially may be termed so). A serious problem with this procedure is that it is extremely unlikely, so far as we can tell, to provide a polynom ial-time simulation of those special U  $(2^n)$  which permit it, which of course are exactly the ones which are of most interest in quantum computation. It still remains to nd a truly e cient and useful design methodology for quantum gate construction.
