# Q uantum M echanics as a C lassical Theory I: N on-relativistic Theory

#### Abstract

T he ob jective of this series of three papers is to axiom atically derive quantum $m$ echanics from classicalm echanics and tw o other basic axiom s . In this rst paper, Schroendiger's equation for the density $m$ atrix is st obtained and from it Schroedinger's equation for the wave functions is derived. The $m$ om entum and position operators acting upon the density $m$ atrix are de ned and it is then dem onstrated that they com $m$ ute. Pauli's equation for the density $m$ atrix is also obtained. A statistical potential form ally identical to the quantum potential of B ohm 's hidden variable theory is introduced, and this quantum potential is reinterpreted through the form alism here proposed. It is show $n$ that, for dispension free ensem bles, Schroedinger's equation for the density $m$ atrix is equivalent to N ew ton's equations. A general non-am biguous procedure for the construction of operators which act upon the density $m$ atrix is presented. It is also show $n$ how these operators can be reduced to those which act upon the wave functions.


## 1 G eneral Introduction

Ever since the establishm ent of the C openhagen Interpretation and it's purely epistem ological point of view, quantum mechanics has been sub ject to criticism, debates and of constant revisionary attem pts trying to alter it in one way or another []][]]. O ther than the hidden variables theories, few attem pts were $m$ ade to reconstruct quantum theory on the lines of $R$ ealism. E ven these theories, according to Bell's theorem 8]-10], m ust posses non-local characteristics little acceptable to a realist such as E instein [1]
$P$ art of the problem resides in the fact that, unlike relativistic theories, it has been hitherto im possible to derive quantum $m$ echanics from classicalm echanics though the insertion of a few com plem entary postulates capable of identifying
the di erences betw een both theories. T he absence of this derivation has led $m$ ost physicists to believe in the existence of an unbridgeable conceptual abyss separating the tw o theories 11]. B ecause ofthis, $m$ ost of the ontologies proposed for quantum $m$ echanics reject $R$ ealism a priori.

In this series of papers we intend to dem onstrate that both relativistic and non-relativistic quantum $m$ echanics can be derived from classical mechanics thorough the addition oftwo som ew hat "natural" postulates which do not alter the classical character of the derivation. W e intend to dem onstrate that, based on a rather sim ple generalization of these postulates, it is possible to construct a relativistic generalquantum theory for ensem bles of single particle system $s$.

O ne of the m ost im portant results, at least w here epistem ology is concemed, is the $m$ athem atically backed negation of the ontologicalorigin of $H$ eisem berg's uncertainty relations. $T$ his is the key to refuting the $C$ openhagen Interpretation as a whole together w ith it's ontology [12]. A lso in the relation to epistem ology, we propose a quantum $m$ odel in which the observer is included $w$ thout its ad hoc postulation being necessary 13]. From there, we m aintain that a general $m$ easurem ent theory in quantum $m$ echanics (and in allofphysics) is im possible, analyzing von $N$ eum ann's [14] attem pt as an exam ple.

In the sam e m anner, and independently of Bell's argum ent 9,15$]$, which we reject, we dem onstrate the errors in von Neum ann's theorem on the im possibility of hidden variable theories. O ur counter example is a theory of local behavior. W e show that B ell's theorem does not necessarily entail in non-local quantum $m$ echanics and that quantum $m$ echanics' hidden variable theory is, in fact, new tonian $m$ echanics itself. W e also take this opportunity to dem onstrate that B ohm 's $7,16,17]$ theory is not truly a hidden variable theory and reinterpret its form alism.

In a totally form al perspective, we show that Schroedinger's equation for the density $m$ atrix is fundam ental, and not that for the probability am plitudes. A lso, D irac's second order equation is show $n$ to be the fiundam entalone (and not his linear equation) 18]. W e also present a generaltechnique for the construction of operators (19].

W e therefore dem onstrate that, starting from ourbasic axiom $s$, it is possible to obtain all of quantum $m$ echanics and $m u c h ~ m o r e, ~ a n d ~ t h a t ~ t h i s ~ t h e o r y ~ i s ~$ nothing $m$ ore than a classical theory.
$T$ his series of papers is divided in the follow ing $m$ anner:
In this rst paper we develop non-relativistic form alism in it's $m$ ost funda$m$ ental results, obtain ing Schroedinger's equations for the density $m$ atrix (w hich we call the density function) and for the wave function (which we call the probability am plitude). W e develop the concept of operators which act upon the density function and upon the probability am plitude, and dem onstrate that the rst commute according to di erent rules from the latter - in the appendix we present a general technique free from am biguities for obtaining operators. $P$ auli's equation is also obtained by including intemaldegrees of freedom associated to the intrinsic $m$ agnetic $m$ om ent. $T$ he basic equations for $B$ ohm 's hidden
variable theory are also found, but only shortly discussed. W e also dem onstrate how to introduce the observer into quantum form alism. T he epistem ological im plications of our results are left for the third paper of this series.

In the second paper we derive Schroedinger's relativistic equations for the density function and for the probability am plitude through sm allm odi cations in the axiom s of the rst paper, $m$ aking them coherent $w$ ith the special theory of relativity. The calculations of the rst paper are repeated in order to nd a relativistic theory for one particle. W e also nd a system ofequations involving E instein's which take into account the e ects of gravitation.

The third and nal paper of this series discusses the epistem ological im plications of the results of the rst two papers. B ased upon the clari cation of H eisem berg's $m$ isconception interpretation of the uncertainty relations, we construct a R ealistic Interpretation to contrast w ith C openhagen's. V on N eum ann's $m$ easurem ent theory is discussed in com parison to the results of our rst paper through Realistic epistem ology. W e dem onstrate that von $N$ eum ann's theorem on the im possibility of a hidden variable theory is not correct but that, on the other hand, Bell's argum entation is also unacceptable. To be m ore precise, we dem onstrate that, taking the non-relativistic case as an exam ple, new tonian theory is the theory of hidden variables of quantum $m$ echanics. Bell's theorem is analyzed and we dem onstrate that it does not im ply in a non-locality ofquantum m echanics. W e discuss B ohm 's theory and dem onstrate that it cannot be a hidden variable theory, since it is not free of the dispersions associated with H eisem berg's relations.

## 2 Introduction

In this paper, we obtain non-relativistic quantum theory's mathem atical for$m$ alism from new tonian $m$ echanics and two additional postulates. For reasons of clarity, these results are presented in an axiom atic way.

In the third section, we present the basic form alism, deriving Schroedinger's equations for the density function and for the probability am plitude. W e introduce the operator concept for these two functions and dem onstrate that they obey distinct com m utation law s. From there we show that H eisem berg's uncertainty relations are not ontological, but purely form al.

In the fourth section, Pauli's equation for the density function is derived taking into consideration the particle's intemalm agnetic $m$ om ents.

In the fth section, we introduce and interpret the idea of statistical potential, form ally sim ilar to B ohm 's quantum potential.
$T$ he sixth section proposes a quantum experim ent arrangem entw here a physical system acting as an extemalobserver is introduced and its in uence can be form ally taken into account.

In the last section, we present our conclusions.

The appendix A discusses som e of $W$ igner $M$ oyal In nitesim al $T$ ransform ation's properties of the state functions $F(x ; p ; t)$. It is also dem onstrated that Schroedinger's equation for the density function can be reduced to N ew ton's equations in the lim it of dispersion free ensem bles.

A ppendix B brings a general free from am biguities $m$ ethod for the construction of operators.

In appendix $C$ the calculationsm ade in the body of the w ork are generalized for three-dim ensional system s com posed ofm any particles.

A ppendix D is concemed w ith the de nition ofm ixed states and the introduction of the concept of density $m$ atrix. The relation betw een the calculations m ade in the m ain text and the trace operation upon the density m atrix is also investigated.

In both this paper and the other two we w ill use the term s "classical" and "quantum " m eaning a classical statistical $m$ echanics built upon phase or conguration space, respectively (as w ill becom e clear ahead).

## 3 A xiom s and Form alism

W e begin our theory w ith ensem bles described by probability density functions in classical phase space written as $F(x ; p ; t)$. The variables which label this function represent the position and the $m$ om entum of the particles that $m$ ake up the ensem ble.

Let us now list the theory's axiom s:
(A 1) N ew tonian particle m echanics is valid for all particles which constitute the system s which com pose the ensem ble.
(A 2) For an isolated system the joint probability density function is conserved:

where ' is a universal param eter (having the sam e value for all transform ations) $w$ ith dim ensions of angular $m$ om entum, is adequate for the description of any non-relativistic quantum system (this de nition di ers from that usually $m$ ade in the literature 20]-22] in its in nitesim alnature just em phasized).

W enow dem onstrate that allnon-relativistic quantum mechanics, and som e additional results, can be obtained from these axiom s.

U sing equation (1) we have

which we call Schroedinger's $F$ irst Equation for the density function ( $\left.y ; y^{0} ; t\right)$. $T$ his equation is valid for allvalues ofy and $y^{0}$, as long as these are in nitesim ally close, as can be seen in (G). It m ust not be forgotten that this consideration is not inconvenient to our calculations, for reasons that will becom e clear ahead. W e have proven the follow ing theorem:
(T 1) The density function $\left(y ; y^{0} ; t\right)$ satis es Schroedinger's First Equation 10) being ' a param eter to be determ ined experim entally (w e know that this param eter is $P$ lank's constant and thus we will henceforth w rite $h$ instead of ${ }^{\prime}$ ).

Let us now suppose that we can w rite

is the probability density in con guration space, as becom es clear if we look at expression (2). This last equation justi es the com $m$ ent $m$ ade after (10); the $m$ ean values of the quantities $w i l l$ alw ays be calculated $w$ ithin the lim it given in 17) so that the calculation of the density function for in nitesim ally close points can be done $w$ thout the loss of generality. (for $m$ ixtures, see appendix D). This does not imply that only the elem ent for which $x$ is equal to zero contributes. The kinem atical evolution of the density function is govemed by
equation (6) which $m$ ixes all the contributions. T he abovem entioned lim it m ust be taken after this equation has been solved.

Equation 16) can be rew ritten as

W e can obtain the constant's value considering the solution for a free particle. C alculations done, it is easy to dem onstrate that this constant should cancel itself. W ith this constant equal to zero, equation (16) is equivalent to

W e introduce the operator concept through the form al identi cation (an apostrophe will alw ays be put in order to distinguish operators which act upon the density function from those that act upon the probability am plitude)

known as $H$ eisem berg's uncertainty relation, $m$ ust be valid. Before this result is interpreted, it is necessary to stress that

This result was, in fact, expected since no hypothesis about the m ean squared deviations associated to the (classical) function $F(x ; p ; t)$ were $m$ ade. It dem onstrates that the relation (30) results from the recognition of the possibility of w riting the density function as the product represented in (11). In thism anner, far from representing a fundam entalproperty ofnature, relation 30) represents a lim itation of our descriptions according to equation 19). We put this as a theorem :
(T 4) Q uantum mechanics, as developed according to equation 19), is only applicable to problem swhere the density function can be decom posed according to (11). In these cases, the product of the $m$ ean quadratic deviations in the position and $m$ om entum of a system represented by the joint probability density function $F(x ; p ; t)$ is such that

$W$ e here note that $m$ anuals com $m$ only assum e that the Second Schroedinger's Equation for the probability am plitude is the fundam ental one to be obtained and that, w riting the density function as in (11), the F irst Schroedinger's Equation is derived. W e dem onstrate here that this sequence is unjusti able. W hile the equation for the am plitudes presents us w ith a dispersion relation such as in (30), the equation for the density function is dispersion free (see appendix D).

The results obtained above are the foundation of the whole non-relativistic quantum $m$ echanical form alism, which we will not derive again.

Let us pass on to the derivation of $P$ auli's equation

## 4 P auli's Equation

Up to this point we have discussed only system sconstituted of particles with no intemal degree of freedom. C onsider now the case in which the system 's com ponents possess an intrinsic $m$ agnetic $m$ om ent capable of coupling to an extemalm agnetic eld. W e can expand this eld around the region occupied by the particle

$T$ he extra degrees of freedom are represented by quantities $m_{i}$, which we do not know. To obtain inform ation about these quantities, we can consider the precession equation which they should obey

where $g$ is the Lande factor. $O$ bviously, we can not know the value of this factor until we study the relativistic problem.

W e have obtained the follow ing result:
(T 5) A body w ith intemalm agneticm om ent capable ofcoupling to an extemal $m$ agnetic eld obeys P auli's Equation (36).

In the second paper of this series we approach the general and special relativistic quantum $m$ echanical problem of ensem bles com posed of single particle system s . W e will also derive D irac's and K lein $G$ ordon's Equations in addition to a general relativistic quantum equation.

## 5 The Statistical P otential

W e can retum to equation (18)

The integration of the system (42), 43) w ill give us a series of tra jectories which w illbe equivalent to the "force" lines associated to the e ective potential 41). The resolution $m$ ethod for this system of equations is as follow $s$ : rst Schroedinger's equation $m$ ust be solved in order to obtain the probability am plitudes referent to the ensem ble. O nce these am plitudes have been obtained, the e ective potential, which will act as a statistical eld for the ensem ble, is buill. O ne rather instructive exam ple of this calculation is It's application to the double slit experim ent 24] (an exam ple of a tim e dependent problem can be found in the literature 25].

It $m$ ust be stressed that the equations for the individual constituents of the system are $N$ ew ton's equations. T hus, the potential 41) m ust not be considered a realpotential, but a ctitious potentialwhich acts as a eld in reproducing, through "trajectories", the statistical results of the original equation 40). We see this potential as a statistical potential.

The discussion of Bohm 's hidden variable theory [] along this reinterpretation of the potential 41) w ill be undertaken in the last paper of this series.

## 6 The O bserver

$W$ th the advent of quantum $m$ echanics, the question of the observer began to occupy a prom inent position in physics. T reated w ith m athem atical rigor for the rst tim e by von $N$ eum ann 14], and later by a series of authors $4,6,17,26,27]$, the observer acquired elevated epistem ological status through quantum theory, even though his function w ithin this theory's form alism is rather disputable 13], since the variables to him associated never occur within the form alism itself (this willbe further discussed in the third paper of this series).
$T$ he various $m$ easurem ent theories which have been proposed have profound epistem ologicaland philosophicalim plications. O ne exam ple is the C openhagen Interpretation's inevitable conclusion that the observer's consciousness is necessary in the $m$ easuring process - as it is responsible for the collapse of the state
vector $w$ hen an observation is $m$ ade 14, 27]. W e shall present a $m$ odel in $w$ hich the observer, seen as a physical system, $m$ ay be introduced into quantum theory. $W$ e are not suggesting a generalm easurem ent theory, as did von $N$ eum ann, but analyzing a speci c physicalsystem. $N$ evertheless, the m odel here proposed w ill give us conditions to discuss the philosophical fram ew ork of $m$ easurem ent theories proposed for quantum theory.

It $m$ ust be noted that the fundam ental equation used, Liouville's equation in phase space, is valid only for a closed system. Such a system [4] m ay have its behavior described by Schroedinger's $F$ irst equation, but then there is no collapse of the state vector (no observer at all). In this manner, the state vector's collapse m ust alw ays be postulated as a consequence of the intervention of a ghost extemal observer, as it is by von $N$ eum ann, for exam ple. A nd $m$ ore, since this observer could be considered a $m$ em ber of a larger system, we are forced, in traditional analysis, to an in nite regression which stops only when an observer $w$ ith a consciousness capable of such a reduction is postulated 27].

Y et let us see how we can treat a particular case in the perspective ofR ealism .
C onsider a two slit experim ent as show $n$ in gure 1. In this experim ent the sourcel sends typel particles through one of the rst sources slits. These particles have distribution $F_{1}^{0}(x ; p ; t)$ when they leave sourcel and, w thout the in uence of extemal factors, w ould have a $F_{1}(x ; p ; t)$ distribution $m$ easured by the detectorsl of the second screen. But let us say that we desire to $m$ easure this distribution in a position previous to the second screen (a typically inter phenom enon $m$ easure). In this case we position source2, capable of em itting type2 particles, as is shown in gure 1. These particles exit source2 w th the distribution $\mathrm{F}_{2}^{0}$ (x;p;t) and if it was not for the typel particles they would hit detectors2 $w$ ith the distribution $F_{2}(x ; p ; t)$. A ccording to the hypothesis of R ealism, we can expect that the alteration of these tw o distributions w illbe the product of collisions betw een both system 's particles (considered distinct here for sim plicity). So, after the collisions take place we expect to nd system 1 and system 2 represented by the distributions $F_{1}^{1}(x ; p ; t)$ and $F_{2}^{1}(x ; p ; t)$ respectively.

W e expect, as we do for Boltzm ann's Equation 28], that the equation satised by the new $F_{1}{ }^{1}$ distribution be now given as

where (2) = ( $\left.y_{2}^{0} ; y_{2}\right)$ refers to system 2 sub ject to a potential $V^{0}(x)$, possibly distinct from $V(x)$ (we are supposing a purely contact based interaction betw een the di erent particles and that there are no multiple collisions between the particles).

This "sym m etry" between observer and observable is extrem ely im portant for the specialtheory of relativity's point ofview. It is also im portant to observe that it is no longer possible to obtain an equation such as Schroedinger's Second Equation from 55) or 56) (of course, for a weak interaction betw een the two system s, such an equation can be approxim ated). The "w ave" properties associated to these particles should, depending on the intensity of the interaction betw een both system, disappear. W e here note that this property, as all of th is problem 's treatm ent, is quite distinct from the state vector's collapse.

W ew illdiscuss the ep istem ologicalim plications of these and other properties of equations 55) and 56) in the third paper of this series.

## 7 C onclusion

From no m ore than three axiom $s$ and within a classical and coherent with Realism view of nature, it was possible to derive all of quantum $m$ echanical for$m$ alism. It was also possible to derive the im portant issue of $H$ eisem berg's dispersion relations, one of the most fundam ental result of the $C$ openhagen Interpretation (12].

In the second paper of th is series, we will undertake relativistic treatm ent.
In the nal paper, we will discuss the epistem ological im plications of the results that we have obtained.

## A $M$ athem atical $P$ roperties of the $T$ ransform ation

$N$ evertheless, we should stress that it was necessary to consider $x$ as being in nitesim al, in order for the density function to satisfy Schroedinger's First Equation. In this $m$ anner, the transform ation 58) can not be perform ed. This $m$ eans that, even possessing the solution to the quantum problem, given by the density function, we can not obtain the probability density $F$ ( $x ; p ; t$ ) in phase space. O $n$ the other hand, it is interesting to note that, if w e have the solution in phase space (usually called classical), we can obtain the density function (usually called quantum ) through the application of 57).

Even in view of the im possibility of the inverse transform ation 58), we can easily dem onstrate that

A lso note that, in the perspective of the present work, the lim it h! 0 would not $m$ ake sense due to the $W$ igner $M$ oyal In nitesim al Transform ation.

## B O perator C onstruction

O ne of the problem sfound win the usual form ulation of quantum $m$ echanics concems the construction of operators which represent a certain function in the phase space 13]. This problem is basically caused by the fact that we usually w ork w ith operators which act upon the probability am plitude and do not com $m$ ute $w$ ith each other. $W$ e have seen, in the third section of this paper, that we can de ne position and $m$ om entum operators which act upon the density function and com $m$ ute $w$ th each other. Therefore we hope to be capable of, given a function $f(x ; p ; t)$, constructing an operator to represent it $w$ hen acting upon the density function. In fact, let $f(x ; p ; t)$ be a function whose $m$ ean value we desire to calculate. In this case we have

$T$ he greatest di cult associated to the $m$ ethods of operator construction in usual quantum mechanics refers to a certain ambiguity which they present 19] or their incom patibility to the one to one correspondence betw een operators and observables postulated in quantum $m$ echanics. For a problem involving $N$ particles the state of the ensem ble is represented by the function $\mathrm{F}\left(\mathrm{x}_{1} ; \mathrm{p}_{1} ;: ; \mathrm{x}_{\mathrm{N}} ; \mathrm{p}_{\mathrm{N}} ; \mathrm{t}\right)$. For this function we w ill have

Schroedinger's Second Equation can be obtained from 79) w ith calculations sim ilar to those realized for the one dim ensional problem .

## D D ensity M atrix

U ntil now we have only dealt w th ensem bles which can be represented by pure states 31]. In this appendix we will proceed to generalize the theory for $m$ ixed states. W e w ill also show that the procedure usually followed in the literature involves an additionalassum ption. Indeed, when developing the densiy $m$ atrix theory one usually begins w ith the am plitudes which are solutions of the Second Schroedinger'sEquation $j$ i and then de ne the density function as the product

where $y$ and $y^{0}$ run independently. W e will suppose throughout this appendix that it is alw ays possible to w rite the density function as the product 11) and w ill show that 80 ) is related to this additional assum ption.

It w as seen for pure states (see appendix B) that, when the decom position given by expression 11) is possible, we can alw aysw rite an operator acting upon
the density function $Q$ as another one acting upon the probability am plitudes $Q, m$ athem atically:

In the above derivation, we begin $w$ ith the density function and an operator acting upon it and then, supposing decom position 82), tumed into a form alism w ith probability am plitudes and the related modi ed operator. W hen $m$ aking such calculations it was necessary to take the lim it $\mathrm{x}!0$. This lim it im plies changing from a com $m$ utative form alism into a non \{com $m$ utative one, as is stated by theorem (T 4). Expression (84) and (91) are equivalent only if it is possible to consider $y$ and $y^{\prime}$ as independent variables (not necessarily in nitesim ally separated). T hat such a supposition is $m$ ade $w$ hen we use decom position (82) w ill now be dem onstrated.

W hen decom position (82) is assum ed, it is easy to show that the density function equation can be written as

So we conclude that, only when it is possible to write the density function as in (82), the $m$ ean values of the operators $Q$ can be calculated using form ulae (85)-91), as is usually done in the literature.
