Combinatorial Computation of Clebsch-Gordan Coe cients

The addition of angular momenta can be reduced to elementary coupling processes of spin- $\frac{1}{2}$ -particles. In this way, a method is developed which allows for a non-recursive, simultaneous computation of all C lebsch-G ordan coecients concerning the addition of two angular momenta. The relevant equations can be interpreted easily, analogously to simple probabilistic considerations. They provide an improved understanding of the addition of angular momenta as well as a practicable evaluation of C lebsch-G ordan coecients in an easier way than within the well-known methods.

I. IN TRODUCTION

A.De nition and properties of Clebsch-Gordan coe cients

A system of two quantum mechanical angular momenta is characterized by the angular momentum operators of the total angular momentum \hat{J}^2 , \hat{J}_z and the operators of the individual angular momenta \hat{J}_1^2 , \hat{J}_{1z} , \hat{J}_2^2 , \hat{J}_{2z} . These operators can be classied into two groups in which the corresponding operators commute [1]:

Hence the basis states can be chosen as

coupled eigenstates, denoted by $j_{1}; J_{2}; J; M i \text{ or } jJ; M i,$

uncoupled eigenstates, denoted by $jI_1; J_2; M_1; M_2 i$ or $j(M_1; M_2) i$.

These complete basis systems are related to each other via an unitary transformation:

The amplitudes h(M $_1$; M $_2$) jJ; M i in (1) are called C lebsch-G ordan (CG) coe cients. General properties of the CG coe cients are given e.g. in Ref. [1]. Here only a few are listed:

CG-coe cients vanish if M \oplus M₁ + M₂.

The total angular momentum J satis es $\mathbf{j} J$ $J_2 \mathbf{j} J$ $J_1 + J_2$.

CG-coe cients can be chosen as real.

B.Conventionalm ethods

A standard m ethod for calculating C G -coe cients (see e.g. [2]) is based on the iterative application of the operator \hat{J} iJ $_y$ on the maximum state

where $J = J_1 + J_2$ and $M = M_1 + M_2$. The e ect of the lowering operator on jJ; M i is given by

The CG-coe cients are obtained by projecting the resulting states onto the uncoupled product state h(M₁; M₂) j.

Furtherm ore, R acah gave an elaborate but explicit form ula for the CG- ∞ e cients (see e.g. [2]). B oth the m ethods are very form all and render the evaluation even in the case of "sm all" angular m om enta cum bersom e. Thus CG- ∞ e cients have been listed in tables (see e.g. [3]).

Here we propose an intuitive way allowing for an immediate computation of CG-coe cients. First we will consider the special case of coupling of two angular momenta to their maximum angular momentum, before we will turn to the general case in section III. Based on these investigations we will provide a very simple way of calculating CG-coe cients in section IV. In the appendix we will prove the equivalence of our method with the Racah formula.

II. ADD IT ION OF TWO ANGULAR MOMENTA TO THEIR MAXIMUM ANGULAR MOMENTUM

By speaking of a spin-J-particle in the following we denote any object with angular momentum J, e.g. also orbital angular momenta, in order to avoid the inconvenient expression \objects with angular momentum J".

A . D ecom position of a particle into spin $\frac{1}{2}$ particles

A coording to Schwinger's oscillator model of angular momentum [1,4] every spin-J-particle can be considered as a composition of 2J spin- $\frac{1}{2}$ -particles. Then a particle described by the state jJ;M i with angular momentum J and z-component M consists of

This idea relies on the fact that the 2J spin $-\frac{1}{2}$ -particles satisfy the same transformation relations under rotation as a spin-J-particle. Thus, if we are interested in the angular momentum of a spin-J-particle, i.e. its transformation properties under rotation, we might consider j=2J spin $-\frac{1}{2}$ -particles as well. Only in this sense we might speak of a spin-J-particles consisting of spin $-\frac{1}{2}$ -particles. In order to distinguish real spin $-\frac{1}{2}$ -particles from the constituent spin $-\frac{1}{2}$ -particles we will call the latter imaginary spin $-\frac{1}{2}$ -particles.

In the following the question, how many possibilities of decomposing a particle described by the state jJ; M i into imaginary spin $-\frac{1}{2}$ -particles exist (see table I), will play a crucial role. We know that there are u=J+M imaginary particles of the j particles after the decomposition in the state *. Then the number of possibilities is given by

We say, the state jJ; Mi consists of sim aginary states. As we will see later on, the CG-coe cients depend on the number of the imaginary states belonging to the particles under consideration. This number is given by the 2Jth row of the binominal expansion (Pascal's triangle) (see table II) for all (for the spin-J-particle) possible M-values.

B.C om putation of the CG -coe cients for $J = J_1 + J_2$

The matrix 0

We will now investigate the special case of the coupling of two particles with angular momenta J_1 and J_2 to a system with the maximum angular momentum

As we have seen in (1), the coupled state jJ;M is composed of all uncoupled states $j(M_1;M_2)$ ifor which $M=M_1+M_2$ holds. Since there must be no interference between the uncoupled states { this would lead to $J < J_1 + J_2$ { , we expect real and positive CG-coe cients (according to the usual phase convention). This enables us to determ ine the CG-coe cients from square roots of probabilities. The square of the CG-coe cient $h(M_1;M_2)$ jJ;M is corresponds to the probability of noting the individual particles in the state $j(M_1;M_2)$ is at the instance of measuring the total angular momentum. This probability follows by decomposing the coupled and uncoupled states according to section IIA into

their imaginary spin- $\frac{1}{2}$ -particles and counting the number of imaginary states generated in this way. We denote the number of imaginary states of the coupled system by s_c and the one of the uncoupled system by s_{c} , respectively.

The quantity s_{uc} is given by the product of the number of the imaginary states of the individual particles, because each of the $\frac{j_1}{u_1}$ states of particle 1 can generate a new state with each of the $\frac{j_2}{u_2}$ states of particle 2. The fact that the coupled state and the sum of all uncoupled states with $M=M_1+M_2$ describe the same physical system suggests that both should have the same number of imaginary states, leading to

where the sum s extends over all u_1 ; u_2 w ith $u_1 + u_2 = u$, corresponding to M $_1 + M _2 = M$. Eq. (3) is known as the addition theorem for binomial coe cients (see e.g. [5]).

The desired probabilities, i.e. the squares of the CG-coe cients, will be obtained by the simple assumption that the combined system is found in each of the $\frac{j}{n}$ imaginary states with equal probability.

If we could determ ine the imaginary state of the system, we would obtain a state after $\begin{pmatrix} j_1 & j_2 \\ u_1 & u_2 \end{pmatrix}$ of $\begin{pmatrix} j \\ u \end{pmatrix}$ measurements in the average, which according to (3) originates uniquely from the decomposition of the uncoupled state $j(M_1;M_2)i$. Hence the desired propability of inding the system in the state $j(M_1;M_2)i$ is given by $\begin{pmatrix} j_1 & j_2 & j \\ u_1 & u_2 & u \end{pmatrix}$. In this way we obtain an expression for the CG- ∞ e cient in the case $J=J_1+J_2$:

Therefore, in this special case the CG-coe cients can be understood in an elementary way. Nature chooses the simplest way, not distinguishing any of the s_c imaginary states. The $u=u_1+u_2$ %-states and the $d=d_1+d_2$ states are coupled with equal probabilities to all possible imaginary states. Some of these states (s_{uc}), however, are interpreted as an uncoupled state. Thus the coupled system consists according to the ratio $\frac{s_{uc}}{s_c}$ of this uncoupled state.

Expressing (4) by J_i ; M $_i$ and using the de nition of the binom ial coe cients, we recover the Racah formula for $J = J_1 + J_2$,

In order to simplify the explicit calculation of CG- ∞ e cients and the generalization to arbitrary total angular momenta, we de neamatrix $_0$ containing all essential information of the rh.s. of (4) for all $u_1; u_2$. The crucial quantities are the values of s_{uc} . The values of s_c only take care for the correct normalization of the CG- ∞ e cients and depend according to (3) on s_{uc} . We deen the matrix $_0$ via their ∞ m ponents

Here u_1 extends from 0 (rst row) to j and u_2 from 0 (rst column) to j, respectively. u_1 is a $2J_1 + 1$ $2J_2 + 1$ -m atrix. Sometimes we will use the angular momenta u_1 ; u_2 as the arguments of u_3 = u_3 (u_4).

One of the essential advantages of (4) compared with the Racah formula (5) consists in the possibility of extracting all results of (4) easily by means of the matrix $_0$. As a rst example we will calculate all CG-coe cients corresponding to the coupling of two spin-1-particles to a spin-2-state according to (4). $_0$ follows according to (6) by multiplying two J = 1-rows of Pascal's triangle, denoted in the following way

Each of the 3 3 components of this matrix reproduces the number of the imaginary states of the state j(M_1 ; M_2)i. The connection between the position in the matrix and the corresponding M or u-value is shown in table III. The maximum state j(1;1)i is found down-right. The diagonals (raising from left to right) correspond to a given $M_1 + M_2 = M$. The M-values of the diagonals increase from $M = J_1 - J_2$ (up-left) to $M = J_1 + J_2$ (down-right). The quantity u appearing in (4) is extracted according to (3) by sum m ing up the diagonal elements. In our example these sums give f1;4;6;4;1g, corresponding to the J = 2-row of Pascal's triangle, as expected from (3). The CG-coe cients are read of from u0 by dividing the components u1 by the sum of the diagonal elements u2 and extracting the square root. This procedure yields the following CG-coe cients, as can also be found in Ref. [3]

U tilizing the $_0$ -m atrices we are able to determ ine all non-vanishing CG-coe cients with $J=J_1+J_2$ in mediately. As a further example we present the coupling of a $J_1=\frac{3}{2}$ -particle with a $J_2=1$ -particle to the $J=\frac{5}{2}$ -state:

III. GENERAL ADD IT ION OF TW O ANGULAR MOMENTA

Next we will consider the general case in which two particles with J_1 and J_2 m ay couple to a total angular m omentum $J < J_1 + J_2$. This problem can also be treated by means of in aginary spin- $\frac{1}{2}$ -particles. Assuming that two of these in aginary particles couple to spin 0, they do not contribute to the total angular momentum J anymore. If there are n spin-0-particles in a system of in aginary spin- $\frac{1}{2}$ -particles, the total angular momentum is reduced to $J = J_1 + J_2$ n. In this way the general addition of two angular momenta can be described by two elementary processes of in aginary spin- $\frac{1}{2}$ -particles, namely the coupling of some in aginary particles to spin 0 and the coupling of the remaining particles to their maximum angular momentum according to section II. First we will consider the coupling of two spin- $\frac{1}{2}$ -particles to spin 0, before we will combine both processes.

A. The matrix n of the coupling to $J = J_1 + J_2$ n

As we will see, the general case $J = J_1 + J_2$ n can also be constructed from a matrix, called n from which we can read of the CG-coe cient, similar to 0, directly. However, we cannot demand positiveness of the CG-coe cients any longer. Negative CG-coe cients will be identified from n simply by a minus sign in front of the corresponding component.

In order to exemplify this prescription we will show $_1(\frac{3}{2};1)$ here. The details of its calculation are given below. It describes the coupling of a spin- $\frac{3}{2}$ -particle with a spin-1-particle to spin $\frac{3}{2}$:

From this we can read o the CG-coe cients (from down-left to up-right), e.g. from the 4th diagonal corresponding to M = $\frac{1}{2}$:

The m inus signs in $_1$ just indicate that the corresponding CG-coe cient is negative. Calculating the normalization, these signs must not be considered in the sum of the diagonal elements, here 15.

We will regard two $_n$ m atrices as equivalent, if they dier only by a factor , denoted by $_n \triangleq _n$. Also two matrices are equivalent, if their diagonals, raising from left to right, deviate only by a factor. In both cases we not the same CG-coe cients.

The matrix n follows from the requirements that

1. am ong the imaginary spin $\frac{1}{2}$ -particles n Spin-0-particles arise

and

2. the remaining imaginary spin $-\frac{1}{2}$ -particles couple to their maximum spin.

Spin-0-particles arise according to (7), if the imaginary spin- $\frac{1}{2}$ -particles generate

The components of $_n$ play the role of non-normalized probabilities, analogously to the interpretation of $_0$. They are composed from the probabilities of the processes 1. and 2. De $_n$ ning

as the m atrix describing the probabilities for the state $% \ \& \ ,$

V as the matrix describing the probabilities for the state ϵ % , and

 \sim_n as the matrix describing the probabilities for the coupling of the remaining imaginary particles to their maximum spin,

the above requirem ents translates directly to the matrix equation

where the products (and) and the subtractions (or) between the matrices have to be performed for each single component. When we talk of probabilities in the following, we may not refer to normalized probabilities, as the product by components in (8) allows for arbitrary factors (normalization) in V and $^{\sim}_{n}$.

B. The matrix (

For calculating (V) $^{[n]}$ we need the probabilities of creating % α -or α % -states from in aginary spin- $\frac{1}{2}$ -particles. The probability of creating % α is proportional to the probability of inding % at particle 1 and α at particle 2 at the same time. This in turn is proportional to the product of the number of the imaginary particles in the corresponding states. An analogous statement holds for α %. Therefore we define

The expression u_1d_2 d_1u_2 can be interpreted (if it is positive) as the surplus of % & -states of an uncoupled state. If it is negative it yields the (negative) excess of & % -states. This pays attention to the fact that according to (1) interference can occur only between uncoupled states but not within an uncoupled state itself.

Perform ing the exponentiation [n] one has to take into account that the probabilities V depend on the number of the spin-0-particles already generated. If e.g. already one % α -state has been built, there are only $u_1 = 1$ and $d_2 = 1$ particles available. Therefore the exponentiation means

All higher exponents (n = 3;4;:::) of V vanish in accordance with the rule jJ_1 J_2j J $J_1 + J_2$. In order to calculate the CG-coe cients of the above example, we need the matrices $\tilde{}_1$ and $\tilde{}_2$ of the remaining system in addition. Their computation is the topic of the next section.

C. The matrix $^{\sim} _{n}$ of the remaining system

The matrix n follows directly from n by removing the imaginary spin- $\frac{1}{2}$ -particles, contained in $(V)^{[n]}$. Here removing a % from the particle imeans that the total number of imaginary spin- $\frac{1}{2}$ -particles and the number of % is reduced by one; i.e., we replace

The binom ial one cients vanish for all unphysical values, e.g. if j_i 1 < u_i or u_i 1 < 0. This corresponds to the fact that there is no state with u_i < 0 or d_i < 0. The matrix $\tilde{}_2$ is obtained from $\tilde{}_1$ by removing an additional spin-0-particle:

In general $^{\sim}$ n is given by

The matrices \tilde{a}_n can be calculated easily, as they consist essentially out of 0 (J_1 $\frac{n}{2}$; J_2 $\frac{n}{2}$). This refers that a system with $J = J_1 + J_2$ n can be imagined as originated from coupling of spin J_1 $\frac{n}{2}$ and spin J_2 $\frac{n}{2}$ to their maximum spin. This will be illuminated in the following example.

D .R esults of the exam ple $J_1 = \frac{3}{2}$ and $J_2 = 1$

We are now able to give all CG-coe cients in form of the $\pm m$ atrices $_0$ to $_2$, producing the well-known results [3].

It should be noticed once m one that a m inus sign in front of a component only indicates that the corresponding CG coe cient is negative. Thus a m inus sign is transferred to the product matrix, although if both the components which are multiplied are negative. (As we will see in the next section in (13), the components which are multiplied have the same sign.) The matrix $_1$ has been discussed already in section IIIA, where the extraction of the CG-coe cients from it has been demonstrated.

Here again we have to take care of the signs when squaring a matrix. The matrix $\begin{bmatrix} 1 \\ 0 \end{bmatrix}$ contains the inverse components of 0 (or a multiple of them).

As we will show in the appendix, (14) and therefore also (8) are equivalent to the Racah formula.

which is equivalent to the result of section IIID up to a factor. In conclusion, (14) provides a very simple method for a practicable computation of CG-coe cients. For obtaining $^{2}_{n}$ and $^{1}_{0}$ only the matrices $^{1}_{0}$ (J₁;J₂) and $^{1}_{0}$ (J₁ $^{\frac{n}{2}}$;J₂ $^{\frac{n}{2}}$) are needed. A ctually, the calculation can be simplied further by considering the rejection symmetry of $^{1}_{0}$ and $^{1}_{0}$ at their center, if n is even. If n is odd, the signs of the rejected components have to be changed. This property of $^{1}_{0}$ and $^{1}_{0}$ corresponds to the relation h(M $_{1}$;M $_{2}$) j;M i = ()^{J₁+J₂} J h(M $_{1}$; M $_{2}$) j; M i [2]. Because of the component-like multiplication and subtraction of the matrices yielding $^{1}_{0}$, only half of the components of $^{1}_{0}$ (J₁;J₂) and $^{1}_{0}$ (J₁ $^{\frac{n}{2}}$;J₂ $^{\frac{n}{2}}$) has to be computed.

V.CONCLUSIONS

In this paper we have demonstrated how the coupling of two angular momenta, J_1 and J_2 , can be understood easily by decomposing each of the angular momenta into imaginary spin- $\frac{1}{2}$ -particles. Counting the possibilities of decomposing the angular momenta J_1 into these imaginary particles by simple combinatorial manipulations (binomial coecients), leads to the CG-coecients in the case of coupling to maximum angular momentum $J=J_1+J_2$. Here the basic assumption of equally distributed probabilities for each of the decompositions has been adopted. For extracting the CG-coecients, it is convenient to introduce the matrix J_1 , denoted in (6). The CG-coecients can be read of directly from the components of this matrix divided by the sum of the diagonal elements and extracting the square root.

The general case, $J=J_1+J_2$ n, can be considered as the coupling of 2n imaginary spin- $\frac{1}{2}$ -particles to spin 0 and the coupling of the remaining imaginary particles to maximum spin. In this way the matrix n, de ned in (8), results, from which the CG-coe cients can be read o in the same way as from 0, apart from the fact that minus signs in front of the components simply indicate negative CG-coe cients. Utilizing a relation between the matrix describing the coupling of the imaginary particles to spin 0 and the one describing the coupling of the remaining system to maximum spin, the matrix n can be found easily by (14). This method, shown to be equivalent to the Racah formula, requires much less computationale ort than the latter one.

The new, probabilistic interpretation of the addition of angular momenta, presented here, provides an elegant and practicable way of computing all CG-coe cients for the coupling of two arbitrary angular momenta.
