# H igh order behaviour of pertunbation recursive relations

A bstract

T he problem of large orderbehaviour ofperturbation theory forquantum $m$ echanicalsystem $s$ is considered. A new approach to it is developed. A n explicit m echanism show ing the connection betw een large order recursive relations and classicaleuclidean equations ofm otion is found. Large order asym ptotics of the solution to the recursive relations is constructed. T he developed $m$ ethod is applicable to the excited states, as well as to the ground state. Singular points of the obtained asym ptotics of the perturbation series for eigenfunctions and density $m$ atrices are investigated and form ulas being valid near such points are obtained.

## 1 Introduction

A factorial grow th of perturbation series coe cients which im plies the divergence of the expansion［1］has been studied in many papers（see，for exam ple，园，园，4，号，6， ［7，［］）．The corresponding large order asym ptotics is usually constructed by repre－ senting the $k$－th order of perturbation theory as a functional integral and applying the saddle－point technique to the obtained form ula．Therefore，high order behaviour of peturbation theory is speci ed by saddle points expressed in term s of classical euclidean solutions．

E xam ples of em loym ent of this $m$ ethod are：
i）calculating large order asym ptotics for quantities like euclidean $G$ reen functions both in quantum $m$ echanics and quantum eld theory［2］；
ii）nding high order behaviour of energy level perturbation theory in quantum m echanics 目，6，7，［8］；
iii）evaluating the asym ptotics of ground state eigenfunction perturbation theory as the num ber of order $k$ tends to in nity and the wave function argum ent is of order $\mathrm{p}_{\mathrm{k}}$ 回］．

It is the form

of the dependence of the H am iltonian on the perturbation theory param eter g that allow s us to $m$ ake use of the saddle－point $m$ ethod and to clarify the role of classical euclidean solutions．H ere $\hat{p}$ is a m om entum operator，$\hat{q}$ is a coordinate operator，the behaviour of the $H$ am iltonian as its argum ent tends to zero is like $p^{2}=2+q^{2}=2$（the harm onic oscilator $H$ am iltonian），so there are no term soforder $1=g ; 1={ }^{p} \bar{g}$ ．Ifthe form of the $H$ am iltonian di ers from（17），one can separate it into a leading（＂classical＂） part having the form（1）that determ ines classical euclidean equations ofm otion and a correction（＂quantum part＂）being of a form like $g \mathrm{f}\left({ }^{p} \bar{g} p_{\mathrm{p}}^{\mathrm{p}} \overline{\mathrm{g}} \hat{q}\right)$ ； 0 ；which can
in uence only a pre-exponential factor (som e exam ples are given in [7, 8]).
H ow ever, one can develop the perturbation theory not only by $m$ aking use of the path integral representation for corresponding quantities. A s a rule, when one investigates quantum mechanical case and, in particular, checks the large order asym ptotics by num erical calculation [10], one applies another technique, nam ely, one studies the perturbation recursive relations expressing the $k$-th order of perturbation theory for the eigenvalue and the eigenfunction in term s ofpreceding orders. Large orders of the recursive relations have not been analyzed except for the case of the quartic potential, $H=p^{2}=2+q^{2}=2 \quad g q^{2}$, see [ 3 , [4]. The explicit $m$ echanism show ing the correspondence between recursive relations and euclidean classical solutions has not been considered yet. It is studied in this paper.
$T$ he $m$ ain idea of the $m$ ethod is the follow ing. $F$ irst, perturbation recursive relations is wrilten in term s of the operator of di erentiation $@=@ k$ w ith respect to the perturbation theory order $k$. Nam ely, the expression for the $k$-th order $k$ of the w ave function perturbation expansion contains the preceding orders $k p$ which can be expressed as e ${ }^{\mathrm{p} \frac{\ominus}{e k}}{ }_{k}$ : Second, consider large order behaviour of recursive relations, i.e. let k be proportional to som e large param eter N . A s it is show n in section 2, there exists such rescaling of the wave function argum ent (being $n$-dim ensional in the case of the $n$-dim ensional quantum $m$ echanics) and of the eigenfunction that after it the coe cients of the derivation operators becom e of order 1/N.T his allow s us to nd the asym ptotic solution to the modi ed equation in a form, analogous to the tunnel sem iclassical approxim ation, nam ely, $e^{\mathrm{N} S}$, where the function $S$ depending on the rescaled coordinates and on the ratio $\mathrm{k}=\mathrm{N}$ satis es the equation of a H am ilton-Jacobi type. A s it is know n, for solying such equation, one $m$ ust consider the corresponding H am iltonian system. A s the num ber of argum ents of the function S is equal to $\mathrm{n}+1$ (one m ore coordinate, $\mathrm{k}=\mathrm{N}$, is added), the classical H am iltonian
system corresponding to recursive relations contains one $m$ ore coordinate and one $m$ ore canonically conjugated $m$ om entum. It occurs that the solutions to this $(n+1)-$ dim ensional Ham iltonian system can be expressed in term s of the solutions to an $n$-dim ensional $H$ am iltonian system associated $w$ th the euclidean equation of $m$ otion (see section 2 form ore details) .

In order to nd the solution to H am ilton-Jacobiequation, one m ust know boundary conditions for the function $S$. For nding such conditions, one can $m$ ake use of the follow ing observation. The $k$ th order of the eigenfunction perturbation theory can be presented as a product of a polynom ial function by a $G$ aussian exponent (进 is the ground state wave function of the non-perturbated system being a harm onic oscilator). The polynom ial function can be approxim ated at large x by a leading power function. The coe cient of it is calculable explicitly. On the other hand, an asym ptotic form ula $m$ ust be valid, in particular, at large values of an argum ent. Section 3 contains a com parison of these two form ulas and obtaining a requirem ent for the function $S$, as well as for the pre-exponential factor, as their argum ent tends to in nity. This allow s us to solve corresponding equation. Section 4 deals w ith such calculation.

The obtained form ulas being applicable not only to the ground state perturbation theory but also to the excited state perturbaton theory are valid when the eigenfunction argum ent is of order ${ }^{\mathrm{P}} \overline{\mathrm{k}}$. W hen it is xed, the asym ptotics has not a saddlepoint form [0], but, nevertheless, can be obtained by recursive relations analysis. Such derivation is presented in section 5 .

Section 6 contains nding the densiy $m$ atrix large order asym ptotics and calculation of som em atrix elem ents. Section 7 deals $w$ th conchuding rem arks.

## 2 Perturbation recursive relations and H am iltonian system s

The purpose of this section is to show a connection between perturbation recursive relations associated w ith the H am iltonians having the dependence [1]) on the perturbation theory param eter and the H am iltonian system associated w ith the classical analog ofeq. (1).

C onsider for the sim plicity the one-dim ensional quantum mechanical case, choose the $H$ am iltonian to be a sum ofkinetic and potential term $s$ and suppose the potential to be even, so

Exam ine the perturbation theory for the equation $H=E: B$ oth eigenvalue and eigenfunction can be expanded into asym ptotic series,

Here n is a num ber of energy level. N otioe that the wave function is expanded at xed value of its argum ent $x$. For the zeroth order of perturbation theory we have an oscilator equation,

The n-th energy level is equal to $E_{n ; 0}=n+1=2$, while the wave function has the form of a product of the $n$-th degree $H$ em ite polynom ialby the $G$ aussian exponent,

Let us choose the constant in this formula in order to $m$ ake the coe cient of the leading power $x^{n}$ to be equal to 1 , so large $x$ behaviour of the $n$-th state eigenfiunction is as follow S ,

The perturbation theory can be developed by the follow ing recursive relations obtained from eq. (2),

$N$ otioe that $n ; k$ is de ned from this relation up to a factor const $n ; 0$, so one m ust im pose an additional condition on $n ; k$, for exam ple, the follow ing,

C onsider the construction of high order asym ptotics. Suppose $k$ to be large, i.e. to be proportional to som e large peram eter $\mathrm{N}, \mathrm{k}=\mathrm{N}$. The aim is to nd such rescaling of coordinate $x$ and function $n ; k$ that provides a possibility ofsearching the asym ptotics in a form $e^{\mathrm{NS}}{ }^{(q)}$, where $q$ is a set of rescaled coordinates and. Such rescaling of x is $x={ }^{\mathrm{P}} \overline{\mathrm{N}}$, nam ely, the expression $\left(\vec{d}=d x^{2}+\mathrm{x}^{2}\right) \mathrm{e}^{\mathrm{N} S(;)}$ is then approxim ately equal to $N\left(\quad(@ S=@\}+{ }^{2}\right) e^{\mathrm{NS}(;)}$, i.e. these two term S are of the sam e order. To make other term $s$ in the left-hand side of eq. (4) of this order it is necessary to suppose that $n ; k$ is approxim ately in $N$ tim es greater than $n ; k$; so we come to the follow ing substitution,

These relations show us that one can nd large $k$ asym ptotics as $x={ }^{p} \bar{k}$ ! const: The latter condition coincides with obtained in [G] by the path integral technique for the ground state.

W e can notioe that all the term s of the left-hand side of recursive relations (4) play an im portant role in constructing large order asym ptotics because of the dependence 17) of the H am iltonian. If there were term s such $\mathrm{as}_{\mathrm{g}}{ }^{2} \mathrm{bxx}^{4}$ (for exam ple, if the potential had a form $\left.x^{2}=2+g^{2}\left(b x^{4}+a x^{6}\right)\right)$ then these term s w ould not in uence a leading order approxim ation for $S$. This is in agreem ent w ith 7].

O ne can also expect that $\mathrm{E}_{\mathrm{n} ; \mathrm{k}}$ asym ptotics has the form,

As the condition (5) is chosen, $A_{n ; k ; n}=0$ : It is easy to obtain from eq. (4) that $E_{n ; k}=(n+1)(n+2) A_{n ; k ; n+2}=2+{ }_{p}^{\mathrm{P}} \underset{\mathrm{p}=4}{ } a_{p} A_{n ; k ; n}$ p; ie. $E_{n ; k}$ is expressed as a nite sum (the num ber of term $s$ does not depend on $k$ ) containing the derivatives of nite order (which also does not depend on $k$ ) of the function $n ; k$ ( $x$ ) $e^{x^{2}=2}$ as its argum ent is equal to zero. A s the $n ; k$ asym ptotics has the form (G), we can make alim it ! 0 and come to eq. ${ }^{(7)}$ ).

It w ill be shown that $S(;)>S(0 ;)$. This implies that we can om it the term $S$ in the right-hand side of eq.(4) as j $k$ because they are exponentially sm all in com parison w th the each order of the left-hand side. This om ission is not valid only if $q$ belongs to a sm all region near zero which decreases as $k$ increases.

N otice also that if $j \quad 1$ then the corresponding term in the right-hand side of eq.(4) is of order $1=\mathrm{N}^{j+1}$ in com parison w th all term $s$ in the lefthand side and, therefore, can in uence only a pre-exponential factor and corrections. Thus, the function $S$ is determ ined only by left-hand side term $s$ and does not depend on a num ber of energy level.

We can also rew rite quantities such as $n ; k$ pas $e^{p \in=@ k} \quad n ; k=e^{\frac{p}{N e}} \quad n ; k$ and, therefore, com e to the follow ing form of recursive relations,

The term s of order lesser than $1=\mathrm{N}$ are om itted in eq. (G). The generalization of form ula (9) to multidim ensional case is straightforw ard.

Let us look for the asym ptotics in a form [1]],

In order to solve it, onem ust consider the corresponding classicalH am ittonian system . In the present case, the classical H am iltonian function depends on two coordinates and , two $m$ om enta, $p$ and $p$, and can be obtained from eq. (10) by substituting the operators $N^{1} @=@$ and $N^{1} @=@$ by $p$ and $p$ correspondingly,

Let us consider it in $m$ ore details. $F$ irst of all, the function (13) does not depend on the coordinate, so the $m$ om entum $p$ is an integral ofm otion. Then, the quantities

Thus, the exam ination of the H am iltonian system corresponding to the perturbative recursive relations can be reduced to the study of the H am iltonian system associated w ith m oving of a particle in the inverted potential. If the latter H am iltonian system is integrable (for exam ple, in one-dim ensional case), the H am iltonian system (15) is integrable, too. The equation for has the form,

and can be solved exactly.
For nding large order asym ptotics ofm atrix elem ents, it is useful to know high order behaviour of perturbation theory for quantities like ${ }^{m}$ in $(x ; y)={ }_{m}(x){ }_{n}(y)$ : It can be found by $m$ aking use of the $n ; k$ asym ptotics (this technique is developed in section 6). But another way of constructing $m$ in ( $x ; y$ ) large order asym ptotics is to apply technique developed in this section. $N$ am ely, the function ${ }^{m}$ in ( $x ; y$ ) obeys the equation,

O ne can develop the perturbation theory $m^{m i n}(x ; y)={ }^{P} g_{k}^{k ; n}(x ; y)$, change the
 relations corresponding to eq. (17) in a way analogous to eq. (9), obtain a $H$ am iltonJacobiequation and reduce it to a H am iltonian system that contains three coordinates $x ; 1 ; 2$, three $m$ om enta $p ; p_{1} ; p_{2}$. The corresponding $H$ am iltonian function is then

T he corresponding H am iltonian equations can be solved as well as in previous case.
O ne can also exam ine the perturbation theory for eigenfunctions in other representations. It occurs that perturbative recursive relations in any presentation are connected w th the $H$ am iltonian system related w th the investigated one by a canonical transform ation. Thus, consideration of the high orders is associated with the investigation of the euclidean equations ofm otion (15).

Let us illustrate this declaration by an exam ple. C onsider for the sim plicity case of the ground state, ie. $n=0$. The function $0 ; k$ has then the form (G),

A ssum e that k and m are proportional to a large param eter, $\mathrm{k}=\mathrm{N} \quad ; \mathrm{m}=\mathrm{N}$; and substract the factor $N^{k m}$ from the coe cients, $A_{k, m}=N^{k} m^{m} A_{k, m}$. For the reduced coe cients $A_{k, m}$ one can obtain in a leading order a pseudodi erential equation,

Thus, one can apply the sam e technique in order to obtain high order asym ptotics in other representations.

## 3 Large $x$ behaviour of the $n, k$ asym ptotics and boundary conditions

As it has been shown in previous section, the problem of nding the large order asym ptotics for the wave function perturbation theory is reduced to the problem of solving the H am itton-Jacobiequation (12) and the equation for ${ }_{\mathrm{n}}$ which is obtainable from eq.(G). To solve them, onem ust know boundary conditionswhich are to be found from other reasoning.

For this purpose, consider the behaviour of $n, k$ at large $x$. This allows us to im pose boundary conditions on the functions $n$; $S$ at large .

As $n ; k$ has the form (g), large $x$ behaviour of it can be obtained by approxim ating the polynom ial function by the leading order,

; having the sam e ratio $\stackrel{p}{=}$ - . T herefore, $\stackrel{p}{=}$ - is the only param eter determ ining whether approxim ation (19) is valid or not. Thus, eq. (19) is applicable at

Taking into account eq. (19) as a boundary condition for $S$; $n$, nd the solution to the $H$ am ilton-Jacobiequation (12) and the equation for $n$ obtained also from eq. (G).

## 4 Large order asym ptotics for the eigen function perturbation theory

The classical trajectory Q ( ) ( g.1b) passes through this point, $\mathrm{q}_{0}$, at tw o euclidean tim e m om ents being approxim ately equal to $\ln q_{0}$ and $\ln c=q_{0}$ because of the $Q()$ asymptotics as ! 1 . (6及) corresponds to negative values of the velocity then it is necessary to nd other extrem um of $B()$ that is minimum.

A nother possibility is as follows. Since the trajectory $Q($ ) passes through each point tw ioe, one can consider the param eters $1_{1}$; 2 such that $Q\left({ }_{1}\right)=Q(2)$ but $Q\left({ }_{1}\right)>0 ; Q\left({ }_{2}\right)<0$ (see g.6c),so that

Let us discuss the obtained result 66). N otice rst that if we substitute by ln c , this expression will be multiplied by ( $1^{\text {n }}{ }^{2}$, while the num bers $n_{1}$ and $n_{2} w$ ill exchange. $T$ his fact is in agreem ent $w$ ith the de nition (60).

Second, notice that when $m_{1}$ and $m_{2}$ increase, the grow th of the coe cients is faster. The ( $k \quad 1$ ) -th order for the $m$ atrix elem ent of $x$ and the $k$-th order for such quantity for $x^{m}{ }^{2}$ have the sam e order of grow th. Therefore, the $k$-th order behaviour for all powers of $g x^{2} ; g(d=d x)^{2}$ is of the sam e order.

## 7 C onclusions

In this paper the explicit $m$ echanism show ing the connection between large order recursive relations for stationary perturbation theory and classicaleuclidean equations ofm otion is found and high order asym ptotics of the solution to the recursive relations is constructed. The results obtained by the path integral approach are indeed reproduced in the developed $m$ ethod. M oreover, when one nds high order asym ptotics of $m$ atrix elem ent 60), one can also nd what region of integration in eq.(62) and what term $s$ in the sum (52) give the $m$ ain contribution to the quantity (60). M aking use of the obtained large order asym ptotics for the wave function and density $m$ atrix, one can also nd the $m$ ain values of quantities like $e^{k f\left(x^{p} \bar{k}\right)}$ at the $k$-th order of perturbation theory as k ! 1 . All calculations are valid both for the ground and for the excited states.

An interesting feature of the eigenfiunction large order perturbation theory as $x={ }^{\mathrm{P}} \overline{\mathrm{k}}=$ const is the divergence ofthe pre-exponential factor at sm all . T his di culty is analogous w ith the divergence of the pre-exponential factor in the sem iclassical expansion large order asym ptotics discussed in 12]. The resolve of the di culty is the follow ing. At sm all associated w th the values of param eter $x$ of order $O$ (1) the asym ptotics is written in another form 45). It is expressed through the grow ing at in nity solution to the harm onic oscilator equation $w$ ith non-trivial right-hand side 48). The connection betw een these asym ptotics allow s us to nd the eigenvalue large order behaviour coinciding w ith previous papers []].
