# G eom etry of one-dim ensional w ave propagation

#### Abstract

W e investigate the geom etrical features of one-dim ensionalw ave propagation, whose dynam ics is described by the (2+1)-dim ensionalLorentz group. W e nd $m$ any interesting geom etrical ingredients such as spinorlike behavior of $w$ ave am plitudes, gauge transform ations, B loch-type equations, and Lorentz-group Berry phases. ## I. IN TRODUCTION

TheBerry phases 1] produced by rotations have been m ost extensively studied forvarious physical system s. A nother interesting class consists of Berry phases produced by Lorentz transform ations. Chiao and Jordan [2] showed that Lorentz-group Berry phases could be observed as a change of phase of the electrom agnetic eld in squeezed states. Successive squeezing operations for either light or $m$ icrow aves by degenerate param etric am pli ens induce a phase shift that can be interpreted geom etrically. T hese kinds of experim ents have draw $n$ considerable interest because they can be view ed as the quantum optical realization of the Lorentz kinem atics. [ $\mathbf{B}^{[ }$[]

A nother optical manifestation of the Lorentz-group Berry's phase was proposed and experim entally veri ed 目]. It is shown that when one cycles light through a sequence of partially polarized states, the light acquires a geom etrical phase.

It is well known that the wave propagation in one dim ension (1D) can be described by the Lorentz-group dynam ics, therefore, one can expect Lorentz-group Berry phases in wave system s. In this paper, we present B erry phases and related geom etrical features seen in the 1D wave propagation in inhom ogeneous $m$ edia.

In Sec. \#, from the 1D wave equation with quasi-periodic potential we derive a Schrodinger-like equation, which explicitly exhibits the Lorentz dynam ics via the generators of $S L(2, R)$. The dynam ical variables of the equation are the two quadrature wave am plitudes, which form a two-colum n state vector.

In Sec. $\prod_{\text {M }}$ a $S L(2, R) B$ loch equation is derived from the Schrodinger-like equation. T he equation is very sim ilar to the conventional SU (2) $B$ loch equation for the spin $-1 / 2$ except that the SL ( $2, R$ ) B loch vector $m$ oves on a conical surface not on a sphere. The sim ilarIty could be very useful for the geom etrical understanding of Lorentz dynam ics, especially because the SU (2) B loch $m$ odel has been successfiully em ployed in various elds such as nuclear m agnetic resonances, nonlinear optics, polarization optics, interferom etry, and atom ic physics, etc.

In Sec. $\mathbb{I V}$, we discuss two-valuedness of the state vectors. A B loch vector represents a pair of state vectors w ith opposite signs. W hen a B loch vector circles around the apex of a cone, the corresponding state vector changes its sign. It is show $n$ that the two-valuedness com es from a sym $m$ etry of the $w$ ave equation $w$ th respect to the translation of half $w a v e-$ length.

Extending the above geom etrical situation, we introduce in Sec. V a local gauge transform ation associated w ith the deform ation of space coordinate.

So far, we have assum ed that the state vector is real because the potential function in the w ave equation is real. It tums out, how ever, the extension to com plex wave functions is very convenient, because a com plex solution could represent two linearly independent real solutions at onœ. In Sec. Vf, we derive a B loch equation for the case of com plex am plitudes. In this case, a B loch vector corresponds to a set of state vectors that di er only in phase factors. The B loch vector m oves on the surface of hyperboloid. T his is the arena where the Berry phase plays a role. In Sec.VI, we de ne the Berry phase for a cyclic evolution of the system .

F inally, we propose a feasible optical experim ent where we can observe the B erry phase for 1D wave propagation.

## II. 1D W AVE EQUATION AND SL (2,R)

Let us start with a one-dim ensional wave equation (the Helm holtz equation) for a monochrom atic wave (x)e ilt

where $k=k(!)$ is the wave num ber in free $(=0)$ space.
$W$ e assum e the spatial variation of the refractive index or the potential $(x)$ has the follow ing form :

The spatialm odulation at wave num ber 2 k strongly modi es the propagation of the $w$ ave with wave num ber $k$ ow ing to the B ragg e ect. The D C com ponent o also has substantial in uences through the $B$ ragg resonance condition.

W e represent the wave ( x ) w ith m ean wave num ber k as

where $A(x)$ and $B(x)$ are slow ly varying envelope functions. These envelopes are nom ally considered to be real functions, since (x) in Eq. (f) is real. However, the extension to com plex functions is som etim es very usefiul as will.be discussed in Sec.V.

Substitution of Eqs. (2) and (3) into Eq. (1) gives

where $i_{i}(i=1 ; 2 ; 3)$ are the $P$ auli's spin $m$ atrioes.
W e have assum ed that $A(x)$ and $B(x)$ do not change appreciably over distances of the order ofk ${ }^{1}$ (slow ly-varying-envelope approxim ation) and neglected the term $s w$ th w avelength 3k (secular-term approxím ation).

The $m$ atrices (G) are the generators of $S L(2, R)$, the two dim ensional real unim odular group, and satisfy the com $m$ utation relations

The (A;B) plane is squeezed in one direction and stretched in the orthogonal direction by the generators $K_{1}$ or $K_{2}$, and rotated by $J_{3}$.

The group SL (2,R) has the close connection (locally isom onphic) to the ( $2+1$ )dim ensional Lorentz group $S O(2,1)$ as does the group $S U(1,1)$. Instead of Eq. © 3 ), if we use a representation

then we have the $S U(1,1)$-Schrodinger equation $w$ ith $K_{1}^{0}=i_{1}=2, K_{2}^{0}=\quad i_{2}=2, J_{3}^{0}={ }_{3}=2$, which satisfy the sam e commutation relations as Eq. (7). In the follow ing discussion, we m ostly use SL $(2, R)$ rather than $\operatorname{SU}(1,1)$.
III. SL (2, R) BLOCHEQUATION \{REALAMPLITUDECASE

Equation ( ${ }^{5}$ ) has a form sim ilar to the Schrodinger equation for the spin- $1 / 2$ ( J ) in time varying magnetic elds $B(t)$; ih $(d=d t) j i=B(t) \quad J j i . T h e$ underlying group for the spin-1/2 dynam ics is SU (2), which is the covering group of the three dim ensional rotation group, SO (3). The B loch equation derived from the spin-1/2 Schrodinger equation apparently re ects the structure of those groups; the B loch vector m oves on a sphere, and the Berry phase for spin-1/2 can be related to the surface area of the sphere.

In order to see the geom etrical structure of SL (2,R )-dynam ics, let us derive the corresponding $B$ loch equation. (A m ore detailed derivation willbe given in Sec.V7. See also Ref. [6].)

which $m$ eans the $B$ loch vector $s m$ oves on the surface of the (upper) cone depicted in $F$ ig. 1.

W hen $(x)$ is constant, tra jectories for s are very sim ple; the vector $s$ lies in a plane that is orthogonal to the vector $\sim=\left({ }_{1}\right.$; 2 ; 3 ), because

A trajectory, which is the intersection of a plane and the cone could be an ellipse, a parabola, or a hyperbola according as ${ }_{3}^{2}$ is greater than, equal to, or less than ${ }_{1}^{2}+{ }_{2}^{2}$. The elliptical, bound tra jectories correspond to the propagating waves in the conduction bands and the hyperbolic, unbound tra jectories correspond to the evanescent waves in the forbidden bands.

O wing to the geom etrical sim plicity and the sim ilarity to the conventional B loch equation, the SL $(2, R)$ B loch equation could be very useful.

In this section, we study a subtler geom etrical feature of $S L(2, R)$ B loch equation. We note the correspondence between ( $A$; B ) and s given by Eq. (1G) is not one to one but two to one; a single vector s represents tw o state vectors w ith opposite signs: ( $A$; $B$ ) and ( $A$; $B$ ).

At rst sight, these two state vectors $m$ ay seem to represent tw o distinct physical situations. W ithin the fram ew ork of the present approxim ation (slow ly varying envelopes), how ever, the two situations are virtually identical. Figure 2 represents the local pictures of waves w th opposite polarities (real lines). A potential w ith period $k^{1}$ is also show $n$ (dashed lines). W e note the dispositions of the waves relative to the potential are the sam e and, therefore, the w aves would evolve identically.
$T$ his degeneracy com es from the fact that the potential ( 2 ) is invariant under the translation $x!x+n k^{1}\left(n\right.$ : integer), as far as the variation of $(x)$ over the distance $n k^{1}$ can be neglected;

On the other hand, from Eq. 3 ), we see that the translation induces $(A ; B)!(1)^{n}(A ; B)$.
In order to see the geom etrical structure of the two-valued representation, we can $m$ ake a cone from the $(A ; B)$ plane as shown in $F$ ig. 3 . $T$ he $(A ; B)$ plane is cut along a line from the origin (+ A axis in this exam ple) and is w rapped to $m$ ake a tw ofold cone $w$ ith apex angle of 60 degrees. W hen the vector $s$ on the cone encircles a closed curve around the apex, we see that the corresponding $(A ; B)$ gains a factor $(1)^{n}$, where $n$ is the $w$ inding num ber of the curve.

Even though, two vectors ( A ; B ) and ( A ; B ) represent (alm ost) the sam e physical situation, we can conveniently detect the $m$ inus sign by interferom etric $m$ ethods, as that for spin $1 / 2$ rotated by 2 [7]. (T he tw o cases have good analogy, but it is only for the latter case that interference experim ents are absolutely required and even in principle there is no other way to detect the $m$ inus sign.)

Figure 4 show $s$ an exam ple of interferom etry. W e have two tra jectories both of which start from $(A ; B)=(1 ; 0)$ at $x=0$. One evolves $w$ ith a constant and the other $w$ th
. A fter som e evolution, they reach conjugate points in the ( $A$; B) plane. Looking at the
 signs opposite.

This situation rem inds us of the sign change of a spinor rotated by 2 , the A haronovBohm e ect with an in nite solenoid, the sign change around the degeneracy of the eigen-
 tical particles in tw o-dim ensional space 10]. In term s of the second analogy, the topological $m$ agnetic ux of $h c=e$ is required to account for the sign change or the phase shift of . The am ount of ux is consistent w ith the (singular) curvature at the cone apex or the apex angle.
$M$ athem atically speaking, $S L(2, R)$ is a two-valued representation of the $(2+1)$ dim ensional Lorentz group, $S O(2,1)$, as SU (2) is for the three-dim ensional rotation group, SO (3). It is very interesting that the tw o-valued representation which is believed peculiar to the quantum regim emanifests itself in the classical context.

It should be noted that the cone introduced here and that for the B loch vector discussed in the previous section have di erent apex angles and di erent param etrization:

## V.GAUGE TRANSFORMATION

In order to generalize the discussion in the previous section, we introduce a (local) gauge transform ation. W e conveniently use the $\operatorname{SU}(1,1)$ am plitudes [see Eq. (8)] A and E:

Here we have an extra term $2 \mathrm{~d}=\mathrm{dx} \mathrm{x}^{0}$ which acoounts for the gauge transform ation. This term can be interpreted as a gauge eld.

In Eqs. (2) and (3), in order to de ne , A, and B, we needed a long yardstick accurately graduated in $2 \mathrm{k}^{1}$. H ow ever, w th the help of the above equations, we can com pare the wave am plikudes for tw o observers whose rulers are not necessarily accurate in a long span.

W e note that the discussion in the previous section can be reproduced by considering the case of constant deviation $(x)=n k^{1}$, which yields $A^{0}=A, E^{0}=E$, and $d=d x^{0}=0$. We consider two coordinate system $\mathrm{s} x$ and $\mathrm{x}^{0}$ shifted by $\mathrm{n} \mathrm{k}^{1}$, and a third coordinate system $x^{\infty}=x+(x)$, w th $(x)=0$ for $x<x_{x}$ and $(x)=n k^{1}$ for $x>x_{2}$; in the interval of $x_{1}<x<x_{2}, x^{\infty}$ sm oothly connects $x$ and $x^{0}$. The integration of the gauge eld

which is independent of the localbehavior of , am ount to the sign factor $\exp (\operatorname{ink} 1=2)=$ $(1)^{n}$ between ( $\left.A ; B\right)$ and $\left(A^{0} ; B^{0}\right)$.

From now on let us consider $j i=(;)^{T}$ as complex am plitudes. Before proceeding, physicalm eaning of com plex am plitudes should be clari ed. At rst sight of Eq. (1]), which has real coe cients, no com plex am plitudes seem s required. In fact, if we decom pose ji into real and im aginary parts

then each of $j 0_{i}$ and $j \omega_{i}$ is a real solution to Eq. (回). Therefore, a com plex solution could represent two independent real solutions. The independence is assured by $0 \infty \quad \infty 000$, where $j^{0_{i}}=\left({ }^{0} ;{ }^{0}\right)^{\mathrm{T}}$ and $j^{0_{i}}=\left({ }^{\infty} ;{ }^{\infty}\right)^{\mathrm{T}}$. A complex solution is convenient in the sense that any real solutions can be represented as $R e(z j$ i) with a com plex num ber $z$.

Starting from the SL (2, R)-Schrodinger equation (5) with complex $j$ i:

In the case of $s_{0} \in 0, s \mathrm{~m}$ oves on the surface of a two-sheet hyperboloid, as show $n$ in Fig. 5. W ithout loss of generality, we norm alize the state vectors as $\mathrm{s}_{0}=1$.

## VII. GEOMETRICALPHASE

In the case of real am plitudes, a density $m$ atrix represents two states. O $n$ the other hand, in the case of com plex am plitudes, a density $m$ atrix represents an in nite num ber of state vectors. For exam ple, the state $j_{i} 0_{i}=e^{i k_{s}} j i, j j_{i}=e^{i k_{s} j} i$ derived from $j i$ and $\dot{\jmath}$ i w ith $K_{s}=s \quad K$ yield the sam e density $m$ atrix;

N ow we have a projective structure in whidh we can introduce the A haronov-A nandan connection [12], thereby we can derive the dynam ical phase and the geom etrical phase associated w ith a cycle of evolution.

T he equivalence class introduced above can be represented m ore conveniently by using a decom position of the group elem ent of $S L(2, R)$ :

An arbitrary state $j$ i can be obtained from $j j^{i}=2^{1=2}(1 ; i)^{T}$, which belongs to a ray $s=(0 ; 0 ; 1)$ as

N ow we see that all the states in a ray can be derived by applying a group action to the states $j i=e{ }^{i J_{3}} j 0 i$, whose real and im aginary parts are given as

Thus the elem ent in a ray can be param etrized by .
Re ecting the two-valuedness discussed in Sec. $\mathbb{V}$, the states $w$ ith and +2 in a ray have opposite signs.

Let us consider a cyclic evolution in which a state j (0)i evolves and retums to a state $j(L) i=\exp (i) j(0) i$, which belongs to the same ray, ie., $(0)=(L)$. The phase di erence is com posed of a dynam ical phase $\quad \mathrm{D}$ and a geom etrical phase ${ }_{G}$.

The geom etrical phase ${ }_{\mathrm{G}}$ or the Berry phase for this system is given as ${ }^{5}$,13]

where $S$ is the area enclosed by the path. The integrand is an invariant two form under the group action. It should be noted that this two form is di erent from that for the surface curvature of the hyperboloid, $\left(\begin{array}{ll}2 s_{3}^{2} & 1\end{array}\right)^{2} d s_{1} \wedge d s_{2}$, or that for the surface area of the hyperboloid, $\left(2 s_{3}{ }^{3}\right)^{1=2} \mathrm{ds}_{1} \wedge \mathrm{ds}_{2}$. In the SU (2) case, all of the three quantities have the same form incidentally.

## VIII. CONCLUSION S

In conclusion, we have explored geom etrical features of 1D w ave propagation. U nderlying group of this problem is the (2+1)-dim ensional Lorentz group. The geom etrical approach
would be very helpful for intuitive understanding of various wave phenom ena. It is also applicable to other system swhich are govemed by the Lorentz dynam ics.

Finally we would like to propose an experim ent to observe the Berry phase and other geom etrical phenom ena for the 1D wave propagation. In Fig. Q $^{\text {, an optical system is pre- }}$ sented. We have a medium whose distribution of refractive index $(x)$ can be controlled extemally. It is possible to write a holographic grating in optical bers or in som e nonlinear media. The light propagated through the $m$ edium is re ected back with perfect $m$ irror $M$. Thus we can prepare a state corresponding to $s(0)=(0 ; 0 ; 1)$ on the $m$ irror side $(\mathrm{x}=0)$. By adjusting the m irror position, we can \tune" the phase of of the intialstate as $j(0) i=(\cos 0=2 ; \sin 0=2)^{T}$ and hence we can $m$ ap out the com plex $j$ ivia Eq. 44). Ifwe set up $(x)$ so that the evolution be cyclic, then the state on the other side $(x=L)$ should be $j(L) i=\left(\text { cos } L_{L}=2 ; \sin { }_{L}=2\right)^{T}$. For a cyclic evolution, $=\quad$ L $\quad 0$ is independent of 0 . $W$ th the $M$ ach-Zehnder interferom eter we can $m$ easure the di erence $={ }_{G}+{ }_{D}$.
