M ECHAN ICAL EFFECTS OF RAD IAT ION PRESSURE QUANTUM FLUCTUATIONS

Abstract

As revealed by space-time probing, mechanics and eld theory come out as complementary descriptions for motions in space-time. In particular, quantum elds exert a radiation pressure on scatterers which results in mechanical elects that persist in vacuum. They include mean forces due to quantum eld uctuations, like Casim ir forces, but also uctuations of these forces and additional forces linked to motion. As in classical electron theory, a moving scatterer is submitted to a radiation reaction force which modi es its motional response to an applied force. We brie y survey the mechanical elects of quantum eld uctuations and discuss the consequences for stability of motion in vacuum and for position uctuations.

1 Introduction

Lorentz electron theory [1] was an early uni cation of elds and particles, in that case electrom agnetic elds and charged particles, in a common and universal description. This fram e played a determ inant role in a consistent developm ent of classical eld theory and relativistic mechanics [2]. This close connection was deeply perturbed by the advent of quantum form alism s, which ultimately emphasize the primary role of quantum elds. W ithin the fram ework of quantum electrodynamics, mechanical elects on charged particles, although obtainable in principle, are usually derived with di culties [3].

W hen taking into account physical limits in space-time probing, eld theory and mechanics emerge as complementary representations in spacetime. Fields are measured by their mechanical elects on test particles, while particle positions are measured through probe elds. Space-time measurements are determined by energy-momentum exchanges between elds and particles. In the same way as radiation of test particles a ects eld measurements, mechanical elects of the probe eld radiation pressure a ect position measurements, and hence the determination of motions in space-time.

Quantum uctuations in pose ultim ate limitations which a ect both particle positions and eld values in space-time [4]. As a consequence of H eisenberg inequalities, oscillators have uctuations which subsist in their ground states. Quantum eld uctuations persist in vacuum, and those vacuum uctuations result in fundamental limitations on the determination not only of elds, but also of positions and motions in space-time [5]. The presence of ultim ate quantum uctuations must then be taken into account in a consistent development of mechanics.

M acroscopic objects feel the e ects of quantum eld uctuations, even in vacuum . A well-known example is that of C asim ir forces between m acroscopic conductors or dielectrics [6]. C asim ir forces can be seen as a m echanical signature of the radiation pressure of quantum eld uctuations. But radiation pressure itself presents quantum uctuations, which result in further m echanical e ects. W hen m oving in a uctuating environment, a scatterer radiates and experiences a radiation reaction force [7]. There results a typical quantum B rownian m otion which is determined by radiation pressure uctuations and which persists in vacuum . W e shallhere brie y survey these e ects, and also discuss the fundam ental consequences for stability of m otion in vacuum and for ultim ate uctuations of position.

2 Radiation pressure of quantum eld uctuations

Re ectors which are immersed in a uctuating eld, like conductors or dielectrics in a uctuating electrom agnetic eld for instance, feel the e ects of eld uctuations. Even at the limit of zero temperature, i.e. in a eld which does not contain any photon, that is in the vacuum state, e ects of quantum eld uctuations persist. Vacuum uctuations are responsible for a mean force, the so-called Casim ir force, between re ectors. Two plane in nite perfect m incors in the electrom agnetic vacuum are submitted to a mean attractive pressure (force per unit area), which decreases like the fourth power of the m incors' distance q (h is Planck constant, A the area, light velocity is equal to 1):

A lthough very weak, Casim ir forces between macroscopic plates have effectively been observed [6]. As a useful simple illustration, we shall also discuss in the following the sim ilar system made of two perfect mirrors in two-dimensional space-time, in the vacuum of a scalar eld. In that case, the mean force decreases like the second power of the mirrors' distance:

For perfect m irrors, the m ean C asim ir force can easily be derived, using the following simple argument [6]. The eld can be considered as a set of free oscillators in each of the space domains delimited by the mirrors. Each of these oscillators possesses (zero-point) quantum uctuations in its ground state, with a corresponding energy of $\frac{1}{2}h!$ (! the oscillator's frequency). The mirrors play the role of boundary conditions for the eld, modifying the spectrum of mode frequencies allowed in the cavity they form. The total zero-point energy of the eld $\binom{r}{n} \frac{1}{2}h!_n$ varies with the mirrors' distance, and results in the mean force (1) between the mirrors. Although it clearly exhibits the role of vacuum eld uctuations, this simple interpretation in terms of vacuum energy leads to problems. Because of its high frequency dependence, the mode spectrum results in a total zero-point energy which is in nite, or which at least corresponds to a high energy density that induces problem atic gravitational and cosm obgical consequences [8]. On another hand, when comparing di erent physical situations, variations of vacuum energy (with the distance for instance) produce nite and observable e ects. M oreover, realistic m infors must clearly be transparent to su ciently high eld frequencies, whose uctuations should then have no incidence on the e ect.

An alternate and more consistent derivation of C asim ir forces uses a localdescription in terms of the radiation pressure exerted by eld uctuations on the mirrors [9]. We brie y recall this derivation in the case of the sim – ple model of mirrors in two-dimensional space-time $((x \)_{=0;1} = (t;x))$ (2). Each mirror determines two regions of space where the scalar eld can be decomposed on two components which propagate freely (Figure 1):

A perfect m irror corresponds to a boundary condition for the eld, saying that the eld vanishes at the m irror's position in space (q):

From now on, we shall use the following notation for Fourier transforms:

In a more realistic model, the mirror partially relects and transmits both components of the eld and is described by a scattering matrix [10]:

The mirror is assumed to be very heavy when compared with the eld energy, so that under rejection momentum is transferred to the eld while its energy is preserved (the mirror's recoil is neglected). s and r are frequency dependent transmission and rejection amplitudes, and must obey the general analyticity and unitarity conditions of scattering matrices which correspond to causality of eld scattering and conservation of probabilities. In addition, we shall assume high frequency transparency, i.e. that rejection coe cients vanish su ciently rapidly when frequency goes to in nity.

Two mirrors form a Fabry-Perot cavity which divides space into three domains where the eld propagates freely (Figure 2).



All elds are determined by input elds and the mirrors' scattering matrices. On each side of each mirror, the radiation pressure exerted by the eld is provided by the eld stress tensor (T):

The force is given by the ux of stress tensor component T 11 through the m irror (di erence between left and right sides; a dot stands for time derivative):

 $< F_1 > = < F_2 > = F_c$ is the mean radiation pressure, or Casim ir force, felt by the m irrors [10].

In vacuum state, the two input eld components are uncorrelated and have identical auto-correlations:

(is H eaviside's step function). A linearly the corresponding vacuum mean energy density is in nite (the spectral energy density increases linearly with frequency), the mean forces exerted on the mirrors (6) are nite, as the reaction coecients of the mirrors (r_1 and r_2) satisfy high frequency transparency ($q = q_2 - q_1$):

g describes the eld spectral energy density inside the cavity. At the limit of perfect m irrors (r = 1), g becomes a sum of delta functions at frequencies equal to the modes of the cavity $(n_{\frac{q}{2}})$ and the C asim ir force between the two m irrors identies with (2).

3 Quantum uctuations of radiation pressure

The radiation pressure exerted on a scatterer is related to the eld stress tensor, so that it is a function of elds (in general a quadratic form, see (5) for instance). Consequently, quantum uctuations of elds also induce quantum uctuations of stress tensors and radiation pressures. The uctuations of C asim ir forces exerted on m irrors, due to quantum uctuations of electrom agnetic elds, have recently been studied [11]. We shall just discuss som e general properties of stress tensor and radiation pressure uctuations in vacuum.

Electrom agnetic elds F and stress tensor components T can be derived from electrom agnetic potentials A (F = 0 A Q A, is M inkowski m etric diag (1; 1; 1; 1)):

Vacuum correlations of electrom agnetic potentials are determ ined from propagation equations (in Feynm an gauge):

These expressions exhibit translation and Lorentz invariances, and a spectrum limited to light-like momenta with positive frequencies (as vacuum is the state of minimum energy, transitions only have positive frequencies). In vacuum, correlations of stress tensors are determined from eld correlations using W ick'rules:

Stress tensor correlations are gauge independent and are in fact completely determ ined, up to a num erical factor, by general sym metries that are satised by correlation functions in vacuum. Translation and Lorentz invariances imply that correlations in momentum dom ain are tensors built from k and

only. Correlations of stress tensors T and T decompose on tensors which are symmetric in indices (;), (;) and exchange of these pairs, and which are transverse because of energy-momentum conservation (@ T = 0). A sM axwell stress tensor is moreover traceless, this leaves only one such tensor . In momentum domain, stress tensor correlations are obtained as convolutions of eld correlation functions in vacuum, so that they only contain time-like momenta (given by adding two light-like momenta of positive frequencies), and thus a factor (k_0) (k^2). Quite generally, as discussed at the end of this section, such factor can also be seen as a consequence of uctuation-dissipation relations characteristic of vacuum, and of Lorentz invariance. By dimensionality, these correlations are proportional to $(k^2)^2$.

W hen seen as a boundary condition for the eld, a perfect m irror determ ines a relation between outcom ing and incom ing elds, which allows one to derive the uctuations of radiation pressure exerted on the m irror from those of incom ing elds. Explicit com putations have been performed for m irrors of di erent shapes [11, 12]. We shall brie y discuss the model of partially transmitting mirror in two-dimensional space-time. The force exerted on the mirror is given by the di erence of eld energy densities between the two sides of the mirror (6). For a single mirror and vacuum input elds, its mean value vanishes. However, the radiation pressures exerted on both sides of the mirror have independent uctuations, and the resulting force still uctuates. Force uctuations on a mirror at rest are stationary and determined by the mirror's scattering matrix (4) and input eld correlations (7) [13]:

Force correlations are positive and always nite. They vanish as $!^3$ around zero frequency (energy-momentum is conserved in vacuum). In particular for a perfect m irror, they are directly related to correlations of momentum densities of incom ing free elds (see (3)):

Correlation spectra in vacuum contain positive frequencies only. Force correlations can similarly be derived for therm all elds. In therm all equilibrium, a uctuation-dissipation relation relates commutators and anticommutators [14]:

(T is the tem perature). This uctuation-dissipation relation, which was rst studied for N yquist noise in electric circuits [15], allows to determ ine uctuations in a state of therm al equilibrium from the commutator only. As discussed in next section, the commutator also identi es with the dissipative part of the linear response of the system to an external perturbation [14]. At the limit of zero tem perature, that is in vacuum, the uctuation-dissipation relation leads to a uctuation spectrum which is limited to positive frequencies:

The factor [!] explicitly shows that correlations (8) are not symmetric under exchange of time arguments and thus exhibits the non-commutative character (i.e. the quantum nature) of uctuations in vacuum.

4 Radiation reaction force

As rst discussed by E instein, a scatterer immersed in a uctuating eld undergoes a Brownian motion [7]. The uctuating force exerted by the eld leads to a di usion process for the scatterer's momentum P, which spreads in time according to:

The momentum distribution being constant at therm alequilibrium, the e ect of the uctuating force must be exactly compensated by the e ect of a further cumulative force which appears when the scatterer moves (with velocity q):

This implies a relation between the momentum di usion coe cient D which characterises force uctuations and the friction coe cient which characterises the mean dissipative force:

(T is the tem perature). In the general quantum case, when sm all displacem ents of the scatterer are considered, a relation still holds between force uctuations exerted on the scatterer at rest and the m ean dissipative force exerted on the m oving scatterer, i.e. the im aginary part of the force susceptibility $_{\rm FF}$:

Indeed, according to linear response theory [14], the susceptibility of a quantity under a perturbation is related to the correlations, in the unperturbed state, of this quantity with the generator of the perturbation. M ore precisely, uctuation-dissipation relations identify the imaginary (or dissipative) part of the susceptibility of a quantity with its commutator with the generator of the perturbation. In the case of displacements, the generator is given by the force itself:

In a therm all state, according to uctuation-dissipation relations (10) and (14), force uctuations are connected with the mean motional force:

At the lim it of high tem perature, E instein's relation is recovered (see 12):

At the lim it of zero tem perature, force uctuations subsist on a scatterer at rest and im ply that, when moving in vacuum, a scatterer is submitted to a

dissipative force. The motional susceptibility of the force is then determined by force correlations in vacuum (8) and uctuation-dissipation relation (14). For a perfect mirror, at rst order in the mirror's displacement, the mean dissipative force is proportional to the third time derivative (see (9)):

M ore recently, e ects of moving boundaries on quantum elds have been discussed to study the in uence of classical constraints on quantum elds, and in particular as an analogy for quantum elds in a classical curved space [16]. A perfect m inform oving in vacuum has been shown to radiate and hence to undergo a radiation reaction force. In two-dimensional space-time, and for scalar elds in vacuum, the radiation reaction force is proportional to the two-dimensional version of A braham vector [17], and identi es with (15) in linearised and non relativistic limits. The radiation reaction force for partially transm itting m informs can also be obtained following this approach. For general motions of the mirror, vacuum incoming elds are transformed into outcoming elds whose correlations do not correspond to vacuum. Then, energy-momentum is radiated by the moving mirror. As the mean stress tensor of outcoming elds di ers from that of incoming elds, the radiation pressure exerted by scattered elds does not vanish and the mirror is submitted to a radiation reaction force (13). The radiation pressure exerted by scattered elds (see (6)) can be obtained using the modi ed scattering matrix (16) [13]:

As expected, this expression and (8) satisfy uctuation-dissipation relation (14). As a consequence of Lorentz invariance of vacuum, the radiation reaction force vanishes for uniform motion; expression (17) leads to (15) for a perfect m irror and also vanishes for uniform ly accelerated motion:

The radiation reaction force felt by a plane perfect m irror in four-dimensional space-time has been obtained for motions in scalar eld [18] and in electrom agnetic [19] vacua. D irect comparison between radiation pressure uctuations and the dissipative force shows that uctuation-dissipation relations are satis ed in these cases.

5 Stability of motion and position uctuations in vacuum

It is well-known from classical electron theory [20], that a radiation reaction force proportional to Abraham -Lorentz vector (15) leads to motions which are either unstable (the so-called "runaway solutions") or violate causality. Perfect m irrors, and in particular m irrors treated as eld boundaries, have motions in vacuum which are a ected by the same stability and causality problem s. However, as we brie y show in the following, partially transm itting m irrors can avoid these di culties [21].

W hen a scatterer is submitted to an applied external force F (t), its motion is determined by an equation which also takes into account the force induced by motion (13). It will be su cient for our purpose to consider small displacements only, so that the equation of motion reads (we generally consider a mirror of mass m_0 , bound with a proper frequency $!_0$; a free mirror is recovered for $!_0 = 0$):

The motional response is best characterised in the frequency domain, by a mechanical impedance Z [!] which relates the resulting velocity to the applied force:

From analytic properties of the scattering matrix (4), it is easily derived that $_{FF}$ is also analytic in the upper half plane (Im (!) > 0), showing that the induced force is a causal function of the scatterer's motion. The mechanical impedance of a perfect mirror is obtained from (15):

As easily seen, the mechanical adm ittance $(Y [!] = Z [!]^{1})$ is no longer analytic but has a pole in the upper half plane. Such a pole corresponds to unstable motions, i.e. "runaway solutions" in the free m irror case. If supplem entary boundary conditions are im posed (at large time for instance) to exclude such solutions, then the resulting motions violate the causal dependence on the applied force.

A partially transm itting m irror is characterised by a force susceptibility of the general form :

High frequency transparency and analyticity lead to a better behaviour of the susceptibility [21]:

This property means that the force susceptibility is related to a positive function [22]. The mechanical impedance de ned by (19) corresponds to a positive function as long as its pole at in nity satisfies:

The inverse of a positive function is still a positive function, and furtherm ore causality follows from positivity [22]. When inequality (22) is satisfied, the mechanical admittance is also a causal function, and no "runaway solutions" can appear (see (19)). m_0 and m_1 can be seen as describing a low and a high frequency mass for the mirror, their difference being a mass correction induced by the free mass of the mirror. Stability in vacuum is insured as long as the free mass of the mirror m_1 is positive, or else as long as the quasistatic mass of the mirror m_0 is larger than the induced mass. Realistic mirrors certainly satisfy this condition, contrarily to perfect mirrors. This discussion also shows the incompatibility between stability in vacuum and mass renorm alisation, since m_1 is in nitely negative in that case (see [23] for a similar discussion for electrons).

W hile motion of the mirror modi es the scattered eld, the radiation pressure exerted by the eld also perturbs the mirror's motion. Equations of the coupled system, mirror and vacuum eld radiation pressure, when treated linearly, can be solved to obtain uctuations for the interacting system in terms of input uctuations only [24]. In particular, equation (18) provides the mirror's position uctuations in terms of input force uctuations. As a consequence of consistency relations satis ed by linear response form alism, position uctuations of the mirror coupled to vacuum elds also satisfy uctuation-dissipation relations, which relate the position commutator to the dissipative part of the mechanical admittance (the mirror's response to an applied force):

F luctuations of the coupled system also satisfy the relations characteristic of vacuum :

The mechanical admittance completely determines position uctuations in vacuum. As shown by expression (23), position uctuations consist of two

main parts. One part corresponds to a resonance peak at the oscillator's proper frequency !₀. These uctuations subsist at the limit of decoupling between mirror and eld and can be seen as proper position uctuations of the mirror; they identify with the uctuations associated with Schrodinger equation for a free oscillator. The other part is a background noise spreading over all frequencies. These are position uctuations induced by the uctuation pressure of vacuum elds and are dominant outside resonance peaks; they describe ultimate position uctuations and correspond to a quantum limit on the sensitivity of an optimal position measurement performed at such frequencies [5, 24].

6 C on clusion

Quantum eld uctuations in vacuum exert a uctuating radiation pressure on scatterers. In agreement with uctuation-dissipation relations, a scatterer moving in vacuum experiences an additional force depending on its motion. Like in classical electron theory, it generally modiles the scatterer's motional response to an applied force. For realistic mirrors, which are transparent to high frequencies, motions can be shown to remain stable and causal in vacuum, a property which is violated by mass renorm alisation.

The quantum Brownian motion induced on the mirror's position by its coupling to vacuum eld radiation pressure can be described consistently within linear response form alism. Position uctuations are determined from the mechanical susceptibility of the mirror through uctuation-dissipation relations. Vacuum eld uctuations then lead to ultimate quantum uctuations for positions in space-time.
