# Q uantum M echanics as a C lassical Theory V II: The C lassicalSpin Eigenfunctions

#### Abstract

In this continuation paper the Schrodinger equation for the half-integral spin eigenfunctions is obtained and solved. W e show that all the properties already derived using the $H$ eisem berg $m$ atrix calculation and $P$ auli's m atrices are also obtained in the realm of these analytical functions. W e also show that E instein-B ose condensation for ferm ions is expected. W e then conclude this series of tw o papers on the concept of classical spin.


## 1 Introduction

In paper V I (hereafter V I) of this series we developed a $m$ ethod by m eans of which it was possible to derive the classical coordinate-m om entum representation for the behavior of particles w ith half-integral spin.

It w as show $n$ there that the $m$ atrix representation of this calculation is readily obtained when we pass from the active to the passive view s and change the $P$ oisson bracket to its sim ilar $m$ atrix com $m$ utator. Then all $m$ atrix $m$ echanics related to the spin property w as derived by straightforw ard calculations.

W e w ill now m ake use of the fact that our classical calculations give us the coordinate-m om entum representation of the spin property which is suitable to be quantized | in the Schrodinger or D irac's sense| to derive the Schrodinger equation for the spin eigenfunction. This will be done in the second section of this paper. This w ill show that H eisem berg's $m$ atrix calculus and Schrodinger's analytical equation give identical results.

In the third section the Schrodinger equation for the spin will be solved and we will show that all the properties derived by $m$ eans of the algebraic calculations are also obtainable with analytical functions.

W e will devote the fourth section to show quantitativelly that ferm ionic E instein B ose condensation is expected by the present theory.

In the last section we will m ake our conclusions.

## 2 The Spin Schrodinger Equation

W e are now in position to derive the Schrodinger equation that will enable us to obtain the half-integral sp in eigenfunctions.
$T$ he two functions

have to be written as operators in a quantization procedure. The spin eigenfunction $w$ ill be the function that $m$ akes these operators diagonal.

The quantization procedure has to be undertaken w th much care since the function $S^{2}$ has term $s w$ th products ofposition and $m$ om entum operatorsw hich do not com $m$ ute. To see this one needs only to look at this function w ritten in the coordinate-m om entum representation

$T$ his states the very di erence from this problem to the one usually found in textbooks on the solution of orbital angular $m$ om entum Schrodinger equations. $W$ hile in the later case one has only the operator $L^{2}$ w th the operator $L$, its square root, unknow $n$, in the present approach both are know $n$ by principle and their relation is de ned by equation (3). This m eans that we w ill have only to $n$ nd the function that $m$ akes the operators $S_{0}$ and $S_{3}$ diagonal to autom atically m ake $\mathrm{S}^{2}$ also diagonal.

The next step is to transform the coordinate-m om entum representation of our problem into an operator representation.

W e begin w ith equation (2) and quantize the function $S_{0}$ in the usualway, giving

W e m ight develop the product represented in expression (6) as a repeated application of a di erential operator to get

This equation will be solved in the next section. H ow ever, it is notew orthy that, for the wave function to be a continuous function of , when a rotation by an angle of 2 k radians is perform ed, we m ust have only half-integral values for m.

## 3 Solution of the Equation

The solution of equation (19) follow s a standard m ethod which we w ill only brie y sketch here. $W$ e begin by looking at the asym ptotic behavior of function $R()$ for very large values of the variable. For this case we put

where the rst tw o choioes select the even series by letting $a_{0}$ free (and $m$ aking $a_{1} 0$ ) and the second two choiges select the odd series by letting $a_{1}$ free (and $m$ aking $a_{0} 0$ ). W e shall choose the plus sign on both cases because the wave function has to be nite at the origin $=0$. We then have

At this point it is easy to see that both choiges of $s$ in equation 25) w ill give exactly the sam e recursion relation and so, also the sam e series direct substitution of $s=2$ jn juth $n$ even and substitution of $s=2$ jn $j 1 \mathrm{w}$ th n odd show s this. W e then w ill work only w ith the choige

where the coe cients $a_{n}$ are given by expression 28) and the ratio $=$ is a structure constant used to identify the actual particle we are interested in as seen in expression (5). This structure constant is necessary since our calculations were generaland re ect the behavior of any half-integer spin particle. It is then possible to calculate quantities such as the radius of the particle in term sof th is constant by perform ing the integral

where N is a nom alization constant. T his density is related w th the intemal structure distribution of the half-integral spin particles and shall not be interpreted as probability distributions| we m ight get the $m$ ass distribution of the electron by $m$ ultiplying the above expression by its $m$ ass, for exam ple.

w here we notioe that the bigger the structure constant, the sm allest the particle. The rst possible values of are given in table I. In this table we show the ' value related to the chosen value and all possible values of jn $j$. The values of the cuto number $N$ and the $m$ ultiplicity associated $w$ ith ' is also shown. It is rem arkable that if we try to put odd values for variable, or else, integer values for variable ', we cannot term inate the series in (39), since in th is case the cuto num ber N is odd, which is not allowed by our choice of the asym ptotic behavior at the origin in expression 29). Since the series does not term inate its asym ptotic behavior for large values of variable is no $m$ ore given by expression 20) and we m ust reject these solutions.

W e also plot the density distributions for the cases ( $\quad=1=2$; min $j=1=2$ ), $(\Upsilon=7=2$; in $j=7=2$ ) and ( $(=9=2$; in $j=3=2$ ) in gures 1,2 and 3 respectively.

Figure 1 show $s$ that the ${ }^{\prime}=1=2$ spin particles structure is som ew hat like a ring (zero density at the origin) $w$ ith $m$ axim um density at a radiusr $=1=2 ; j n j=1=2$, depending on the structure constant.

In gure 2 the sam e behavior of gure 1 is attained but we m ight see that the distance of the $m$ axim um density from the origin is now $r_{\bullet=7=2 ; j n} j=7=2(=)$ which is greater than the one for the half spin case. We can visualize this as the increasing of a bentrifugal force giving the screening of the particle $m$ atter distribution| we are considering the sam e value for the structure constant.
$F$ igure 3 show s that the sam e ring structure w ill be present in all functions (they depend on $r^{2 \dot{j} j}$ which alw ays $m$ akes the densities tend to zero in the vicinities of the origin). For the cases where the di erence in the quantum num bers ' and in jare di erent from zero we also nd the appearance of nodes re ecting the multiple ring structure of these particles. The num ber of these concentric rings will be given by the expression ( ${ }^{\text {min }} \boldsymbol{j}+1$.

## 4 B ose $\mp$ instein $C$ ondensation

In the previous paper (VI) we have shown that, if the param eter has a low er bound, then the phenom enon of Bose $E$ instein condensation $w$ ill be expected for som e tem perature $T_{\text {cond }}$. $T$ his is precisely what we have found. In $T a b l e ~ I$ we note that the param eter has the value m in $=2$ as a lowerbound.
$T$ his implies that the ferm ion shallbe supplied with at least the energy

to continue to act as a ferm ion.
B ecause of this low er bound for the energy of the ferm ions we expect that, at som e value of the tem perature, condensation takes place.

## 5 C onclusion

In these two papers we aim ed at show ing that: (1) the concept of spin is not a particularity of the quantum $m$ echanical form alism and $m$ ight also be represented in the realm of classicalm echanics from where we can extract a $m$ odel for it (or a picture). (2) even in this case space quantization' $m$ ight be obtained apart from a constant (phenom enologically obtainable) which we relate to $P$ lanck's constant. (3) the concept of spin is related to the sym $m$ etries generated by the Lie algebra associated w ith its Lie G roup (SU (2)); since this group is the sam e generated by classical phase-space functions obeying the sam e Lie algebra w ith the product de ned as the P oisson bracket, there is no im possibility in deriving the concept of classical spin. (4) this classical representation of the spin $m$ ight be quantized' using traditionalm ethods to derive a Schrodinger equation which is an analytical representation for this quantily. The solution of this equation, when squared, w ill give us inform ation on the particle intemal structure, as for exam ple its m ass or charge distribution or its m ean radius, in term s of som e characteristic constant related to each particle and identifying it. (5) all expected quantum properties already obtained by $H$ eisem berg $m$ atrix calculations, using $P$ auli's $m$ atrioes, are also obtained $w$ ith this $m$ ethod and this result rea $\mathrm{m} s$ the form al identity betw een $H$ eisem berg's $m$ atrix calculus and Schrodinger's one. (6) spin is not a characteristic of relativistic calculations although it is better represented in the realm of this theory where Lorentz invariance m ight be im posed. (7) ferm ionic B ose E instein condensation has a very intuitive explanation by $m$ eans of the $m$ inim um energy the ferm ions have to possess in order to behave like ferm ions.

W e hope that these calculations will help in clarifying som em isconceptions rather di used in the literature about the classical versus quantum status of half-spin particles and also about the possibility of an analytical representation of the concept of half-spin.

A side the epistem ological aspects, we also hope that the possession of the spin eigenfunctions $w$ ill help the investigations in areas such as superconductivty, B ose E instein condensation and $m$ any others.
