# Generalized Unruh e ect and Lamb shift for atom s on arbitrary stationary trajectories

#### A bstract

We study the spontaneous de-excitation and excitation of accelerated atom s on arbitrary stationary trajectories (\generalized U nruh e ect"). We consider the e ects of vacuum uctuations and radiation reaction separately. We show that radiation reaction is generally not altered by stationary acceleration, whereas the contribution of vacuum uctuations di ers for all stationary accelerated trajectories from its inertial value. Spontaneous excitation from the ground state occurs for all accelerated stationary trajectories and is therefore the \normal case". We furtherm ore show that the radiative energy shift (\Lam b shift") of a two-level atom is modi ed by acceleration for all stationary trajectories. A gain only vacuum uctuations give rise to the shift. O ur results are illustrated for the special case of an atom in circular motion, which m ay be experimentally relevant.

### 1 Introduction

Recently, a new physical picture for the spontaneous excitation of a uniform ly accelerated two-level atom (the Unruh e ect [1]) has been put forward [2]. Following a quantum optical approach it is based on the distinction of the two competing mechanisms which operate to excite an atom in the quantum vacuum : vacuum uctuations and radiation reaction. Vacuum uctuations tend to excite an atom in its ground state and de-excite it in an excited state. On the other hand, radiation reaction leads always to a loss of internal excitation energy. For an inertial atom in the ground state, the two contributions cancel exactly, so that a very subline balance between vacuum uctuations and radiation reaction prevents the spontaneous excitation of the atom [3]. If the atom is in the excited state, both contribution add up to the well-known spontaneous emission rate. It has been shown in [2] (see also [4]) that uniform acceleration will disturb this balance. Spontaneous transitions from the ground state to the excited state become possible: the Unruh e ect. Sim ilarly, the rate of spontaneous emission is modiled from its inertial value for a uniform ly accelerated atom .

It is interesting to investigate the  $\$  ne structure" of these processes by considering vacuum uctuations and radiation reaction separately. In the case of uniform acceleration, the contribution of vacuum uctuations is changed from its inertial value, while the contribution of radiation reaction remains exactly the same as for the inertial atom. Their combined action leads to the spontaneous excitation or de-excitation described above.

In this paper, we will concentrate on more general states of motion of the atom .We consider arbitrary stationary trajectories in M inkowski space, which can be characterized as a motion along a timelike K illing vector eld or, equivalently, by the condition that the geodesic distance between two points on the trajectory depends only on their proper time di erence [5].We will ask for which of these trajectories there is a spontaneous excitation of the atom (\generalized U nruh e ect").Furtherm one we will discuss whether it is a general trait that the contribution of radiation reaction is not modified by the acceleration or whether this holds only in the special case of uniform acceleration. Another question is whether it is true also for more general trajectories that the atom is excited because it perceives the vacuum uctuations di erently.

O ur results are summarized in a number of theorems. The rst one shows that the contribution of radiation reaction is the same for all stationary accelerated trajectories as in the inertial case. A coordingly, radiation reaction is a purely local concept that is not sensitive to the actual state of motion of the atom. This can be understood heuristically: the eld is radiated away by the atom with the velocity of light. Since the atom 's trajectory is timelike, the only moment it can act back on the atom is precisely at the time it is emitted. The mechanism of radiation reaction is thus restricted to act at this point of the trajectory alone.

Next we show that the contribution of vacuum uctuations di ers for allatom s on accelerated stationary trajectories from that of an inertial atom. Together, these two results dem onstrate that a generalized Unruh e ect takes place for all stationary trajectories except the inertial ones. In this sense, the spontaneous excitation of an atom is the norm all case and the non-occurrence of the Unruh e ect for inertial atom s is an exception.

The second main part of the paper is concerned with the radiative energy shift of accelerated atom s. The \Lamb shift" for a uniform ly accelerated two-level atom has been calculated already in [6]. This shift can be explained qualitatively as follows: For a uniform ly accelerated atom, the M inkowski vacuum appears as a therm albath of particles called R indler quanta. The AC Stark shift associated with these particles is responsible for the atom 's modi ed Lamb shift.

In Sec. 4, we will investigate the Lamb shift for atom s on arbitrary stationary trajectories, where a simple interpretation in term s of R inder particles is no longer possible. A lready for an inertial atom, the energy shift diverges and must be regularized, for example by imposing a cuto energy. Consequently, it may be di cult to isolate the modi cations introduced by the acceleration. We overcome this problem by referring to a recently proved theorem [7] that connects the radiative energy shifts to the transition rates between the levels, which are much easier to calculate. In this way, we can show that the acceleration induced modi cation of the Lamb shift is always nite. This allows an unam biguous separation into a (divergent) inertial part and a nite correction caused by the acceleration.

W e will then consider the individual contributions to the Lamb shift. W e will show that the e ect of radiation reaction is the same for an atom on an arbitrary stationary trajectory as for an inertial one. It is equal for both levels and does not contribute to the relative shift. C ontrarily, the e ect of vacuum uctuations is modiled for any accelerated stationary trajectory. The total shift dilers always from its inertial value.

As an illustration of our results, we treat in Sec. 5 an atom in circular motion. The spontaneous excitation for a two-level atom on such a trajectory has been treated previously [8, 9, 10] and may be of experimental relevance. We discuss the contributions of vacuum uctuations and radiation reaction separately and determine the evolution of the mean atom ic excitation energy towards its equilibrium value. Furthermore, we identify the Einstein coe cients for spontaneous excitation and de-excitation. Finally, the Lamb shift for a circulating atom is calculated by applying the theorem of Ref. [7]. The correction due to the acceleration is isolated and com pared with the uniform ly accelerated case.

# 2 Vacuum uctuations and radiation reaction: the general form alism

As a basis for the discussion of the behaviour of accelerated atoms in arbitrary stationary motion in Special Relativity, we will brie y recall the model and the Heisenberg picture form alism that was used to treat the case of uniform ly accelerated atoms in previous publications [2, 6]. We consider a pointlike two-level atom on an arbitrary stationary space-time trajectory x() which interacts with a scalar quantum eld . denotes the proper time on the trajectory. A characterization of stationary motion in M inkowski space has been given by Letaw [5], resulting in two equivalent conditions: (a) the trajectory follows the orbits of a time like K illing vector eld, or (b) the geodesic distance between two points x() and  $x(^{0})$  on the trajectory depends only on the proper time interval  $^{0}$ .

Property (a), mentioned above, ensures that the metric along the path of the atom does not change and guarantees the existence of stationary states. For our two-level atom, these will be called j+i and j i, with energies  $\frac{1}{2}!_0$ . The atom 's undisturbed H am iltonian with respect to its proper time can then be written

where  $R_3 = \frac{1}{2}j + ih + j + \frac{1}{2}j$  in j is the pseudospin operator commonly used in the description of two-level atoms [11, 12].

The free Hamiltonian of the scalar quantum eld that governs its time evolution with respect to is

with creation and annihilation operators  $a_{k}^{y}$ ,  $a_{k}$ . A tom and eld are coupled by the interaction

where is a small coupling constant,  $R_2 = \frac{1}{2}i(R = R_+)$ , and  $R_+ = j + ih = jR_+ = j$  ih  $jR_- = j$  in k = j.

We can now write down the Heisenberg equations of motion for the atom and eld observables. The eld is always considered to be in its special relativistic vacuum state jDi (Minkowski vacuum). To isolate the contributions of vacuum uctuations and radiation reaction to the rate of change of atom ic observables, their solution for the eld is split into its free or vacuum part <sup>f</sup>, which is present even in the absence of the coupling, and its source part <sup>s</sup>, which represents the eld generated by the atom itself. If we consider now the eld state individual contributions of vacuum uctuations and radiations and radiation reaction to the rate of change of atom ic observable G, we obtain the individual contributions of vacuum uctuations and radiation reaction to the rate of change of G. Follow ing D alibard, D upont-R oc and cohen-Tannoud ji [3], we choose a symmetric ordering between atom and eld variables. Below we repeat only the necessary de nitions and central expressions of [2] and [6].

Our rst aim is the discussion of spontaneous emission and spontaneous excitation from the ground state j i which we will call generalized Unruh e ect. We therefore concentrate on the mean atom ic excitation energy  $hH_A$  () i. It has been shown in [2] that the contributions of vacuum uctuations (vf) and radiation reaction (rr) to the rate of change of  $hH_A$  i can be written (cf. [3, 13])

with  $ji = j_a;0i$  representing the atom in the state  $j_ai$  and the eld in the M inkowski vacuum state  $j_0i$ . They are expressed in terms of the statistical functions of the atom

 $C^{A}$  and  $C^{F}$  are called symmetric correlation functions,  $^{A}$  and  $^{F}$  linear susceptibilities. Note that the dependence on the trajectory x() of the atom in (4) and (5) is contained entirely in the statistical functions of the eld, which have to be evaluated at two points on the atom 's world line. The atom registers the in uence of the M inkow skivacuum when following its speci c space-time trajectory.

The explicit form of the statistical functions of the atom is given by

where  $!_{ab} = !_a$   $!_b$  and the sum extends over a complete set of atom ic states. The statistical functions of the eld are

where t = t()  $t(^{0})$ , x = x()  $x(^{0})$  and P denotes the principal value.

In a next step, we consider the \Lamb shift" of the two-level atom, i.e. the radiative energy shifts of its levels due to the coupling to the quantum vacuum. To this end, one studies the evolution of an atom ic observable G and traces out the eld degrees of freedom in its equations of motion. It is then possible to identify an elective H am iltonian for the atom which acts in addition to H<sub>A</sub> (cf. [3, 13]). The expectation value of H<sub>eff</sub> in an atom ic state jai gives the radiative shift of this level. A gain the division of the eld into free and source part allows the identi cation of the contributions of vacuum uctuations and radiation reaction. A s has been shown in [6], the radiative energy shifts of level jai are given by

As we restrict ourselves to the model of a two level atom the statistical functions of the atom (10) and (11) can be simplified: The level spacing  $!_{ab}$  is given by  $j!_{ab}j = !_{o a;b}$  and the matrix element  $ja \Re_{2}^{f}(0) j_{D}j_{D}^{f}$  is reduced to

Hence the sum mation in (10) and (11) breaks down. In the following theorem s we nevertheless use the unevaluated form ulas (10) and (11) to stress the structure of the results so that possible extensions to multi-level atom s are easily made (cf. [7]).

## 3 Relaxation rates for atom s on arbitrary stationary trajectories

Based on the formalism presented above, we will discuss in this section some general features of the relaxation rates (4) and (5) for atom s in arbitrary stationary motion. Two special cases, discussed in a previous paper [2], are an unaccelerated atom in uniform motion (or at rest) and a uniform ly accelerated atom with constant acceleration a. It was found in [2] that for a uniform ly accelerated atom the contribution of radiation reaction (42) to hdH<sub>A</sub> =d i is the same as for an atom at rest. On the other hand, the contribution of vacuum uctuations is changed by the in uence of acceleration. This means that spontaneous excitation of a uniform ly accelerated atom in the ground state becom es possible and provides a physical picture of the U nruh e ect.

The question arises: is this structure a special feature of the uniform ly accelerated trajectory or does it appear in a similar way for other stationary trajectories too? W e will prove two theorem s which show that indeed spontaneous excitation of the atom takes place for any non-inertial trajectory

Theorem 1: The contribution of radiation reaction to the rate of change  $h_{d}^{H_{\lambda}}$  i of the mean atom ic energy is for all stationary trajectories equal to that of an atom at rest:

Proof: In Eq. (5), the only dependence on the trajectory of the atom is through the linear susceptibility of the eld. It is therefore su cient to analyze F. We will show that it is equal in the distributional sense (i.e. integrated over an arbitrary test function) for all timelike trajectories. Starting from Eq. (13), we apply F to a test function f ( $^{0}$ ). Since its Fourier transform f(!) exists, it can be split in a part f<sup>(+)</sup>( $^{0}$ ) that vanishes for  $^{0}$ ! + i1 and a part f<sup>()</sup>( $^{0}$ ) that vanishes for  $^{0}$ ! i1 :

We calculate the integral via the residue theorem and treat rst the case where the contour can be closed in the upper half complex <sup>0</sup> plane. Due to the i structure of the two parts of <sup>F</sup>, only the poles on the real <sup>0</sup> axis contribute. We notice that for real <sup>0</sup>, the denom inator of (18) vanishes only for lightlike separated points x () and x (<sup>0</sup>). Because our trajectory is timelike, the only contribution comes from  $^{0}$  = . We can therefore expand the denom inator in (18) around this point:

The term in square brackets is just the square of the four-velocity u = 1 and we obtain

where we have absorbed the positive quantity  $dt=d^{0}$  in  $\cdot$ .

The evaluation of the integral (18) is now straightforward. One nds

For the  $f^{()}$  part which vanishes for  ${}^{0}!$  if the contour must be closed in the lower half plane and the same result is found. By adding the two contributions, the desired result is obtained.

Eq. (21) shows that for any accelerated trajectory,  $^{\rm F}$  has the same functional form as for an inertial one. Note that it was not necessary to assume stationarity in deriving (21).

To complete the proof, we calculate from (5) and (10) the contribution of radiation reaction to the rate of change of  $hH_A$  i:

where u = 0. The integrand is symmetric so that we can extend the lower limit to 1. The evaluation of the integral is trivial and we obtain (16) with (17). This expression is independent of the trajectory x(). It is the same formula we found already in [2] for an inertial atom and a uniform ly accelerated atom.

It is worth noting, that the structure of (16) and (17) is maintained for multi-level atom s, since we did not use any properties restricted to the two-level model.

Theorem 2: The contribution of vacuum uctuations to hdH  $_{\rm A}$  =d i di ers for any accelerated stationary trajectory from that of an atom at rest.

Proof: Using (11), we write Eq. (4) in the form

We recognize that the integral appearing in this expression is the Fourier cosine transform of the sym metric correlation function  $C^{F}(u)$ . Hence, to show that (23) deviates from its inertial value for a noninertial form of  $C^{F}(u)$ , we can use the uniqueness theorem of the Fourier transform ation: if  $C^{F}(u)$  is of bounded variation and the integral converges, the Fourier integral is unique. The rst requirement is trivially fulled for the monotonic function  $C^{F}(u)$ . To show that the second one is also met, we use the explicit form (12) of the symmetric correlation function. Apart from the convergence factor, the term appearing in the denominator is the geodesic distance ( $^{0}$ ) between the two points x() and x( $^{0}$ ) on the trajectory of the atom, expressed as a function of the proper time . Now we use the fact that for any two points, the four-distance along their connecting geodesic is maximal. Therefore

is the four-distance as measured along the world line. Hence we always have

But the right-hand side of (27) is just the expression appearing in the symmetric correlation function for an inertial atom (cf.Eq. (35) of [2]). Thus we have

for any accelerated stationary atom . Using (23), the proof for a two level atom is complete.

Consequence: Taking the contents of Theorem s 1 and 2 together, we see that for an accelerated atom in its ground state, the balance between vacuum uctuations and radiation reaction, which prevents spontaneous excitations for inertial atom s, is never maintained in the non-inertial case. Spontaneous transitions from the ground state to the excited state therefore take place on an arbitrary accelerated stationary trajectory, leading to the generalized Unruh e ect. In addition, the spontaneous emission rate for an atom in the excited state is always altered through the in uence of the not necessarily uniform acceleration.

### 4 Lamb shift for arbitrary stationary trajectories

As mentioned in Sec. 2, it is possible with the same form alism to identify the contributions of vacuum uctuations and radiation reaction to the Lamb shift of the two-level atom. It is interesting to ask the same questions for the energy shifts as for the relaxation rates: how are the two contributions ( $E_a$ )<sub>vf</sub> and ( $E_a$ )<sub>rr</sub> of (14) and (15) modiled for an atom on an arbitrary stationary trajectory?

To investigate this problem we do not start directly from the formulas (14) and (15). Instead we use a relation between relaxation rates and energy shifts that was derived under very general assumptions in our previous paper [7]. Applied to the special model we are discussing here, it reads

where  $ab^{rr}_{ab}$  and  $ab^{rr}_{ab}$  have been de ned in (24) and (17). With the help of this theorem, it is easy to formulate the analogue of Theorem 1 for the radiative energy shifts, especially for the relative shift =  $E_{+}$  E of the two levels (\Lamb shift"), which is the measurable quantity:

Theorem 3: (a) The contribution of radiation reaction to the energy shift  $E_a$  is for all stationary trajectories equal to that of an atom at rest. (b) Radiation reaction does not contribute to the relative energy shift of a two-level atom :

Proof: Both conclusions follow simply from Eq. (30) together with (17).

Since equation (30) is not restricted to the two-level atom, part (a) of Theorem 3 can be extended to multi-level atom s.Part (b) will not remain true in the general case because of di erent coupling strengths of the energy levels to the eld. How ever, there will be no in uence of the motion to the relative shift and it will remain constant.

It is not so easy to obtain an analogue of Theorem 2, because of the divergence of the level shift of the atom at rest. We must rst show that the additional level shift to the inertial one due to the in uence of the motion is nite.

Theorem 4: The additional contribution ( $E_a$ )<sub>vf</sub> ( $E_a$ )<sub>vf</sub><sup>inert</sup> of vacuum uctuations to  $E_a$  due to acceleration is nite for all stationary trajectories.

in the lim it j! <sup>0</sup>j! 1 . A short calculation shows that the integrand of (33) goes faster to zero as  $\frac{1}{1^{\frac{1}{100}}}$  and hence the total integral converges.

This fact agrees with our expectation that the additional energy shift due to an accelerated motion should be a continuous function of the acceleration without divergences, so that for weak acceleration this additional contribution goes continuously to zero.

Theorem 5: The contribution of vacuum  $\$  uctuations to  $E_a$  di ers for any accelerated stationary trajectory from that of an atom at rest.

P roof: U sing equation (14) with the linear susceptibility of the atom (11) we can write for the additional contribution to the inertial value of the energy shift

The integral appearing is just the Fourier sine transform of  $C^{F}(u) = C_{inert}^{F}(u)$ . In Theorem 4 we have shown that the integral converges, so that the Fourier transform exists and is unique. Equation (28) ensures that there will always be a contribution of vacuum uctuations to the energy shift of an atom at rest for any accelerated stationary motion.

It is easy to see, that for the two level system the relative energy shift is given by

This agrees with the total Lamb shift for a two-level atom, since according to (32), radiation reaction does not contribute to the relative shift of the two levels. Because of the divergence of the Lamb shift, it is useful to split the Lamb shift in the diverging part inert, which is equal to the Lamb shift of an atom at rest, and the non-diverging rest D appearing for any accelerated moving atom

Below we will evaluate D for a special case.

Result: The Lamb shift of an accelerated two-level atom always deviates from its inertial value, although only the contribution of vacuum uctuations gives rise to this modi cation.

### 5 Application: A tom in circular m otion

To illustrate the use of our theorem s, we consider the concrete situation of an atom in circular motion on the trajectory

with constant radius R and magnitude of velocity v. In (39), =  $(1 \quad \sqrt[2]{})^{1=2}$  is the usual relativistic factor, ! = v=R is the angular velocity, and a =  $v^2 \, {}^2=R = {}^2 \, {}^2R$  the magnitude of acceleration. The \circularUnnuh e ect" for a two-level system on the trajectory (39) has been discussed by several authors [5, 9, 10]. W e will discuss separately the contributions of vacuum uctuations and radiation reaction to the Unnuh e ect and spontaneous emission. Furtherm ore, we will be able to study the evolution of the atom ic population to its equilibrium value and identify the Einstein coe cients for the spontaneous processes. Finally, application of Eqs. (31) and (30) will allow us to determ ine the Lamb shift of an atom in circular motion.

The statistical functions of the eld can be evaluated with the help of

It is easy to verify by explicit calculation that the contribution of radiation reaction to hdH  $_{\rm A}$  =d i is given indeed by (17), as stated by Theorem 1.

The contribution of vacuum uctuations is more di cult to obtain. It is calculated from Eq. (4) via the residue theorem so that we need to know the zeroes of the denominator. This leads to an equation of the form  $x^2 = v^2 \sin^2 x$ , which is not analytically solvable. The problem becomes tractable in the \high velocity lim  $t^m$  [9, 10]. For v > 0.85, we can expand the sine to nd the zero with the sm allest in aginary part (besides x = 0). Because the exponential in the numerator of the resulting integral, zeroes with larger in aginary part can be neglected. In this way, we obtain

The total rate of change of the atom ic excitation energy can be found by adding the contributions of vacuum uctuations and radiation reaction:

We recognize that spontaneous excitation  $(!_a < !_b)$  is possible as well as spontaneous de-excitation  $(!_a > !_b)$ . As stated by the contents of theorem s 1 and 2, the balance between vacuum uctuations and radiation reaction which is present for an inertial atom becomes upset.

From Eq. (45), it is possible to get in second order in a di erential equation for  $hH_A$  i, (cf. [2])

From (47) we see that the system evolves towards an equilibrium population

C om parison of (47) with the solution of an appropriately de ned rate equation (cf. Eq. (65) in Ref. [2]) allows the identication of the two E instein coe cients A  $_{\#}$  and A  $_{\#}$  for spontaneous emission and the Unruh e ect. W e obtain

The spontaneous emission rate  $A_{\#}$  shows a modi cation of the value  ${}^{2}!_{0}=8$  for an atom at rest, in accordance with Theorem 2. Spontaneous excitation (the \circularUnruh e ect") occurs with a rate  $A_{\#}$ . Its value is in accordance with previous results [9, 10],

Following [9] we can de ne an e ective tem perature by

which is higher by a factor  $\frac{p^2}{3}$  than the Unruh tem perature for linear acceleration  $T_U = \frac{a}{2}$ .

W ith the help of Eqs. (31) and (30), we can determ ine from  $hdH_A = d_{f}$  and  $hdH_A = d_{f}$  the contributions of vacuum uctuations and radiation reaction to the Lamb shift of the circularly moving two-level atom . We know already that the contribution of radiation reaction is the same as for an inertial atom and thus does not contribute to the relative energy shift:

The Lamb shift , i.e. the relative shift of the two levels can be found by evaluating the b sum m ation in (57) for each of the levels separately:


The rst one of the two terms appearing in square brackets, coincides with the Lamb shift  $_{inert}$  for an atom at rest. The second one represents the in uence of the circular acceleration, which gives the nite correction D to the level shift. With the help of Eq. (3.354.3) from Ref. [14], it can be evaluated in closed form . We obtain



E idenotes the principal value of the exponential integral function [14]. A plot of the acceleration-induced correction D to the inertial emission rate  $\lim_{inert} = \frac{2}{8}!_0$  as a function of  $\frac{a}{!_0}$  is shown in Fig. 1. For an estimation of the order of magnitude we consider an electron, moving in a circular orbit

For an estimation of the order of magnitude we consider an electron, moving in a circular orbit perpendicular to a uniform magnetic eld  $\beta_0 j = B_0$  (cf. [9]). The magnetic and electric elds in the co-moving frame are

The splitting of the two energy levels "spin up" and "spin down" in the rest fram e is given by

Therefore we get for ultra-relativistic electrons (v ' 1, g=2) the ratio  $a=!_0$  1, which gives rise to a correction D of the relative energy shift with value  $D = _{in ert} 1.5\%$ .
