Statisticalm echanics of qpłoosons in D dim ensions

This paper is concemed w ith statisticalproperties of a gas ofqp-bosons w ithout interaction. Som e therm odynam ical functions for such a system in D dim ensions are derived. B ose E instein condensation is discussed in term s of the param eters $q$ and $p . F$ inally, the second-order correlation function of a gas of photons is calculated.

1. In the last twenty years, di erent types of deform ed bosons have been introduced [1-8]. There use for obtaining realisations of quantum algebras is now widely widespread (e.g., see $[4-6,8]$ ). W e shall deal here w ith qp-bosons [6-8] associated to the annihilation (a), creation ( $\mathrm{a}^{+}$) and num ber operator $(\mathbb{N})$ characterized through their action
on the ordinary Fock space $F:=\mathrm{fjni}: \mathrm{n} 2 \mathrm{~N} g$. (The operators $\mathrm{a}, \mathrm{a}^{+}$and N span a qp-deform ed W eylH eisenberg algebra.) The qp-deform ed num ber in (1) are de ned by

The particular cases $p=1$ and $p=q^{1}$ correspond to $q$-deform ations $m$ ainly used in the $m$ athem atical and physical literature, respectively. In the general case, $H$ erm itean conjugation requirem ents dem and that ( $q ; p$ ) 2 $R \quad R$, or $(q ; p) 2 C \quad C$ with $p=q$ or $(q ; p) 2 S^{1} \quad S^{1} w$ th $p=q=q^{1}$ [9].

N um erous w orks have been devoted to the study of the statistical therm odynam ical properties of a gas of deform ed bosons ( $m$ ainly $q$-bosons) w ithout interaction [10-21]. (W hen writing this Letter, we becam e aw are of a paper [21] dealing w th qp-bosons.) In particular, the phenom enon of B ose $E$ instein condensation of deform ed bosons has been studied by several authors $[10,13,14,16,20,21]$. Furtherm ore, the deform ation of the correlation function of order tw o for a gas of photons has been recently investigated by M an'ko et al. [15]. M ost of the preceding works concem q-and qp-bosons in $D=2$ or 3 dim ensions and are restricted to q $2 R$ [10-20] and ( $q ; p$ ) $2 R \quad R$ [21].

W e derive in this Letter the (them odynam ical) properties of a gas of qp -bosons in $D$ dim ensions for param eters $q$ and $p$ varying in ve dom ains.

TheB ose $\mp$ instein condensation ofqp-bosons is discussed in a new approach. $F$ inally, we obtain the correlation function $g^{(2)}$ for a gas ofphotons described by qp-bosons.
2. W e start w ith the H am ittonian (in a second-quantized form )

which describes a gas of qp-bosons w thout interaction. In eq. (3), is the chem ical potential while $\mathrm{E}_{\mathrm{k}}$ and $\mathrm{N}_{\mathrm{k}}$ are the kinetic energy of a qp-boson and the num ber operator for the qp-bosons, in the km ode, respectively. $T$ he qp-analogue of the B ose factor for the k m ode is then

$w$ here $Z:=\operatorname{tr} e^{H}$ is the partition function and $=\left(k_{B} T\right)^{1}$ the reciprocal tem perature. A s a trivial result, we have

$T$ he partition function $Z$ is thus independent of the deform ation param eters $q$ and $p$. Then, the B ose factor $\left(f_{k}\right)_{q p}$ reads

which can be shown to converge in each of the follow ing ve cases : (i) (q;p) $2 \mathrm{R}^{+} \mathrm{R}^{+} \mathrm{w}$ th $0<\mathrm{q}<\mathrm{e}$ and $0<\mathrm{p}<\mathrm{e} \quad$; (ii) ( $\left.\mathrm{q} ; \mathrm{p}\right) 2 \mathrm{R}^{+} \mathrm{R}^{+}$ $w$ th $p=q^{1}$ and $e<q<e \quad ;$ (iii) $(q ; p) 2 R^{+} \quad R^{+} w$ th $p=1$ and $0<q<e \quad ;($ (iv $)(q ; p) 2 C \quad C$ with $p=q$ and $0<\dot{\operatorname{qj}} \dot{j}<e \quad ;(v)$ $(q ; p) 2 S^{1} \quad S^{1} w$ th $p=q=q^{1}$.

At this stage, it is im portant to justify the choioes $m$ ade for eqs. (3) and (4). The qp-bosons are not new particles. They are still bosons. Thus, (3) and (4) correspond to the basic form ulas for the statistical $m$ echanics of bosons. Here, we do not deform the basic form ulas. The trace and the exponential in eq. (4) are nondeform ed functions. W e only use (through the form alism of second quantization) creation and annihilation operators that satisfy qp-deform ed com $m$ utation relations. The form chosen for $H_{k}$ in eq. (3) is nothing but the usual one where the num ber operator takes its eigenvalues in N . The deform ation cannot enter the theory at this level by replacing $N_{k}$ by $a_{k}^{+} a_{k}$ in (3) since we would obtain an \occupation num ber" $\left.a_{k}^{+} a_{k}=\left[\mathbb{N}_{k}\right]\right]_{\text {qp }}$ that would not have its eigenvalues in $N . O n$ the contrary, we m ust keep $a_{k}^{+} a_{k}$ rather than $N_{k}$ in (4). Indeed, should we use $N_{k}$ in place of $a_{k}^{+} a_{k}$ in (4), we would get a nondeform ed value of the B ose factor. A s a conclusion, eqs. (3) and (4) constitute a reasonable starting point for a ( $m$ inim al) deform ation of the B ose distribution.

Follow ing ref. [9], we can use the param etrisation

The obtained expression for $\left(f_{k}\right)_{q p}$ is

which clearly exhibits the q \$ p sym m etry. In the (ve) lim iting situations where' ! 0, we recover the ordinary B ose distribution $f_{k}=(e \quad 1)^{1}$. $N$ ote that $\left(f_{k}\right)_{q p}$ can be rew rilten as

For the purpose of practical applications (in Section 3), it is useful to know the developm ent of the distribution $\left(f_{k}\right)_{\mathrm{qp}}$ in integer series. In this respect, we have

3. In the therm odynam ical lim it, the energy spectrum of the system of qp-bosons $m$ ay be considered as a continuum. $T$ hus, $\left(f_{k}\right)_{q p}$ is replaced by the qp-dependent factor $f()$ which is $\left(f_{k}\right)_{q p} w$ ith $E_{k}=$ ". Therefore, in physical applications, we have to consider integrals of the type

W e are now in a position to derive som e them odynam ical quantities, in $D$ dim ensions, for a free gas of $N$ ( $D$ ) qpłbosons contained in a volum e $\mathrm{V}(\mathrm{D})$. The density $\quad(\mathrm{D})=\mathrm{N}(\mathrm{D})=\mathrm{V}(\mathrm{D})$ is given by [14]

In eq. (15), $g$ is the degree of (spin) degeneracy and $m$ the $m$ ass of a qpboson. The total energy can then be calculated to be

4. W e now exam ine the condensation of a system of qp-bosons in $D$ dim ensions. The corresponding density for such a system is given by (14) which can be rew ritten as

in function of the integral $J_{\frac{D}{2}} 1$. As in the case of ordinary bosons, we de ne the B ose tem perature $\mathrm{T}_{\mathrm{B}}(\mathrm{D})$ for the qp boosons by taking $=0$. By introducing $=0$ in $J_{\mathrm{D}_{2}}$, we nd that the tem perature below which we obtain a Bose $\mp$ instein condensation is given by

T he study of the convergence of the series (23) determ ines if B ose E instein condensation takes place or not.

In the lim iting cases where' ! 0, eqs. (22) and (23) give back the well-known results according to which there is (respectively, there is not)
condensation in $D=3$ (respectively, $D=2$ ) dim ensions. A san illustration, we recover that the B ose tem perature is

Retuming to the general case, we can prove the follow ing results valid for $D$ arbitrary.
(i) C ase ( $\mathrm{q} ; \mathrm{p}$ ) $2 \mathrm{R} \quad \mathrm{R}$ : the series (23) converges for $0<\mathrm{q}<1$ and $0<p<1$. Thus, there is Bose $\pm$ instein condensation of $q p-b o s o n s$ for $0<q<1$ and $0<p<1$. In addition, there is no Bose q instein condensation (i.e., $T_{B}(D)=0$ ) for $q$ boosons corresponding to $p=q^{1}$. In contradistinction, B ose $\mp$ instein condensation takes place for $q$-bosons corresponding to $\mathrm{p}=1 \mathrm{w}$ hen $0<\mathrm{q}<1$.
(ii) C ase ( $q$; p) $2 \mathrm{C} \quad \mathrm{C}$ : Bose E instein condensation occurs either for the $q$-bosons corresponding to $p=q$ when $0<\dot{\mu j}<1$ or for all $q-b o s o n s$ corresponding to $p=q=q^{1}$.

These results have to be com pared to the ones corresponding to the lim iting situation where' ! 0 forwhich Bose E instein condensation exists only when D 3.
5. A s a nal faœt of this Letter, we would like to discuss the consequence of a qp-deform ation of the correlation function $\mathrm{g}^{(2)}$ of order two associated to the radiation eld. In the nondeform ed case, we know that $g^{(2)}$ takes tw o valhes, viz., $g^{(2)}=1$ for a coherent $m$ onom ode radiation and $g^{(2)}=2$ for a chaotic $m$ onom ode radiation. A $n$ interesting question arises : Is it possible to interpolate betw een the latter two values by replacing the ordinary bosons of the radiation eld by qp-bosons ?

O ur basic hypothesis is to describe the radiation eld by an assem bly of qp-bosons w ith the H am iltonian

T he corresponding B ose statisticaldistribution for the $k \mathrm{~m}$ ode is then given by (10) where is replaced by $=\mathrm{h}!\mathrm{k}$. In the case of qp-bosons, we adopt the de nition

The abbreviation $\mathrm{hX} i \operatorname{in}$ (26) denotes the m ean statistical value $Z^{1} \operatorname{tr} e^{h} X$ for an operator $X$ de ned on the Fock space F. Equation (26) can be developed as

w ith convergence conditions that parallel the ones for $\left(f_{k}\right)_{q p}, c f$. cases (i)(v) in Section 1 where must be replaced by $=2$. For instance, when
(q;p) $2 \mathrm{R}^{+} \mathrm{R}^{+}$, we must have $0<\mathrm{q}<\mathrm{e}^{\overline{2}}$ and $0<\mathrm{p}<\mathrm{e}^{\overline{2}}$.] The qpdeform ed factor $g^{(2)}$ depends on the param eters $q$ and $p$ in a sym $m$ etrical $m$ anner ( $q \$ p$ symmetry). It also presents a dependence on the energy $h!k$ of the $k m$ ode and on the tem perature $T$. In the lim iting cases ' ! 0 , we get $g^{(2)}=2$ that tums out to be the value of the correlation function for the choatic $m$ onom ode radiation of the black body. Let us now exam ine the cases of low tem peratures and high energies. In these cases, $e$ is the dom inating term in each of the di erences occuring in eq. (30). Therefore, we have

at low tem perature or high energy. It is thus possible to reach the value $\mathrm{g}^{(2)}=1 \mathrm{w}$ thout em ploying coherent states. Equation (31) show s that we can interpolate in a continuous way from $g^{(2)}=1$ (coherent phase) to $g^{(2)}=2$ (chaotic phase). It should be observed that we can even obtain either $\mathrm{g}^{(2)}>2$ or $\mathrm{g}^{(2)}<1$ from eq. (30). The situation where $\mathrm{g}^{(2)}<1 \mathrm{~m}$ ay be interesting for describing antibunching e ects of the light eld (arising from the \nonclassical" nature of the radiation eld, cf. ref. [21]).
6. In this work, we concentrated on the in uence of a qp-deform ation of the W eylH eisenberg algebra on the statistical properties of a gas of bosons in D dim ensions. We discussed the phenom enon of Bose E instein condensation in term softhe deform ation param eters $q$ and $p$. B ose $£$ instein condensation occurs in $m$ ost of the dom ains $w$ here the $q$ and $p$ param eters $m$ ay vary. In the case $(q ; p) 2 R^{+} R^{+} w$ th $p=q^{1}$ and $D$ arbitrary, Bose E instein condensation does not take place. For the latter case, we $m$ ay ask the question : A re there any topological interactions (leading to som e quasi-ferm ionic behavior through som e exclusion rule) that prevent the condensation of the corresponding $q$-bosons ?

An im portant result of the present w ork concems the correlation function $g^{(2)}$ for a gas ofphotons. T he qp-deform ation considered here $m$ akes it possible to obtain a continuum ofvalues for $\mathrm{g}^{(2)}$. In particular, such values $m$ ay be greater than 2 or lesser than 1 .

T o close this Letter, it should be observed that altemative choiges, nonlinear in $\mathrm{N}_{\mathrm{k}}$, are possible for the H am ittonians H (eq. (3)) and h (eq. (25)), choices that seem to re ect m ore deeply the quantum group structure of the qp-deform ed $W$ eylH eisenberg algebra. In this direction, we m ay mention, in the case $p=q^{1}$, the works of refs. $[11,12,15,19,20]$. W e have justi ed above our choice for eq. (3) (and eq. (4)). The case of eq. (25) is $m$ ore delicate. It would be interesting to investigate the situation where $h_{k}=$ $\left.(1=2) h!_{k}\left(\left[\mathbb{N}_{\mathrm{k}}\right]_{\mathrm{q}_{\mathrm{p}}}+\left[\mathbb{N}_{\mathrm{k}}+1\right]\right]_{\mathrm{qp}}\right)$ since the latter expression corresponds to a qp-deform ed oscillator. T he corresponding partition function can then be expressed in series of $B$ essel functions $w$ ith som e convergence problem. O ur choige for eq. (25) does not lead to convergence problem and represents the rst attem pt to derive a deform ation of the second-order correlation function in a nonperturbative way. W e hope to return on these $m$ atters in the future.
