Chaos in the Quantum Measurement Record

We investigate measures of chaos in the measurement record of a quantum system which is being observed. Such measures are attractive because they can be directly connected to experiment. Two measures of chaos in the measurement record are de ned and investigated numerically for the case of a quantum kicked top. A sm ooth transition between chaotic and regular behavior is found.

Understanding how chaotic behavior arises in quantum systems has been the subject of much research in recent years [1,2]. The purpose of this Letter is to investigate m easures of chaos which are determ ined wholly by the measurem ent record of a quantum system which is undergoing observation. Such m easures are attractive because they can be directly connected to experim ent. It is wellknown that the dynam ics of a quantum system depend on how that system is observed. This is in contrast to classical system s, for which it is usually assumed that m easurem ents can be perform ed without disturbing the system. Thus we are led to a view of chaos in which the initial state, the free (Ham iltonian) dynam ics, and the observation scheme are all regarded as parameters which can be varied in order to gain a better understanding of chaos in speci c system s.

The Letter is organized as follows. We begin by reviewing some ideas from algorithmic information theory, which are then used to de ne a measure of chaos in the measurement record. A second measure of chaos in the measurement record is de ned using the Shannon entropy. An inequality between these two measures is proved. A numerical investigation of these measures is then performed for the specic cexample of the quantum kicked top. We conclude with some general observations and comments on how the present approach to quantum chaos may be extended.

Suppose a series of m easurem ents is made on a system, either classical or quantum. The result is a sequence of results, R_1 ; R_2 ;:::, which we call the measurem ent record. An intuitively appealing m easure of chaos is the rate of grow th of the inform ation needed to describe the m easurem ent record. If this occurs very quickly, then the m easurem ent record is di cult to describe, and we would say that the system is chaotic. If the rate of inform ation grow th is slow, then the m easurem ent record is easy to describe, and we would say that the system is regular.

To make this idea precise, we need to know how to quantify the \inform ation needed to describe the measurement record". The solution to this problem is known as algorithm ic information theory, which was created independently by Solomono, Kolmogorov and Chaitin β {5]. They dened the algorithm ic information content I (s) of a string s to be the length of the shortest possible description of that string. More rigorously, I (s) is the length of the shortest algorithm which generates the string s. An algorithm, as de ned by Turing [6], can be represented as a program for a universal computer, U: A data string s is used as input to such a program p, which then perform s the algorithm on the data string. If the program ever halts then it prints an output string, U (p; s).

For a particular universal computer U we dene the algorithm ic information content I_U (s) of a string s to be the minimum length jpjtaken over all program sp for U such that U (p;;) = s, that is the program p prints out s when nothing is input. The conditional algorithm ic information content I_U (s) of s given another string t is dened to be the minimum length jpjtaken over all program sp such that U (p;t) = s. Note that here and elsewhere it is assumed for convenience that p and s are represented as binary strings. In chapter six of [7] it is proved that

where o(1) is an order one constant which does not depend on s or t. This intuitively reasonable inequality is important in our later reasoning.

We now turn brie y to classical system s, using algorithm ic information theory to de ne a measure of chaos, and seeing how this measure relates to other measures of chaos for classical system s. Suppose a classical system is initially at a point x_0 in some phase space. At times $t_1; t_2; ::: a$ measurement is carried out on the system. We suppose that this measurement can be modelled as follows: There is a partition of cells covering phase space, labelled 1;:::; n and the measurement at time t_i determines which of these cells, R_i , the system is in at that

time. De ne the rate of information production of the classical system to be

$$R(\mathbf{x}_0) := \lim_{n \neq 1} \sup_{n \neq 1} \frac{I(\mathbf{R}_1; \dots; \mathbf{R}_n)}{n}: \qquad (2)$$

A minor technical point is that this de nition is independent of which universal computer U is used to dene algorithm ic information, and thus no subscript U is needed on I or R. This follows from the fact [7] that for any two universal computers U_1 and U_2 , there is a constant C such that for any string s,

It can be proved (see [8] for a review and references) that

where h is the topological entropy of the system . Positivity of the topological entropy is widely regarded as one of the best indicators of chaos in a classical system , and thus we can see that if R (x_0) is ever positive then the topological entropy is positive and thus the system is chaotic.

Consider now the case of a quantum mechanical system which is observed at times $t_1;t_2;...$, producing a measurement record $R_1;R_2;...$ Again, the rate of information production may be dened as

In general the sequence $R_1; R_2; ::::$ is a random sequence because of the inherently probabilistic nature of quantum m easurem ents. In order to estim ate the rate of inform ation production we use the result (see [9] for recent results and references) that the average algorithm ic inform ation of a random sequence $R_1; :::; R_n$ given background inform ation $B = fp_{r_1}; :::; r_n$ given background inform ation $B = fp_{r_1}; :::; r_n$ satis es the inequality

where H $_{\rm n}\,$ is a form of the Shannon entropy H , which is de ned by

and the sum is over all the possible values $r_1; :::; r_n$ that $R_1; :::; R_n$ can take, and by convention $0 \log_2 0 = \lim_{x \ge 0} x \log_2 x = 0$.

Applying the inequality (1) and the approximation result (6) we nd that the average rate of information production satis as the inequality

$$\overline{R} \quad \lim_{n \leq 1} \sup \frac{H(R_1; \ldots; R_n)}{n} = :R_s; \quad (7)$$

where R_S is the asymptotic rate at which Shannon information is produced. R_S is another measure of chaos for the system, and can be interpreted in the following way. Suppose an experimentalist repeats the experiment a large number of times, obtaining on each run a measurement record R_1 ;:::; R_n . Then the Shannon noiseless coding theorem [10] tells us that $H(R_1$;:::; R_n) is the smallest average codeword length that can be used to encode the measurement record. Thus R_S represents the asymptotic rate of growth of the average codeword length needed to encode the measurement record. See [9] for a precise account of the distinction between Shannon entropy and algorithm ic information.

In practice, R_s was found to be considerably easier to compute than R. Furtherm ore, the inequality (7) allows us to obtain bounds on \overline{R} by computing R_s . We will now numerically estimate R_s for the quantum kicked top.

The kicked top (see [11] and references therein) is a simple system whose classical analogue is known to exhibit chaos. In units where h = 1, the evolution of the quantum kicked top from kick to kick is given by the unitary operator

where j is the angular m om entum quantum number for the system. In this Letter we have used j = 18.

W e suppose a projective m easurem ent is perform ed on the system immediately after each kick. The projectors used are

where J_z jj;m i = m jj;m i. This measurem ent determ ines whether the J_z component of angularm on entum is nonnegative or negative. If the state just before the measurement is j i, then the respective probabilities for the outcomes are given by the projection postulate as h \mathcal{P}_+ j i and h \mathcal{P}_- j i:

In the num erical examples studied in this Letter the initial states of the system were chosen to be spin coherent states, which are de ned by [11]

In particular, we consider the state

for which the means $hJ_xi;hJ_yi$ and hJ_zi are located in the region of the classical con guration space for which

the classical kicked top is found to be regular, and the state

for which the means $hJ_x i$; $hJ_y i$ and $hJ_z i$ are located in the region of the classical con guration space for which the classical kicked top is found to be chaotic.

In order to numerically estimate the rate of growth R_S of the Shannon entropy for an initial state j i the following procedure was used. Suppose N kicks are performed on the system, and N measurements, one immediately after each kick. This will result in a sequence of measurement results $Z_1; :::; Z_N$. The probability of this measurement history is given by the projection postulate,

U sing these probabilities the Shannon inform ation of the m easurem ent record,

$$H_n := H (Z_1; :::; Z_n);$$
 (15)

was computed for the range $1 \quad n \quad N$.

The results of this procedure when N = 15 are shown in gure 1. The lower line plots H_n for an initial state \Re i, and the upper line plots H_n for an initial state f i. There are two important things to note about this graph. First, for both initial states the growth in I_n settles down to be roughly linear in n very quickly. This has also been found to be the case with other initial states. Second, the system started in the state \Re i corresponding to the classically regular region show sam uch lower rate of inform ation production than the state f i, which corresponds to the classically chaotic region.

The nature of chaos in this system is strikingly illustrated by choosing 500 points at random from the X > 0; Y > 0; Z < 0 octant of the unit sphere, and calculating

$$\mathfrak{R}_{\mathrm{S}} \coloneqq \frac{\mathrm{H}_{15}}{15}; \tag{16}$$

which, assuming H_n settles down quickly to a linear rate of grow th, as found above, can be regarded as an approximation to R_S. This quantity was computed for each of the initial spin coherent states whose m eans correspond to the random points on the sphere. Figure 2 plots \Re_S as a function of the angle on the unit sphere between the point on the unit sphere corresponding to the initial coherent state, and the point at = 2.25; = 0.63, which is an elliptic xed point for the classicalm ap, and located deep in the regular region. The graph show s that the rate of inform ation production generally increases as this distance increases. That is, the quantum system becomes more chaotic as the means are moved away from the elliptic xed point of the classical map. This is broadly

sim ilar to the classical situation, where the elliptic xed point is surrounded by a regular region, which is surrounded by a sea of chaos. W hat is striking is that in the quantum case there is a much smoother transition between the two regimes. Instead of a sharp chaotic and a sharp regular region there is a continuous transition between chaotic and regular behavior.

Furtherm ore, although R has not been computed, using the inequality (7) we can place an approximate lower bound on \overline{R} , corresponding to the num erically computed value of \mathbb{R}_s . We see that \overline{R} is always positive for the initial states plotted in gure 2.

Twom easures of quantum chaos have been developed in this Letter, and num erical evidence for the existence of a sm ooth transition between chaotic and regular behaviour in the quantum kicked top presented. The chief advantage of using measures determined wholly by the m easurem ent record is that they can be directly related to the data available in an experiment. Technically, the approach to quantum chaos sketched in this Letter may appear sim ilar to that of Schack, Caves and co-workers [12{16], in the sense that algorithm ic information theory is used in both approaches. However, physically the two approaches are quite di erent. The present approach uses m easures determ ined by the m easurem ent record, whereas Schack, C aves and co-workers focus on m easures determ ined by the state vector or density operator of the quantum system.

The reader may object that in the present approach to quantum chaos an appropriate choice of observation schem em ay induce or suppress chaos in the m easurem ent record of system s whose classical analogues are, respectively, chaotic or not chaotic. For example, the quantum Zeno e ect (see [17] for an overview and references) predicts the complete suppression of quantum dynam ics when appropriate measurements are performed on a quantum system. Such a system will never show chaos in the measurem ent record, according to our de nitions, even if it is classically chaotic. O ther examples m ay also be found [18]. A brief answer to such objections is that the degree of chaos depends on all three of the initial state, the free dynamics, and the observation scheme. To obtain classical results we must assume the system is being observed in an appropriate \classical" fashion. This is certainly not the case for the quantum Zeno effect. However, this should not be taken to imply that observation is the sole cause of chaos in the measurem ent record. A swe have seen, chaos in the m easurem ent record depends also on the system 's initial condition, and it can be shown [18] that it depends on the free dynam ics as well. These issues will be dealt with more completely in [18].

The approach to quantum chaos sketched in this Letter may be extended in a number of ways. More generalm easurem ent schem es may be considered, using formalisms such as quantum trajectories [19{22]. In particular, it is necessary to consider in perfect m easurem ents, which introduce extra noise into the m easurem ent record. C bosely related is the idea of studying the e ect of interactions with the environm ent other than the coupling to a m easuring device. Finally, it is interesting to exam ine m ore thoroughly how varying the initial state, the system H am iltonian and the observation scheme a ect the degree of chaos seen in the m easurem ent record. These and other issues will be dealt with in a m ore extensive paper [18].
