Quantum StateDiusion and Time Correlation Functions

Abstract

In computing the spectra of quantum mechanical systems one encounters the Fourier transforms of time correlation functions, as given by the quantum regression theorem for systems described by master equations. Quantum state di usion (QSD) gives a useful method of solving these problem sby unraveling them aster equation into stochastic trajectories; but there is no generally accepted de nition of a time correlation function for a single QSD trajectory. In this paper we show how QSD can be used to calculate these spectra directly; by form ally solving the equations which arise, we arrive at a natural de nition for a two-time correlation function in QSD, which depends explicitly on both the stochastic noise of the particular trajectory and the time of measurement, and which agrees in the mean with the ensemble average de nition of correlation functions.

1 Introduction

In quantum optics, a common experimental situation involves a system in a cavity which is monitored by measuring the spectrum of output photons. In order to compare theory to experiment it is necessary to calculate this output spectrum.

W hat is commonly found is that the intensity of the output spectrum is given by the Fourier transform of two-time correlation functions of system variables [1]. In the case of a system isolated from its environment (apart from the measurement process itself), these correlation functions are simply the expectation values of products of H eisenberg operators at di erent times, e.g., $hq(t_2)q(t_1)i$.

As it is di cult to completely isolate a system from the environment, this approach does not always succeed. In the case of a quantum open system interacting continually with an external reservoir, one instead describes the system by a master equation, which - within the Markov approximation - can be written in Lindblad form:

The L_m are a set of environm ent operators which give the collective e ects of the environm ent, and we have taken h = 1.

The density operator gives the probability for the expected outcom es of m easurements on the system. In this case, one can still calculate output spectra, and nd Fourier transforms of time correlation functions; these are no longer the expectation values of products of H eisenberg operators in the system H ilbert space alone, but are more complicated objects whose form is given by the quantum regression theorem [2, 14, 4].

Unfortunately, for complicated system s equation (1) can be very di cult to solve either analytically or numerically. In that case, it is often advantageous to consider an unraveling of the master equation into individual quantum trajectories, each one represented by a single state at every moment in time. One of these unraveling techniques is quantum state di usion (QSD) [5]. In this, the normalized vector j i representing the pure state of the system evolves according to the QSD equation:

This is an Itô stochastic di erential equation, in which the d $_m$ represent independent complex W iener processes. These satisfy

where M represents an ensemble average of the noise. QSD reproduces the master equation in the mean:

(This is what is meant by an unraveling of the master equation.) Expectation values for operators obey a similar relationship:

The use of Q SD as a practical algorithm to solve master equations has been widely investigated [5]. This includes calculations of output spectra in quantum optics [6]. While it seems reasonable that there should be a relationship between output spectra and time correlation functions in Q SD analogous to that in Schrödinger orm aster equation dynamics, this has been di cult to show, as there is no generally accepted de nition of a time correlation function for a single Q SD trajectory. Since Q SD is fram ed in terms of a nonlinear stochastic di erential equation for an evolving state, it is not obvious how to generalize this to products of operators at di erent times.

G isin [7] has attempted to provide a H eisenberg picture for stochastically evolving operators. Sonderm ann [8], using the same stochastic equations, has suggested another de nition for time correlation functions. In both cases it is di cult to relate this to the usual QSD form alism. In this paper we attempt to nd a de nition which arises from the QSD equation itself.

In section 2 we derive the output spectrum of a quantum mechanical system, and show its relationship to time correlation functions, as given by the quantum regression theorem.

In section 3 we derive a quantum output spectrum using Q SD, and show how it leads to a natural de nition of a two-time correlation function for a single Q SD trajectory. Unlike the correlation functions which arise in the master equation derivation, these Q SD functions depend explicitly on the m easurement time and the noise. On average, however, these dependencies vanish, and the result agrees with the usual de nition of a time correlation function.

In section 4 we look brie y at alternative unravelings, and discuss the use of these techniques for the practical computation of spectra. Finally, in section 5 we summarize our results and draw conclusions.

2 Spectra and time correlation functions

Consider a rather idealized model of an experimental set-up for measuring the output spectrum of a quantum mechanical system. Suppose we have a system with Hamiltonian H_1 and Hilbert space H_1 weakly coupled to an output mode with Hamiltonian $H_2 = !b^{3}b$ and Hilbert space H_2 . We assume weak coupling to minimize the perturbation of the system evolution. For simplicity we assume a linear interaction: $H_1 = q(b+b^{3})$ where the operator q represents a physical quantity of the system, like position for example, b and b^{3} are the annihilation and creation operators for the output mode, and is small.

The total H am iltonian of the system plus output m ode is

and operates on the combined H ilbert space H $_1$ H $_2$. Let the system degrees of freedom also be coupled to an environment, described by a set of environment operators L_m acting on H $_1$. The system plus output mode obeys the master equation (1) with H am iltonian (6).

If the output mode is initially in the ground state, so that the initial density matrix is of the form $= _{00}$ jDihOj, we can approximate at later times

where the $_{ij}$ are time-dependent operators on H $_1$; we have explicitly separated the system and output m ode degrees of freedom and neglected all but the rst excited state of the output m ode. We then have $_{01}$; $_{10}$ and $_{11}$ 2 , and can rewrite equation (1) in the form

L is the time evolution superoperator restricted to the system degrees of freedom :

To lowest order, $_{00}$ evolves according to a norm alm aster equation, with no reference to the output mode at all. The other components $_{ij}$ represent the weak signal transmitted via the interaction with the output mode.

W e can solve these equations:

where $S_{t_1}^{t_2} = \exp(L(t_2 t_1))$ is the time evolution superoperator from time t_1 to time t_2 given by (9). The excitation of the output mode is what is measured, so we are interested in the expectation value $hb^ybi = Trfb^yb$ g = $Trf_{11}g$. We not this by taking the trace of equation (12). Equation (1) preserves the trace, so in taking the trace of (12) the factor exp(L(t t^0)) has no e ect, and may be dropped. Thus,

where the last equality de nest the two-time correlation function $hq(t^0)q(t^0)i_{QRT}$. Note that $hq(t^0)q(t^0)i_{QRT}$ is determined by the evolution operator S_0^t of the reduced mixed state $_{00}$, in accordance with the quantum regression theorem [2]. We see that the expected output has the form of a Fourier transform of a two-time correlation function; this is just like the result in classical physics [9]. Examining output modes at dimensional frequencies ! gives the spectrum of the system.

3 Spectra and tim e correlations in QSD

We can calculate the results of section 2 with QSD by using relation (5). We solve the QSD equation (2) for a state in the combined Hilbert space $H = H_1 + H_2$, starting with an initial condition $ji = j_0 ij0i$. By averaging hbybi_(t) over m any trajectories we reproduce (13). This was done in [6] for the case of second harm onic generation.

How can we interpret $hb^y bi_{(t)}$ for a single trajectory? Let's exam ine a little more closely the evolution (2). We can separate the components of

The QSD equation becomes a pair of coupled equations

Note that (16) is identical to the usual QSD equation for the system alone to rst order in . Just as in section 2, this approximation gains an extra order of in accuracy for free. Thus, the system degrees of freedom have the usual quantum state di usion behavior, essentially unin uenced by the interaction with the output mode. Exactly as in (8), we have an almost unperturbed system, with a weak signal transmitted to the outside world.

Equation (17) is interesting, in that all of the expectation values in this equation are calculated with respect to $j_0 i$, so this is a driven linear equation with time-dependent coe cients. Given the solution j_0 (t) i, we can nd j_1 (t) i, at least in principle.

W e form ally integrate (16) to get

where T (; $_{0})_{t_{1}}^{t_{2}}$ is the time-evolution operator from time t_{1} to time t_{2} . It explicitly depends on the noise and the initial state $j_{0}i$, since the QSD equation is nonlinear. Given this time-evolution operator, the solution to (17) is

The output spectrum is then

where the and_0 have been suppressed for conciseness. This expression resembles a Fourier transform of some kind of correlation function, just as was the case in section 2; but this correlation function is de ned for a single QSD trajectory.

W e can bring this rather closer to the treatm ent in section 2 by introducing the projector

These P_{ij} are not them selves projectors; however, $P_{00}^2 = P_{00} + O(^2)$, and therefore can be considered a projector to good approximation.

W e de ne a tim e evolution superoperator for these partial projectors

Note that the two central operators $T_{t_0}^{t_y}T_{t_0}^{t}$ can not be replaced with $T_{t_0}^{t_0^{wy}}$.

Accordingly, in analogy with (13) we de ne a measurement-dependent two-time correlation function for QSD:

Note that this assumes $t_1 < t_2$; for $t_1 > t_2$ an analogous expression can be form ed. This function C in QSD has the nice feature that it is the trace of a

product of two operators, each involving one of the times t_1 and t_2 , similar to correlation functions of classical stochastic processes (which are products of the random variables at di erent times [9]). However, it also has the strange feature that the $\$ nal" time t appears in this de nition. This is why we term C a measurement-dependent correlation function, rather than a true correlation function. Note that in perfect analogy with the quantum regression theorem, C (\hat{O}_2 ; t_2 ; \hat{O}_1 ; t_1 ;t) is determined by the evolution operator S (; $_0$) $_{t_1}^{t_2}$ of the reduced system's pure state j $_0$ (t) i.

It remains to establish the relation between the function C (\hat{O}_2 ; t_2 ; \hat{O}_1 ; t_1 ;t) and the QRT correlation function introduced in section 2. For this purpose we note that $P_{11} = j_1$ in $_1$ jprovides an equivalent expression for the output signal:

Note that in section 2 it was possible to remove the time evolution superoperator $S_{t^0}^t$, as it did not a ect the trace. This is not true in the single trajectory case, as explained above; so the function C depends explicitly on time, as mentioned above. Nevertheless, taking the mean over the noise of C $(\hat{O}_2; t_2; \hat{O}_1; t_1; t)$, one recovers the correlation function derived for mixed states from the quantum regression theorem :

Note that the dependence on the naltimet vanishes in the mean.

W hile the de nition (30) arises naturally in this derivation, and has the correct average behavior, its dependence on t remains a puzzling and rather annoying feature. It is possible to make a di erent de nition, closely related to that of (30), which avoids this problem. Since the operator S (; $_0$)^t_{t₂} in the de nition (32) vanishes in the mean, we can de ne a true two-time correlation function:

In this way the $\$ nal time" t disappears and the correlation function is form ally identical to the QRT case (but for vectors instead of matrices). Moreover, the correlation function then appears as a scalar product of two vectors:

Certainly, this once again reproduces the QRT correlation function in the mean, and gives exactly the same $hb^{y}bi_{(t)}$ for a single trajectory:

W hile this de nition removes the dependence on the naltimet, this two-time correlation function still has some interesting features, related to the fact that the QSD time-evolution superoperator (24) does not preserve the trace. In particular, we note that if the second operator \hat{O}_2 is the identity \hat{I} , then

contrary to the case of the QRT. If $\hat{O_1} = \hat{I}$ no such di culty arises. Since unravelings of the master equation do not generically preserve the trace, this feature will arise in any similar derivation. This might be one argument for using an unraveling speci cally chosen to preserve the trace, such as that used by G isin in his discussion of a Heisenberg picture for QSD [7,8]. In any case, the desired relation does hold in the mean:

Fortunately, correlation functions of the above form would not arise in any physically reasonable measurement scheme, since $\hat{1}$ does not describe an interaction.

The de nition of the two-time correlation function (34), and its relation to the quantum regression theorem (37) are the main results of this article. The central line of arguments can be summarized as follows:

4 A lternative unravelings and practical calculations

W hile the de nition (34) arises naturally from the Q SD analysis of this problem, it is not the only possible de nition of a time correlation function for a single trajectory; indeed, there are an in nite number of such de nitions, corresponding to di erent unravelings [10].

O ne such alternative unraveling has already been proposed by G isin as a possible de nition of a time-correlation function for individual trajectories, as well as providing a sort of H eisenberg picture corresponding to Q SD [7]. Here we will suggest yet another such alternative unraveling.

In particular, rather than solving the Lindblad master equation itself and then solving for the output spectrum, one m ight instead begin with the expression (13) and attempt to unravel the time-correlation function directly.

W hat form would such an unraveling take? In QSD, one unravels the density operator evolution into many trajectories, each consisting of a single state, and with a mean = M (j ih j). This works because is herm itian:

= ^y. For a time correlation function, this is no longer su cient. The form given by the quantum regression theorem is

where $S_{t_1}^{t_2}$ is the time-evolution superoperator dened by the master equation (1); however, the \initial state" (t₁)q is not herm itian. Therefore the evolution from t₁ to t₂ cannot be unraveled in terms of pure states.

One can, how ever, consider a pair of vectors j i and j i such that M (j ih j) does reproduce the correct evolution. Such a diad equation is quite analogous to the usual QSD equation.

One pair of coupled equations that do the job are

so this has the correct evolution in the mean. If j i = j i then these coupled equations reduce to the ordinary QSD equation (2). Note that in general, how ever, the norm alization of j i and j i is not preserved.

The technique for calculating time correlation functions is as follows. If the initial density matrix is a pure state, $(0) = j_0 \text{ in } _0 \text{ j}$, then one begins with both states equal j i = j i = j_0 i, and evolves them to time t_1 according to (42), which is equivalent to the QSD equation (2). At time t_1 , multiply h (t_1) j! h (t_1) jq and continue to evolve the diad according to (42). At time t_2 , multiply j (t_2) i! qj (t_2) i and take the trace. The mean over m any such trajectories equals the time-correlation function (41).

This pair of equations (42) shares m any properties in common with the QSD equation (2), but unlike QSD is not uniquely de ned. Since only the composite diad j ih jis important, the norm and phase can be shifted arbitrarily between these two states. D iosi has likened this to a gauge freedom [10]. M any such pairs of equations are therefore possible, as well as others with properties radically di erent from QSD; just as QSD is one of m any unravelings of the m aster equation, albeit with unique symmetry properties. To solve for output spectra, of course, one must still Fourier transform the calculated time correlation functions.

In fact, one can see that there are two distinct approaches to computing output spectra using Q SD . One is to use the de nition (34) or alternative de nitions such as (42) to calculate the time-correlation function, averaging over m any runs, and taking the Fourier transform (13).

A lternatively, one can solve the QSD equation for the entire system plus output mode; the state is then in the larger H ilbert space $H_1 = H_2$. This is essentially the approach taken by Schack et al. [6], who have also shown that these techniques can be used to calculate other quantities of interest, such as the spectrum of squeezing.

Both approaches appear to have their advantages and disadvantages, and to be roughly equal in computational di culty. It is likely that the best approach will vary from problem to problem.

Note also that if we had unraveled the master equation (1) using an unraveling other than QSD, an exactly analogous argument would have followed. We would be able to resolve the equation for the system plus output mode into a pair of coupled equations, one corresponding to the unperturbed evolution of the system alone, the other to an output signal completely driven by the system. Thus, this type of argument could be used to de ne a notion of time correlation functions for single trajectories in any unraveling, such as the Quantum M onte C arb techniques or the orthojum ps of D iosi [4, 11, 12].

These Quantum M onte Carlo (or Quantum Jump) techniques deserve further comment, as there have already been a number of papers published on their use in the calculation of time correlation functions [13, 14, 15]. These are relevant to our current discussion, since it can be shown that the equations for Quantum Jumps become identical to those for QSD in the case of heterodyne measurements [16].

The treatment of G ardiner, Parkins, and Zoller [14] is particularly interesting in this context. Their de nition of the time correlation function involves de ning an auxiliary vector j ;ti which is driven by the evolution of the quantum jump vector j ;ti, but does not in turn a ect it.

As stated in that paper [14] their equations are rather di erent. In particular, they are considering only real noise, and have not gone to the weak coupling lim it we have assumed in this paper, where the output has a negligibly weak e ect on the system over short times. W isem an and M ilburn [16] have generalized this treatment to consider the case of heterodyne measurements, introducing complex noise and showing that this lim it is exactly equivalent to the Q uantum State D i usion equation. In the lim it of heterodyne measurement with weak coupling to the external mode, the equation for j; ti becomes the Q SD equation (2), and the two vectors j; ti and j; ti obey a pair of coupled equations identical to (16) and (17). The output spectrum is given by the mean of h; tj; ti, just as in (20). From this, one could follow an argument exactly analogous to that of section 3 in this paper to arrive at a de nition of a two-time correlation function identical to (34).

5 Conclusions

In calculating quantum optical spectra, a common approach is to calculate the quantum time correlation function and derive the spectrum by taking its Fourier transform. This time correlation function has a form given by the quantum regression theorem, and requires a solution of the master equation.

Quantum state di usion provides in many cases an e cient method of solving the master equation. But hitherto, an appropriate de nition of the time correlation function for a single QSD trajectory has been lacking, making QSD less useful for the calculation of spectra.

In this paper we have derived such a de nition in a straightforward way, quite analogous to the derivation in the case of the full master equation. This correlation function in the mean has the form given by the quantum regression theorem, and the equations for it are very close to the original Q SD equation, up to 0 (²) in the interaction strength.

This de nition can be used as a practical num erical tool in computing quantum optical spectra. O ther possible de nitions and their potential for practical use have been brie y discussed.

F inally, let us discuss the meaning of our result in the simple case of a dam ped harm onic oscillator at zero tem perature. The stationary solution is the ground state. Hence, once the system has reached this state, nothing happens, and it is clear that the spectrum of the damped oscillator is not contained in the evolution of its state vector. Nevertheless, the quantum regression theorem tells us that all spectra, in particular the one corresponding to the position uctuation, are contained in the evolution operator for the corresponding master equation. Sim ilarly, the results presented here tell us that the spectra are also contained in the stochastic evolution operator T (; $_{0})_{t_{1}}^{t_{2}}$ of the QSD description of the damped oscillator. The physics behind this is that whenever a spectrum is measured, the system's environm ent is changed, hence its dynam ics is perturbed. For example, to measure the spectrum of position uctuations, something like weak position measurem ents have to be applied, and the ground state is no longer stationary [17]. However, in contrast to standard quantum measurements, this perturbation can be made arbitrarily small (corresponding to small am plitudes of the measured spectrum) over an arbitrarily long period of time. To rst order, the system 's evolution is una ected, but its states acts like a source for the signal, as rejected by our equations (16) and (17). Hence the una ected evolution operator (Liouville operator or Q SD propagator or other stochastic propagator [4, 13]) contains the information about spectra that cannot actually be measured without a ecting (i.e., weakly perturbing) the system's evolution.


