Dark pair coherent states of the motion of a trapped ion

A bstract

We propose a scheme for generating vibrational pair coherent states of the motion of an ion in a two-dimensional trap. In our scheme, the trapped ion is excited bichromatically by three laser beams along dierent directions in the X-Y plane of the ion trap. We show that if the initial vibrational state is given by a two-mode Fock state, the nal steady state, indicated by the extinction of the uorescence emitted by the ion, is a pure state. The motional state of the ion in the equilibrium realizes that of the highly-correlated pair coherent state.

A variety of generalized coherent states has been constructed to describe di erent physical phenom ena [1]. Mathematically, the constructions of these sets of generalized coherent states are associated with particular Lie groups. The Glauber coherent states, dened as the right eigenstates of a single-mode boson annihilation operator are associated with the Heisenberg group. Beyond these canonical coherent states, particular generalized coherent states associated with the noncompact SU (1,1) group have been extensively studied [1 {6]. A coording to Barut and Girardello [3], these associated coherent states are dened as the eigenstates of the SU (1,1) lowering operator, whereas in the denition given by Perelom ov [4], they are generated by the SU (1,1) analogue of the displacement operator. These two sets of coherent states are dierent though they are closely related to the SU (1,1) group.

Regarding the two-mode boson realization of the SU (1,1) group, a special set of coherent states of the Barut-G irardello type known as pair coherent states (PCS) can be formulated [1]. If \hat{a} (\hat{a}^y) and \hat{b} (\hat{b}^y) denote two independent boson annihilation (creation) operators, then $\hat{a}\hat{b}$ ($\hat{a}^y\hat{b}^y$) stands for the pair annihilation (creation) operator for the two modes. The pair coherent states j; q_{FCS} are defined as eigenstates of both the pair annihilation operator $\hat{a}\hat{b}$ and the number difference operator $\hat{Q} = \hat{a}^y\hat{a}$ $\hat{b}^y\hat{b}$, i.e.,

where is a complex number and q is the \charge" parameter which is a xed integer. Furtherm ore, the PCS can be expanded as a superposition of the two-m ode Fock states,

where $N_q = [j j^q I_q (2 j j)]^{1=2}$ is the normalization constant (I_q is the modiled Bessel function of the rst kind of order q). Pair coherent states were introduced by Hom and Silver [5] to describe the production of pions and applied to other problems in quantum eld theory [1]. In quantum optics, PCS are regarded as an important type of correlated two-mode state, which possess prominent nonclassical properties such as sub-Poissonian statistics, correlation in the number uctuations, squeezing, and violations of Cauchy-Schwartz inequalities [2].

The experim ental realization of such nonclassical states is of practical importance. A garwal [2] suggested that the optical PCS can be generated via the competition of 4-wavem ixing and two-photon absorption in a nonlinear medium. This is the only scheme proposed to generate PCS known to us. In this Rapid Communication we propose a scheme to generate vibrational PCS of a trapped ion. Recently, due to remarkable advances in laser cooling of a trapped ion [7], it has become possible to realize nonclassical states of the centre-of-mass (CM) motion of a single trapped ion. An ion con ned in an electromagnetic trap can be regarded as a particle with quantized CM motion moving in a harmonic potential. Exciting or deexciting the internal atom ic states of the trapped ion by a classical laser driving eld changes the external states of the ion motion, as atom ic stimulated absorption and emission processes are always accompanied by momentum exchange of the laser eld with the ion. If both the vibrational amplitude of the ion is much smaller than the laser wavelength, i.e., in the Lamb-Dicke limit [7], and the driving eld is tuned to one of the vibrational sidebands of the atom ic transition, then this model can be simplied to a form similar to the Jaynes-Cum m ings m odel (JCM) [8] in which the quantized radiation eld is replaced by the quantized CM motion of the ion. As the coupling between the vibrational modes and the external environm ent is extremely weak, dissipative e ects which are inevitable from cavity damping in the optical regime, can be signicantly suppressed for the ion motion. This unique feature thus makes it possible to realize cavity QED experiments without using an optical cavity. Following this approach, nonclassical vibrational states of the trapped ions such as Fock [9], squeezed [10] and Schrodinger cat states [11,12] have been proposed and observed [13].

Consider the quantized motion of a two-level ion of mass M which is trapped in a two-dimensional (2-D) isotropic harmonic potential characterized by the trap frequency. The creation (annihilation) of vibrational quanta in the X and Y directions is described by the operators \hat{a} (\hat{a}^{y}) and \hat{b} (\hat{b}^{y}) respectively. The position operators are given by $\hat{x}=(\hat{a}+\hat{a}^{y})$ and $\hat{y}=(\hat{b}+\hat{b}^{y})$, where $\hat{a}=(\hat{a}+\hat{a}^{y})$ is in our scheme, which we sketch in Fig.1, the ion is driven bichromatically by three laser beams in the X-Y plane. The rst two lasers are both tuned

to the second lower vibrational sideband and applied to the ion along directions with an angle =4 and 3 =4 relative to the X -axis, respectively. The third laser which drives the ion along the X -axis is resonant with the atom ic transition frequency. In the rotating-wave approximation, the Hamiltonian describing the coherent evolution is

where the st two terms describe the free evolution of the external and internal degrees of freedom of the ion and the last indicates the atom – eld interaction. The operators $^+$ and $^+$ are raising and lowering operators for the two-level ion obeying commutation relations $[^+, ;^-] = ^-_z$ and $[^-_z;^-] = ^-_z$. The transition in the two-level ion is characterized by the dipole matrix element D and the transition frequency !0: The negative frequency part of the classical electric driving eld is given by

where $2E_j$ and $_j$ indicate the amplitudes and phases of the driving lasers respectively. We have introduced new position operators x^0 and y^0 which are related to x and y by a =4 rotation in the X-Y plane,

so that for the creation (annihilation) operators \hat{A} (\hat{A}^y) and \hat{B} (\hat{B}^y); de ned in the X 0 and Y 0 directions respectively, we obtain the following transform ation

A coording to Vogeland de M atos Filho [11,14], if the ion is in the resolved sideband lim it and the driving laser is resonant with one of the vibrational sidebands, then the ion-laser

interaction can be described as a nonlinear JCM . Following Refs. [11,14], the Ham iltonian of Eq.(3) can be written in the interaction picture as

where $_{j}$ = DE $_{j}$ =h are the Rabi frequencies, and the Lamb-Dicke parameter = k has been de ned assuming k_{2} ' k_{0} = k:

As the damping of vibrational quanta can be signicantly suppressed in an ion trap, the dominant decay process is the spontaneous emission from the two-level ion, and the time evolution of the system in the interaction picture can be described by a density operator obeying the master equation [9,11]

where is the spontaneous decay rate of the excited state of the ion, and the modi ed density operator

where = h 2 exp (2 =2), and = $_0$ 1 2 exp (i_0): D is regarding the constant driving term , the elective H am iltonian of Eq.(11) is identical to the non-degenerate two-mode JCM [15].

For a m aster equation of the form of Eq.(10), the steady-state solution $^{\circ}$ is a pure state [9{11]

where jgi is the atom ic ground state and j i de nes the vibrational state of the ion. When the system reaches the steady state d_s =dt = 0. A ssum ing a steady state of the form above gives $[\hat{H}_{\tau}^{0}, \hat{h}_{s}] = 0$; as the dissipative term on the right hand side of Eq.(10) vanishes in this case. Consequently, a su cient condition for us to generate the vibrational steady state j i is to ensure \hat{s} satis es the restriction $[\hat{H}_{i}^{0}; \hat{s}] = 0$; or equivalently $\hat{h}_{i}^{0} = \hat{s}$ j i: Evidently, this is identical to our rst de nition of a PCS given above in Eq.(1). In order to generate a fully characterized PCS, however, we need another constraint to ensure that the nal vibrational state remains an eigenstate of the number dierence operator Q Eq.(1)]. This can be achieved by properly choosing the initial vibrational state. In view of the fact that $[\hat{a}\hat{b};\hat{Q}] = 0$; it follows that the number dierence is a constant of motion in processes involving simultaneous pair annihilation or creation. Thus for an initial vibrational state j $_0$ i, if the conserved \charge" condition is initially satis ed, i.e., \hat{Q} j $_0$ i = qj $_0$ i, then this condition holds for the whole time evolution of the system described by Eq. (10). Regarding the feasibility of an experimental realization, it seems that the two-mode Fock state j $_0$ i = jm + q;m $i_{\mathbb{F}}$ is best suited to ful 1the conserved \charge" condition. Without loss of generality we may set the initial vibrational state as $j_0 i = jq; 0i_F$ (q 0) which, according to recent work, can be prepared with very high e ciency [13].

In order to identify the validity of our analytic argument and to gain insight into the transient behaviour we have solved the master equation, Eq.(10), numerically employing a Monte-Carlo state-vector method [16]. Our numerical analysis was performed using a high-order unravelling technique [17] in a nite (truncated) Fock state basis with a cut-o chosen

such that an increase of this cut-o does not alter the result of our integration.

We nd that the system evolves from an initial product of a two-mode Fock state and a superposition of the internal states of the ion into the pure steady state [Eq.(12)] as expected. Fig 2 depicts the excitation number distribution in the two vibrational modes at dierent times, showing the system as it evolves from the initial pure state j $_0i = jei$ j7;6i into its steady state. The steady-state excitation number distribution Fig 2 (d)] is indistinguishable from that of a PCS with = 2 and q = 1: This is the expected result since the particular choice of the initial state determ ines the conserved \charge" $q = h_0 \cancel{1} \cancel{0} j_0 i = 1;$ and from Eqs.(1) and (11) the second number de ning the PCS is determined by the driving term the e ective H am iltonian, which in the example shown is = 2: We verify that the steady state is pure by calculating the trace of the square of the density operator ${\rm Tr}(^{^{2}}_{s})$ from the steady state obtained in our numerical integration. We not $Tr(^2_s) = 0.9997$: Fig. 3 shows the transient behaviour of the internal state of the ion. We depict the time evolution of the inversion, h_z^i ; [Fig.3(a)] and the imaginary part of the polarization, ih 1 ; [Fig.3(b)]. We note the timescale for the system to reach the steady state is much longer than it would take the same ion to reach its steady state in a resonance uorescence experiment.

One may exam ine the existence of the PCS by observing the collapses and the revivals of the atom ic inversion. This is illustrated by switching of the carrier eld suddenly once the system has reached the steady state. In this case, the system is equivalent to the non-degenerate two-mode JCM interacting with a PCS when the ion is initially in its ground state. The time evolution of such a system has been investigated by several authors [18]. In particular, when q = 0 the Rabi oscillation of the atom exhibits exactly periodic behaviour. However, as the atom is decay is essential to the present treatment and cannot be ignored, the collapses and revivals of the Rabi oscillation of the trapped ion are substantially different from the previous results. One possible way to suppress the complications caused by the atom is decay is to increase the intensities of the driving lasers so that the ratio = is lowered. Thus, in the short time regime the in tense of spontaneous emission can be eliminated.

In conclusion, we have proposed a scheme for the realization of pair coherent states of

the CM motion of a trapped ion. In our scheme, three laser beams, one of which is tuned to the carrier frequency and the other two to the second lower vibrational sideband, are used to drive the ion trapped in a 2-D isotropic harmonic potential well. In appropriate limits, the system will relax to a steady state due to the spontaneous emission from the ion. If the vibrational state of motion of the ion is initially prepared in a Fock state, then the steady state of the system is a pure state given by a product of the atomic ground state with a PCS of the vibrational motion. In this case, the two parameters, and q, that characterize the PCS are determined by the intensities and phases of the driving lasers and by the number difference between the two vibrational modes determined by the initial Fock state respectively.






