Geometric Foundation of Spin and Isospin

A bstract

Various theories of spinning particles are interpreted as realizing elements of an underlying geometric theory. Classical particles are described by trajectories on the Poincare group. Upon quantization an eleven-dimensional Kaluza-Klein type theory is obtained which incorporates spin and isospin in a local SL (2;C) U (1) SU (2) theory with broken U (1) SU (2) part.

The theories that describe the spinning property of electrons and other particles developed completely dierent regarding the classical and the quantum description. The classical approach initiated by Frenkel [1] and Thom as [2] was continued with many e orts [3, 4, 5], but never settled to a generally accepted theory, as recent work shows [6, 7, 8, 9, 10]. One apparent reason was that its relation to the quantum theory, as developed by Dirac [11], never was fully claried [5, 12]. On the other hand, Dirac's theory was soon accepted, supported by experiment, further developed and immersed in the general framework of the representation theory of the Poincare group [13, 14]; today it forms the basis of particle description in modern elementary particle physics.

There are two characteristic problem s common to most classical theories of spinning particles. The rst is, that equations for momentum—like spin variables are dened so that total spin is conserved, but no conguration space is dened, on which corresponding position variables live. As a result, the equations of motion cannot be derived through variation of some action. The second problem is, that the constraint that is intended to reduce the number of independent spin variables from six to three, fails to be handled easily. In this short article we show that by taking the missing spin conguration space to be the Lorentz group, we obtain a variational principle and a full canonical formalism. We show that the unconstrained theory is in agreement with the main ideas of the standard model of electroweak interactions; the six independent variables describing spin as well as isospin.

C lassically spin is described in a Lorentz covariant theory by an antisym m etic tensor S_{ab} ; a;b = 0;1;2;3 [1, 2, 4, 5]. The equations of m otion for a particle w ith

four-velocity u are supplemented with equations for the spin variables S_{ab} , [4]

The total spin is conserved:

A llowing for the inclusion of gravitational elds we distinguish between coordinate (holonomic) indices, denoted by ; ;:::= 0;1;2;3 and Lorentz (anholonomic) indices a;b;:::= 0;1;2;3, which are raised and lowered by the (possibly nontrivial) space-time metric g and the Minkowski (at space-time, background) metric $_{\rm ab}$, respectively; g and $_{\rm ab}$ are related through the existence of a tetrad (Vierbein) eld $_{\rm ab}$

The tetrad eld may also be used to switch from holonomic to anholonomic indices and vice versa.

The second constraint in (2) restricts the number of independent spin variables to three, since the time-like components S_{0i} ; i=1;2;3 then vanish in any particle rest frame. The spin equation (1) is constructed to comply with this constraint. But when one seeks to derive this equation from a Ham iltonian [9] or Routhian [10], this constraint is not easy to handle. Poisson-D irac brackets

are postulated, but since these are not compatible with the constraint, modications are needed [9, 10]. The brackets (5) represent the Lie algebra of the Lorentz group, with the idea that the S_{ab} correspond to the in nitesimal generators $_{ab}$ of Lorentz transform ations,

in the D irac representation. Our idea is to take the Lorentz group, or rather SL (2;C) as its universal covering, as base manifold for position variables, with the spin variables residing in the cotangent space, since then the correspondence (6) is obtained naturally. We were lead to this idea also from the theory by Barut and Zanghi [7]. Modelling after the structure of the D irac equation, they introduced a classical spinor of four complex variables $z=(z)_{z=1,2,3,4}$; in a

way so that z and $z = z^{+}$ become canonically conjugate variables. In this theory the relations (2) and (3) are equivalent to

which means that if we arrange the four complex numbers z into a matrix

then the condition $\det G(z)=1$ for G(z) to be in SL(2;C) is equivalent to (7). So we are motivated to describe a classical spinning particle by a trajectory (x (); ()) on the manifold $M=R^4$ SL(2;C), the twofold covering of the Poincare group when equipped with the usual semidirect product. The parameter is assumed to be invariant under the action of the Poincare group on itself (which we do not distinguish from M), for the action from the left as well as for the action from the right. In the framework of gravitation theory, where the space-time part can be equipped with a nontrivial metric, the action from the left, which is the usual one dened by

becomes a composition of a coordinate transformation $x\ 7!$ $_0x+a$ and a (global) Lorentz gauge transformation 7! $_0$, which are separately imbedded into the larger groups of general coordinate transformations and local Lorentz gauge transformations, respectively [15]. Dirac four-spinors have no transformation law under general coordinate transformations, but Einstein's theory of general relativity can be extended to these objects as a local gauge theory [15, 16].

Before we de ne a H am iltonian we look at the quantized theory rst, since we like to achieve correspondence with the minimally coupled D irac equation. In a geometric approach we take all position variables for equal, so that the quantum states are taken to be functions on M . Functions on the Lorentz group are obtained by taking coordinates! ab in the Lie algebra and exponentiate these with any representation D of the in nitesimal generators to obtain functions

U pon quantization the spin m om entum variables S_{ab} become $\;$ rst order di erential operators

that act on the spin position coordinates! of M . A coording to general theorem s [17], the coe cient functions f $_{ab}^{cd}$ (!) can be choosen so that not only the \hat{S}_{ab}

satisfy the com mution relations of the Lie algebra sl(2;C), but also act on the column vectors $_{d}^{D}$; d xed, by multiplication with the in nitesimal generator in any representation:

This realizes the action from the left of the group SL (2;C) on M; we can also realize the action from the right, whence the row vectors in (11) are transform ed. We further add one dimension as S 1 for the quantized electric charge and arrive at a Kaluza-K lein type theory in eleven dimensions on the manifold M $^0=$ R 4 SL (2;C) U (1) where the minimally coupled D irac equation attains the form

Here is the coordinate of S^1 , $\hat{q} = @=@$ the quantized charge, so that D_a is a local U (1) SL (2; C)-gauge covariant derivative w ith gauge potentials A_a and a.

Since the spin of a particle eld is described through its dependence on the variables!, for consistency the same must hold for the interaction elds that carry spin, so the gauge potentials and the tetrad eld must also depend on!. These transform under the fundam ental representation of the Lorentz group, so are column vectors with

or tensor elds with the corresponding rule for all indices. Since the fundam ental representation has four column vectors, we have a freedom of choice for the spin- 1 elds, which will be interpreted below.

We now de ne a Ham iltonian for a particle moving on the manifold M 0 , extending the ansatz by van Holten [9] to gravitational elds, and supply the missing variational principle. We look at the mass squared obtained from the Dirac equation (14) iterated:

Here it is important to note that the multiplication with the $\,\,$ -m atrices commutes with the covariant derivatives D $_{\rm a}$ since these are scalar operators. We put the symmetrized operator product in (16) in correspondence with the classical momentum variables, reduce the anticommutator to

and use the freedom to add term swhich contribute to the D irac equation only as mass constants, to arrive at a Hamiltonian H which is the squareroot of a nondegenerate quadratic form in the momentum variables,

This Ham iltonian is a function H (x;!; p;S;q) on the cotangent bundle of M where the external elds do not only depend on the space-time position x, but also on the internal coordinates! and , describing their spin and charge. From the action Z

we derive by independent variation of all variables the canonical equations

Sm all variations of the position variables are given by a near-identity Poincare transform ation,

so that the in nitesim alvariation gives the action of the in nitesim algenerator on H. The law (15) hence gives those contributions from the external elds to the spin equations which were previously generated by the brackets (5). The canonical equations of motion (21) conserve the total spin, and lead to conserved sources for the external elds, but do not satisfy the constraints (2). For a discussion of the rst of these constraints we refer to van Holten [9], the second constraint can be done without, as we now show.

The Ham iltonian (18) corresponds to the Laplace-Beltram i operator on the manifold M 0 w ith the metric having signature + ; + + + ; . W ithout external elds we have

so that the mass squared as eigenvalue of this operator depends on spin and charge. Any wave function (x;!;) can be decomposed in the following way. We start with the Fourier decomposition with respect to the space-time variables,

Next we use the fact that for a given four-vector p a SL (2;C) transform ation can be decomposed as

where U is an element of SU (2), and the matrices $\begin{pmatrix} 0 & 0 & 0 \\ 1 & \text{and} & 0 & 0 \end{pmatrix}$

with; 0 real,; 0 complex, are boosts which transform the apex (m;0;0;0) into p and $p^{0} = ^{1}$ p, respectively [13, 18, 19]. This transform ation is given by

We may replace the six coordinates! ab by three coordinates u_i parametrizing SU (2) and the three coordinates 0 ; 0 [18]:

Four ier decom position on the compact manifold SU (2) now gives a discrete sum over all irreducible representations D $_{\rm S}$ of SU (2),

The interesting point is, that any irreducible representation occurs with the multiplicity of its dimension. The columns of these representations transform under the action of the group from the left as W igner's induced representations [13], with the coordinates 0 ; 0 left invariant. With an inverse Foldy-W outhysen transform ation these representations can be brought into the standard Dirac form, for any spin [6]. Especially we get spin-1/2 particles in doublets. The action from the right transform sthe coordinates 0 ; 0 and rotates them ultiplets. If we restrict the action to the SU (2) subgroup of SL (2;C), the transform ations do not depend on the momentum variables, SU (2) right is a global gauge group. The transform ation of the invariant volume element of the coordinates p^{0} ; under the transform ation (27) into an SU (2)-invariant volume element,

suggests to introduce two complex coordinates

on which the group U (1) SU (2) $_{right}$ acts naturally. Thereby the generator of the electrom agnetic gauge group becomes (1 $_3$)=2, as in the standard model of electroweak interactions, and the spin-1/2 doublet can be interpreted as isospin doublet. So we see that six independent spin variables naturally lead to a quantized theory describing spin and isospin. The di-culty to implement the second constraint in (2) can therefore be understood as follows. The overall commuting charge in this theory is not the electric charge, but the hypercharge, which may elect isospin rotations, thereby obstructing this constraint.

We obtain the full structure of a local U(1) SU(2)_{right} gauge theory by replacing the coupling in (14) by

where g is a coupling constant, the operators $\hat{}_b=(\hat{}_0;\hat{}_1)$ are di-erential operators in the coordinates $_1;_2$, representing the Lie algebra of U (1) SU (2) $_{\rm right}$, acting on any representation as multiplication with the matrix representation of the in nitesimal generators in analogy to relation (13). The B $_a^b$ are four real local gauge elds, a singlet and a triplet, taken to be the four column vectors of the fundamental representation, with B 1 and B 2 given phase factors sin and \cos , respectively, accounting for their electric charge.

In this model the topology breaks the U (1) SU (2) right-sym metry in the way of the standard model, since the point $^0=0$ does not correspond to any point in the manifold M 0 . This reduces nite gauge transform ations to the subgroup U (1) U (1) generated by $^\circ$ 0 and $^\circ$ 3. The dierent topology with repect to $_1$ and $_2$ gives rise to sym metry breaking elects through the boundary conditions which we have to impose. We may generate a discrete mass spectrum by equipping these internal variables with harmonic oscillator potentials, as was already considered by Dirac in a model with two real variables [6, 20]. Then, even with identical oscillator frequencies, the boundary condition that states have to vanish at $_2=0$, eliminates the uncharged ground state in favour of two massive charged states. This reproduces also the chiral structure of the standard model with two neutrinos, for which we have the left-and righthanded uncharged ground states of the oscillator on $_1$, and the electron and the positron, as the two oppositely charged ground states of the oscillator on $_2$ with left-handed and right-handed components each.

Concluding, we have shown that classical spinning particles are naturally described on an eleven-dimensional manifold with SL (2;C) U (1) as internal space. We proposed a Ham iltonian chosen such that rst quantization leads to a minimally coupled unied Kaluza-Klein type theory with a local SL (2;C) left U (1) SU (2) right gauge group, with a broken U (1) SU (2) right part that is nonlinearly related to the SL (2;C) right group.
