Quantum Mechanics as a Classical Theory XII: Direction and Interference

A bstract

In this paper we will be concerned with the explanation of the interference and direction patterns observed as an outcome of the Young double slit experiment. We will show that such explanation may be given only in terms of a corpuscular theory, which has been our approach since the rst paper of this series. This explanation will be accomplished with an extension we make here of the domain of applicability of the Born-Sommerfeld rules that we derived in paper X I of this series.

1 Introduction

The problem's referring to the explanation of the interference and di raction patterns one observes in a double slit experiment, for example, are usually considered as those for which a corpuscular theory seems much inadequate to deal with.

We have already discussed, very brie y and only qualitatively β], about the possibility of giving this explanation using only the corpuscular picture. We will now use the results of paper XI of this series [11] to show quantitatively that this is actually the case that a corpuscular explanation for the phenomena of interference and direction do exist.

In the second section we will generalize the conclusions of paper [11] with respect to the connections between the Born-Som merfeld quantization rules and the formalism based upon the Schrodinger equation. This extension will be needed to include within the domain of applicability of the Bohr-Som merfeld rules systems that are not periodic on conguration space. We will show that these rules are associated with more general symmetry properties of the physical systems and include the periodicity as a particular case.

The third section will deal with the direction of particles by a spatially periodic system. This study has nothing new and was in fact already developed

in the early days of quantum mechanics [13]. It will be discussed here for completeness. The approach we use here is based upon the Bohr-Sommerfeld rules and its relations with the Schrodinger equation approach were already clarified in paper XI and the previous section.

The fourth section will take into account the problem slightly dierent of the diraction of particles by an aperture. The form alism to be used will be the same of the third section.

We will, in the fifth section, dealwith the problem of interference and diraction of particles due to the presence of a double slit Young interferom eter. We will show that our results agree perfectly well with those found in the literature based upon an undulatory approach.

The last section will be devoted to the conclusions.

2 Sym m etry and Quantization

In a previous paper [11], we showed that the probability am plitudes in conguration spacemay be obtained from the in nitesimal Wigner-Moyal transformation dened over the phase space as

In this case, we showed that, if the system has a con guration space periodicity, given by

where Q is the period, then we get the Bohr-Som m erfeld quantization rules

if in (2) we have the sign + or , respectively. We also showed there that these rules are valid for each individual system composing the ensemble.

However, one should note that the periodicity argument is not, in any sense, essential in the derivation. Indeed, even if the amplitude (q;t) is not periodic, in the sense that equality (2) is valid for any integer multiple of the period Q, this equality may still be valid for just one specic value of Q. In other words, it means that the value of the amplitudes at a given point q shall be equal (except for a signal) to their value at the point q+Q, for some Q.

In this case, the same quantization rules given by expression (2) apply and it is in this sense that they will be used in section four and ve.

3 Laue Di raction

We call a Laue di raction that one in which some particle collides with a periodic structure (e.g. a crystal lattice) making an angle with respect to some axis perpendicular to the surface of this crystal and is elastically rejected by it.

If we suppose that the crystal has identical planes spaced regularly by a constant distance d (see $\,$ gure 1) m easured with respect to the z-axis, we may conclude [12] that the quantization rules in the z-direction becomes

where we used that the crystal is a periodic structure of period Q = d in this direction.

Any interaction of the crystal with an incident particle must be such as to let the crystal momentum p_z quantized, varying it by the amount

Looking at gure 1 it is easy to see that this interaction induces a momentum transfer from the incident particle to the crystal (or vice versa) given by

where we wrote

being a characteristic length¹ related to the particle. In this case, the equation for the momentum balance gives the expression

$$n = 2d\sin(); (8)$$

which is the equation for the maximum intensity positions of the Laue (or Bragg) diraction of particles by a periodic structure.

This allows us to say that the direction pattern one obtains making a ux of particles to hit upon the surface of a crystal lattice is exactly the same one gets using the undulatory approach², precluding one to make any reference to the objective existence of \material waves" or, which is the same, to the concept of duality; being necessary only to consider the quantization of momentum transfer.

4 Di raction by an Aperture

In this problem we do not have in general any periodic structure. We have, instead, as shown in gure 2, a ux of particles incident at right angles upon a screen on which we made an aperture of size a, and being scattered by the atom s on the borders of this aperture at angles .

The important thing to stress here is that this system has a spatial symmetry. Indeed, it is easy to note that the probability amplitude shall have the same value (except for a sign) in each border of the aperture. This gives

since the probability density is the same at both points.

U sing the results of the second section of this paper we may write, using equation (9),

where all the quantities have the same meaning as in the previous section 3 . Making all the calculations we get

$$n = a \sin(i); (11)$$

which is the same expression for the intensity \mathbf{m} in im a of the direction pattern 4 .

We must stress here the distinctions between the explanation of the two di raction behavior we have analyzed. The Laue di raction is due to a spatial periodicity possessed by the crystal lattice. The di raction by an aperture is associated with a particular symmetry of the system (a rotation of about the axis perpendicular to the screen), being unnecessary that the screen itself be periodic. This is the explanation for the appearance, in the rst case, of the crystal period, while in the second case we have the appearance of the aperture dimension.

We may say, following the interpretation of the last section, that the introduction of the aperture in the screen changes or rede nest he relation of momentum transfer between the screen and the incident particles. These changes are responsible for the quantized scattering relations given by (11).

5 Double Slit.

We may account for this problem in exactly the samemanner as we did with the direction by an aperture in the last section.

To begin with, consider rst gure 3. In this gure we have two apertures of length a, made over some screen, symmetrically placed as related with the x-axis. These apertures are at heights z=+c=2 and c=-c=2 of the x-axis. A ux of particles passes through these apertures and are dejected as they interact with their borders.

Such a system possesses, as becomes clear in gure 3, the following $\operatorname{sym} \operatorname{m} \operatorname{e-tries}$

$$(c=2 a=2) = (+c=2 + a=2)$$
 and $(c=2) = (+c=2)$: (12)

The last one of these sym m etries gives the m om entum quantization

$$p_z c = n_1 h; (13)$$

where n₁ is some integer number.

The rst sym metry in (12) gives

$$p_z (c+a) = (n_2 + 1=2)h;$$

where n_2 is a second integer number⁵.

Solving the equations (13) and (14) we get

$$n = csin();$$

where we made $n = n_1$ and $m = n_2$ n_1 .

The rst expression re ects the intensity maxima condition related with the interference pattern for a double slit spaced by a distance c, while the second expression re ects the conditions, also for the intensity maxima, related with the direction by an aperture of width a.

Except for the information about the relative intensities, as we already stressed, these conditions for the intensities extrem a are exactly those obtained in the literature, when we use the undulatory approach to the problem. In this case, as was presented in the previous sections, it was not necessary to go beyond the scope of a corpuscular theory to give a mathematically grounded explanation of the phenomena considered.

In the same sense as with the diraction by an aperture problem, we may say that the introduction of a second aperture on the screen modi es the quantized momentum transfer relations between the particle and the screen itself. These new relations will be responsible for the interference and diraction patterns⁶.

 $^{^5}$ The criterion for using the second, and not the $\,$ rst, possibility in (3) to represent the intensity maxima, is certainly arbitrary within this theory, as we have already stressed. The Bohr-Sommerfeld rules give only the positions of the maxima an minima but not a means of distinguishing them both.

6 Conclusion

As we have said in the introductory section, the problems of diraction and interference | mainly the later | were always considered as the ones forbidding a phenomenological interpretation of the quantum formalism based only upon a corpuscular model.

This paper has shown that such an interpretation is indeed possible, avoiding the need to appeal to an undulatory description. Each individual particle is scattered at quantized angles. After more and more particles are scattered (more systems composing the ensemble are considered), we begin to see the gures, known as the interference and/or diraction patterns. These patterns are, of course, a property of the ensemble, while each scattering refers to only one particle. That's why the amplitudes refers to ensembles while the Bohr-Sommerfeld rules refer to individual systems.


The behavior of this group of systems (of the ensemble) will be of an undulatory character which is described by the Schrodinger equation by means of the amplitudes. Since this undulatory behavior refers to the ensemble and not to the individual systems, they have no essential (objective) character. This essential character has to be attributed to the individual particles, according to what we have done in the postulates of this theory [1]-[11].

Figure 1: Laue (or B ragg) di raction by a periodic structure.




Figure 2: Di raction through an apperture.




Figure 3: Interference and di raction from a double slit.
