# G eneralized B inom ial States: Ladder O perator A pproach

#### Abstract

W e show that the binom ial states (BS) of Stoler et al adm it the ladder and displacem ent operator form alism. By generalizing the ladder operator form alism we propose an eigenvalue equation which possesses the num ber and the squeezed states as its lim iting solutions. T he explicit form s of the solutions, to be referred to as the generalized binom ial states (GBS), are given. C orresponding to the wide range of the eigenvalue spectrum these GBS have as widely di erent properties. Their lim its to num ber and squeezed states are investigated in detail. The tim e evolution of BS is obtained as a special case of the approach.

## 1 Introduction

The number and the coherent states of quantized radiation eld play im portant roles in quantum optics and are extensively studied [1]. The binom ial states (BS) introduced by
 and the most classical coherent states, and reduce to them in two di erent lim its. Som e of
 atom s [ $]$ ], have been investigated in the literature. The BS is de ned as a linear superposition of num ber states in an $M$-dim ensional subspace

The nam e binom ialstate' com es from the fact that their photon distribution finj; M if $=$ $\left.j_{n}^{M}()\right)^{3}$ is simply a binom ial distribution $w$ th probability. In the two lim its ! 1 and
! 0 (in both cases \de nite probability") it reduces to num ber states: $\mathfrak{j l}$; M i $=\mathrm{M}$ i and j0; M i = joi, respectively. In a di erent lim it of M ! 1 ; ! 0 with $\mathrm{M}={ }^{2}$ xed ( real constant), j; M i reduces to the coherent states (not the m ost general ones, only those w ith real am plitude ), which corresponds to the P oisson distribution in probability theory [7]. It is well know $n$ that the binom ial distribution tends to the Poisson distribution in the above lim 让[]. The notion of BS was also generalized to the interm ediate num ber-squeezed states [G] and the num ber-phase states [9], as well as their q-deform ation [10].

It is well known that the num ber and the coherent states are the eigenstates of the num ber operator N and the annihilation operator a, respectively. So we naturally ask if BS is an eigenstate of a proper linear com bination of the num ber operator and the (densitydependent) annihilation operator, or in other words, if it adm its a ladder operator de nition. The answer is positive. In Sec 2 we show that BS is the eigenstate of the com bination ofnum ber operator $N$ and raising operator $J_{M}^{+}=P \bar{M} \quad N$ a of $S U$ (2) via its H olstein Prim ako realization. This ladder operator form alism enables us to easily derive their displacem ent operator form alism. The result show s that BS is in fact a special SU (2) coherent states, as noted in 10].

In Sec.3, we generalize the ladder operator approach ofB S tow ards the generalized bino$m$ ial state ( $G B S$ ) in the sense that they reduce to the num ber and coherent, squeezed states
in certain lim its. Recall that the squeezed states of the radiation eld are the eigenstates of a linear com bination of its creation and annihilation operators. So we replace the linear com bination of raising and low ering operators of SU (2) instead of the raising operator in the ladder operator form of binom ial states and thus obtain an eigenvalue equation of proper linear com bination of all generators of SU (2) (to be referred to as G BS equation for convenience). The GBS equation is exactly solved using a m ethod developed in the investigation of the squeezed states of SU $(1,1)$ algebras [13] and its $\mathrm{M}+1$ distinct eigenvalues and corresponding eigenstates are found. In Sec. 4 we show that these solutions degenerate to the num ber, coherent and squeezed states in di erent lim its. In Sec. 5 we point out that BS and its tim e evolution are the special case of GBS equation with a special eigenvalue. We conclude in Sec. 6 .

## 2 Ladder operator approach to B S

Let us rst consider the ladder operator form alism ofBS. To this end we suppose that the BS is an eigenstate of a linear com bination of the num ber operator N and a density-dependent annihilation operator $f(\mathbb{N})$ a, nam ely,

where constants , and a function $f(\mathbb{N})$ are to be determ ined. Taking into account that

It is interesting that the operators appearing in the above equation (2.4) are the well-known H olstein $P$ rim ako realization of Lie algebra SU (2):

$T$ his characterization of the $B S$ in term sof the $S U$ (2) operators is consistent $w$ ith the original de nition (1.1), (12) in the two lim its of \de nite probability" ! 1 and ! 0 :
respectively. To achieve the coherent state in som elim it, we multiply $\mathrm{P}_{-}$on both sides of (2.4). Then, considering the lim it M ! 1 and ! 0 with xed $M={ }^{2}$ ( is a real constant) for nite $n$, we arrive at the equation

which is nothing but the ladder (annihilation) operator de nition of coherent state.
H ere we would like to rem ark that the binom ialstate is only one eigenstate of the operator ${ }^{\mathrm{P}}-{ }_{N}+{ }^{\mathrm{P}} \overline{1} J_{\mathrm{M}}^{+}$corresponding to the eigenvahe ${ }^{\mathrm{P}}-_{M} . T$ his operator generally has $M+1$ eigenvalues and eigenstates since it is in fact an $(M+1) \quad(M+1) \mathrm{m}$ atrix. In Sec.5, the com plete eigenvalues and eigenstates w ill be presented.

From the ladder operator form of $S$ we can easily derive its displacem ent operator form .

C om paring (2.8) w th the atom ic coherent states and its ladder operator form in 12], we nd that the BS can be w ritten as

So BS can be viewed as a special SU (2) coherent state, as noted in 10].

## 3 GBS equation and exact solutions

On the basis of the above analysis, we shall propose a m ore general eigenvalue equation, the G BS equation, which possesses the num ber and the squeezed states as its lim iting solutions, and present its exact solutions in this section.

From the discussions in Sec. 2 we see that in the lim it ! 0 and M ! 1 with xed $M={ }^{2},{ }^{P}-J_{M}^{+}!a$. In fact, we also have ${ }^{p}-J_{M}!\quad a^{y}$ in the sam e lim it. Recall that

[^1]the squeezed states of a single $m$ ode radiation eld can be de ned as the eigenstates of the operator $a+a^{y}$, where two complex numbers and satisfy $j=j<1$. So, to achieve the GBS, we should replace $J_{M}$ in the (2.4) by the operator $J_{M}^{+}+J_{M}$. (Note that $j=j<1$ was necessary for the convergence of an in nite series for the squeezed state. In the GBS case such a constraint is not necessary since the operators are nite $m$ atrioes.) In sum $m$ ary, we propose the follow ing equation

Equation (3.1) is an eigenvalue equation for an $(M+1) \quad(M+1)$-m atrix. So, generally speaking, it has up to $M+1$ di erent eigenvalues. If we expand the state $j$ i in term $s$ of the number states, 3.1) w ill lead to a recursion relation with three term s , which is di cult to solve in its full generality. H ere we shall use a m ethod used in the investigation of the squeezed states of su $(1,1)$ algebra [13]. W e w rite the state $j i$ in the form

From 3.19) we have two possibilities: $\quad M A_{0}=2=0$ or $C_{M}=0$. In the rst case, we can determ ine one eigenvalue ${ }_{\mathrm{M}}=\mathrm{M}_{0}=2$ and its corresponding eigenstate from 3.11). If $C_{M}=0$, we still have tw o possibilities: $+A_{0} M=2 A_{0}(M 1)=0$ or $C_{M} \quad=0$. Perform ing the analysis in the sam e way, we obtain all eigenvalues and eigenstates. ## 4 Lim it to num ber and squeezed states

In this section we discuss the lim iting cases of the G B S obtained in the previous section. Let us rst consider the lim it ! 1 . In this case (3.q) requires $=0$ or $\sin r=0(r=m: m$ integers) and $A_{0}$ ! 1 and (325) reduces to

Therefore we conclude that the lim it to the num ber states is true not only for the binom ial states ( $=1$; $=0$ and $k=M$ ) but for the m ore general GBS equations and all of their eigenstates.

Then we tum to the lim it to the coherent and the squeezed states. A s before we let M ! 1 ; ! 0 w th $\mathrm{xed} \mathrm{M}={ }^{2}$. H owever, in the present context we have a whole range of the param eter $\mathrm{k}, 0 \mathrm{k} \quad \mathrm{M}$, whose lim it m ust be speci ed, too. We consider two sim ple cases.

C ase 1. $W$ hen $k=K+p$, where $K=M=2$ for even $M$ and $M \quad 1)=2$ for odd $M$, and $p$ is nite. In this case ( $2 k \quad M$ ) is a nite integer and ${ }^{\mathrm{P}}-(2 \mathrm{k} \quad \mathrm{M})$ goes to zero in the lim it

(T he exceptional case of $=0 \mathrm{w}$ illbe discussed in som e detail in the next section.) Therefore in these cases the naive ! 0 and $M$ ! 1 lim it does not exist for the GBS. In order to de ne proper lim its in these cases we have to consider the situation in which and are dependent.

## 5 The case $=0$ : tim e evolution of B S

In this section we consider the special case $=0$, for which no $S U$ (2) rotation is necessary to $m$ ake $A=0$, ie. $D()=1$. The eigenvalues and eigenstates are directly obtained from (3.14) and 3.15, 3.16) w th $A_{0}=P-$ and $A_{+}=P \overline{1}$
where $D_{0}$ and $D_{0}^{0}$ are norm alization constants. In particular, if $=1$, we recover the binom ial states for $k=M$ and $n d$ all the other eigenstates of the operator in 2.4). A ll these states fork M are new. If $j \mathrm{je}^{i} \in 1$, we shall se that $j$ is not essentialbut that its phase is related to the time evolution of the states $j ;{ }_{k} i$. In fact $j j$ dependence in (5.3) can be absorbed by a new param eter $==(+j j(1))$, which also satis es $0 \ll 1$. So, w ithout loss of generality, we suppose $j j=1$ in the follow ing. To understand the physical $m$ eaning of the phase of the param eter $=e^{i}$, we consider the tim e evolution of the states (5.3). Suppose that at the initial tim et $=0$, the radiation eld is in the state (5.3), then at any time $t$, it is in the state $U(t) j ; k i$, where $U(t)=e^{i H t=h}$ is the evolution operator and $H=!(\mathbb{N}+1=2)$ is the $H$ am iltonian of the singlem ode radiation eld. It is obvious that

from which we see that the phase can be understood as the shift of the origin of the tim $e$.

The state $j ; ~ m i$ is essentially the binom ialstate. It can also be understood as the SU (2) coherent states. In fact, it is not di cult to see that

where ${ }^{0}=\arctan ^{\mathrm{q}} \overline{=(1)}^{\mathrm{i}} \mathrm{e}^{\mathrm{i}}$. From 5.5) we see that the states 5.3) are the general SU (2) coherent states due to the arbitrariness of .

It is easy to see that the special cases discussed in the previous section (i) $k=\frac{M}{2}+p$, (iia) $k=M \quad p$, (ib) $k=p$, ( $p$ : nite) reduce to the coherent states $j e^{i}={ }^{p} \overline{2} i$ (i), j $e^{i} i$ (iia)


## 6 C onclusion

W e have found that, am ong the threem ethods for de ning the coherent state of the radiation eld, the ladder and displacem ent operator $m$ ethods can be generalized to the study of the BS. The only exception is the $m$ inim um uncertainty $m$ ethod. $T$ his is understandable since the BS is betw een the m ost non-classicaland the m ost classicalstates, not the m ost-classical state ( $m$ inim um uncertainty state).

On the basis of the analysis ofB S we proposed an G BS equation and solved it exactly. The eigenstates of the GBS equation corresponding to $M+1$ distinct eigenvalues are allobtained and their tim e evolution is discussed. These states range from the displaced binom ial states (for $k=M$ ) to the binom ial states (for $k=0$ ). They degenerate to the num ber states and the coherent and squeezed states in two di erent lim its. The originalBS of Stoler et al is only an eigenstate of a specialGBS equation ( $=0$ and eigenvalue ${ }^{p}-\mathrm{M}=2$ ).

Further investigation of the statistical and phase properties of the GBS obtained in this paper will be published elsew here.
