Coherent states for quantum systems with a trilinear boson Hamiltonian

We introduce a set of coherent states which are associated with quantum systems governed by a trilinear boson Hamiltonian. These states are produced by the action of a nonunitary displacement operator on a reference state and can be equivalently dened by some eigenvalue equations. The system prepared initially in the reference state will evolve into the coherent state during the rst instants of the interaction process. Some properties of the coherent states are discussed. In particular, the resolution of the identity is derived and the related analytic representation in the complex plane is developed. It is shown that this analytic representation coincides with a double representation based on the Glauber coherent states of the pump mode and on the SU (1,1) Perelom ov coherent states of the signal-idler system. Entanglement between the eld modes and photon statistics of the coherent states are studied. Connections between the coherent states and the long-time evolution induced by the trilinear Hamiltonian are considered.

I. IN TRODUCTION

Various nonlinear processes in quantum optics, such as parametric amplication, frequency conversion, Ram an and Brillouin scattering, and the interaction of two-level atoms with a single-mode radiation eld, are described by a trilinear boson Hamiltonian of the form [1{29}]

Here \hat{a} , \hat{b} , \hat{c} are the boson annihilation operators of the three eld modes with angular frequencies $!_a$, $!_b$, $!_c$, respectively, which satisfy the energy conservation law

The concept of coherent states has been introduced by G lauber [30] for the single-m ode quantized radiation eld whose dynam ical sym m etry group is the W eylH eisenberg group [31]. Perelom ov [32] and G im ore [33,34] have generalized the concept of coherent states to quantum systems whose dynam ical sym m etry group is an arbitrary Lie group.

In the present paper we introduce coherent states for quantum systems whose dynamics is governed by the trilinear boson Hamiltonian (1.1). This Hamiltonian is a linear combination of operators that do not form a nite-dimensional Lie algebra, and hence a direct application of the Perelom ov formalism becomes impossible in this case. Therefore, we dene the coherent states as eigenstates of some non-Hermitian operators or, equivalently, as

states produced by the action of a nonunitary displacement operator on a reference state. We show that during the rst instants of the time evolution (i.e., in the short-time approximation) this reference state is evolved into the coherent state. Moreover, the coherent states have an important property of resolution of the identity. Thus we are able to develop an analytic representation in the complex plane. Some quantum statistical properties of the coherent states are also discussed. In particular, we study photon statistics of the pump mode and the entanglement between the pump and the signal-idler subsystems. We also consider connections between the coherent states and the long-time dynamics governed by the trilinear boson Hamiltonian.

II.PHYSICAL MODELS

The dynam ics induced by the H am iltonian (1.1) can be better understood by revealing its sym m etries. It can be easily shown that the operators

Therefore, a state of the system can be characterized by two quantum numbers. The Ham iltonian (1.1) can be written in the form

The form (2.5) is convenient for description of processes with underlying SU (1,1) sym m etry, e.g., for parametric amplication where the modes \hat{a} , \hat{b} , and \hat{c} are identiced as the pump, signal, and idler modes, respectively. The signal-idler system possesses an SU (1,1) sym metry, and the Casim ir operator

Thus k takes discrete values $k = \frac{1}{2};1;\frac{3}{2};2;:::$ that corresponds to the so-called discrete series of representations [35]. The representation H ilbert space is spanned by the complete orthonormal basis k;ni (n = 0;1;2;:::),

For the two-mode realization (2.6) the states jk; ni can be expressed in terms of Fock states of the modes:

This form implies that there is more photons in the mode \hat{b} than in the mode \hat{c} . However, since the Ham iltonian is symmetric in the operators \hat{b} and \hat{c} , we may by denition refer to the mode with larger number of photons as the mode \hat{b} and to the mode with smaller number of photons as the mode \hat{c} . Certainly, this denition is incomplete if an initial state is given, for example, by a superposition $\hat{j}_b\hat{j}_c + \hat{j}_b\hat{j}_b\hat{j}_b$. In such a case we must use two SU (1,1) representations: \hat{k} ; $\hat{n}_b = \hat{j}_b + 2k$ $\hat{l}_b\hat{j}_b\hat{j}_c$ and \hat{k} ; $\hat{n}_b = \hat{j}_b\hat{j}_b + 2k$ $\hat{l}_b\hat{j}_b$. However, for the sake of simplicity, we will not consider such situations.

There is a number of nonlinear optical processes described by the Hamiltonian (2.5). For degenerate parametric amplication or second harmonic generation, one has

In this case $\hat{K}^2 = 3=16$, so k=1=4 or 3=4. The dynam ics induced by the corresponding H am iltonian has been studied for both second harmonic generation [36,37] and degenerate parametric amplication [38{42}]. For the intensity-dependent two-mode coupling, the SU (1,1) generators are given by

III.COHERENT STATES

The evolution operator $\hat{U}(t) = \exp(i\hat{H}t)$ can be written as

If the mode \hat{a} is highly excited and its depletion can be neglected through the evolution of the system, one can use the so-called param etric approximation [6,14]. In this approximation the mode \hat{a} is treated classically, i.e., the operators \hat{a} and \hat{a}^y are replaced by c numbers and prescrively. In this case Eq. (3.2) defines the SU (1,1) Perelom ov coherent states. In the context of the boson realizations (2.6) and (2.12), these states are identified as the well-known two-mode and one-mode squeezed states, respectively. (Limitations to squeezing in degenerate parametric ampliers due to quantum uctuations in the pump have been discussed in Refs. [38(42)].) The SU (1,1) coherent states have been also considered [45(47)] in the context of the Holstein-Primako realization (2.13).

In what follows we will consider the general (pure quantum) case, when the parametric approximation is not valid. However, it is customary to use the short-time approximation [10,12,17,24,27,29] in which one assumes jzj 1. In order to clarify the algebraic meaning of this approximation, we use the Baker-Campbell-Hausdor theorem expressed as the Zassenhaus formula [48]:

Equation (3.13) shows that the coherent states $j_2;k_2;L_1$ are produced by the action of the (nonunitary) displacement operator $\exp(z \hat{a} \hat{K}_+)$ on the reference state $j_2;k_3;0_1$. IV.RESOLUTION OF THE IDENTITY AND ANALYTIC REPRESENTATIONS

The above results for the analytic representation in y plane can be easily transformed for the analytic representation in z plane. We just use the expression (3.14) for the coherent states and obtain

It is interesting to study how the coherent states jy;k;Li of the whole three-m ode system are related to the G lauber coherent states of the pump and to the SU (1,1) Perelom ov coherent states of the signal-idler system. We consider this relation by using the corresponding analytic representations. The G lauber coherent states are given by [30]

This relation shows that the analytic representation in the coherent-state basis jy;k;Li is equivalent to the double representation based on the G lauber coherent states of the pump and on the SU (1,1) Perelom ov coherent states of the signal-idler system.

V.MODE ENTANGLEMENT AND QUANTUM STATISTICS OF THE COHERENT STATES

The quantum nature of the dynam ics induced by the trilinear boson Ham iltonian leads to strong entanglem ent between the pump and the signal-idler subsystem s [27]. We study here the entanglem ent between the eld modes when the whole three-mode system is in the coherent state $j_{ij};k;Li$. This is a pure state and therefore the total entropy is zero. However, quantum correlations between the modes lead to the increase of the marginal entropy of each mode. The von Neumann quantum entropy S_i of the mode i (i = a;b;c) is defined by [53]

In our case the index of correlation $I_{a\to c}$ between the pump and the signal-idler subsystems is equal to twice the marginal entropy of the pump mode: $I_{a\to c} = 2S_a$.

It can be shown that the purity param eter S_i^{pur} represents a lower bound for the corresponding entropy S_i , i.e., S_i^{pur} S_i . Moreover, in the present case the purity parameters satisfy relations valid for the entropy, such as the Araki-Lieb theorem. In particular, this gives

This quantity is presented in Fig. 1 versus jzj=1=jyj for k=1 and various values of L. As jzj increases, S_a^{pur} rapidly grows, reaches a maximum, and then decreases. The greater is the initial number L of the pump photons, the higher is the maximum of S_a^{pur} , i.e., the stronger is the entanglement. In the limit jzj=1, the purity parameter increases as

We see that for jzj 1 the entanglement between the pump and the signal-idler subsystems is very weak. This result is expected due to the fact that the coherent states are obtained by the repeated application of the annihilation operator â with no creation operator ây being applied. Therefore, as jzj becomes large, the pumpmode tends toward the vacuum and is then more pure and more uncorrelated to the signal and idler modes.

We also consider photon statistics of the pump mode â for the whole system in the coherent state jy;k;Li. The photon-number distribution is given by

This distribution is plotted in Fig. 2 versus n for k=1, L=10, and various values of j = 1 = j j. We see that P_a (n) is very sensitive to the value of j = 1 = j j. We can further investigate photon statistics of the pump mode by evaluating the expectation value and the variance of the number operator $\hat{N}_a = \hat{a}^y \hat{a}$. It is easy to not the following expressions:

Num erical results are presented in Fig. 3 where $h\hat{N}_a i$ and $h(\hat{N}_a)^2 i$ are plotted versus p = 1 = r for k = 1 and L = 10. We also consider some approximate results. In the limit p = 1, we obtain

i.e., photon statistics of the pum p m ode is close to that of the Fock state J.i. However, as jrj increases, photon statistics rapidly changes. In the lim it jrj 1, we obtain

Therefore, for j: 1 photon statistics of the pum p m ode is close to be Poissonian. Because the purity parameter S_a^{pur} in this lim it is very small [see Eq. (5.12)], i.e., the pum p is almost disentangled from the signal-idler system, the state of the pum p m ode is close to a slightly excited pure state with Poissonian statistics. This result can be simply explained by the repeated application of the pum p-m ode annihilation operator with no creation operator being applied. For j: 1 this leads to the strong depletion of the pum p m ode.

VI.LONG-TIME EVOLUTION AND FUNDAMENTAL LIMIT ON THE ENERGY TRANSFER

We know that the coherent states <code>j:k:Liwith j:j 1</code> are produced from the initial state <code>jLik:0i</code> during the rst instants of the time evolution. However, this simple physical meaning is not valid in general for the coherent states with large values of <code>j:j</code>. Nevertheless, it should be interesting to study the connection between these states and the long-time evolution induced by the trilinear Ham iltonian.

We consider the dynamics of the initial state Lik; 0i. For general Lthe eigenvalue equation (4.17) can be solved numerically by a diagonalization of the interaction Ham iltonian. For L = 1 and L = 2 this can be done analytically. By studying these simple situations, we can understand general features of the long-time dynamics. For L = 1 we obtain

where = $ij j_{1} = 2kj j$. We see that the evolution is periodical. Therefore, it is su cient to consider only the time range 0 $_{1}t$ 2. The coherent state for L = 1 is

It is easy to check that this state can be written (up to an unimportant phase factor) in the form (6.1) with real $z=(2k)^{1-2}\tan(_1t)$. Thus the coherent state \dot{p} ; k; liexactly describes the dynam ics induced by the trilinear Hamiltonian. The rst instants of the time evolution ($_1t$ 1) and the moments with $_1t$ close to and 2 are described by the coherent states with \dot{p} ; 1, while at the moments with $_1t$ close to =2 and 3 =2 the system evolves into the coherent state with \dot{p} ; 1.

For L = 2 the situation is more complicated. In this case we obtain

This state with jzj 1 coincides with the state $j_t;k;2i$ with $_2t$ 1 (for z=j $_t$). However, for other moments of time this simple connection is not valid in general. For example, at the moment $_2t==2$ "," 1, the state $j_t;k;2i$ of Eq. (6.3) has the form

where we have assumed z to be real and positive, and g = 1 = (2k + 1z). The state $j_z; k; 2i$ of Eq. (6.5) does not coincide in general with the state $j_z; k; 2i$ of Eq. (6.4). It is seen that these two states coincide only in the lim it k " 2 1 (with g =").

In order to understand why the system does not evolve in general into the coherent state $\dot{\mathbf{p}}; k; 2i$ with $\dot{\mathbf{p}}; j$ 1, consider the result (5.23) for the mean photon number $h\hat{N}_a i$. Indeed, for $\dot{\mathbf{p}}; j$ 1, $h\hat{N}_a i$ is very small, i.e., almost all the photons are in the signal-idler system. This result contradicts to a fundamental limit on the energy transfer, that exists for the evolution of the initial state $\mathbf{j}.i\mathbf{k}; 0i$. It was retahown by Drobny and Buzek [56] that such a fundamental limit on the energy transfer exists in the multiphoton down-conversion, when the signal mode $\hat{\mathbf{b}}$ is initially in the vacuum state and the pump mode $\hat{\mathbf{a}}$ is excited. A particular case is the two-photon down-conversion (i.e., the degenerate parametric amplication), described by the Hamiltonian (2.5) with the two-photon SU (1,1) realization (2.12). In this case only less than 3=4 of the pump photons can be transferred in average from the pump to the signal mode [56].

A sim ilar lim it holds also for the evolution induced by the general H am iltonian (2.5) for the initial state Li_{k} ; 0i. For L = 1, we nd

In this case the single photon being initially in the pumpm ode can be completely transferred to the signal mode. Therefore, there is no prohibition on the production of the coherent states with arbitrarily large values of $j_{Z}j_{L}$. However, for L>1 there does exist the lim it on the energy transfer. For L=2, we obtain

The e ciency of the energy transfer is de ned as the maximum mean number of photons which can be in principle transferred from the pump to the signal-idler system, divided by the initial number of the pump photons. For L=2, the e ciency is

In particular, in the degenerate parametric amplication we have k=1-4 and =3-4, in accordance with the results of D robny and Buzek [56]. However, in the non-degenerate parametric amplication the eciency rapidly approaches 1 as k increases. Therefore, the coherent states with large values of jujcan be produced in the limit k=1, as we have seen from the comparison of Eqs. (6.4) and (6.5).

We also not an heuristic relation between the coherent states and the long-time evolution induced by the trilinear H am iltonian. Consider the state j_{t} ; k; 2i at the moment $_{2}$ t = $_{2}$ t:

We compare this state with an even superposition of two coherent states,

where A is a normalization factor and we assume z to be real. It is easy to see that the superposition state $j_z;k;2i_e$ coincides with the state $j_t;k;2i$ of Eq. (6.9) for $z^2=2$. In this special case the long-time dynamics can be described by using a discrete superposition of the coherent states. However, any quantum state obtained during the time evolution of the system can be expanded in the coherent-state basis by using the identity resolution (4.1).

VII.CONCLUSIONS

In this paper we have introduced the coherent states for quantum systems, whose dynamics is governed by a trilinear boson Ham iltonian. This dynamics is complicated because the operators which compose such a Ham iltonian do not form a nite-dimensional Lie algebra. Therefore, the standard formalism of Perelom ov cannot be used in this case. Nevertheless, we have shown that in each invariant subspace there does exist an overcomplete set of the coherent states. During the rst instants of the time evolution the system prepared in a special initial state will evolve into the coherent state. Using the coherent-state basis, we have constructed the resolution of the identity and the analytic representation in the complex plane. This analytic representation coincides with a double representation based on the G lauber coherent states of the pump and on the SU (1,1) Perelom ov coherent states of the signal-idler system. We have studied the entanglement between the eld modes and photon statistics of the coherent states. We have also considered connections between the coherent states and the long-time evolution induced by the trilinear boson Ham iltonian.
