# TRAJECTORY-COHERENT STATES FOR THE CALD IROLA -KANAIHAM ILTONIAN

## Abstract

In this paper we construct the trajectory-coherent states of a dam ped harm onic oscillator. We investigate the properties of this states.

#### I. IN TRODUCTION

At present the coherent states are widely used to describe many elds of theoretical physics [1]. The interest and activity in coherent states were revived by the paper of G lauber [2], who showed that the coherent states could be successfully used for problem of quantum optics Recently N ieto and Simmons [3] have constructed coherent states for particles in general potential, H artley and R ay [4] have obtained coherent states for time-dependent harm onic oscillator on the basis of Lew is R isenfeld theory; Yeon, Um and George [5] have constructed exact coherent states for the damped harm onic oscillator.

Some time ago Bagrov, Bebv and Ternov [6] have constructed approximate (for h ! 0) solutions of the Schrödinger equation for particles in general potentials, such that the coordinate and momentum quantum -m echanical averages were exact solutions of the corresponding classical H am iltonian equations; these states were called trajectory-coherent (TCS). The basis of this construction is the com plex W KB m ethod by V P M aslov [7{9].

The aim of this work is to construct the trajectory-coherent (TCS) states of a damped harm onic oscillator by using the Caldirola – Kanai Ham iltonian and the complex W KB m ethod. It is shown that this states satisfy the Schrodinger equation exactly.

II. THE CONSTRUCTION OF TCS.

Consider the Schrodinger equation

where the symbol of operator  $\hat{H}$  – the function H (x;p;t) is arbitrary real and analytical function of coordinate and m om entum . The method of construction TCS in this case has been described in detail in [6], hence we shall illustrate som e m om ents only. For constructing the TCS of the Schrödinger equation it is necessary to solve the classical H am iltonian system

and the system in variations (this is the linearization of the Hamiltonian system in the neighbourhood of the trajectory x(t); p(t))

where H (x;p;t) is the classical H am iltonian;

b is complex number obeying the condition Im b > 0, and x(t); p(t) are the solutions of system (2).

Consider the dam ped harm onic oscillator [5,10,11]

and the phase S (x;t) is the complex -valued function (Im S > 0) is the approximate solution of the Cauchy problem (6) for the Schrodinger equation (1). We should note that in the case of the quadratic system s, for example, for H am iltonian (4) the function (7) is the exact solution of the equation (1).

Solving the di erential equations (2), (3) we obtain

It is easy to check that the function (7), where x(t); p(t); w(t); z(t) are dened by (8) satisfy the equation (1) exactly as for  $!^2 > 0$  as  $!^2 < 0$  (!! i!).

Further, we de ne "annihilation" operator  $\hat{a}(t)$  and "creation" operator  $\hat{a}^+$  (t) as [6]:

Now, by calculating the uncertainty in x and  $\hat{p}$  in the TCS and CS one nds:

For the dam ped harm onic oscillator (4) we choose R eb = 0 (it is necessary for m inim ization of the uncertainty relations in the initial instant of time [12]), Im b = m!, where > 0 shows the initial uncertainty of coordinate; and we denote = =2!.

By using (8),(16)-(21), in the case  $!^2 = !_0^2 \frac{1}{4}^2 > 0$  for  $(\hat{x})_{\text{rcs}}^2$ ; ( $\hat{p}$ ) $_{\text{rcs}}^2$ ;  $(\hat{x})_{\text{cs}}^2$ ;  $(\hat{p})_{\text{cs}}^2$  we obtain

We should note, that in the special case = 1 the formula (23) coincides with formula (14) from [5]. The function (23) is equal to zero, and, therefore, the minimization of the uncertainty relations has place in the instants of time

and we can obtain the minimization for any instant of time t obeying the condition (26) We should notice, that the formula (23) can be easily obtained from (25) by means of replacement ! ! i! and, therefore ! i; ! i: In a case of harmonic oscillator (= 0) as (23) and (25) bring to g(t) = 0, that coincides with results, received in Ref.12.
