Quantum stochastic resonance in driven spin-boson system with stochastic limit approximation

A fier a brief review of stochastic lim it approxim ation with spin-boson system from physical points of view, am pli cation phenom enon | stochastic resonance phenom enon | in driven spin-boson system is observed which is helped by the quantum white noise introduced through the stochastic lim it approxim ation. Signal-to-noise ratio resonates at certain tem perature if another noise parameter is chosen properly. Not only the stochastic resonance in usual sense, but also the possibilities of the new and interesting phenom ena | \anti-resonance" and \double resonance" | are shown with som e choices of . The shift in frequency of the system due to the interaction with the environm ent | Lam b shift | has an important role in these phenom ena.

I. IN TRODUCTION




FIG.1. Response of a particle in a bistable potential to an external periodic perturbation with (a) too sm all, (b) appropriate, and (c) too strong noise.

Stochastic resonance (SR) phenomena were rst discovered in connection with periodically recurrent glacial age. Since then this phenom enon has been found to occur in various elds and has been attracting wide attention. In short SR is phenom enon whereby, in contrast to com m on sense, added noise seems to help to amplify a signal. Let us brie y review SR phenom enon using the bistable potential model, driven by a periodic perturbation. A classical particle in a potential V (x), which has two local m in im a, is perturbed by a periodic external force with an amplitude and a frequency under the in uence of noise (Fig. 1). If the amplitude is small, the particle in one of the stable states cannot go over the potential barrier to the other stable state [Fig. 1 (a)], in other words, the system does not respond to the input perturbation. The addition of noise changes the situation; now the

particle is kicked by the random force and can go over the barrier. How ever if the noise is too strong the response to the input signal may be smeared. This is because in this case the particle moves random ly irrespective of the periodicity of the perturbation F ig. 1(c)]. How ever at a certain added noise strength the particle can be made to travel back and forth between the two stable state, synchronizing with periodic perturbation of frequency F ig. 1(b)]. That is the system responds to the input.

More precisely we can characterize SR as follow:

(1) The power spectrum of the response of a system to a periodic input has a main sharp peak at the input frequency if the noise strength (or tem perature) is chosen properly.

(2) The signal-to-noise ration (SNR) of the response resonates at a certain noise strength (or at a certain tem - perature).

Besides the periodicity in the emergence of glacial ages [2], SR phenomenon are widely found in nature. For example SR is found in the nerve of the agellum of a cray-

sh's tail $[\beta]$ (however in this case, unlike the bistable system described above, a threshold reaction is triggered by noise). Therefore SR m ay be a universal concept.

In this paper we discuss SR in bistable model at the quantum level, that is quantum stochastic resonance (Q SR).O focurse this e ect has already been widely studied [1,4], however our particular interest is \quantum noise," or \quantum dynamics with dissipation." That is, we are interested in how noise is introduced into the quantum dynamics to produce Q SR. This is not only im portant question for Q SR, but it is also relevant for the

understanding of several other fundam ental aspects of quantum mechanics, that is the problem s of relaxation, decoherence, measurement and so on. However quantum mechanics is usually written in term s of causal determ inistic theory governed by unitary time evolution. It is therefore hard, in principle, to introduce the notion of \noise" or \dissipation" (with nite degrees of freedom).

In these circum stances there are several di erent ways to proceed. One of the most popular approaches is to introduce an \environm ent," \reservoir" or \heat bath," whose detailed speci cation one does not know but which has in nite degrees of freedom. The whole system (i.e. \system " + \environm ent") is then treated in the quantum mechanical way [5{8].

Through this interaction, the system exchanges energy with the environment | \dissipation" | , and then it is reasonable to assume that some kind of \noise" or \ uctuation" would appear due to some \ uctuationdissipation relation."

A long these lines A coardiet al. [9{11] have introduced the stochastic lim it approximation (SLA) as a way to realize \quantum white noise." The SLA is one way to deal with the van H ove lim it, which is the weak coupling lim it given by, ! 0 and time coarse-graining lim it given by, $t ? = {}^{2}t$. This lim it ensures that a system in a heat bath approaches canonical state [13].

As is explicitly shown in Sec. III for the spin-boson system, the spin system in the heat bath composed of bosons actually approaches the canonical state under the SLA. Furtherm ore, one can discuss in portant properties in quantum dissipative dynam ics within this fram ework, such as the dependence on tem perature of the shift in frequency of the system due to the interaction with the heat bath.

We here focus our attention on the quantum white noise introduced through the SLA, and study QSR as part of investigations of the properties of this noise. A fter the introduction of the model to be studied | the driven spin-boson system | in Sec. II, the SLA is brie y reviewed in Sec. III with the spin-boson system. U sing this method, we discuss, in Sec. IV, QSR in the driven spin-boson system and the role of the quantum uctuation and dissipation introduced through the SLA. Section V is devoted to concluding remarks with comments on the experimental feasibility of the phenomenon studied here. In the Appendix, we add comments on the SLA from a physical point of view.

II.DRIVEN SPIN-BOSON SYSTEM

Here let us introduce the model the driven spin-boson system [1,4] as a special case of the bistable model in Sec. I.




FIG.2. Bistable system at the quantum scale.

A.Spin system

Consider the situation where the system illustrated in Fig. 2 is in a deep cold heat bath and its dynam ics are nuled mainly by the lowest tunnel-splitted pair of levels j i, where therm all hopping to upper levels can be neglected. If the tunneling am plitude between the two wells is su ciently small, we are able to consider two \localized" states, j i and \Re i, which are approximately the ground states of left and right wells, respectively. Taking the set of these states as the H ilbert space basis, this system can be described by the H am iltonian,

which is essentially the spin-1/2 H am iltonian with the parameter characterizing the tunneling am plitude between the twowells, and characterizing the di erence in energy between the jli and \Re i states. Hereafter, we call it the spin system. By introducing a new basis rotated by the angle = $\cos^{1}(=!_{0}) = \sin^{1}(=!_{0})$,

This two-level system is driven by a periodic forcing with frequency and amplitude . This applied force can be described by the perturbative H am iltonian

O f course, there are m any other possibilities for the system driving instead of (2.5), e.g., $W^{0} = (\Re \text{ ihL j} + J \text{ ihR }) \sin t$, but we choose the perturbation (2.5) since it corresponds to classical SR in the bistable m odel.

Note that X is an order parameter in discussing QSR phenomenon in Sec. IV, which measures the transitions between the states j and R i under the in uence of the external perturbation.

B.Boson system and its interaction with the spin system

As mentioned in Sec. I, one must introduce an \environment" for the spin system to dissipate and be disturbed. The environment is chosen as a set of bosons in this paper, whose H am iltonian is given by

Here, a_k and a_k^y are respectively annihilation and creation operators for a boson of mode k with energy $!_k > 0$, and satisfy the commutation relations

The spin system interacts with the bosons via the interaction H am iltonian

where characterizes the strength of the interaction, and the structure function g_k is a coupling of the bosons of \mathfrak{R} ode k with the spin system subject to the condition

dk $j_{j_k} f < 1$. Note that the spin system and the boson system are coupled with the bilinear product of the spin operatorX and the boson operators. A lthough som e speci ed choices of the coupling m ay result in certain outputs, the details of the m icroscopic H am iltonian are not so signi cant for the derivation of dam ping dynam ics. A com m ent on this point can be found in Sec. IIIB 2.

The system to be analyzed in this paper is thus given by the total H am iltonian

III. STOCHASTIC LIM IT APPROXIMATION

In this section we brie y review the stochastic lim it approximation (SLA) formulated by Accardi et al. [9{11]. For simplicity, let us consider the case where there is no external perturbation, i.e., = 0 [10,11,7]. The Ham iltonian of the system concerned in this section is thus

W e entrust the m athem atical details to Ref. [9] or [11], but note that several physically important points are em – phasized and added to the work in Ref. [10] and [11]. Furtherm ore in the appendix we add som e comments on the SLA taken from slightly di erent point of view to that taken by A coardi et al.

For comments on these limits from a physical point of view, see the Appendix. The correlation time is vanishingly small. However at the same time, we should be careful to note that equation (3.9) is ill-de ned. Fortunately, how ever, noticing the commutators [10,11]

Note that tr_B denotes the trace over the boson-degrees of freedom. This is the procedure for \partial trace." It reduces the e ects of the interaction between the spin system and the boson environment to the spectral function J (!) de ned in Eq. (3.12). The damping coe cient in Eq. (3.11) and the frequency shift in Eq. (3.20)

with Eq. (3.14) are both given in term s of J (!).

The damping coe cient and the frequency shift are obtained from and , respectively, by replacing the spectral function J(!) with the temperature modied one J(!).

Notice that the long-time limits of the operators $D_0()$! tanh(b=2) and D ()! 0 are both cnumbers (or unit operators of the spin system multiplied by c-numbers). This means that the spin system approaches some unique state irrespective of the initial state s. In fact, the averages of any spin system operators, which are composed of D (), approach unique values. O ne can further con rm that the long-time limit of the state of the spin system is nothing but the therm all state at the temperature T. Taking averages of D () with some arbitrary initial state s, one obtains the matrix elements of the system density operator de ned by

B.Comments from physical points of view

1. O rders of param eters

It is important to clarify the order of magnitude of the parameters. In this form alism, one considers that the new time is physical and that, if they are measured in this macroscopic time, the parameters of the spin system should have some meaningful values, e.g., $!_R$ or $!_0$, instead of $!_0$, should be nite. On the other hand, the time scales of the boson system should be measured in the microscopic time t. This can be seen in the emergence of the delta function in Eq. (3.10). This is due to the coarse-graining in time, t? = ${}^2t(! 0)$. It rejusted to the form

that characteristic time scales of the boson system, like the correlation time for example, are vanishingly small when measured in the macroscopic time. That is they are negligible when compared to the characteristic times of the spin system, such as $1=\frac{1}{2}$ for example. This is the situation which occurs in the stochastic limit.

As for the temperature, the physically interesting situation is where the temperature T is such that $!_0$ has some nite value, which is contained in and through J $(!_0)$ [see Eqs. (3.23) and (3.24)] and in the therm al equilibrium distribution (3.27b). That is, the rescaled temperature $T = T = {}^2$ should be nite.

2. Choice of the coupling

In this paper, the spin-boson system is coupled through the speci c choice of the coupling, in particular, the choice X . Of course, there are many other possibilities, such as $V = (\Re ihL j + jL ihR j) dk (g_k a_k^{Y} + g_k a_k)$, but they all result in the sam e dam ping dynam ics (3.22) except for the prefactors $(=!_0)^2$ and $(=!_0)^2$ in the de nitions of in Eqs. (3.23a) and (3.23c). [O ne has to noand tice, however, that the special choice of the interaction $V = (j+ih+j j ih j) dk (g_k a_k^y + g_k a_k)$ gives the special = 0, which is also included in Eqs. (3.22). situation = 0 also exists for som e special The possibility of choices of V.] From a sem i-phenom enological point of view, Eqs. (3.22) are su cient for the description of experiments. Know ledge of the parameters $\frac{1}{2}$, , and from an experiment would enable one to predict the dynam ical developm ent of any quantities. Details of the m icroscopic H am iltonian would not have much e ect on the macroscopic behavior.

IV.QUANTUM STOCHASTIC RESONANCE

Now let us discuss Q SR in the driven spin-boson system (2.10) with the SLA. By observing the response of the system to the external perturbation (2.5) through the dynamics of the \position" operator

Responding to the input perturbation, X () oscillates around the therm alequilibrium state with the frequency of the perturbation $\tilde{}$.




FIG.3. Functional form of (a) physically realistic, (b) 0 hm ic case," and (c) 0 constant case" spectral function J (!).




FIG.4. Schematic forms of the frequency shift for (a) 0 hm ic case and (b) constant case."

called the \constant case" [Fig. 3(c)]. A Lthough a physically realistic spectral function J (!) m ay have a cuto at high frequency $_{\rm C}$ as sketched in Fig. 3(a), it may be reasonable to consider that c can be in nitely large com pared to the characteristic frequency of the spin system $!_0$ in the stochastic lim it situation. We hence adopt the model spectral functions given by Eqs. (4.10a) and (4.10b) and illustrated in Figs. 3 (b) and (c). Their nam es come from the functional forms in the regions around $on-shell'' ! = !_0$ which are assumed to be the regions 0 < ! < and < ! for each case. Note that J (!₀), and given by Eq. (3.23a), have the same value for hence both cases, and the dimensionless parameter controls its magnitude, i.e., the noise strength. The di erence between the two cases manifests itself in the temperature dependence of the frequency shift given by Eq. (3.23c)(Fig. 4). Note further that the function I (!) de ned by the dispersion relation (3.24b) does not converge with the m odel spectral functions (4.10). Since the asym ptotic behaviors of J (!) in these models are constant as !! 1, one has to apply a subtracted form to the dispersion relation. A fter a subtraction at $! = !_1$, this becomes

There are two important parameters concerning the environment or the noise, i.e., the temperature T and




FIG.5. Temperature- and -dependence of SNR for (a) Ohm ic case" and (b) $constant case" with = 0.10!_0$, = 2.0!_0, = 0.50!_0, and =!_0 = 0.35. (a⁰) and (b⁰) are enlarged versions of (a) and (b), respectively. Darker grays correspond to larger R (~).




FIG.6. Tem perature-dependence of SN R for $\ O hm ic case"$ with (a) = 0:59, (a⁰) = 0:65, and (a⁰⁰) = 0:70, and for $\ constant case"$ with (b) = 3:5, (b⁰) = 4:5, and (b⁰⁰) = 15.

the noise strength . In Fig. 5, the SNRs R (~) for both cases are shown in the -T plane. One may realize at rst sight that SNR depends deeply on the choice of J (!), namely, on the temperature dependence of the frequency shift . The temperature dependences of the SNRs are shown in Fig. 6(a) for the \0 hm ic case" with = 0:59, and in Fig. 6(b) for the \constant case" with

= 3.5. maximum values are seen at around the temperature kT $0.3!_0$ for both cases, that is, SR occurs. Roughly speaking, these maximum points correspond to the minima of the denominator in the right hand side of Eq. (4.7). One has to notice, however, that this does not occur for all : for some it occurs, and for others it does not. And beyond these two possibilities, one can

The second maximum comes from the overlapping e ect of a negatively decreasing factor $!_R$ beyond its zero point and a positively decreasing P lanck distribution. And it does not correspond to a genuine SR. It has no counterpart in classical system s. The behavior of the frequency shift may

be the key to these phenom ena.

V.SUMMARY

Q SR in the driven spin-boson system is discussed with quantum white noise introduced through the SLA. The SLA is a fram ework which can be used to describe the van H ove lim it, which ensures the approach of system in a therm alenvironment to the therm alequilibrium state. SNRs versus noise parameters temperature T and the noise strength | are studied with two model spectral functions J (!). The occurrence of SR depends on the choice of . For some the system does not resonate, for other values it does, and a new phenomenon | anti-resonance and double resonance | is observed. The tem – perature dependence of the frequency shift of the system

due to the interaction with the environment | Lamb shift | may be the key to these phenomena. In this sense, QSR owes its existence to a quantum e ect, which is different from the classical SR, where random force itself is important. To understand this point, this system should be studied in the crossover area between the quantum and classical regimes. This work is now in progress.

It should further be emphasized that the analysis here is from the microscopic view point, not from a sem iphenom enological view point. In the latter there is no criterion which would tell us how to incorporate the dam ping coe cient and the frequency shift into the phenom enological equation properly. Here the dam ping dynam ics is obtained from the fundam entalm icroscopic Ham iltonian underneath the theory.

F inally, let us m ention experim ental situations for the present analysis.

(1) The physical time is not that . Experimental data should be compared with the theoretical predictions from the analysis in this paper in the macroscopic time .

(2) It is very di cult in general to prepare precise quantum mechanical initial conditions experimentally. Fortunately, however, SNR is obtained from the stationary behavior of the system at large times 1=, and is irrespective of the initial condition.

(3) It is possible to control J (!) in the cavity QED experiment. In fact, the life-time of the unstable state of an atom can be successfully controlled by changing the modes of the electrom agnetic eld, i.e., by changing J (!). This means that it may be possible to observe SNRs with di erent choices of J (!) in the cavity QED.

There may be technical di culties to overcom e, but it may be possible to observe experimentally the phenom – ena predicted here. This would also be an experimental veri cation of SLA itself.

If the st and higher derivatives of the spectral function $J^{(n)}(!_0)$ (n = 1;2;:::) do not have singularities, one can safely neglect all terms o other than $J(!_0)$ from the expansion. This corresponds simply to the choice of diagonal singularity, i.e., only the boson m ode $!_k = !_0$ contributes to the damping coe cient in the scaling limit ! 0.

From the above considerations, it is convenient to rewrite Eq. (A 2) as

Thus, one can see that, in the lim it ! 0, (1) the right hand side of Eq. (A 4) vanishes in the case of \under" SLA (< 2), while (2) it diverges in the case of \over" SLA (> 2), and (3) it has a form allim it in the case of \critical" SLA (= 2). Therefore the only meaningful result occurs in the = 2 case.
