Constructing quantum error-correcting codes for p^m -state systems from classical error-correcting codes

A bstract

W e generalize the construction of quantum error-correcting codes from F₄-linear codes by C alderbank et al. to p^m -state system s. Then we show how to determ ine the error from a syndrom e. Finally we discuss a system - atic construction of quantum codes with e-cient decoding algorithm s.

1 Introduction

Quantum error-correcting codes have attracted much attention. Among many research articles, the most general and system atic construction is the so called stabilizer code construction [6] or additive code construction [2], which constructs a quantum error-correcting code as an eigenspace of an Abelian subgroup S of the error group. Thereafter Calderbank et al. [3] proposed a construction of S from an additive code over the nite eld F $_4$ with 4 elements.

These constructions work for tensor products of 2-state quantum systems. However K nill [8, 9] and Rains [12] observed that the construction [2, 6] can be generalized to n-state systems by an appropriate choice of the error basis. Rains [12] also generalized the construction [3] using additive codes over F $_4$ to p-state quantum systems, but his generalization does not relate the problem

of quantum code construction to classical error-correcting codes. We propose a construction of quantum error-correcting codes for p^m -state systems from classical error-correcting codes which is a generalization of β 1.

Throughout this note, p denotes a prime number and m a positive integer. This note is organized as follows. In Section 2, we review the construction of quantum codes for nonbinary systems. In Section 3, we propose a construction of quantum codes for p-state systems from classical codes over $F_{\,p^2}$. In Section 4, we propose a construction of quantum codes for p^m -state systems from classical linear codes over $F_{\,p^{2m}}$. In Section 5, we discuss a systematic construction of quantum codes with e cient decoding algorithms.

2 Stabilizer coding for pm -state system s

2.1 Code construction

We review the generalization [8, 9, 12] of the construction [2, 6]. First we consider p-state system s. We shall construct a quantum code Q encoding quantum inform ation in p^k -dimensional linear space into C^{p^n} . Q is said to have minimum distance d and said to be an $[h;k;d]_p$ quantum code if it can detect up to d 1 quantum local errors. Let be a primitive p-th root of unity, $C_p;D$ p unitary matrices de ned by $(C_p)_{ij} = \int_{j=1; i \bmod p} f(D_p)_{ij} = \int_{j=1; i d$

For row vectors $a=(a_1,\ldots,a_n)$, $b=(b_1,\ldots,b_n)$, $(a \not b)$ denotes the concatenated vector $(a_1,\ldots,a_n,b_1,\ldots,b_n)$ as used in $[\beta]$. For vectors $(a \not b)$; $(a^0 \not b^0)$ 2 F_p^{2n} , we do not the alternating inner product

Theorem 1 Let C be an (n k)-dimensional F_p -linear subspace of F_p^{2n} with the basis $f(a_1 p_1), \ldots, (a_{n-k} p_{n-k}) g_r C^2$ the orthogonal space of C with respect

to the inner product (1). Suppose that $C = C^2$ and the minimum weight (3) of C^2 n C is d. Then the subgroup S of E generated by fX $(a_1)Z$ (b_1) , ..., X $(a_{n-k})Z$ $(b_{n-k})g$ is Abelian, and an eigenspace of S is an $[n;k;d]_p$ quantum code.

Next we consider quantum codes for p^m -state system s, where m is a positive integer. But the code construction for p^m -state system s is almost the same as that for p-state system s, because the state space of a p^m -state system can be regarded as the m-fold tensor products of that of a p-state system. We shall construct a quantum code encoding quantum information in $p^{m \cdot k}$ -dimensional linear space into $C^{p^m \cdot n}$. Corollary 2 Let C be an (mn m k)-dimensional F_p -linear subspace of F_p^{2m} with the basis $f(a_1 \not b_1)$, ..., $(a_{mn m k} \not b_{mn m k})g$, $C^?$ the orthogonal space of C with respect to the inner product (1). Suppose that C $C^?$ and the minimum weight (4) of $C^?$ n C is d. Then the subgroup S of E generated by $fX(a_1)Z(b_1)$, ..., $X(a_{mn m k})Z(b_{mn m k})g$ is Abelian, and an eigenspace of S is an $[n;k;d]_{b^m}$ quantum code.

2.2 Error correction procedure

In this subsection we review the process of correcting errors. Let H = C $^{\rm p}$, H $^{\rm n}$ Q the quantum code constructed by Theorem 1, and H $_{\rm env}$ the H ilbert space representing the environm ent. Suppose that we send a codeword j i 2 Q , that the state of the environm ent is initially j $_{\rm env}$ i 2 H $_{\rm env}$, and that we receive j 0 i 2 H $^{\rm n}$ H $_{\rm env}$. Then there exists a unitary operator U such that

If U acts nontrivially (0 n) subsystems among n tensor product space H $^{\rm n}$, then is said to be the number of errors.

We assume that 2+1 d, where d is as in Theorem 1. If we measure each observable in H n whose eigenspaces are the same as those of X (a_i) Z (b_i) for $i=1,\ldots,n$ k, where X (a_i) Z (b_i) is as defined in Theorem 1, then the entangled state j 0 i is projected to A j i $_{env}$ i, for some A 2 E and j $_{env}$ i 2 H $_{env}$, by the measurements. By the measurement outcomes we can nd a unitary operator A 0 2 E such that A 0 A j i = j i.

The determ ination of A^0 requires exhaustive search in general. Thus the computational cost nding A^0 from the measurement outcomes is large when both n and d are large. However, in certain special cases we can eciently determine A^0 . An ecient method nding A^0 is presented in Section 3.2.

R em ark 3 The error correction method presented in this subsection is not explicitly mentioned in the papers [2, 3, 6]. Still, it can be derived from general

facts on quantum error correction presented in [1, 5, 10]. A readable exposition on the error correction procedure is provided by P reskill [15].

3 Construction of quantum codes for p-state systems from classical codes

3.1 Codes for p-state system s

In this subsection we describe how to construct quantum codes for p-state systems from additive codes over F $_{\rm p^2}$. Let! be a primitive element in F $_{\rm p^2}$.

Proof: When p=2 the assertion is obvious. We assume that p=3. Suppose that p=3 then p=3 th

Since ! is a prim it ive element, ! 2 \oplus ! 2p . Thus the inner product (1) of (a b) and (a 0 b 0) is zero i the inner product (5) of (a b) and (a 0 b 0) is zero. Thus we have

Theorem 5 Let C be an additive subgroup of F $_{p^2}^n$ containing p^n k elements, C 0 its orthogonal space with respect to the inner product (5). Suppose that C 0 C and the m in im um H am m ing weight of C 0 nC is d. By identifying 1 (C) with an Abelian subgroup of E via X ()Z (), any eigenspace of 1 (C) is an $[\![n;k;d]\!]_p$ quantum code.

We next clarify the self-orthogonality of a linear code over F_{p^2} with respect to (5).

 $^{^1\}text{Them}$ ap (5) is F $_p$ -bilinear but does not take values in F $_p$. It is neither F $_{p^2}$ -bilinear nor F $_{p^2}$ -sesquilinear. Thus calling the m ap (5) \inner product" is a little abusive. But the m ap (5) can be converted to an F $_p$ -bilinear form by dividing it by ! 2 ! 2p . For this reason we call the m ap (5) \inner product".

Lem m a 6 Let C be a linear code over F_{p^2} , and C^0 the orthogonal space of C with respect to (5). We do no $C^p = fx^p jx 2 Cg$ and $(C^p)^2$ the orthogonal space of C^p with respect to the standard inner product. Then we have $C^0 = (C^p)^2$.

Proof: It is clear that C^0 (C^p)? . Suppose that $x \ 2 \ C^0$. Then for all $y \ 2 \ C$, hx; y^p i hx;

Theorem 7 Let C be an [n; (n k)=2] linear code over F_{p^2} such that C $(C^p)^2$. Suppose that the minimum Hamming weight of $(C^p)^2$ nC is d. Then any eigenspace of $(C^p)^2$ is an $[n; k; d]_p$ quantum code.

3.2 Error correction for p-state system s

In this subsection we consider how to determ ine the error from measurements with quantum codes obtained via Theorem 7. We retain notations from Theorem 7. Suppose that g_1, \ldots, g_r is an F_{p^2} -basis of C. Then F_p -basis of 1 (C) is $(a_1 \, b_1) = {}^1$ (g_1) ; $(a_2 \, b_2) = {}^1$ $(! \, g_1)$, ..., $(a_{2r} \, b_{2r}) = {}^1$ $(! \, g_r)$. Suppose that by the procedure in Section 2.2, the error is converted to A.2 E that corresponds to 1 (e) for some e.2 $F_{p^2}^n$ via X ()Z (), and the original quantum state is j i. We know which eigenspace of X (a_i) Z (b_i) the vector A j i belongs to By Eq.(2)

If we have a classical decoding algorithm for $(C^p)^2$ nding the error e from a classical syndrome hg_1^p ; ei , ..., hg_r^p ; ei , then we can not the quantum error A 2 E.

R em ark 8 In this section we assumed that! is a primitive element in F_{p^2} . It is enough to assume that! belongs to F_{p^2} and $!^p$,! are linearly independent over F_p .

4 Construction of quantum codes for p^m -state systems from classical codes

4.1 Codes for p^m-state system s

In this subsection we show a construction of quantum codes for p^m -state systems from classical linear codes over $F_{p^{2m}}$. Our construction is based on the

construction [4] by Chen which constructs quantum codes for 2-state systems from linear codes over F $_{2^{2m}}$. We modify his construction so that we can estimate the minimum weight (4) from the original code over F $_{p^{2m}}$.

Lem m a 9 T is alternating and nondegenerate.

Proof: First we show that T is alternating, that is, T (a;a) = 0 for alla 2 F_p^{2m} . Let x = (a) 2 $F_{p^{2m}}$, and $xx^{p^m} = c_1 + 2m e^{p^{2m-1}}$ for c_i 2 F_p . Then $(xx^{p^m})^{p^m} = c_{m+1} + c_{m+2} + 2m e^{p^m} + c_1 +$

We assume that $x \in 0$, which implies that $a \in 0$. Since $x (=x^{p^m})^{p^m} = p^m$, T $(a; x^{p^m}) = 1$, which shows the nondegeneracy.

P roposition 11 Let C $F_{p^{2m}}^n$ be a linear code over $F_{p^{2m}}$, and C 0 the orthogonal space of C with respect to (6). Then the orthogonal space of (C) with respect to (1) is (C 0).

Proof: For $e = (e_1, ..., e_n); e^0 = (e_1^0, ..., e_n^0) 2 F_{p^{2m}}^n$, the inner product (1) of $(e) = (a_{1;1}, ..., a_{n;m}; b_{1;1}, ..., b_{n;m})$ and $(e^0) = (a_{1;1}^0, ..., a_{n;m}^0; b_{1;1}^0, ..., b_{n;m}^0)$ is equal to

If $e_ie_i^{\mathbb{C}^m}=c_1+2\hbar$ $\mathbb{C}^{\mathbb{C}^{2m-1}}$, then T (1 (e_i); 1 (e_i^0)) = c_{m+1} c_1 . Thus if $he_ie_i^{\mathbb{C}^m}$ i=0 then the inner product (1) of (e) and (e 0) is zero, which implies (C 0) is contained in the orthogonal space of (C) with respect to (1). Comparing their dimensions as F_p —spaces we see that they are equal.

Theorem 12 Let C $F_{p^{2m}}^n$ be an $[n; (n \ k)=2]$ linear code over $F_{p^{2m}}$, $C^{p^m}=fx^{p^m}$ jx 2 Cg, and $(C^{p^m})^2$ the orthogonal space of C^{p^m} with respect to the standard inner product. Suppose that C $(C^{p^m})^2$, and the minimum Hamming weight of $(C^{p^m})^2$ n C is d. Then the minimum weight (4) of (C) is d, and (C) is self-orthogonal with respect to the inner product (1). Any eigenspace of (C) is an $[[n;k;d]]_{p^m}$ quantum code.

4.2 Error correction for p^m-state system s

In this subsection we consider how to determ ine the error from measurements with quantum codes obtained via Theorem 12. We retain notations from Theorem 12. Suppose that g_1, \ldots, g_r is an $F_{p^{2m}}$ -basis of C.

Suppose that by a similar procedure to Section 2.2, the error is converted to a unitary matrix corresponding to (e) for e 2 F $_{p^{2m}}^{n}$. We exabasis f $_{1}$, ..., $_{2m}$ g of F $_{p^{2m}}$ over F $_{p}$. Then F $_{p}$ -basis of (C) is f ($_{j}g_{i}$) ji = 1, ..., r, j = 1, ..., 2m g. First we shall show how to calculate he; $g_{i}^{p^{m}}$ i for each i. For j = 1, ..., 2m, let $(a_{j})_{p_{j}}$ = ($_{j}g_{i}$). As in Section 3.2, by the measurement outcom es we can know the inner product (1) of (e) and ($_{j}g_{i}$), denoted by s_{i} , for j = 1, ..., 2m.

For $x=c_1+2^m c^{p^{2m}-1}$ 2 $F_{p^{2m}}$, c_1 , ..., c_{2m} 2 F_p , we denne $P(x)=c_{m+1}$ c_1 . Then P is a nonzero F_p -linear map. As discussed in the proof of P roposition 11, $s_j=P$ (he; $p_j^m g_i^{p^m}$ i) $=P(p_j^m he; q_j^{p^m}$ i). We denote the map $P_{2m}:F_{p^{2m}}!$ F_p^{2m} , x $P(p_j^m x)$, ..., $P(p_j^m x)$. Then P_{2m} is an F_p -linear map, and P_{2m} (he; $P_j^{p^m}$ i) $=(s_1,\ldots,s_{2m})$. If P_{2m} is an isomorphism, then noting he; $P_j^{p^m}$ i from P_{2m} is an isomorphism.

Lem m a 13 [11, Theorem 6.1, Chapter III] Let W be a 2m -dimensional vector space over a eld K with a basis fx_1, \ldots, x_{2m} g, and \widehat{W} the dual of W, that is, the K-linear space consisting of linear maps from W to K. Then there exists a basis ff_1, \ldots, f_{2m} g of \widehat{W} such that $f_k(x_j) = {}_{jk} \cdot ff_1, \ldots, f_{2m}$ g is called the dual basis.

Lem m a 14 There exist 1, ..., 2m 2 F p^{2m} such that P $(j^{p^m})_k$ = jk.

Proof: Notice that f $_1^{p^m}$, ..., $_{2m}^{p^m}$ g is an F_p -basis of $F_{p^{2m}}$. The dual space $P_{p^{2m}}$ can be regarded as $F_{p^{2m}}$ -linear space by dening xf: u P_p for x $2 F_{p^{2m}}$ and f $2 P_p^{p^{2m}}$. Let f_1 , ..., f_{2m} be the dual basis of $f_1^{p^m}$, ..., $f_m^{p^m}$ g. Since $P_p^{p^{2m}}$ is one-dimensional $F_{p^{2m}}$ -linear space and $P_p^{p^{2m}}$, $P_p^{p^{2m}}$, $P_p^{p^{2m}}$, $P_p^{p^{2m}}$. It is clear that $P_p^{p^{2m}}$ is $P_p^{p^{2m}}$.

Proposition 15 P_{2m} is an isomorphism.

Proof: It su ces to show that P $_{2m}$ is surjective. For (a_1, \ldots, a_{2m}) 2 F_p^{2m} , P_{2m} $(a_{1 1} + \ldots, a_{2m}) = (a_{1}, \ldots, a_{2m})$, where $_k$ is as in the previous k = 1 k = 1.

As in Section 32, the errore can be determined by a classical error-correcting algorithm for $(C^{p^m})^2$ from $(C^{p^m})^2$ from $(C^{p^m})^2$; ei.

5 Notes on the construction of codes with e - cient decoding algorithms

It is desirable to have a system atic construction of quantum codes with e cient decoding algorithm s. Calderbank et al. $[3, Section\ V\]$ showed a construction of cyclic linear quantum codes using the BCH bound for the minimum distance. With their construction we can correct errors up to the BCH bound using the Berlekam p-M assey algorithm.

If we use the Hartmann-Tzeng bound [7] or the restricted shift bound [13] then we get a better estimation of the minimum distance, and we can correct more errors using modiled versions of the Feng-Rao decoding algorithm in [13, Theorem 6.8 and Remark 6.12]. The algorithms [13, Theorem 6.8 and Remark 6.12] correct errors up to the Hartmann-Tzeng bound or the restricted shift bound.

We cannot construct good cyclic codes of arbitrary code length. So we have to often puncture a cyclic code as in [3, Theorem 6 b)] to get a quantum code with e cient decoding algorithms. In classical error correction, we correct errors of a punctured code by applying an error-and-erasure decoding algorithm for the original code to the received word. But there is no (classical) received word in quantum error correction. So we decode a quantum punctured code as follows: Let C 0 F n_q be a (classical) linear code, h^0_1 , ..., h^0_r the rows of a check matrix for C 0 , C the punctured code of C 0 obtained by discarding the rst coordinate, h_1 , ..., h_{r-1} the rows of a check matrix for C , and $0h_i$ the concatenation of 0 and 00 and 01 for 02. We can express 01 as

where a_{ij} 2 F $_q$ [14, Lem m a 10.1]. Suppose that an error = $(e_2; :::; e_n)$ 2 F $_q^n$ occurs and that we have the syndrom e s_1 = hh_1 ; ei, ..., s_{r-1} = hh_{r-1} ; ei. W e want to nd e from $s_1, ..., s_{r-1}$ using an error-and-erasure decoding algorithm for C 0 . We can nd $s_1^0, ..., s_r^0$ 2 F $_q$ such that

for i= 1, ..., r 1. Then there exists $e^0 = (e_1; :::; e_n)$ 2 F $_q^n$ such that

because the condition (7) in plies that $h0h_i$; $e^0i = s_i$ for i = 1, ..., r 1. If we apply an error-and-erasure decoding algorithm to the syndrom $e s_1^0, ..., s_r^0$ with the erasure in the rst coordinate, then we not e^0 .

Note that the algorithms [13, Theorem 6.8 and Remark 6.12] are error-only decoding algorithms but we can modify them to error-and-erasure algorithms along the same line as [16, Section VI].
