# The XXC M odels

## A bstract

A class of recently introduced $m$ ulti-states XX m odels is generalized to include a defor$m$ ation param eter. This corresponds to an additional nearest-neighbor C C interaction in the de ning quadratic ham iltonian. C om plete integrability of the one-dim ensionalm odels is show $n$ in the context of the quantum inverse scattering $m$ ethod. The new $R-m$ atrix is derived. The diagonalization of the XXC m odels is carried out using the algebraic Bethe A nsatz.

## 1 Introduction

M ulti－states bosonic H ubbard m odels which generalize the usual su（2） m odel were recently introduced．These models were shown to be integrable and to have an extended sym $m$ etry ［回，园，系］．They are built by coupling tw o copies ofX X free－ferm ions＇ m odels［4，［5，3］．These higher dim ensional＇rem ion＇m odels were not obtained as part of a quantum group structure．The quantum group approach to the construction of solutions to the Yang－B axter equation results in higher dim ensional models $w$ ith sym $m$ etries re ecting the root structure of the underlying algebra［6］．The combination low ering－raising operatons in the R m atrix generically involves all the roots of the algebra．T he free－ferm ions＇models are also higher dim ensional and they have sim ple expressions in term $s$ of the generators of the fundam ental representations of $s u(n)$ ． H ow ever they involve only a subset of the set of roots of $s u(n)$ ．T he diagonalization of the $m$ odels reveals an $s u(2)$ structure which does not correspond to the know $n$ integrable higher－ spin representations．

A $n$ integrable deform ation of the XX m odels is found and studied in this paper．For the lowest dim ensional model the XXC model is nothing but the usual su（2）XXZ model．The $R-m$ atrix for the higher dim ensionalm odels retains the form of the XXZ m odel and can be seen as a multistate generalization of the latter $m$ odel．The $m$ atrix is given and show $n$ to satisfy the Yang－B axter equation．Speci c representations are given．Integrability of the $m$ odels is a sim ple consequence of the quantum inverse scattering fram ew ork．T he sym $m$ etries of the new $m$ odels are obtained．D iagonalization of the XXC m odels using the algebraic Bethe A nsatz $m$ ethod show $s$ that their spectrum is highly degenerate，and is a generalization of the su（2） XXZ spectrum．I conclude w ith som e rem arks．

## 2 The XXC m odels

$C$ onsider a m atrix $R$ of the form

where is an arbitrary com plex param eter and is the spectral param eter．T he operators $P^{(i)}$ act on the tensor product of two copies of the sam e space $C^{n}$ ．They are taken to satisfy the algebra derived in［3］．Let $\mathrm{E}_{\mathrm{i}} \quad \mathrm{P}_{\text {ii＋}}{ }^{(3)}$ ，that is， $\mathrm{E}_{\mathrm{i}}$ acts non－trivially on the adjacent spaces i；i＋1．The de ning relations of the tree－ferm ions＇algebra $A$ are：

$w$ here $f A ; B g=A B+B A . T$ he fourth equation just expresses the fact that $E_{i}$ and $E_{j}$ com $m$ ute when they act non－trivially on disjoint spaces．The operators $P{ }^{(1)}$ and $P^{(2)}$ form a com plete set of pro jectors on the tensor product space $C^{n} \quad C^{n}$ ：

$w$ here $I$ is the identity operator．The operator $P^{(1)}$ is equal to the square of the operator $P{ }^{(3)}$ ， and $\mathrm{P}^{(2)} \mathrm{P}{ }^{(3)}=\mathrm{P}^{(3)} \mathrm{P}^{(2)}=0$ ．At $==2$ the m atrix（ $\mathbb{1}$ is equal to the m atrix found in B］．

O ne then checks that $R$ satis es the $Y$ ang－B axter equation

$w$ here the param eter is the sam e for all six factors．The argum ent of R will not be w ritten in what follow s．The calculation is straightforw ard if tedious．O ne can expand both sides of the

Y B E, use elem entary trigonom etric relations and the relations satis ed by the ${ }^{(i)}{ }^{\text {(i) }}$ 's to conclude. A ltematively, setting $q=e^{i}$ and $y=e^{i}$ and multiolying the $Y B E$ by 2igy, one can also verify that the YBE is satis ed for the six values $q=0 ; 1 ; i ; 1$. It is then enough to check that the coe cient of $q^{1}$ vanishes identically to conclude that the YBE is satis ed for all values of , and .

It is easy to check that the regularity and unitarity properties hold:

The rational lim it of $R$ is obtained by letting ! , dividing by $\sin$ and taking the lim it
! 0. These $m$ anipulations conserve all the properties of the $R \mathrm{~m}$ atrix. In particular, one obtains

Explicit representations of the foregoing algebra were given in 目]. Let $E$ be the $n n$ $m$ atrix w ith a one at row and colum $n$ and zeros otherw ise. Let $n, n_{1}$ and $n_{2}$ be three integers such that

The $n_{1} n_{2}$ param eters $x_{a}$ are anbitrary com plex num bers. Latin indices belong to $A$ while greek indices belong to $B$. These operators satisfy all the de ning relations of the algebra $A$. The restriction $n_{1} \quad n_{2}$ just avoids a double counting of distinct $m$ odels since one has the obvious sym m etry $A \$ B$. For $n_{1}=1, n_{2}=n \quad 1$, and all the $x_{a}$ equal to each other, one recovers the $\operatorname{su}(\mathrm{n}) \times \mathrm{XX}$ m odels found in 可]. A llow ing the tw ist param eters x to be unequal am ounts to a multiple deform ation of these $m$ odels.

It is possible to perform a gauge' transform ation which puts these m odels in a Tem perleyLieb form. O ne obtains

$R^{T L}()$ satis es the $Y$ ang-B axter equation.
$T$ he transfer $m$ atrix is the generating functional of the in nite set of conserved quantities. Its construction in the fram ew ork of the $Q$ uantum Inverse Scattering $M$ ethod is by now well known 7, 6, 9]. The Lax operator on a chain at site iw ith inhom ogeneity $i$ is given by:

$w$ here $P$ is the perm utation operator on $C^{n} \quad C^{n}$. Them onodrom y $m$ atrix is a product of Lax operators, $T()=L_{0 M}():: L_{01}()$, where $M$ is the num ber of sites on the chain and 0 is the auxiliary space. The transfer $m$ atrix is the trace of the $m$ onodrom $y m$ atrix over the auxiliary space 0: ( ) = $\operatorname{Tr}_{0}\left[\left(\mathrm{~L}_{0 \mathrm{M}}::: \mathrm{L}_{01}\right)()\right]$. A set of conserved quantities is then given by

The Y BE im plies the follow ing intertw ining relations for the elem ents of the $m$ onodrom y $m$ atrix:

Taking the trace over the auxiliary spaces, and using the cyclicity property of the trace, one obtains $[(1) ;(2)]=0$. The ham iltonians $H_{p}$ therefore $m$ utually com $m$ ute.

The quadratic ham iltonian calculated from (16) is equal to

Periodic boundary conditions are im plied. T hese ham iltonians can be w rilten sim ply in term $s$ of $s u(n)$ herm itian traceless $m$ atrices. For $\dot{x}_{a} j=1$ and real the ham iltonians are herm itian. The rational lim it yields: $H_{2}={ }^{P}{ }_{i}\left(P_{i i+1}^{(3)} \quad P_{i i+1}^{(2)}\right)$. It is possible to get a positive relative sign between $P{ }^{(3)}$ and $P^{(2)}$; one lets ! + , and takes the rational lim it for the rational ham iltonian.

For all the representations of the operators $P{ }^{\text {(i) }}$ given above one can introduce the bonjugation' m atrix 目]

and verify that $P^{(2)}=\frac{1}{2}(I+C \quad C)$. D ropping the part proportional to the identity in 18$)$ gives the quadratic XXC ham iltonian. For $n=2$ this is nothing but the XXZ m odel for su (2).

For all the param eters equal to one param eter, $x_{a}=x ; 8 a 2 A ; 82 B$, the linear $m$ agnetic- eld operators

com $m$ ute $w$ ith the transfer $m$ atrix. T he proof of 3$]$ still holds. The full local sym $m$ etry is su ( $n_{1}$ ) su( $n_{2}$ ) $u(1)$. O ne consequence is that one can add $m$ agnetic- eld term $s$ for each sym $m$ etry generators, $w$ thout spoiling the integrability of the $m$ odels.

## 3 A lgeb raic B ethe A nsatz

The diagonalization by algebraic Bethe A nsatz of the XXC m odels is sim ilar to the one for the X X m odels. W e refer the reader to $\mathbf{3}^{3}$, 目] for details and give here the results. I am considering the case $\mathrm{x}_{\mathrm{a}}=\mathrm{x}$ to avoid unessential com plications which are peculiar to the higher dim ensional models ( $n$ 3).
 A set of B ethe A nsatz eigenvectors is then obtained from the action of certain elem ents of the $m$ onodrom $y m$ atrix, the $C \quad T_{1}$, and is given by:
where the param eters $i$ and the coe cients $F$ are to be determ ined. This A nsatz also van ishes identically if $p>M$; the proof of this fact is sim ilar to that of (3].

O ne then applies the transfer $m$ atrix on the state $j_{1} ;::: ; p^{i}$ and $w$ ith the help of relations (17) com m utes it through the C 's. The corresponding eigenvalues of ( ) are

Here $\left(n_{2} ;\right.$ ol is an eigenvalue of the unit-shift operator ${ }^{\left(n_{2} \text { ip }\right)}$, for a chain of $p$ sites and $n_{2}$ possible states at each site. The coe cients $F$ pi::i; 1 are such $F$ is an eigenvector of ${ }^{\left(n_{2} ; D\right)}$ for the eigenvalue ${ }^{\left(n_{2} ; \mathbb{D}\right)}$. Finally the B ethe A nsatz equations are just
$N$ ote that these equations im ply the vanishing of the residues of $\left(\left(n_{1} ; n_{2}\right) ; M\right)(; f \quad i g)$ at the $j^{\prime}$ s.
The operator ${ }^{\left(n_{2} \mathbb{F P}^{2}\right)}$ can be written as a product of disjoint perm utation cycles. O ne also has $\left(n_{2} ; p\right)^{p}=$ I. The eigenvalues $\left(n_{2} ; p\right)$ are then $q^{\text {th }}$ roots of unity, where $q$ is a divisor of $p$, and are highly degenerate. T he degeneracy of an eigenvalue depends on $p$ and $n_{2}$.

O ne can perform the above diagonalization procedure over the pseudo-vacuum j̈ai (a 1). $T$ he set of eigenvalues is exactly the sam e as the one found above and the eigenvectors have the sam e structure but form a completely distinct set, at least for $0 \quad \mathrm{p}<\mathrm{M}$. O ne can also start w ith any of the vectors $j \vec{j}$ i, 2 B and obtain yet other sets of eigenvectors. The superscript $n_{2}$ is replaced by $n_{1}$ in (22), ( $n_{2}$ ip) and ( $n_{2}$;D). These features re ect a large degeneracy of the spectrum .

The rational lim it is obtained by letting ! , i ! i, dividing the eigenvalue (22) by $(\sin )^{\mathrm{M}}$ and taking the $\lim$ it $\quad 0$. For $==2$ the above results reduce to those of [ $\sqrt{2}$. For arbitrary the eigenvalues and the B ethe A nsatz equations have the form of those of the
 the unit-shift operator by algebraic B ethe A nsatz, since this operator appears system atically as one of the conserved quantities for all the su ( $n$ ) XXZ spin-chains. This re ects the underlying sym $m$ etry seen above.

A detailed study of the spectrum is desirable. In particular, the them odynam ic lim it of the spectrum would shed some light on the di erences between the XXZ spectrum and the XXC one. Taking the logarithm of the B ethe A nsatz equations show $s$ that the distribution of integers characterizing the solutions w ill get a contribution from the ${ }_{\left(n_{2} \text { ip }\right)}$ correction. This may result in a denser spectrum. W hether this in uences the central charge and the conform al weights rem ains to be clari ed.

A feature of the m odels w ith $n$ 3, is the term $p m$ in the expression of the eigenvalues. This seem $s$ to im ply a jum $p$ in the spectrum of (). H ow ever note that, because of the de nition of the conserved quantities, the ham ittonians $H_{1} ;::: ; H_{M}$ are not a ected by this term. For vanishing inhom ogeneities, the $M^{\text {th }}$ power of the eigenvalues of $(0)=(\sin )^{M}$ is equal to one because one has the unit-shift operator for $M$ sites and $n$ states; one can verify that the $M$ th pow er of the eigenvalues (22) is equal to one, after using equations 23). The eigenvalues of $\mathrm{H}_{2}$
(at $i=0$ ) for the trigonom etric and rational cases are equal to

Finally, for $=2+i k, k 2 \mathrm{Z}$, the decorated YBE is not satis ed and it is not possible to couple, a la Shastry [4, 3], tw o X X C copies for generic values of.
