# C oupled nonlinear Sch rodinger equations with cubic-quintic non linearity : Integrability and soliton interaction in non $K$ err m edia

#### Abstract

W e propose an integrable system of coupled nonlinear Schrodinger equations w ith cubic-quintic term sdescribing the ects ofquintic non linearity on the ultra-short opticalsoliton pulse propagation in non-Kerr media. Lax pair, conserved quantities and exact soliton solutions for the proposed integrablem odelare given. Explicit form oftw o-solitons are used to study soliton interaction show ing $m$ any intriguing features including inelastic (shape changing) scattering. A nother novel system of coupled equations w ith th-degree nonlinearity is derived, which represents vector generalization of the known chiral-soliton bearing system.


## I. IN TRODUCTION

O ptical solitons have prom ising potential to becom e principal carriers in telecom $m$ unication due to their capability of propagating long distances w thout attenuation and changing their shapes [1] 1414.1 is being paid theoretically and experim entally to analyse the dynam ics of optical solitons in optical waveguides (for exam ple silica bers) under di erent contexts $\left[\left.\begin{array}{ll}1 \\ 1\end{array} \right\rvert\, \frac{1}{6}\right]$. Such investigations are helpfill for realizing optical soliton applications, particularly in soliton-based optical oom m unication system s [ waveguides used in such optical system s are usually of $K$ err type [7] . C onsequently the dynam ics of light pulses are described by the nonlinear Schrodinger ( $\mathbb{N} L S$ ) fam ily of equations $w$ ith cubic nonlinear term $s$ [17 1 intensity of the incident light eld becom es stronger, non-Kerr nonlinearity e ect com es into play and due to this additionale ect, the physical features and the stability of N LS soliton can change $\bar{\beta}_{1}^{1} 1$.
$T$ he way through which non $K$ err nonlinearity in uences NLS soliton propagation is described by the NLS fam ily of equations w ith higher-degree nonlinear term s $[\underline{d}[1][$. Therefore investigations on these evolution equations becom $e$ im portant from a theoretical point of view. P articularly this im portance has received a boost after the experim ental
 for describing the non $K$ erre ects are not com pletely integrable and can not be solved exactly by the inverse scattering transform m ethod. In such non-integrable system s , therefore, the details of soliton-interaction during collision can not be described exactly and hence are still open to debate. H ow ever, num erical stim ulations [1] [1] show that even the slightest change from the $K$ err nonlinearity results in the two solitons annihilating each other, merging or creating $m$ any new solitons, depending on the initialinclination of the tw o solitons and their shapes. But besides the im portant problem of com puter tim e, the num erical approach is not very appealing in the sense that it is not a sim ple task to get physical insight from purely num erical experim ents. T he idea therefore is to use approxim ate analyticalm ethods
 treating the quintic nonlinear term s due to non $-K$ erre ect as perturbations of the cubic $N$ LS equations, i.e. restricting the e ects of quintic nonlinearity to be less predom inant than the cubic term $s$, the $N L S$ equations are studied both analytically and num erically in

In this paper we have obtained for the rst time (to our know ledge) an integrable system of coupled NLS equations including cubic-quintic tem s describing the e ects of quintic nonlinearity with arbitrary coupling, which generalizes the coupled hybrid N LS equationsw ith cubic nonlinearity [2] are derived for the proposed integrablem odel. W e also nd exact soliton solutions for ourm odeland using the explicit form of the tw o-soliton solution we study the associated soliton collision. A rem arkable interrelation betw een the new ly proposed integrable $m$ odel and the celebrated $M$ anakov $m$ odel $\left.{ }_{2} \overline{2}_{2}^{1}\right]$ helps to use the recently discovered general tw $0-$ soliton solution of the later $m$ odel [2]3. This reveals the fascinating occurrence of shape changing inelastic soliton collision also in the present $m$ odel, in addition to some other interesting features. $W$ e believe that such a study using higher-order solitons ( $m$ ultisolitons) becom es im portant in the light of the proposalby $H$ asegaw a and $N$ yu [24] regarding "eigenvalue com $m$ unication", in which the inform ation $m$ ay be transm itted by higher-order solitons and a recent one sugested by Jakubow ski, Steiglitz and Squiev ["- [-] on nontrivial inform ation transm ission system, which uses the $m$ ore general tw o-soliton solution of the $M$ anakov system [2"] derived by $R$ adhakrishnan, Lakshm anan and

H ietarinta in [2]. W e also nd that the $H$ am ittonian of the present integrablem odel is associated with a non-canonical P oisson bracket (P B ) structure. H ow ever, using the sam e H am iltonian w ith canonicalP B relations we derive another coupled system $w$ ith quintic nonlinearirity, which $m$ ay be transform ed to a vector generalization of the chiral-solitonic m odel of A glietti et al [3]in'].

The plan of our paper is as follow s. The basic evolution equation $w$ ith cubic-quintic nonlinearity which describes the soliton evolution in non-K errm edia w ith parabolic nonlinearity is discussed in Sec-II. Sections III is devoted to the proposed $m$ odeland presents its integrability property by explicit construction of the Lax pair as well as the hierarchy of conserved quantities generated through a recurrence relation, which in tum is derived from a coupled R icatti equation using the Lax operator. Sec IV gives the exact soliton solution for our cubic-quintic nonlinear evolution equation and using the explicit analytic solution we study here the collision process of solitons so as to understand the in uence of quintic nonlinear e ects on the $M$ anakov $m$ odel. Section $V$ establishes the interrelation and gauge transform ation betw een our system and the $M$ anakov $m$ odel including the anyon-like nonultralocalP B for ourm odel. Sec V I presents a vector generalization of the chiral soliton bearing system starting from the sam e H am iltonian and discusses som e of its interesting features. Sec V II gives concluding rem arks.

## II. BASIC EVOLUTION EQUATIONS

G enerally when high opticalintensities (orm aterialsw ith high nonlinear coe cients even at m oderate opticalintensities, for exam ple sem iconductor doped glasses, organic polym ers, thin liquid lled capillaries, etc.) are considered, it is necessary to take into account higher pow er nonlinearities arising from an expansion of the refractive index in powers of intensity $I$ of the light pulse : $n=n_{0}+n_{2} I+n_{4} I^{2}+:: ;$ where $n_{0}$ is the linear refractive index coe cient and $n_{2} ; \mathrm{n}_{4}::$; are nonlinear refractive index coe cients [

where $e$ is a unit vector in the direction of w ave polarisation, $R(r)$ describes the transverse eld $m$ odes, in which $r$ is a two dim ensional vector in the $x-y$ plane and $A(z ; t)$ is a slow ly varying am plitude. H ere we assum e that $R(r)$, which is $m$ ainly de ned by the linear e ects, corresponds to the $m$ odal distribution of the fundam ental ber $m$ ode $\mathrm{H}_{\mathrm{E}}$ 11, for sim plicity. Then from the equations (1) and (2), assum ing the tem poral dispersion of the dielectric perm itivity to be sm all, using the slow ly varying envelope approxim ation and follow ing the procedure in section 2.1 of [8ind, the follw ing nonlinear partial di erential equation for A ( $z ; t$ ) can be obtained,

Equation (4) describes the e ects of quintic nonlinear term sproportional to the real param eters and 3 on the dynam ics of pulse envelope allow ing self-phase m odulation and higher-order linear and nonlinear dispersions. For pulse w idths greater than 100 fs, one can neglect the last three term sof (4) and the resulting equation is a wellstudied $[\overrightarrow{3}[1][]$ sim ple norm alized NLS equation w ith cubicquintic nonlinear term s . Further the system (4) is a special case of the dynam icalequation considered for the ber system w th saturating nonlinearity [12 ${ }_{1}^{\prime \prime}$.

It is of further interest to extend the above analysis to include m ultim ode e ects. For this purpose, there are several ways to generalize equation (4) to a set of coupled equations depending on the physical situations. A fairly general form of coupled nonlinear Schrodinger (CNLS) equation with cubic-quintic nonlinearity is

There is a large am ount of theoretical work [1] [1] devoted to the CNLS fam ily of equations with cubic nonlinearity. H ow ever, to the know ledge of the authors, to date the CNLS equationsw ith non-K err nonlinearity have received very little attention in the literature, particularly in connection w ith the integrability aspects. In the follow ing sections, by identifying one such integrable nonlinear evolution equation, we derive the two-soliton solution so as to get som e idea about soliton interaction in non-K errm edia.

## III. IN TEGRABILITY PROPERTYOFTHEPROPOSED MODEL:LAX PA R AND CONSERVED QUANTITIES

It is evident that eq. (5) does not exhibit the explicit rotational sym m etry in the intemal space spanned by the vector ( $q_{1} ; q_{2}$ ): H ow ever, for $B=1$ such a sym $m$ etry is restored. Integrable system s , as is well know n , possess in nite num ber of conserved quantities in involution, of which usually the low er ones are of physical im portance. Explicit form $s$ of such conserved quantities for the integrable system (9, can be derived from a recurrence relation obtained from the $R$ icatti equation related to the Lax operator. ## IV．EXACT SOLITON SOLUTIONSAND SCATTERINGOFSOLITONS IN THE GENERALIZED MANAKOV MODELIN NONKERR MEDIA

T he proposed system $(\underline{\bar{g}})$ w ith quintic nonlinearity allow s exact $N$－soliton solutions，which can be found for exam ple by H irota＇s $m$ ethod follow ing the sam e procedure as in the M anakov m odel． H ow ever a m ore direct and convenient way is to use the know $n$ solutions of the $M$ anakov $m$ odel $\left(\overline{T_{1}}\right)$ them selves for constructing the soliton solutions of（ $(\underline{q})$ ． $T$ his is possible due to the interrelation betw een these $t w o m$ odels，which $w$ illbe established in the next section．T hus we nd the explicit 1－soliton solution of $(\underset{\substack{9}}{(\underline{)}}$ ）in the form

together with a constant phase．Com paring with the $M$ anakov soliton we see that there is an interesting phase change in the carrier wave．The plane wave like character in the $M$ anakov $m$ odel has been deform ed into a wave su ering com pression and rari cation of the phases in a kink－like pro le（see F ig． $1 \mathrm{a}, \mathrm{b}$ ）．This show sthat the e ect of quintic nonlinearity of our m odel appears in the soliton phases and therefore in the derivatives of the soliton pro le $q_{a x} ; G_{a t} ;$ which $m$ ust also change the $m$ om entum and energy of the soliton．

N ow exploiting the higher－soliton solutions of the $M$ anakov $m$ odel it is also possible to nd higher－solitons for（ $\overline{1}$ ）
 understand the soliton collision in birerefringent ber．How ever the im portance of nding higher－soliton solutions in
explicit form has been understood only quite recently of the integrable $M$ anakov $m$ odel, tw o of the authors $\left(\mathbb{R} R\right.$ and $M L$ ) and $H$ ietarinta $\left.\left[{ }^{2}\right]_{1}^{1}\right]$ have show $n$ that the soliton in birefringent ber can in general change its shape after interaction due to an intensity redistribution am ong the $m$ odes, eventhough the total intensity rem ains conserved. This shape changing collision arising essentially due to the change in polarisation angle helps to realise the exciting possibility of sw itching betw een com ponents. (H ow ever, the standard shape-preserving collision property of the (1+1) dim ensionalsoliton system is recoverd, when restrictions are
 concept, Jakubow ski, Steig]itz and Squier [25] have designed sequences of solitons operating on other sequences of soltons that e ect logic operations and suggested nontrivial in form ation transform ation system .

N ow in order to investigate the im plication ofthis property ofsoliton when the additionalcubic and quintic nonlinear term s are included, we construct the tw o-soliton solution of the system $(\underline{\overline{9}})$ and expect again a non-trivial change in the soliton phase as in the case of 1-soliton solution. Such a two-soliton solution expressed com pactly through that of the $M$ anakov system $\left(\underline{I}_{1}\right)$ ( $q_{1}$; $\Phi_{M}$ ) takes the form (see eq. (24) below)
where a general tw o-soliton solution [23] of the $M$ anakov $m$ odel is given by

 and $k_{2}$ determ ine the am plitude, velocity and phase of the asym ptotic soliton. A swe have detected already, we see also here that the two-soliton solution (19) of $\overline{(\underline{q})}$ ) di ers from that of the $M$ anakov $m$ odel in phase-term $s$ in a nontrivial way. C learly, the phase change depends on the values of the real free param eters $1 ; 2$; 1 and 2 ; and vanishes for the trivial choioe giving back the $M$ anakov soliton. A natural question therefore arises: D oes this change in phase of ( $q_{1} ; q_{2}$ ) for non-zero values of $1 ; 2 ; 1$ and $2 ;$ which in tum accounts for the e ect of the quintic term $s$ in ( $\overline{\underline{I}})$, $m$ ake any qualitative change in the behaviour of soliton collision? T his can be directly studied using the two-soliton solution (19-20) parallel to the procedure of the $M$ anakov $m$ odel given in Ref. [2]]. In order to answer the above question, we have plotted pictures of soliton collision corresponding to the function (jint ; jipt f) instead
 the e ect of phase term $s$ are re ected. For com paring $w$ th the pure $M$ anakov $m$ odel let us consider rst the case
 values $\mathrm{k}_{1}=1: 5+\mathrm{i} 0: 5 ; \mathrm{k}_{2}=2: 0 \quad \mathrm{i} 0: 7,1=1=2=1$, and $2=\frac{(39+\mathrm{i} 80)}{89}$. At $\mathrm{z}=7$, we have tw 0 well seperated asym ptotic pro les as shown in Fig. 2a. D uring the propagation, these two solitary pro les interact with each other as shown in F ig. 3 and change form after interaction. For exam ple, at $\mathrm{z}=+7$ they have the pro les as shown in $F$ ig. 2b. The change in shape disappears if we apply the elastic collision (shape-preserving collision) condition, nam ely $1: 2=1: 2$ by follow ing the work of [23]. In Figs. 2-3, as mentioned, there is a splitting in each of the asym ptotic pro les which appear before and after interaction. This happens due to the follow ing reason. In the case corresponding to the $M$ anakov $m$ odel one obtains

From (21) one can note that for suitable choice of the param eters $\mathrm{k}_{\mathrm{nR}}$ and $\mathrm{k}_{\mathrm{nI}}$, the solitary w aves get peaked around two values as show n in F igs. 2-3.

N ow to investigate thee ect ofnon-zero values of $1 ; 2 ; 1$ and 2 or in otherw ords to see the nontrivialcontributions due to cubic-quintic generalization $(\underline{\underline{g}})$, we evaluate $q_{j t}=\left[q_{j M} t+i q_{j M} j_{j t}\right] \exp \left(i_{j}\right)$; $j=1 ; 2$ : and plot the asym ptotic behavior of the tw o-soliton solution (19) to the quintic generalization of the $M$ anakov $m$ odel Eq. ( $\mathbf{c}_{1}$ ) in $F$ igs. 4a,b. The corresponding interaction pro le of the soltons during their propagation is shown in $F$ ig. 5. W e observe rstly that, as in the case of $M$ anakov $m$ odel, here also generically the fascinating shape changing inelastic collision persists. H ow ever, in this case one can overcom e the splitting e ect off igs. 2-3 corresponding to the $M$ anakov
model. For exam ple, if we set $1_{2}=2=1=2=1$, in (19) then the splitting of solitons disappear, as evident from Figs. 4-5. T he reason for this is that now we have
where 1 and 2 are equalto 1 and 2 for $j=1$, while to 1 and 2 for $j=2$. Since here the second term dom inates over the rst in the region of splitting, the splitting e ect naturally gets supressed. C om paring Figs. 3 and 5 it
 our generalized $m$ odel is $m$ uch higher than that for (20) corresponding to the $M$ anakov $m$ odel. The above processes vividly dem onstrate the nontriviale ect of the additional term $S$ involving param eters $1,2,1$ and 2 appearing in Eq. ( $\underline{\underline{I}}_{1}$ ).

## V.RELATION W ITH THEMANAKOVMODEL

A swe have m entioned above there exists an interesting interrelation betw een the quintic generalization (9) and the M anakov m odel $\left(\bar{I}_{1}\right)$, which in fact we have used already in deriving the soliton solutions of $(\overline{\underline{-1}})$. We establish now this relationship by show ing that the Lax operators of these tw o m odels are related through a local gauge transform ation [29]\{31], while the elds are connected by a nonlinear transform ation in dependent variables.

It is known [32].] that under a gauge transform ation of the Jost function ${ }^{\circ}=g$ with the gauge eld $g 2 U$ (3), the Lax operators transform as

$w$ ith its elem ents $1 ; 2$ being the sam efunctions of $z$ and $t$ as in Eq. (11c) and perform ing the transform ation (2in), one can conveniently rem ove the diagonal term $s$ involving $1 t$; $2 t$ and $1 z ; 2 z$ in the Lax pair ( $11 \mathrm{a}, \mathrm{b}$ ). It can be observed further that the resultant gauge transform ed Lax operators reduce exactly to those of the M anakov m odel

along with their conjugates. At the sam e tim e transform ation (24) reduces the equations ${ }_{(1)}^{(9)}$ ) to those of the $M$ anakov m odel (7기).

The above points establish the relationship betw een these $m$ odels and justi es the form of soliton solution presented in the earlier section for the $m$ odel $(\underline{\underline{q}} \overline{(1)})$. M oreover, this procedure also provides an altemative proof of the integrabilly of ourm odel. It is im portant to note that under such gauge transform ation the $P$ oisson bracket structure of the elds
 through the $M$ anakov elds and assum ing standard canonical relation (2G) for the $M$ anakov $m$ odel, we can derive the anyon-like relations for the elds of ( $\overline{\underline{\prime}} \overline{)}$ ):

N ote that at $x=y$ the elds exhibit canonical property, while at $x \in y$ their behavior is nonultralocal and $m$ im ics anyon-like properties $\overline{1} \overline{1} \overline{1}]_{1}^{1}$ in the classical lim it. It $m$ ay be rem arked here that the generalized $M$ anakov equation (9) can be derived directly from the $H$ am iltonian (17) by carefulapplication of the PB structure (25) and the relation $@_{x}\left(\begin{array}{ll}x & y\end{array}\right)=\left(\begin{array}{ll}x & y\end{array}\right)$.
 other hand if nevertheless one considers them to be canonical, i.e.

from the sam e $H$ am iltonian ([1] $\overline{1})$ ) we can derive com pletely di erent coupled equations $w$ th fth-degree nonlinearity. If for sim plicity we assum e $1=2=1=2=0$, we can derive these equations easily from $C_{3}$ as
and sim ilarly for $q_{2}$ by interchanging the indices $1 \$ 2$ in $\left(2 \overline{7}_{1}\right)$. We notice that this system of coupled equations again w ith cubic-quintic nonlinearity is a new system which is di erent from Eq. (傗) presented earlier. To anlyse these equations m ore closely we perform again a nonlinear variable change as $q_{b}!Q_{a}=q_{G} e^{i}{ }_{0} \quad w$ ith $t=N$
 form w ith only cubic nonlinearity:

where we have denoted $j=j_{1}+j_{2} i_{a}=i\left(Q_{a} Q_{a t} \quad Q_{a} Q_{a t}\right): W$ e immediately recognize that this is nothing but the vector generalization of the A gliettiet alequation [B3], how everw ith the addition of a cubic nonlinearity com ing from the $M$ anakov $m$ odel. $N$ evertheless the system (28) show sem arkable property close to the chiral-soliton feature of [331]. In particular assum ing the 1-soliton form as $Q_{a}=A_{a} S(t \quad v z) e^{i\left(\frac{v}{2} t+!z\right)}$ onem ay conclude that here the quantity $=1+\mathrm{v} 0$ acts as the ective coupling constant of the nonlinear term, which regulates the intensity of the soliton. $T$ herefore for the soliton velocity $v>\frac{1}{0}$ only (w ith $0>0$ ) M anakov m odel like bright solitary wave solution can exist. W ith decreasing velocity the e ective coupling constant also decreases, which interestingly in uences the intensity of the soliton to increase and re ects a possible nonintegrable property of the $m$ odel. $F$ inally for the soliton velocity $\mathrm{v}=\frac{1}{0}$ the nonlinear term to sustain the soliton disappears and hence no such soliton can appear anym ore. H ow ever for the negative velocity below this value, $v<\frac{1}{0}$; the sign of ips and kink-like exact dark soliton can appear. For $0<0$ the whole picture reverts. This am azing solitonic feature evidently is a generalization of the chiral soliton property of [33]. due to the presence of $M$ anakov term as well as the $m$ ulti-com ponent nature and $m$ ay have im portant applications in nonlinear optics. T he suspected nonintegrable nature of this system and consequently the originalchiral-solitonic system [3]'] can be convincingly proved by show ing that the conserved quantities of the $m$ odel are not in involution (in particular using the canonicalbracket ( $\left.\overline{2} \overline{\sigma_{1}}\right)$ it can be show $n$ that $f_{C_{2}} ; \mathrm{c}_{3} g \in 0$ ). Therefore though this system possesses Lax pair and in nite conserved quantities, their noninvolutiveness spoils the integrability. $T$ he involution of the conserved quantities how ever is restored if we use the noncanonicalbracket (25) and this ensures the exact integrability of $(\underset{\substack{9\$}}{\bar{q}}\).

## V II. C O N C LU SIO N

W e have constructed the Lax pair of the proposed integrable CNLS equation $(\underset{-1}{(9)} \mathbf{~}) \mathrm{w}$ ith cubic-quintic nonlinearity goveming the soliton propagation in non $K$ errm edia, and using it generated the in nite set of its conserved quantities in explicit form. We also presented the exact one and two-soliton solutions of the $m$ odel using those of the well know M anakov m odel. It has been dem onstrated through the explicit tw o-soliton solution of the proposed m odel that the intensity of the t-derivative of soliton in the interaction region is $m u c h$ higher than that of the $M$ anakov $m$ odel. M oreover, the localized part of the tim e derivative of the $M$ anakov soliton gets splitted and peaks around tw o values as show $n$ in $F$ igs 2 and 3. H ow ever, such splitting can be suppressed in the generalized cubic-quintic equation $(\underline{g})$ having nonzero 's and 's as has been dem onstrated in Figs. 4 and 5. These gures also con m that the shape changing inelastic soliton collisions, as in the M anakov case, persist in our m odel. W e believe that our results w ill be found equally usefulin $m$ ore generalsituations like Eq. (5) by taking ourm odelas the unperturbed part and treating the rem aining term $s$ as perturbations.

W e have also established the relationship betw een the proposed $m$ odel and the $M$ anakov $m$ odel at the Lax pair level as well as at the eld solution level, which shows an intriguing change in the canonical structure, nam ely the bosonic relations of $M$ anakov $m$ odel transform $s$ into the anyonic relations of the present system .

A nother rem arkable fact is that assum ing the standard canonical structure for our elds we are able to derive from the sam e H am iltonian yet another coupled system with cubic-quintic nonlinearity. This novel model, which tums out to be nonintegrable, represents a vector generalization of gliettiet alm odel, fam ous for exhibiting chiral-soliton solutions. Such chiral-soliton property also prevails in the present vector case show ing fascinating properties of the solitons, like changing intensity with soliton velocity, vanishing of bright solitons and appearance of dark solitons below certain velocity etc. Such properties $m$ ay have im portant applications in nonlinear optical processes.
