## A NEW CLASS OF OPTICAL SOLITONS

## ABSTRACT

Existence of a new class of soliton solutions is shown for higher order non-linear Schrodinger equation, describing third order dispersion, K erre ect and stimulated R am an scattering. These new solutions have been obtained by invoking a group of nonlinear transform ations acting on localised stable solutions. Stability of the solutions has been studied for dierent values of the arbitrary coe cient, involved in the recursion relation and consequently, dierent values of coe cient lead to dierent transmission rate for almost same input power. A nother series solution containing even powers of localised stable solution is shown to exist for higher order nonlinear schrodinger equation.

Theoretical prediction of H asew aga and Tappert that an optical pulse in a dielectric bre forms an envelop soliton [1] and subsequent experimental veri—cation by M ollenauer [2] have made a signicant acheivement in ultra-high speed telecommunication. Contrarary to conventional optical pules, solitonic optical pulses are dispersion less, which makes them so important for long distance communication. Optical solitons are currently under intense study not only for providing distortsion less signal transmission, but also for many nonlinear optical applications in bre.

Nonlinear Schrodinger equation (NLS) and their various higher order gener-

alizations play a pivotal role in describing the dynam ics of optical solitons. The successful propagation of NLS solitons for long distance transm ission eventually turns out to be limited to a few kilometers [2]. This is due to the fact that solitons, which follow the dynamics of NLS cannot take care of propagation loss, as it propagates along the optical bre and consequently the pulse needs to be reshaped time to time to compensate propagation loss. As a remedy, at present, a Raman pump light is used to send a signal simultaneously along the bre to adjust the propagation loss [3, 4]. This is acheived by utilizing the e ect of stimulated Raman scattering. It is seen later [5, 6, 7] that the e ect of stimulated Raman scattering already exists withing the spectra of soliton solutions, if we include a few more terms in the equation of motion over NLS. No additional pump light is needed in the later case to adjust the propagation loss. The equation of motion, thus obtained, is called higher order nonlinear Schrodinger equation (HNLS):

 $@_z E = i[_1@ E + _2 \not E \not f E] + [_3@ E + _4@ (\not E \not f E) + _5@ (\not E \not f) E]$  (1) where, E is envelop of electric eld propagating in z direction at a time . Notice that in absence of last three terms, (1) reduces to NLS. The coe cients of the higher order terms, namely \_3, \_4 and \_5 respectively represent third order dispersion (FOD), self-steeping (SS) related to Kerre ect and the self frequency shifting via stimulated Raman scattering. It is the last term, which plays an important role in the propagation of distortsion less optical pulses over long distance. On the other hand, for ultra-short pulses, the e ects of last three

term s cannot be neglected.

Several attempts are made to nd the soliton solutions of HNLS (1) [, 8-12] by various methods like Hirota's bilinear method, Painleve analysis, Backlund transformation, inverse scattering technique. Recently, HNLS is solved for soliton solutions by inverse scattering technique method for an arbitrary value of the one cients [13], where it is convenient to solve a gauge equivalent equation,

The equations (1) and (2) are related explicitely through the following gauge transformation:

One solution, found by inverse scattering method, may be given by [13]

where, n is dimension of the Lax operator and the location of the simple pole is chosen at  $=\frac{1}{2}($  + i ) in the complex spectral parameter plane, and being real parameters. Simple sech type structure of one soliton in (4) is quite interesting, since it m ay be obtained from the output of a mode locked laser. N soliton solutions is obtained for a more a general dynamical equation in [14].

In this paper, we discuss a new class of solution of (1). For this, let us assume a trial solution of (1) in the form

where land m are real parameters and y() is chosen as a real function. Substituting (5) in (1), we obtain a set of two dierential equations in y:

Notice that (6) leads a solution of the form

sech type solution of (6) is a desired one, as it has been obtained earlier [13] by inverse scattering method (4). In this paper, however, we look for a more general solution of the form

Substituting (12) into (6), we obtain

Unfortunately, nontrivial values of  $C_0$  lead only to trivial solutions of (6) consistent with the conditions (12). Thus  $C_0=0$  is an acceptible solution and consequently the recursion relation among the coe cients  $C_j$  m ay be given by

for j=0;1;2;3; . If we now choose arbitrary, all the even coe cients become trivial

whereas odd coe cients satisfy a recursion relation

provided the coe cients satisfy the conditions (12), which is not surprising, as we will see  $y = \text{sech}(E_0)$  itself is a special solution of (12). It is interesting to observe from the recursion relation (15) that if the arbitrary coe cient C  $_1$  is chosen to be unity all higher order coe cients starting from C  $_3$  become zero and the series leaves with one term,  $y = \text{sech}(E_0)$ . Thus the solution (10) already exists as a special case in (12) for nontrivial odd coe cients. Notice that a similar solution also exists for NLS [15].

Let us we now introduce an operatorial notation for the series solution (12) as

i.e. the coe cients satisfy the recursion relations (14) and (15). It em erges from (16) and the recursion relations that

im plying that fH  $_{C_1}$ ;  $C_1 \in Og$  is the com m utative multiplicative group of nonlinear transform ation (GNT). Thus, like NLS, the com m utative group of nonlinear transform ations for HNLS also leads to a new solution by operating on stationary localised solutions. The advantage of GNT m ethod is that it enables us to

determ ine the stability of the new solution by the following relation

The main motivation in obtaining new type of solutions by GNT method is to increase the transmission rate. It is observed in NLS that higher values of the coe cient C <sub>1</sub> gives rise to higher transmission rate for almost the same input power [15]. Interestingly, the new form of solutions (14) and (15) also assert the same conclusion for HNLS with an added advanatge that HNLS takes care of propagation loss, unlike NLS.

Let us present another interesting solution for  ${\tt H\,N\,L\,S}$ , which emerges from the recursion relation (14). If we choose  ${\tt C\,2}$  arbitrary and impose the condition that

whereas even coe cients will satisfy a recursion relation, given by

To conclude, a new class of soliton solutions are obtained for HNLS. This is found by invoking a group of nonlinear transform ations acting on a stable

localised solution. It turns out that the new solution reduces to the most stable one for  $C_1 = 1$ . For higher values of  $C_1$ , however, it leads to a faster rate of propagation for an almost same input power. This ,indeed, is a considerable improvement in the eld of all optical communication through bre. The existence of another solution of HNLS, where allodd coe cients are trivial, also earns a lot of interest and needs to be investigated more thoroughly. It is quite useful to see the consequences of the even series solution in the context of bre communication.
