

LINEAR WEINGARTEN FACTORABLE SURFACES IN ISOTROPIC SPACES

Abstract. In this paper, we deal with the linear Weingarten factorable surfaces in the isotropic 3-space \mathbb{I}^3 satisfying the relation $aK + bH = c$, where K is the relative curvature and H the isotropic mean curvature, $a, b, c \in \mathbb{R}$. We obtain a complete classification for such surfaces in \mathbb{I}^3 . As a further study, we classify all graph surfaces in \mathbb{I}^3 satisfying the relation $K = H^2$, which is the equality case of the famous Euler inequality for surfaces in a Euclidean space.

Keywords: Isotropic space; factorable surface; Weingarten surface; Euler inequality.

1 Introduction

Let M^2 be a regular surface of a Euclidean 3-space \mathbb{R}^3 and κ_1, κ_2 principal curvatures of M^2 . A surface M^2 in \mathbb{R}^3 is called a *Weingarten surface* (*W-surface*) if it satisfies the following non-trivial functional relation

$$\phi(\kappa_1, \kappa_2) = 0 \tag{1.1}$$

for a smooth function ϕ of two variables. (1.1) immediately yields

$$\delta(K, H) = 0, \tag{1.2}$$

where K and H are respectively the Gaussian and mean curvatures of M^2 .

(1.2) is equivalent to the vanishing of the corresponding Jacobian determinant, i.e. $|\partial(K, H) / \partial(u, v)| = 0$ for a coordinate pair (u, v) on M^2 .

If M^2 is a surface in \mathbb{R}^3 verifying the following relation

$$aH + bK = c, \quad a, b, c \in \mathbb{R}, \quad (a, b, c) \neq (0, 0, 0), \tag{1.3}$$

then it is called a *linear Weingarten surface* (*LW-surface*). If $a = 0$ or $b = 0$ in (1.3), then the LW-surfaces reduce to the ones with constant curvature. Many geometers extensively have studied such surfaces, see [8, 10, 17], [19]-[21], [37].

On the other hand, let M^2 be a graph surface of a smooth function $z = z(x, y)$. If $z(x, y) = f(x)g(y)$, then M^2 is called a *factorable surface* or *homothetical surface*. For geometric results on these surfaces in ambient spaces, see [1]-[4], [11, 14, 22, 35, 36].

Most recently, the first author and M. Ergut [1] classified the factorable surfaces with constant relative and constant isotropic mean curvature in the

isotropic 3-space \mathbb{I}^3 which has been introduced by K. Strubecker [34] and H. Sachs [31, 32].

Several classes of surfaces in \mathbb{I}^3 have been studied by I. Kamenarovic ([15]), B. Pavkovic ([28]), Z. M. Sipus ([33]) and M.K. Karacan and et al. ([16]).

The main goal of this paper is to study LW-factorable surfaces in \mathbb{I}^3 . In the present paper, we provide a classification for the LW-factorable surfaces in \mathbb{I}^3 . As a further study, we classify the graph surfaces in \mathbb{I}^3 satisfying the relation $K = H^2$.

2 Preliminaries

The isotropic 3-space \mathbb{I}^3 is a Cayley–Klein space defined from a 3-dimensional projective space $P(\mathbb{R}^3)$ with the absolute figure which is an ordered triple (ω, f_1, f_2) , where ω is a plane in $P(\mathbb{R}^3)$ and f_1, f_2 are two complex-conjugate straight lines in ω . For more details, we refer [5, 7, 9, 27, 29, 30, 32]

The homogeneous coordinates in $P(\mathbb{R}^3)$ are introduced in such a way that the *absolute plane* ω is given by $X_0 = 0$ and the *absolute lines* f_1, f_2 by $X_0 = X_1 + iX_2 = 0$, $X_0 = X_1 - iX_2 = 0$. The intersection point $F(0 : 0 : 0 : 1)$ of these two lines is called the *absolute point*. Affine coordinates in $P(\mathbb{R}^3)$ are given by

$$x_1 = \frac{X_1}{X_0}, \quad x_2 = \frac{X_2}{X_0}, \quad x_3 = \frac{X_3}{X_0}.$$

Consider the points $x = (x_1, x_2, x_3)$ and $y = (y_1, y_2, y_3)$. *Isotropic distance* $d_{\mathbb{I}}(x, y)$ of two points x and y is defined as

$$d_{\mathbb{I}}(x, y) = (y_1 - x_1)^2 + (y_2 - x_2)^2.$$

The lines in x_3 -direction are called *isotropic lines*. The plane containing an isotropic line is called an *isotropic plane*. Other planes are *non-isotropic*.

Let M^2 be a graph surface in \mathbb{I}^3 corresponding to a smooth function $z = z(x, y)$ on a open domain $D \subseteq \mathbb{R}^2$. Then it is parameterized as follows

$$r : D \subseteq \mathbb{R}^2 \longrightarrow \mathbb{I}^3 : (x, y) \longmapsto (x, y, z(x, y)). \quad (2.1)$$

It follows from (2.1) that M^2 is an admissible surface immersed in \mathbb{I}^3 (i.e. without isotropic tangent planes). The reader can find a well bibliography for surfaces of \mathbb{I}^3 in [32].

The metric on M^2 induced from \mathbb{I}^3 is given by $g_* = dx^2 + dy^2$. This implies that M^2 is always flat with respect to the induced metric g_* . Thus its Laplacian is given by

$$\Delta = \frac{\partial^2}{\partial x^2} + \frac{\partial^2}{\partial y^2}.$$

The *relative curvature* K and the *isotropic mean curvature* H of M^2 are respectively defined by

$$K = z_{xx}z_{yy} - (z_{xy})^2 \quad (2.2)$$

and

$$H = \Delta z = \frac{z_{xx} + z_{yy}}{2}. \quad (2.3)$$

A surface is called *isotropic minimal* (resp. *isotropic flat*) if H (resp. K) vanishes.

3 LW-factorable surfaces in \mathbb{I}^3

Let M^2 be a factorable surface in \mathbb{I}^3 . Then it is a graph surface of a smooth function $z(x, y) = f(x)g(y)$. By (2.2) and (2.3), the relative and isotropic mean curvatures of M^2 respectively turn to

$$K = (f''f)(g''g) - (f')^2(g')^2 \quad (3.1)$$

and

$$2H = f''g + fg'', \quad (3.2)$$

where $f' = \frac{df}{dx}$ and $g' = \frac{dg}{dy}$, etc.

We mainly aim to classify the LW-factorable surfaces in \mathbb{I}^3 . For this, let M^2 be a LW-factorable surface in \mathbb{I}^3 satisfying the relation (1.3). Since at least one of a , b and c is nonzero in (1.3), without loss of generality, we may assume $b \neq 0$. By dividing both sides of (1.3) with b and putting $\frac{a}{b} = 2m_0$ and $\frac{c}{b} = n_0$, we write

$$2m_0H + K = n_0, \quad m_0, n_0 \in \mathbb{R}. \quad (3.3)$$

When $m_0 = 0$ in (3.3), M^2 becomes a factorable surface in \mathbb{I}^3 with $K = \text{const.}$, however, such surfaces were already classified in [1]. In our framework, it is meaningful to take $m_0 \neq 0$.

By (3.1) – (3.3), we get

$$(f''f)(g''g) - (f')^2(g')^2 + m_0(f''g + fg'') = n_0. \quad (3.4)$$

We have to distinguish some situations in order to solve (3.4).

Remark 3.1. *From now on, we use the notation c_i to denote nonzero constants and d_i to denote some constants, $i = 1, 2, 3, \dots$*

Case 1. $f(x) = f_0 \in \mathbb{R} - \{0\}$. By (3.4), we find

$$g(y) = \frac{n_0}{f_0 m_0} y^2 + d_1 y + d_2. \quad (3.5)$$

Similarly, it can be obtained from (3.4) that $f(x) = \frac{n_0}{g_0 m_0} x^2 + d_3 x + d_4$ when $g(y) = g_0 \in \mathbb{R} - \{0\}$.

Remark 3.2. *In Case 1 (i.e. in the case $f(x) = f_0$ or $g(y) = g_0$, $f_0, g_0 \in \mathbb{R} - \{0\}$), M^2 is an isotropic flat factorable surface in \mathbb{I}^3 with $H = \frac{n_0}{m_0}$.*

Case 2. Let f be a linear function, i.e. $f(x) = c_1x + d_5$. It follows from (3.4) that

$$-c_1^2(g')^2 + m_0\{(c_1x + d_5)g''\} = n_0. \quad (3.6)$$

Taking partial derivative of (3.6) with respect to x gives $m_0c_1g'' = 0$, namely $g(y) = c_2y + d_6$. With similar arguments, we can find if g is a linear function in (3.4), so is f .

Remark 3.3. In Case 2 (i.e. in the case $f(x) = c_1x + d_5$ and $g(y) = c_2y + d_6$), M^2 is an isotropic minimal factable surface in \mathbb{I}^3 with $K = -(c_1c_2)^2$.

Case 3. f and g are non-linear functions. By dividing (3.4) with the product ff'' , we have

$$g''g - \frac{(f')^2}{ff''}(g')^2 + m_0\frac{g}{f} + m_0\frac{g''}{f''} = \frac{n_0}{ff''}. \quad (3.7)$$

By taking partial derivative (3.7) with respect to y and then dividing with $g'g''$, we deduce

$$1 + \frac{gg'''}{g'g''} - 2\frac{(f')^2}{ff''} + \left(\frac{m_0}{f}\right)\frac{1}{g''} + \left(\frac{m_0}{f''}\right)\frac{g'''}{g'g''} = 0. \quad (3.8)$$

We have two cases:

Case 3.1. $g''' = 0$, i.e.

$$g(y) = c_3y^2 + d_7y + d_8. \quad (3.9)$$

Then (3.8) reduces to

$$1 - 2\frac{(f')^2}{ff''} + \left(\frac{m_0}{2c_3}\right)\frac{1}{f} = 0. \quad (3.10)$$

(3.10) can be rewritten as

$$\left(\frac{m_0}{2c_3} + f\right)f'' - 2(f')^2 = 0. \quad (3.11)$$

After solving (3.11), we find

$$f(x) = -\left(\frac{1}{c_4x + d_9} + \frac{m_0}{2c_3}\right). \quad (3.12)$$

Considering (3.9) and (3.12) into (3.4) gives that

$$\frac{c_4^2}{(c_4x + d_9)^4} (4c_3d_8 - d_7^2) - \frac{2m_0c_3}{c_4x + d_9} - m_0^2 = n_0. \quad (3.13)$$

In the particular case $d_7 = d_8 = 0$, we obtain the following contradiction

$$x = -\frac{1}{c_4} \left(\frac{2m_0c_3}{n_0 + m_0^2} + d_9 \right)$$

since x is an independent variable.

Case 3.2. $g''' \neq 0$. By taking partial derivatives of (3.8) with respect to x and y , we conclude

$$\left(\frac{f'}{f^2} \right) \frac{g'''}{(g'')^2} - \frac{f'''}{(f'')^2} \left(\frac{g'''}{g'g''} \right)' = 0. \quad (3.14)$$

Since $f' \neq 0 \neq g'''$, neither f''' nor $\left(\frac{g'''}{g'g''} \right)'$ can vanish in (3.14). Then (3.14) can be rewritten as

$$\frac{f'(f'')^2}{f^2 f'''} = \frac{(g'')^2}{g'''} \left(\frac{g'''}{g'g''} \right)'. \quad (3.15)$$

Since the left side of (3.15) is a function of x , however the right side is a function of y . Then both sides have to be equal a nonzero constant, i.e.

$$\frac{f'(f'')^2}{f^2 f'''} = c_5 = \frac{(g'')^2}{g'''} \left(\frac{g'''}{g'g''} \right)'. \quad (3.16)$$

From the left side of (3.16), we write

$$\frac{f'''}{(f'')^2} = \frac{1}{c_5} \frac{f'}{f^2} \quad (3.17)$$

or, by taking once integral with respect to x ,

$$f'' = \frac{c_5 f}{c_5 d_{10} f + 1} \quad (3.18)$$

for an integration constant d_{10} . Assuming $d_{10} = 0$ in (3.18) gives $f'' = c_5 f$. By putting this in (3.4) we derive

$$(f^2)(g''g) - (f')^2(g')^2 + m_0 f(c_5 g + g'') = n_0. \quad (3.19)$$

Dividing (3.19) with f and then taking partial derivative with respect to x imply

$$g''g - \left\{ 2\frac{f''}{f} - \left(\frac{f'}{f} \right)^2 \right\} (g')^2 = \frac{-n_0}{f^2}. \quad (3.20)$$

If $2\frac{f''}{f} - \left(\frac{f'}{f} \right)^2$ is some constant in (3.20), then, by taking a partial derivative of (3.20) with respect to x , we obtain

$$0 = \frac{2n_0 f'}{f^3},$$

which is not possible since f is non-linear. Now by again taking partial derivative of (3.20) with respect to x , we deduce

$$-\left\{2\frac{f''}{f} - \left(\frac{f'}{f}\right)^2\right\}' \frac{f^3}{2n_0 f'} = \frac{1}{(g')^2}. \quad (3.21)$$

Since $g''' \neq 0$, the right side of (3.21) is a function of y , but the left side is either a nonzero constant or a function of x . Both cases are not possible.

Therefore we have proved the following:

Theorem 3.1. *Let M^2 be a LW-factorable surface which is the graph of $z(x, y) = f(x)g(y)$ in \mathbb{I}^3 . Then we have one of the following statements:*

- (A) $f(x) = f_0 \in \mathbb{R} - \{0\}$, $g(y) = c_6 y^2 + d_{11} y + d_{12}$;
- (B) $g(y) = g_0 \in \mathbb{R} - \{0\}$, $f(x) = c_7 x^2 + d_{13} x + d_{14}$;
- (C) $z(x, y) = (c_8 x + d_{15})(c_9 y + d_{16})$.

By Remark 3.2, Remark 3.3 and Theorem 3.1, we immediately derive the following.

Corollary 3.1. *The LW-factorable surfaces in \mathbb{I}^3 are only the ones whose both K and H are constants.*

4 Graph surfaces with $K = H^2$

Let M^2 be a surface of the Euclidean 3-space \mathbb{R}^3 . The Euler inequality for M^2 including the Gaussian (K) and mean curvature (H) follows

$$K \leq H^2. \quad (4.1)$$

For more generalizations of this inequality, see [6], [24]-[26].

The equality sign of (4.1) holds on M^2 if and only if it is totally umbilical, i.e. a part of a plane or a two sphere in \mathbb{E}^3 .

Now we are interested with the factorable surfaces in \mathbb{I}^3 satisfying $K = H^2$. For this aim, let us reconsider (3.1) and (3.2). If $K = H^2$, then

$$(f''g - fg'')^2 + 4(f'g')^2 = 0. \quad (4.2)$$

(4.2) immediately implies that

$$f''g - fg'' = 0 \text{ and } f'g' = 0. \quad (4.3)$$

By (4.3) we conclude that either $f = \text{const.}$ and $g(y) = c_1 y + d_1$ or $g = \text{const.}$ and $f(x) = c_2 x + d_2$. It yields that a factorable surface satisfying $K = H^2$ is a non-isotropic plane in \mathbb{I}^3 .

Therefore we have proved the following:

Proposition 4.1. *The factorable surfaces in \mathbb{I}^3 satisfying $K = H^2$ are only non-isotropic planes.*

As a generalization of Proposition 4.1, we are able to investigate all graph surfaces in \mathbb{I}^3 satisfying $K = H^2$. More precisely, let M^2 be a graph surface of the smooth function $z = z(x, y)$ in \mathbb{I}^3 . If $K = H^2$ on M^2 , then we get

$$(z_{xx} - z_{yy})^2 + 4(z_{xy})^2 = 0. \quad (4.4)$$

(4.4) yields that

$$z_{xy} = 0 \quad (4.5)$$

and

$$z_{xx} = z_{yy}. \quad (4.6)$$

By (4.5), we derive

$$z(x, y) = \alpha(x) + \beta(y) \quad (4.7)$$

and considering (4.7) into (4.6) gives

$$\frac{d^2\alpha}{dx^2} = \frac{d^2\beta}{dy^2} = d_3, \quad d_3 \in \mathbb{R}. \quad (4.8)$$

By solving (4.8), we find

$$\alpha(x) = \frac{d_3}{2}x^2 + d_4x + d_5, \quad \beta(y) = \frac{d_3}{2}y^2 + d_6y + d_7. \quad (4.9)$$

(4.9) implies that M^2 is either a non-isotropic plane ($d_3 = 0$) or a parabolic sphere ($d_3 \neq 0$) of \mathbb{I}^3 . For more details of planes and spheres in \mathbb{I}^3 , see [29, 32].

Consequently, we have

Theorem 4.1. *A graph surface of a function $z = z(x, y)$ in \mathbb{I}^3 with $K = H^2$ is either (a piece of) a non-isotropic plane or (a piece of) a parabolic sphere given by*

$$z(x, y) = c_3(x^2 + y^2) + d_8x + d_9y + d_{10}.$$
